The handshake that may end a recurring nightmare

lulations, song and dance erupted in a packed hall in Ethiopia's capital, Addis Ababa, as South Sudan's President Salva Kirr and rebel leader Riek Machar signed what they called the "final final" peace deal.

The two hugged and smiled as they exchanged the signed documents at an extraordinary summit of regional leaders, who have been pushing for the former enemies to end a brutal five-year civil war that has killed tens of thousands of people and forced four million people from their homes. It has taken 15 long months of shuttling between the region's capitals to negotiate this latest attempt to bring peace to the world's youngest nation.

"As we witness this historic milestone, we remember and grieve for the victims of the violence and hope this agreement closes that dark chapter in South Sudan," Ethiopian Prime Minister Abiy Ahmed said after the signing.

And it has been a dark and

shameful period for the country - with both sides accused of horrendous atrocities. The UN has documented horrific accounts of gang rape, throats being slit and mass shootings.

Amid hyperinflation, aid agencies have warned again that the humanitarian situation in the oil-rich country

continues to worsen, with millions facing starvation.

Speaking to the BBC after the ceremony, negotiators from both sides said they realised the task ahead in bring lasting peace for their people.

"Our people are right to doubt us, because we have let them down so many times," opposition negotiator Stephen Par Kuol said.

"But this time around, we are telling the people of South Sudan to count on us to implement this agreement fully."Martin Lomuro, South Sudan's cabinet affairs minister, agreed that the "severity of the war" had dented confidence.

"But this is much more of an agreement that is designed to

lay a foundation for a new country and this is why I feel so good about it because before we haven't had a chance to build a proper nation," he said.

Realistically both sides have reached a stalemate - and run out of money. Plus pressure from South Sudan's neighbours, who are hosting many of those who have fled, has led to a more sober reconciliation.BBC



World leaders bid farewell to Kofi Annan

orld leaders and royalty have paid their respects to one of Africa's most famous diplomats, Kofi Annan, at his funeral in his home country of Ghana.

It is the climax of three days of mourning which saw thousands of Ghanaians file past his coffin as it lay in state in the capital, Accra.

Annan died on 18 August in

Switzerland at the age of 80.He was UN secretary-general from 1997 to 2006, the first black African to hold the world's top diplomatic post.

He was awarded the Nobel Peace Prize in 2001 for helping to revitalise the international body, during a period that coincided with the Iraq War and the HIV/Aids pandemic. Mourners in


traditional black and red attire filled the main hall of the Accra Conference Centre, which sits about 4,000 people. More are watching proceedings on a giant screen in an auditorium just outside the hall.

There have been hymns and a performance by soprano and human rights campaigner Barbara Hendricks.

Annan's nephew Kojo Amoo-Gottfried read a eulogy, describing how he had led a hunger strike in his secondary school to protest against the quality of food in the dining hall. There were also a moving tribute by his wife, Swedish lawyer and artist Nane Maria Annan. She described how her husband was always excited to return home, and thanked Ghana for giving the world such an extraordinary man.

She said her husband had an irresistible aura of radiant warmth.Ghana's President Nana Akufo-Addo described Annan as "one of the truly

More than 50 dead in Sudan landslide



ore than 50 people are now known to have been killed in a mudslide in a mountainous area of Sudan's Darfur region.

The disaster happened in a remote area in Jebel Mara on Friday, when heavy rainfall caused a hillside to collapse onto a village.

But details are only now emerging due to the remoteness of the area affected. There were many children among the dead, a local official, Amin Muhamad Osman told BBC Focus on Africa.

"This is such a remote area that the affected villages are out of mobile phone coverage, so locals have to walk 7km to get phone reception. We are now trying to coordinate relief efforts."BBC

"But we are grateful that God used him over the years to work for humanity, for peace. Today, as he lies here, he has finished his work."BBC

The war crimes ${f bill}^1$ before U.S. Congress

THE UNITED STATES Government for the very first time sends a very strong signal on growing calls for the establishing of a war crimes court for Liberia by the introduction of Resolution 1055 in the 2nd Session of the 115th Congress, seeking a war crimes tribunal for Liberia to prosecute suspected perpetrators of war and economic crimes here.

THE RESOLUTION WAS introduced in Congress on Friday, September 7, 2018 by U.S. Lawmaker Daniel M. Donovan Jr., a Republican from New York, and Co-sponsored by Congressman Hank Johnson, a Democrat from Georgia.

THE ACTION BY Congress comes at the time when officials in Liberia are providing variant interpretations of the Truth and Reconciliation Commission (TRC) process in the country which calls for prosecution of people, who committed heinous crimes during the civil war as contained in its final recommendation.

SOME MEMBERS OF the 54th Liberian Legislature, including Speaker Bohfa Chambers and Senator Prince Johnson are vehemently against war crimes court, with the Speaker calling for restorative justice instead, while Sen. Johnson, a former rebel leader, is claiming amnesty from prosecution.

BUT IN THEIR joint resolution, both Representative Donovan, Jr. and Congressman Johnson remind that the Government of Liberia has not fully implemented the recommendations of the Truth and Reconciliation Agreement to date, including the establishment of an Extraordinary Criminal Tribunal, noting the TRC listed individuals, corporations, and institutions recommended for further investigation and prosecution, among other recommendations.

THE BILLS BEFORE the U.S. Congress seems to strongly indicate that America wants an end to impunity in Liberia, and those who think it is business as usual, should rethink now.

EVEN LIBERIANS THEMSELVES are calling for justice. Too often, they have been threatened and misled by people who plunged their lives in misery to believing if they entrusted them with state power the country will be better. But that's an illusion.

AS LONG AS warlords and their political advisors and financiers continue to parade the corridors of power in our nation despite their past deeds, this nation will continuously swim in a vicious circle of fragile peace and violence.

WE CAN BUT only hope the Weah administration will exercise wisdom and good leadership for the sake of the hundreds of thousands of our fellow compatriots, including women, children and elders were forced to their graves thru the barrel of the gun, by heading the call from the U.S. Congress and Liberians both at home and abroad for the establishment of a war crimes tribunal to stamp out impunity.

To give more young women the opportunity to develop their talents and put their skills to work, today's leaders must clear a path for the female leaders of tomorrow.

destined for leadership. My dad never let me forget that heady observation, and as a result of his constant encouragement, I took every opportunity I had to pursue our friend's prophecy. Today, I owe much of my success to my late father, whose belief in me was unwavering.

Unfortunately, most African girls are not as lucky as I was. While many girls possess leadership qualities, social, political, and economic barriers stymie their potential. This is especially true for girls in rural parts of Africa, where poverty, abuse, and tradition conspire to limit opportunity.

The heartbreaking story of my childhood friend, Chrissie, is illustrative. Chrissie was the star student in the village in Malawi where I grew up. But she dropped out of secondary school because her family could not afford the \$6 in monthly fees. Before Chrissie was 18, she was married with a child; she has never left the village where we were born.

Chrissie's experience is repeated millions of times over in my country, across Africa, and around the world. Today, more than 130 million girls worldwide are out of school through no fault of their own. By the time many African girls turn ten, their fate is already determined. Some are victims of harmful cultural practices, like female genital mutilation and child marriage, while others are unable to escape the poverty that grips their families and communities.

send to school, and in many regions, boys are viewed as "safer" investments. Girls, meanwhile, are married off, or sent to work in the fields or as domestic helpers. These decisions about the allocation of educational opportunity severely stunt female leadership potential.

One of the objectives of the Joyce Banda Foundation is to strengthen the financial independence of Malawian women, and thereby create the conditions for the development and emergence of young girls as future leaders. Evidence shows that when women work, they invest 90% of their income back into their families,

> Changing endemic cultural norms about gender and identity - and developing more female leaders - begins in the classroom. School-age girls must be taught to value themselves and one another, and that it is their right to be educated, healthy, and empowered. At the Joyce Banda Foundation School in Blantyre, Malawi. educators have adopted a curriculum based on four building blocks: universal values, global understanding, service to humanity, and excellence.

> Parts of Africa are moving in the right direction. Today, nearly a quarter of Sub-Saharan Africa's lawmakers are women, up from just 10% in 1997. Rwanda, meanwhile, has the highest percentage of female legislators in the world. And throughout Africa, women have been elected to leadership roles at all levels of government.

> Still, much work remains. As the Bill & Melinda Gates Foundation will make clear in its annual Goalkeepers report later this month, governments must recommit to supporting female leaders' development by investing in the health and education of women and girls. Delivering services to girls under ten years of age, especially in rural areas, is essential if Africa is ever to achieve lasting gender equality.

Over the course of my career in Malawi first in civil society, then as a Member of Parliament, and finally, as president - I became convinced that the only way to Economic bias is especially damaging to change Africa's misogynistic narrative is by girls. He was disgraced by the lawmakers, handcuffed and jailed following his failure to speak to matters involvinh him and Bomi County Representative Edwin Melvin Snowe during a contempt hearing before the House of Representatives.

The contempt hearing results from Fahngon's insults and loose accusations against Snowe during a recent street encounter in which he is seen in a video, pointing his finger at the lawmaker's face .--Edited by Winston W. Parley

Monrovia say they have suspended 14 officers for the alleged disappearance of murder suspect Alusin Jalloh, a Sierra Leonean national.

Alusin is alleged to have murdered and extracted the body parts of his seven - year old foster son Victor Fahnbulleh.

The police's administrative action is triggered by a mass protest by residents of Montserrado County District #17 who recently petitioned lawmakers to summon and demand police chief Col. Patrick Sudue to produce the escapee's living body.

In a release issued Thursday, 13 September, the police warned all officers to be

Police say these officers are

being held in connection to the improper and illegal release of Alusin Jalloh who allegedly murdered seven years old victim Victor Fahnbulleh of the Virginia Community.

Speaking to reporters Thursday, 13 September, Police Spokesman Moses Carter says two officers in person of Patrolman Amos N. Neeplay, and Patrolman Thomas G. Cheayee have been suspended indefinitely and charged with the crime of obstructing government functions in violation of Chapter 12, Subchapter "A" Section 12.3 of the Penal Code of Liberia.

Mr. Carter has sounded a strong caveat to all officers of the LNP to be very mindful in the discharge of their duties.

"Any officer caught violating the Standard Operations Procedure (SOP) and the Duty Manual of the LNP will face the full weight of the laws of the Republic," he says.

He assures the family of the murdered seven year old boy that the LNP will do everything humanly possible to ensure that justice is served.

According to him, suspect Alusin will face re-arrest, indicated that the LNP is working very hard with its Interpol counterparts and Joint Security Officers assigned at various entry points of the 15 counties here.--Press release

Il a été humilié par les législateurs pour avoir insulté et accusé vaguement Edwin Melvin Snowe, représentant du comté de Bomi. Il a été honteusement





menotté sur ordre des législateurs et mis en prison après plusieurs heures d'audience pour outrage.

M. Fahngon a passé sa première nuit de détenu au siège de la police nationale du Libéria parce que la prison centrale de Monrovia était fermée au moment où les législateurs rendaient leur verdict.

La Chambre des représentants a dit avoir pris la décision parce que Fahngon a refusé de s'expliquer lorsque lui et son patron, le ministre de l'Information, Eugene Nagbe, ont comparu mercredi. Fahngon a tenu à ne mot dire jusqu'à ce que son avocat se présentât. Mais ce dernier n'est jamais arrivé.

Il a fait valoir que les législateurs lui avaient demandé de comparaître avec son avocat à 11 heures, ce qu'il prétend avoir fait, mais sans son avocat qui devrait le rejoindre. Il a attendu en vain jusqu'à 13h pour apprendre que ce dernier ne serait pas disponible. Il a expliqué qu'on lui a demandé de parler en absence de son avocat, ce qu'il a refusé de

faire, citant l'article 21 (c). Mais le président de la Chambre des représentants, M. Bhofal Chambers, a fait comprendre à M. Fahngon que son avocat ne serait là que pour le conseiller et non pour parler pour lui.

Les parlementaires se sont donc réunis en séance exécutive et décidé au cours de cette séance d'appeler l'avocat de l'accusé.

La confrontation entre le député Snowe et le ministre Fahngon n'était qu'une altercation de rue entre deux citovens. Tout a commencé quand le législateur a tenté de faire libérer un employé du palais de l'Assemblée législative, Kelvin D.J. Matadi, qui avait été emprisonné par le ministre.

Fahngon avait fait arrêter Matadi pour l'avoir pris en photo pendant qu'il dansait dans une boite de nuit. Matadi avait été donc placé en détention dans un commissariat de police. 

'économiste en chef de la Banque mondiale pour l'Afrique, Albert Zeufack, a rendu public le rapport d'Évaluation des politiques et des institutions en Afrique (CPIA), le Libéria ayant récolté la note de 3,1%.

M. Zeufack a fait savoir que la revue révèle une qualité inchangée des politiques et des performances institutionnelles en Afrique.

L'Évaluation des politiques et des institutions en Afrique (CPIA) est un outil de diagnostic annuel destiné à mesurer la qualité des structures politiques et institutionnelles publiques, et leur capacité à soutenir une croissance durable et à réduire la pauvreté. Ce rapport attribue à chaque pays des notes selon 16 critères, ainsi qu'un score global. Son objectif est de renseigner les pouvoirs publics sur l'impact de leurs efforts déployés pour soutenir la croissance et lutter contre la pauvreté. Les notes obtenues servent aussi à déterminer le volume des prêts concessionnels et des dons que la Banque mondiale accorde aux pays à faible revenu d'Afrique subsaharienne.

Les pays sont notés sur une échelle de 1 (note la plus faible) à 6 (note la plus élevée) pour 16 indicateurs de développement regroupés dans quatre catégories : gestion économique ; politiques structurelles; politiques d'insertion sociale et d'équité ; gestion et institutions du secteur public. En 2017, la note moyenne pour la région ressortait à 3,1. La situation est toutefois très contrastée entre les 38 pays d'Afrique subsaharienne qui bénéficient de l'aide de l'Association internationale de développement (IDA) (figure 1). Le Rwanda demeure en tête du classement régional et mondial, avec une note de 4. Parmi les autres pays arrivés en tête du classement régional, on trouve le Sénégal, avec la note de 3,8, suivi de près par Cabo Verde, le Kenya et la Tanzanie, qui obtiennent tous les trois la note de 3,7.

L'efficacité de l'investissement est d'autant plus grande que la qualité des structures institutionnelles est meilleure

Il y a une corrélation entre l'efficacité de l'investissement et la qualité des politiques et des institutions, et cette corrélation est plus forte en ce qui concerne l'efficacité de la gestion du secteur public. Bien que la corrélation ne soit pas nécessairement synonyme de causalité, les institutions d'un pays peuvent créer des incitations à investir, encourager l'appropriation technologique et favoriser l'accumulation de capital humain, ce qui facilitera une croissance plus forte sur le long terme. En revanche, des institutions faibles risquent d'encourager la recherche de rente et la corruption, rendant les activités moins productives. Elles risquent également de décourager l'investissement des entreprises et l'accumulation de capital humain, conduisant ainsi à une croissance plus faible.

La qualité moyenne des politiques et des institutions dans les pays d'Afrique subsaharienne est restée, dans l'ensemble, inchangée en 2017. Cette stabilité contraste avec la détérioration observée les années précédentes. La tendance à la stagnation de la note globale de la CPIA dans la région en 2017 se reflète dans celle de la gestion économique.

Les pays africains doivent surveiller la progression de leur ratio dette publique/PIB

La note régionale dans le domaine de la politique de la dette est tombée à 3,1 en 2017. Cette détérioration intervient pour la deuxième année consécutive. Elle reflète le poids croissant de la dette publique dans les pays africains. L'alourdissement du fardeau de la dette pose des risques de non soutenabilité de l'endettement public à terme. La composition de la dette a en outre changé, les pays tendant davantage à se financer sur les marchés, au détriment des emprunts concessionnels traditionnels. En mars 2018, près de la moitié des pays à faible revenu de la région présentaient un risque élevé de surendettement ou étaient surendettés, soit plus du double par rapport à 2013.

Le développement de l'Afrique dépendra de sa capacité à exploiter les possibilités offertes par les nouvelles technologies La part des adultes disposant de comptes bancaires mobiles en Afrique subsaharienne est passée de 12 à 21 % entre 2014 et 2017. Cette augmentation est, de loin, la plus élevée parmi toutes les régions du monde. La mise en place progressive, au niveau des pays, de systèmes régionaux centralisant l'évaluation du crédit offre des perspectives de meilleure inclusion financière au cours des prochaines années. Les Africaines doivent prendre leur place au sommet

ans, un ami de la famille a dit à mon père qu'il pensait que j'étais destiné à de grandes choses. Mon père m'a toujours rappelé cet enivrant augure et grâce à son encouragement constant, j'ai saisi toutes les occasions pour que la prédiction de notre ami se réalise. Aujourd'hui, ma réussite est due en grande partie à mon défunt père, qui a toujours cru en moi.

Hélas, la plupart des jeunes Africaines n'ont pas eu cette chance. Même si beaucoup de jeunes filles possèdent des qualités de dirigeantes, des barrières sociales, politiques et économiques contrecarrent leur potentiel. C'est particulièrement vrai pour les jeunes filles dans les régions rurales de l'Afrique, où la pauvreté, les sévices et la tradition font partie du complot qui limite leurs horizons.

Le témoignage déchirant de mon amie d'enfance, Chrissie, est éloquent. Chrissie était l'élève modèle dans le village du Malawi où j'ai grandi. Mais elle a dû quitter l'école secondaire, car sa famille n'avait pas les moyens de payer les frais mensuels de 6 \$. Avant ses 18 ans, elle était déjà mariée et mère d'un enfant¹; elle n'est jamais sortie du patelin où elle est née.

Le parcours de vie de Chrissie se répète à des millions d'exemplaires dans mon pays, dans toute l'Afrique et dans le monde entier. Aujourd'hui même, plus de 130 millions de jeunes filles dans le monde ne vont pas à l'école et ce ne sont pas elles qui en décident. Dès que les jeunes Africaines atteignent dix ans d'âge, leur sort est déjà réglé. Certaines sont victimes de coutumes rétrogrades, comme la mutilation des organes génitaux féminins et le mariage d'enfants"; pour d'autres, leurs familles et communautés en proie à la pauvreté les empêchent d'améliorer leur sort.

La discrimination économique nuit particulièrement aux perspectives des jeunes filles. Lorsque les ressources sont limitées, les familles de peu de moyens doivent decider lequel de leurs enfants ira à l'école. Dans bien des régions, les parents jugent que les études des garçons constituent un investissement plus «"sûr"». Pour les filles, ils préfèrent les marier ou les envoyer travailler dans les champs ou comme domestique. Cette discrimination endémique retarde grandement la participation potentielle des femmes aux décisions collectives.

L'un des objectifs de la Fondation Joyce Banda consiste à renforcer l'indépendance financière des femmes du Malawi et par ce fait même de créer les conditions du développement et de l'épanouissement futur de jeunes filles dans des postes décisionnels. Les faits tendent à montrer que lorsque les femmes travaillent, elles réinvestissent 90 % de leur revenu pour le bien-être de leur

OMBA, MALAWI - Alors que j'avais huit famille, au lieu de 35 % pour les hommes. Mieux encore, dès que les femmes ont leurs propres sources de revenus, elles sont plus en mesure de participer à la vie politique.

> Pour faire évoluer les normes culturelles endémiques liées à l'identité sexuelle – et former plus les dirigeantes de demain —, il faut commencer en classe. Il faut inculquer aux jeunes filles d'âge scolaire des notions d'estime de soi et d'autrui et leur confirmer qu'elles ont droit de poursuivre des études, de vivre leur vie en santé et de devenir autonomes. À l'école de la fondation Joyce Banda à Blantyre, au Malawi, les enseignants ont adopté un curriculum qui repose sur quatre pierres d'assise : adhérer à des valeurs universelles, adopter une vision globale, rendre service à la communauté humaine et rechercher l'excellence.

> Plusieurs régions de l'Afrique se dirigent dans la bonne direction. Aujourd'hui, près du quart des législateurs de l'Afrique subsaharienne sont des femmes, en hausse de 10 % depuis 1997. pposition Alternative National Congress (ANC) political leader Alexander Cummings is alarming here that the governance process under the leadership of President George Manneh Weah is speedily deteriorating.

During a press conference Thursday, 13 September, Mr. Cummings warned that if nothing is done, it could lead the country to a downward trend in the near future.

Mr. Cummings says while it will be immature for anyone to judge the government with barley eight months in power, he however observes that there are indicators from the administration that seem to point in the wrong direction.

According to him, those indicators must claim the attention of all peace loving Liberians and those that believe in good governance.

Making his case further, Cummings points to legislative processes geared towards the impeachment of Associate Justice Kabineh M. Ja'neh, based on claims levied by ruling party Coalition for Democratic Change (CDC) representatives Thomas Fallah and Acarous Gray.

The House of Representatives has passed a bill of impeachment and forwarded the instrument to the Liberian Senate where it is being reviewed for Senators' action.

If the Senate concurs, Associate Justice Ja'neh will

have to face impeachment trial.

But Mr. Cummings believes that the lawmakers' action against Justice Ja'neh has no legal basis but only intended to settle political score.

According to him, the impeachment proceedings are also intended to silent another independent branch of government who's member

provided by the House of Representatives.

According to Article 71, the Chief Justice and Associates Justices of the Supreme Court and the judges of subordinate courts of records shall hold office during good behavior.

It says they may be removed upon impeachment and conviction by the Legislature based on proved misconduct,

suggest to international partners that Liberia as a country is not carefully observing its extractive sector.

The Extractive Industries Transparency Initiative (EITI) is a global standard for the good governance of oil, gas and mineral resources.

It seeks to address the key governance issues in the extractive sectors.

The EITI Board decided on 4 September 2018 to suspend Liberia for not having published the EITI report for the fiscal period ending June 2016 within the 1 July 2018 deadline.

The decision followed a request by the Government of Liberia to extend the reporting deadline, set by the EITI Standard.

The Board found that the request did not meet the criteria for granting an extension.

The ANC political leader indicates that the suspension of Liberia from the board is an embarrassing situation that should be addressed speedily in order to regain the confidence of the international community and investors.

Speaking on the economy of the state, Cummings points out that government is yet to stabilize the foreign exchange rate here, noting that business tycoons are the ones who decide the rate for the next day despite government efforts.--Edited by Winston W. Parley

He murdered the victim before his family after an encounter at the Parker Paint Intersection where Demann informed the deceased that he was under arrest for violating government regulation banning motorcycles in the area. Defendant Demann allegedly used excessive force on 29 April resulting to the death of victim Lamin, a resident of the Soul Clinic Community.

Marketers protest outside Court

arket women here have begun a mass protest against Vice President Jewel Howard Taylor's suspension of the president of the Liberia Market Association (LMA) and two other top officials.

Dozens of LMA protesters who had assembled outside the Civil Law Court at the Temple of Justice in Monrovia threaten to close markets and continue protesting for three days to compel VP Taylor to reinstate LMA president Madam Alice Yeebahn.

Madam Taylor recently suspended LMA president Madam Yeebahn; LMA vice president Abraham Barchue; and LMA Assistant Secretary General Madam Lawuo Hiami.

Madam Taylor's office says she suspended the officials due to alleged perennial allegations of corruption, financial mismanagement, misappropriation of resources and other acts inimical to the existence of the Association.

But during a protest outside the Civil Law Court where some marketers said they have filed a lawsuit, they insist that their president return to office while an audit is conducted.

In an interview with a spokesperson for protesters, Yaessey Jalloh said "we want our president back ... or we will close down all businesses."

According to Yaessey who sells at Redliglight Market in Paynesville, Vice President Taylor suspended LMA's president on grounds that she wanted an audit to be conducted at the entity.

"Our president can go back in office then audit can go on," Yaessey insists.

According to her, over 30 markets were represented by protesters outside the court at the Temple of Justice, and warns that they will continue if they did not get result on Thursday, 13 September.

According to Yaessey, the suspended LMA president has carried some improvements at the institution, including rise in workers' income.

She claims that Madam Yaessey's suspension comes as a result of alleged jealousy.

for the reopening of the case, Court "C" read the indictment to the indictees Thursday to begin a new trial.

The two indictees pleaded not guilty, thus joining issues with the government.

But their lawyer Cllr. Arthur T. Johnson informed the Court that "another jury trial" at Court "C" is prohibited by law because the same court already has an ongoing jury trial there.

Cllr. Johnson says the defendants are exercising their constitutional rights under Chapter 3 Article 21 (h) that addresses the rights to jury trial.

The counsel requests that

his clients be purged of jury trial and that Judge Boima Kontoe sit as jury de factor to decide both the issues of facts and law.

Judge Kontoe has granted the defense's request, but he has deferred further proceedings in the case to Tuesday, 18 September at 1pm.

The case sparks out of an alleged criminal scheme claimed by prosecutors in which co-defendants Parker and Kpabar-Pailey are accused of having awarded two "sole source" contracts to codefendant Deneah Martins Flomo and his Denmar Enterprise.

Murderer officer gets 25 yrs

he Criminal Court "A" at the Temple of Justice has sentenced disrobed police commander Roosevelt Demann to 25 years prison term for the murder of motorbike operator Benyan Lamin this year.

But convict Demann's lawyer Cllr. Augustine C. Fayiah has announced an appeal to the Supreme Court against the ruling.

Following the court's ruling Thursday, 13 September at the Temple of Justice, convict Demann was placed under correction officers' custody and taken to the Monrovia Central Prison.

He will serve 20 years in prison, and the remaining five years on community service if he continues to exhibit good conduct during his prison term

Cllr. Fayiah, however, says he may not agree with the ruling, but the law has taken its course because he does not expect people to believe in the strength of men but in the rule of law.

However, he hinted of exercising his right under the law by appealing to the Supreme Court. According to him, he is of the view that the State did not prove the "intent" for the crime the suspect has been convicted for.

He claims the sentence was unrealistic. "When ... someone is charged for infamous crime, whether they plead guilty or not, that plead, it does not mean anything because the court will set that plead aside and enter the plea of not guilty. So whether he plead guilty or not, the State must still prove the case," he argues.

In consultation with his client, Cllr. Fayiah says the indictee "has taken the risk"

Family, friends and loyalists of Ms. Parker and codefendant Kpabar - Pailey were seen in jubilant mood in the courtroom Thursday, 13 September when they heard that Judge Boima Kontoe had granted bench trial in the retrial of the case.
