

Ethiopia's Abiy gives half of ministerial posts to women

thiopia's Prime Minister Abiy Ahmed has appointed women to half of his government's ministerial posts, including the job of defence minister.

Explaining his decision in a speech to Parliament, Mr Abiy said women were "less corrupt than men" and would help restore peace and stability.

Ethiopia is now the only African state after Rwanda to have equal gender representation in the cabinet.

Mr Abiy also cut the number of ministerial jobs from 28 to 20. Since becoming prime minister in April, he has carried numerous massive reforms.

He has ended two decades of conflict with neighbouring Eritrea, released thousands of political prisoners and loosened the state's tight grip on parts of the economy.

Aisha Mohammed was named as Ethiopia's first female defence minister. She is from the country's Afar region in the north-east, and had served as construction minister.

Muferiat Kamil, the former speaker of parliament, became the country's first Minister of Peace. She will be overseeing the country's intelligence and security apparatus, including the federal police. Mahlet Hailu,

Ethiopia's deputy permanent representative to the UN, tweeted the list of new ministers:

50% Femmes!!!. Maintien de la parité de genre au sein du remaniement du gouvernement du Premier Ministre de l'#Ethiopie. Un nouveau elan pour délivrer les reformes Mr Abiy said that

his reform process needed to continue to address the structural and strategic problems that pushed the country into chaos.

He said women had made a great contribution to restoring peace and stability, were less corrupt, respected their work and could sustain the drive for change. The 42-year-old became prime minister in April after the unexpected resignation of

Hailemariam Desalegn.

It followed three years of protest led by ethnic Oromos, who were demanding an end to what they considered their political and economic marginalization.

Mr Abiy is Oromo himself, but his appeal for trust and unity to "heal our wounds... and work together to develop our country" has received a cautious welcome from many within Ethiopia.-BBC



Uganda says landslide death toll rises to 43, begins relocations

he death toll from a landslide in Uganda last week has risen to 43 and displaced residents deemed most at risk in the disaster-prone region will be resettled immediately, the government said on Tuesday.

vernment said on Tuesday. Torrential rains unleashed a deluge of boulders, mud and water down Mount Elgon near the border with Kenya, uprooting trees, pulverizing homes and burying residents in the town of Bukalasi and some nearby villages.

Landslides have become more common in mountainous

parts of the East African country in recent years because of expanding settlement and cultivation that have denuded mountainsides of forest cover and other vegetation.

A government statement put the final death toll at 43, up from an initial figure of 31, and said a further 21 people were injured with around 800 left homeless.

It said the cabinet had "directed resettlement of persons at risk of (further) landslides to begin immediately". Around 32.7 billion shillings (\$8.66 million) had been allocated to finance emergency relocations of the most vulnerable people.

A 2,800-acre plot had been procured for relocations, with a further 5,500 people also vulnerable to landslides to follow the initial 800. In all, some 100,000 people deemed to be living in the likely path of landslides will be resettled in coming years.-Reuters

Boko Haram faction kills second aid worker in Nigeria

n aid worker with the International Committee of the Red Cross (ICRC) has been killed in Nigeria by Islamist militants who kidnapped her last March.

Hauwa Liman, a midwife, was killed days after kidnappers set a deadline.

The ICRC said it was devastated by the news. The Nigerian government called the murder "inhuman and ungodly".

Ms Liman was taken with two others in the northern Nigerian town of Rann. Fellow midwife Saifura Ahmed Khorsa was killed last month. What more do we know about the kidnappings?

Ms Liman, 24, and Ms Khorsa were working with internally displaced people at a health centre supported by the ICRC in Rann, Borno State, the epicentre of militant activity. Alice Loksha was working as a nurse in another centre supported by Unicef.

They were abducted after Iswap fighters attacked the town on 1 March 2018. Three other humanitarian workers and eight members of the security forces were killed in the attack.

Last month, the ICRC

Ms Sharibu was one of 110 schoolgirls who were kidnapped in the northern town of Dapchi last February. Most of the other students were freed but Ms Sharibu, who reportedly refused to convert to Islam, remains in captivity.

received a video showing the killing of Ms Khorsa.

Exactly a month later, on Monday, another video appeared showing the killing of Ms Liman. A local reporter, who said he had seen it, reported that Ms Liman was shot at close range.

The ICRC said she was a "sociable, dynamic and enthusiastic woman who was much loved by family and friends. She was truly dedicated to her work helping vulnerable women in her family's home area".-BBC

Where the Ministry of Education fails

THE DEPTH OF complacency or sheer lack of supervisory will, by educational authorities in the country, particularly officials at the Ministry of Education has come to public glare with the excruciatingly damning reports of persistent rape of young girls between ages 10 and 16 at More Than Me Academy, infecting the victims with the HIV virus.

WE BELIEVE STRONGLY if the Ministry of Education had effectively exercised its supervisory functions at learning institutions across the country, the sad situation involving less fortunate and vulnerable little girls at the American-run charity where its Liberian liaison officer, HIV/AIDS-positive Mcintosh Johnson persistently raped and infected his preys, from 2014 up to his demise in prison in 2016 would have quickly been brought to check.

NEWS ABOUT THE incident broke here after separate publications by two American outlets, ProPublica and TIME, respectively, graphically detailing the abuses.

CHIEF EXECUTIVE OFFICER (CEO), Ms. Katie Meyler confirms the number of girls, who were raped at the MTM Academy, could have been a quarter of the school, saying, "Everyone over the age of 11."

HOW COULD THE Government of Liberia, particularly the Ministry of Education, which licensed MTM Academy, and placed 20 schools in its care under the Liberia Education Advancement Program or LEAP turn a blind eye on what unfolds in those institutions that saw our young girls or dare say, babies being sexually exploited, abused and infected, as they suffered.

THE MINISTRY'S COMPLACENCY is so glaring, as indicated in statement issued by the charity, calling on the Ministry of Education to visit the Academy at any time for a complete inspection. Does the Ministry need an official invitation to carry on its statutory functions? We say absolutely no! It is not only frustrating, but highly disheartening that, in the words of the Female Journalists Association of Liberia or FeJal, an NGO could carry a humanitarian face yet leads its targeted beneficiaries through another dark and bleak path with life-threatening consequences.

MORE THAN ME is an American charity that was reportedly established in 2009 by U.S. citizen Katie Meyler, to rescue vulnerable girls in Liberia by taking them off the streets into schools, specifically from the densely populated impoverished slum community of West Point along the U.N. Drive in Monrovia.

BUT REPORTS REVEALED the girls were raped right from the onset of the program that was meant to help transform their lives and give

"WE ARE DEEPLY, profoundly sorry. To all the girls who were raped by Macintosh Johnson in 2014 and before: we failed you.

"WE GAVE JOHNSON power that he exploited to abuse children. Those power dynamics broke staff ability to report the abuse to our leadership immediately. Our leadership should have recognized the signs earlier and we have and will continue to employ training and awareness programs so we do not miss this again. We are moved by the courage and bravery of the girls who came forward and it is a tragedy that they ever had to. To the survivors that have HIV, we remain committed to supporting you. We are heartbroken by what happened and also have fundamentally changed how we operate as an organization since this incident", MTM pleads in a statement issued subsequently.

IN A RATHER belated response, the Ministry of Education says it takes all incidents of sexual assault against students extremely serious and will speedily inquire into the article to ascertain the details of allegations made, being aware that its first duty is to protect Liberian children while educating them. But we still maintain this is a responsibility it failed to execute in the first place.

The Martyrdom of Jamal Khashoggi

Arab countries have a long history of rewarding journalists who toe the official line, while punishing those, like the disappeared Saudi commentator Jamal Khashoggi, who dare to speak truth to power. And the United States has a long history of arming their oppressors.

MMAN - The London-based daily Al-Araby Al-Jadeed recently published a cartoon, by the Jordanian artist Emad Hajjaj, depicting a faceless man wearing a red and white keffiyeh and sweeping his brown thawb in such a way that it looks almost like he is performing a magic trick. Whipped up by his movement, papers float around him. At the bottom of the frame, the hand of another man, wearing what appears to be a white button-down shirt, reaches up, apparently having let go of his pen in order to try to grab onto something, to save himself. The caption reads, "The disappearance of Saudi journalist Jamal Khashoggi."

The cartoon names the victim, but not the perpetrator. True, any Arab - indeed, virtually everyone - knows exactly who is responsible for Khashoggi's disappearance: Crown Prince Mohammed bin Salman of Saudi Arabia. But the fact that a well-known cartoonist had to disguise the culprit's image speaks volumes about the fear felt by independent journalists in the Arab world. Khashoggi's disappearance has only deepened their anxiety.

Arab countries have a long history of rewarding journalists who toe the official line, while punishing those, like Khashoggi, who dare to speak truth to power. Since the failed Arab Spring revolutions - of which Tunisia is the only success story - citizens across the region have found themselves with a stark choice between radical Islamist regimes and military rule. Efforts presenting democratic alternatives have been systematically repressed.

Discrediting, constraining, or otherwise silencing independent journalists is a key tool of this repression. Autocratic governments create laws and regulations to protect themselves and their cronies from criticism or exposure by independent media. They claim that only the journalists on their payroll - who praise their rulers and criticize the regime's opponents - are legitimate; all others are enemies of the state.

Such behavior is not limited to dictatorships. Even in the United States - long admired for its robust free press, protected by the First Amendment of the US Constitution, and powerful investigative journalism, which once brought down a president - President Donald Trump's administration routinely attacks independent journalists, labeling them traitors, paid agents, and purveyors of "fake news."

Trump may simply be trying to appease his right-wing base and avoid accountability for his innumerable mistakes and misdeeds. But his attacks on the US press, together with his silence on attacks occurring elsewhere, have gone a long way to embolden violators of press

freedom around the world.

It does not help that many of those pressfreedom violators - including Saudi Arabia - are among America's closest allies. Trump has been true to America's all-too-frequent willingness to place lucrative military contracts ahead of human rights, saying that he would be "very upset and angry" if Saudi Arabia were found to be responsible for Khashoggi 's death, while ruling out a halt to big military contracts.

America's fellow NATO member Turkey is the world leader in imprisoning journalists, yet the Trump administration has complained only about the detention of one (recently released) American pastor, and that was just to placate America's "religious right" (beginning with Vice President Mike Pence). The US authorities have said nothing about Al Jazeera journalist Mahmoud Hussein's nearly two-year detention in Egypt.

Nor has the Trump administration commented on the fact that, in March 2017, the United Arab Emirates sentenced the Jordanian journalist Tayseer al-Najjar to three years imprisonment and a fine of 500,000 UAE dirhams (approximately \$136,000) over a Facebook post. Even countries that are not particularly close US allies - such as Myanmar, where two Reuters journalists have been sentenced to seven years imprisonment - do not face pushback from the US.

Independent journalists have one goal: to find the truth and share it widely. When governments can repress those journalists with impunity, and when others compromise their supposed commitment to basic human rights for political or partisan goals, the truth remains hidden, with serious consequences.

I have known Khashoggi for years, both in a professional and a personal capacity. He is a Saudi patriot, who is not opposed to his country's system of rule. Yes, he has critiqued policies, such as the inhumane war in Yemen and how Saudi rulers deal with dissent. But his arguments were always based on facts. He is not a dissident or a rebel, but a monarchist who wants to see his country do better than it is. And now he may have paid the ultimate price for

For Arab freedom fighters, the road ahead is long and treacherous. Building on the sacrifices of true heroes and genuine democrats, journalists and cartoonists like Hajjaj will continue to speak truth to power, as they fight for basic human rights like freedom of the press. It is truly unconscionable, however, that they must go into battle without the support of those who claim to have their backs.

America's Ongoing Civil War

EW YORK -America continues be in a state of civil war. Not just a civil war, but the civil war. In the first round, back in the 1860s, the Confederacy lost. Yet now the Confederacy is temporarily on top. The United States remains one country divided by two cultures.

From the start, the US has been a battleground of two competing visions. America's founding credo was that "all men are created equal." Yet the founding reality was that white males were far more equal than everyone else. White men owned slaves, denied the vote to women, and took the lands and lives of native Americans.

During the 1861-1865 Civil War, the slaveholding Confederacy, formed by 13 secessionist states, was defeated by 19 northern states and then occupied by the federal government for a dozen years. Yet after "Reconstruction" ended in 1877, the South vigorously practiced systemic racism for almost a century, until the US Congress enacted the 1964 Civil Rights Act and the 1965 Voting Rights Act, mainly with the support of northern Democrats. From that moment, Southern white voters deserted the Democratic Party en masse. The Republicans embraced the so-called Southern strategy, based on resisting the rise of African-Americans and other minority groups and opposing legislation that would transfer any funds, status, or power to them.

The Republicans thereby became the party of the South, and the Democrats the party of the Northeast and Pacific West, with the Midwest and western mountain states the swing regions. The industrial Great Lakes region tended toward the Democrats while the Midwestern farm states and mountain states leaned Republican. The Midwestern and mountain states also carried the frontier culture of white settlers suppressing native Americans and Asian and Hispanic immigrants.

Gun ownership marks another divide between Democrats and Republicans. The Republican Party's gun culture reflects the same cultural forces that shape its antiminority views. In a brilliant book, Loaded, historian Roxanne Dunbar-Ortiz reminds us that the "well-regulated militias" mentioned in the US Constitution's Second Amendment, which enshrines the right to bear arms, were groups of white men that raided native American villages and hunted down escaped slaves.

As Avidit Acharya, Matthew Blackwell, and Maya Sen powerfully argue in their recent book Deep Roots: How Slavery Still Shapes Southern Politics, it is the legacy of slavery and post-Civil War segregation that gave rise to the South's current political culture. "It is within formerly high-slave areas," they show, "that whites are the most likely to oppose the Democratic Party, oppose affirmative action, and express sentiments that could be construed as racially resentful."

Both before and after the Civil War, poor Southern whites accepted their lowly status because they prized their superiority over even more desperate African-Americans. Racial politics thus blocked the emergence of class politics, which would have brought poor whites and poor blacks together to demand more public services paid for by higher taxes on elite whites.

Of the 26 senators representing the 13 former Confederate states today, 21 are Republicans and five are Democrats. Of the 38 senators now representing the 19 northern states of 1861, 27 are Democrats and nine are Republicans (two Independents, Bernie Sanders and Angus King, caucus with the Democrats). President Donald Trump is a geographical anomaly, a pro-southern racist from liberal New York. Trump, a champion of the white male southern culture, is shunned by his home state (59% disapproval as of September 2018). He is more Mississippi than Manhattan.

The cultural divide was on full display in the Senate proceedings that recently confirmed Judge Brett Kavanaugh to the US Supreme Court. Kavanaugh's Senate defenders were mainly white men of the South and Midwest who deflected the questioning of Kavanaugh's white male prerogative to drink and carouse as a young man by instead attacking the nominee's accusers. Mitch McConnell of Kentucky, a former slave state, successfully orchestrated Kavanaugh's confirmation. Lindsey Graham of South Carolina, the first slave state to secede in 1860, was Kavanaugh's most aggressive promoter on the Senate Judiciary Committee, describing sexual assault allegations against Kavanaugh as "the most unethical sham since I've been in politics." John Kennedy of Louisiana, another former Confederate state, called the hearings "an intergalactic freak show."

The Democrats and Republicans are parties not just of different cultures and regions, but also of different economies. The Northeast and Pacific states lead the US in high technology, innovation, higher education, well-paying jobs, and per capita income. The South lags far behind. Not only are the working-class white men of the South and Midwest defending their status and racial privileges; they are also fighting for their jobs in industries where automation and foreign trade have steadily eroded employment.

Working-class southern whites would have much to gain from abandoning the Republicans' race-based politics in favor of class-based politics. It is, after all, white corporate elites, not poor African-Americans, Hispanics, and other minorities, who deprive working-class whites of quality public schools, affordable health care, and environmental safety. Southern white male senators play up the culture war in part to shield the Republicans' mega-rich donors, who feast on corporate tax cuts and environmental deregulation while the party scapegoats African-Americans and Hispanics.

The declining predominance of non-Hispanic whites in the total population has probably widened America's cultural divide during the past 20 years. And with non-Hispanic whites expected to become a minority of the total population by around 2045, America's ongoing civil war could worsen. It will not end until working-class Americans of all regions, races, and ethnicities join forces to demand higher taxes and greater accountability of the rich corporate elite.

The Brexit Endgame

ONDON - The United Kingdom's "Remainers," who still hope to reverse Britain's decision to leave the European Union, have placarded British cities with a simple question: "Brexit - Is It Worth It?" Well, is it?

The answer given by economics is clear: certainly not. In terms of the costs and benefits of leaving, the result of the 2016 Brexit referendum was plainly irrational.

And yet economics also clearly shaped the decision. The Brexit propagandists brilliantly channeled palpable economic resentment, especially against immigration, into hostility toward the EU. But the resentment was against the home-grown damage inflicted on the British economy by its neglectful rulers. As Will Hutton and Andrew Adonis accurately note in their recent book Saving Britain, "Our problems are made in Britain; they can only be solved in Britain. Europe does not impede this mission..."

But Hutton and Adonis miss Brexit's crucial non-economic dimension. They rightly recall the long and intimate relationship between Britain and the European continent. But Britain has never been part of a European state. Although the European Union is very far from being the "superstate" of Margaret Thatcher's nightmare, its governmental aspirations lack legitimacy, not just in Britain, but among many of its members. Despite talk of European citizenship, politics remain obstinately national. Britain's Leave campaign was a revolt against not only economic mismanagement, but also the pretension of supranational government.

One possibility is that Britain doesn't leave the EU after all. The organizers of a campaign for a "people's vote" - a second referendum on the final exit terms - believe that when people know the true cost of leaving, they will reverse the decision taken in 2016. A second vote could be triggered by the government's failure to win parliamentary approval of the divorce settlement it has agreed with the EU.

A second possibility is that Britain "crashes out" of the EU on March 29, 2019, with no divorce deal. In this case, forecasters paint a doomsday scenario of economic collapse, gridlock on roads and rail, shortages of food, medicine, and fuel: 1940 all over again (but not exactly Britain's finest hour).

British Prime Minister Theresa May's government is promoting a third possibility: half in, half out. Approved by the Cabinet in July at the prime minister's country house, the so-called Chequers plan proposes that when Britain leaves the EU, the two sides enter into a free-trade agreement covering goods and agricultural produce, but not services. The plan, devised by May's adviser Oliver Robbins, is a heroic attempt to solve the Irish border problem.

That problem arises from a commitment by both Britain and the Republic of Ireland to keep a "frictionless" border between the Republic of Ireland, which remains in the EU, and Northern Ireland, which, as part of the UK, leaves it. But to maintain an open border in Ireland would mean creating a customs border between two parts of the UK.

Hence the Chequers plan for a continuation of free trade in goods between Britain and the EU. Britain would make sure that goods entering Northern Ireland, but bound for the EU via the Republic of Ireland, paid their EU customs duties and conformed to EU health and safety standards.

The Brexiteers in May's Conservative Party oppose the Chequers plan, because it implies too much integration with the EU. And EU leaders don't like it, either, because Britain cannot be allowed to be in for some purposes and out for others.

The final possibility is another "half in, half out" scenario. Britain would leave the customs union, but remain in the European Economic Area, which includes the 28 members of the EU plus Norway, Liechtenstein, and Iceland. EEA countries, though free to set their own tariffs, follow nearly all of the EU rules and pay contributions to the EU budget. So the EEA option would be even more anathema to hardline Brexiteers than the Chequers plan.

So what will happen? Most bets are on Britain formally leaving the EU in March 2019, but "temporarily" remaining in the customs union, giving it two or three years to negotiate the final divorce settlement. The Brexiteers will be enraged by such a "soft" exit, but it will probably be enough to ensure parliamentary approval. The referendum decision to leave the EU will be honored, but its harsh economic consequences will be postponed: a triumph of pragmatism over ideology.

If the Brexit trajectory turns out this way, it will be a good illustration of the double character -and function - of politics. John Maynard Keynes put the matter well: "Words ought to be a little wild, for they are the assault of thoughts upon the unthinking," he wrote in 1933. "But when the seats of power and authority have been attained there should be no more poetic license. On the contrary, we have to count the cost down to the penny which our rhetoric has despised."

Politicians exist to give voice to resentments bottled up by "unthinking" conservatism. They let loose feelings which we would be better off without, but whose suppression threatens political explosions. But it is also their job to ensure that such irruptions do not have extreme consequences. From time to time, the balancing act breaks down, as it did in 1914, when the momentum of events overwhelmed belated attempts at compromise. It happened again in the 1930s, because fascism and communism were irredeemably extremist. But mostly politicians do their double job, which, in the last analysis, is to preserve domestic and international peace.

Thus, the Brexit compromise, if it happens, may be a moderately optimistic foretaste of the fate of populism in our century. The resurgence of economic nationalism which unites Brexit, Trumpism, and the European far right will not lead to the breakdown of trade, hot wars, dictatorship, or rapid de-globalization. Rather, it is a loud warning to the political center - one that may cause even the current crop of extremists to shrink from the consequences of their words.

eputy Finance Minister for Fiscal Affairs Samora Wolokollie says government is committed to partnering with the Liberia Christian Association of the Blind (CAB) in fighting discrimination against persons with disabilities in Liberia.

The Deputy Finance Minister made the assertion on Monday, 15 October when he proxied for Finance Minister Samuel Tweh at the celebration of the World White Cane Safety Day held at the Monrovia City Hall.

He spoke on the theme: "Engaging Government's Pro-Poor Development Strategy for Inclusive Social Development and Economic Sustainability of the Blind in Liberia."

Deputy Minister Wolokollie asserts that the George Weahled government will develop a sustainable framework for the development of the physically challenged persons, stressing that being a blind person is not a state of choice.

He indicates that after nine months, the government has drafted a pro - poor development agenda for prosperity and development of

the country which will shortly be presented to the Liberian people for their inputs.

Mr. Wolokollie pleads with Liberians not to discriminate against persons with disabilities on the basis of their condition in society.

The Deputy Finance Minister assures that government will increase support to the blind and ensure that they have equal access to education, health and public transportation, and build the capacity of persons with disabilities.

According to Minister Wolokollie, government will also ensure that public buildings are erected in a way that persons with disabilities can access them and provide them with equal work and equal pay.

On behalf of Minister Tweah, Minister Wolokollie presented \$77,500.00 Liberian Dollars to CAB and additional \$5,000.00 Liberian Dollars as his personal package to CAB to enhance the operations of the blind organization.

Meanwhile, CAB is calling on government to pay particular attention to the disadvantaged and underprivileged sector of society during the Poor-Pro Consultation process.

The organization pleads with government to ensure

that persons with disabilities are included in the planning and implementation process.

Additionally, the organization notes that improved security in Liberia will help to prevent disability on grounds that about 25% of disability results from injuries, violence and vehicular accidents.--Edited by Winston W. Parley

Français Scandale financier: Le LP tape fort sur le pouvoir

'opposition accuse le président de la république, le président de la Coalition pour le changement démocratique (CDC) au pouvoir, et les officiels du gouvernement libérien d'avoir semé la confusion pour brouiller l'affaire concernant la disparition présumée de plusieurs milliards de dollars libériens.

S'exprimant dimanche 14 o c t o b r e l o r s d'un e conférence de presse, le président par intérim du Parti de la Liberté, le sénateur Steve Zargo, a fait part de son inquiétude et accusé les représentants du gouvernement d'acheter des maisons dans les pays voisins seulement en moins neuf mois de pouvoir.

Le président George Manneh Weah, la Banque centrale du Libéria et le ministre des Finances, Samuel Tweah, ont affirmé qu'aucun argent n'a disparu.

Mais l'administration a mis en place une commission

d'enquête spéciale chargée de faire la lumière sur cette question d'argent. Elle a aussi invité les partenaires internationaux, y compris les États-Unis, à participer à l'enquête.

Selon le sénateur Zargo, à peine neuf mois à la tête du

pays, le gouvernement de la CDC a provoqué le plus grand scandale financier de l'histoire du pays, faisant spécifiquement référence aux 15,5 milliards de dollars libériens présumés manquants.

Le sénateur de Lofa et

membre du bureau exécutif du LP a indiqué que, compte tenu des prétendues irrégularités et fraudes qui ont entaché les élections de 2017, les Libériens pensaient qu'avec l'arrivée d'une n o u v e l l e é q u i p e gouvernementale, le pays prendrait une toute nouvelle direction.

« Malheureusement, l'émergence du gouvernement CDC a ravivé et renforcé le cauchemar que les Libériens avaient connu avec la corruption sous les administrations précédentes. Du président au ministre des Finances; du ministre des Finances au ministre de la Justice ; du ministre de la Justice au ministre de l'Information; du ministre de l'Information au président du CDC, au maire de la ville de Monrovia, et ainsi de suite, il y a eu une vague de déclarations non coordonnés, imbibées de mensonges et de distorsions d'informations », a affirmé le sénateur Zargo.

Selon le sénateur Zargo, cette affaire de 15 milliards de dollars libériens est la preuve que le gouvernement de la Coalisation pour le Changement démocratique se dirige tout droit dans le gouffre.

Pour lui, le conseil des gouverneurs de la Banque centrale a déjà sapé le travail de la commission d'enquête par le fait de publier ce qui est censé être un rapport interne selon lequel tous les billets de banque imprimés et importés dans le pays sont arrivés à bon port.

« En tant que parti politique qui s'engage à faire respecter la loi, nous avons publié une déclaration le 25 septembre 2018, attirant l'attention du gouvernement sur la nécessité d'une enquête rapide, structurée et indépendante sur cette affaire afin de préserver l'image de notre pays », a déclaré le sénateur Zargo.

Selon lui, une telle démarche permettrait de gagner la confiance des partenaires internationaux du Libéria, principalement des institutions financières auprès desquelles ce pays sollicite de l'aide au développement. "Ceci, pour nous, est la marque d'une opposition mûre", a-t-il ajouté.

Il a dit qu'alors que l'on a t t e n d d e voir le gouvernement prendre honnêtement l'initiative de résoudre ce qui constitue aujourd'hui un casse-tête national, "un vaste projet apparemment destiné à déformer, à confondre et finalement à enfouir l'affaire au fond de la mer, est en train d'être mis en place par les membres du parti au pouvoir."

Répondant à une déclaration du président du parti au pouvoir, Morlu, qui a récemment estimé que le parti de la liberté (LP) devrait faire l'objet d'une enquête car il avait introduit dans le pays une flotte de véhicules pendant la campagne de 2017, le sénateur de Lofa a indiqué que « le Parti de la liberté n'avait jamais exercé de contrôle sur le coffre-fort de la Banque centrale ». « Nous n'avons aucune autorité pour commander l'impression de billets de banque. Nous ne contrôlons pas les points d'entrée (Roberts Field et le port franc de Monrovia). Comment alors aurions-nous pu prendre une partie de vos plus de 15 milliards de LRD pour acheter des pick-ups? ».

Dans le même temps, le Parti de la liberté félicite le gouvernement des États-Unis pour avoir proposé des experts pour aider le pays à déterminer les circonstances entourant les prétendus conteneurs d'argent manquants.

Le parti de Charles Brumskine, candidat malheureux aux élections présidentielles de 2017, a appelé le gouvernement à fournir aux experts étrangers tout le confort dont ils peuvent avoir besoin pour faire leur travail efficacement.

es natifs du comté de Nimba, membres d'une association intitulée « Citoyens de Nimba Unis pour la Paix et la Réconciliation », fustigent avec énergie le sénateur Prince Yormie Johnson qu'ils accusent d'avoir dit du mensonge qui, selon eux, est dangereux pour la population de Nimba.

Le secrétaire général de l'association, Aphonso Korto, s'est inscrit en faux par rapport à la récente déclaration du sénateur Johnson selon laquelle le représentant de Samuel G.

Kogar veut inciter le peuple à la révolte contre le gouvernement du Libéria. « Cette affirmation est fausse et erronée », a-t-il dit dans une déclaration qu'il a lue lundi.

Le représent int Kogar a dû nier avec véhémence, affirmant que jamais il n'a incité qui que ce soit à révolte. Selon Korto, leur enquête indépendante a établi que le législateur de Nimba n'a jamais été associé aux propos que lui prête le sénateur Johnson.

L'association dit regretter que ce mensonge ait non seulement créé une distance dangereuse

entre les deux dirigeants du même comté, mais risque aussi de nuire à l'image de l'ensemble du comté de Nimba. « Comme vous le savez. le comté de Nimba a été affecté par ce type de comportements malsains, comme cela avait été le cas au temps de feu chef Jerry Gonyon qui, dans les années 1990, a mal informé et dit des mensonges au feu président Samuel K. Doe, qui, sans procéder à aucune enquête, a arrêté et tué arbitrairement bon nombre de fils du comté de Nimba. Et malheureusement aujourd'hui, le sénateur Johnson a repris le flambeau du célèbre chef Jerry Gonyon pour confondre les gens de Nimba ", a-t-il expliqué.

Scandale financier : Le ministre de la défense demande au libériens de la fermer

e ministre libérien de la Défense, Daniel ■Ziahnkan, participe désormais au débat sur la disparition présumée des 16 milliards de dollars libériens. Il demande aux libériens, particulièrement aux critiques, de se taire et de permettre au gouvernement et aux partenaires internationaux de mener l'enquête de manière approfondie. « Il serait décent de la part de ces gens s'ils accordent une chance au processus en gardant leurs opinions », a-t-il

Le ministre Ziahnkan a déclaré lors d'une émission radiodiffusée lundi à Paynesville, dans la banlieue de Monrovia : « Ce n'est pas parce que vous connaissez la théorie de la demande et l'offre que vous n'allez pas donner une chance à l'enquête. Je pense que le commandant en chef, le président George Manneh Weah, a ordonné l'ouverture d'une enquête immédiate sur l'argent manquant. Cet ordre devrait être respecté en attendant le résultat de l'enquête. »Du président George Manneh Weah au ministre des Finances en passant par les ministres de la Justice et de l'Information, le président du CDC et le maire de la ville de Monrovia, la liste est longue, il y a eu des flots d'annonces contradictoires sur la disparition présumée des

milliards de dollars libériens.

Le ministre Ziahnkan estime que « trop de commentaire ne contribuera pas à résoudre ce scandale financier. Seule une enquête menée par des experts internationaux et des enquêteurs locaux peut faire toute la lumière sur ce scandale ».Il a salué les États-Unis et l'Union européenne pour avoir accepté de contribuer à la recherche de la vérité, ajoutant que l'intervention de ces deux puissances mondiales permettra à l'enquête d'aboutir à des conclusions fiables répondant aux meilleures normes internationalesEn ce qui concerne l'hôpital militaire, le ministre Ziahnkan a expliqué que les travaux de construction sont en cours et que le gouvernement libérien a débloqué 2 millions de dollars américains. La BAD décaisse € 50 millions pour un projet l'interconnexion routière Guinée - Guinée-Bissau

Les gouvernements de la Guinée et de la Guinée Bissau vont bénéficier de 50 millions d'euros sous forme de dons et de prêt, en financement de la première phase du projet d'aménagement de la route Boké-Québo, corridor routier entre Conakry-Bissau.

Le coût total du projet est estimé à 117,19 millions d'euros. La première phase va coûter 79,94 millions d'euros et la Banque africaine de développement (BAD) a déjà mobilisé 30 millions d'euros de l'Union européenne, rapporte un communiqué de presse de la banque panafricaine publié jeudi.

C'est dans cette perspectives que le Conseil d'administration de la BAD a approuvé au profit de la Guinée un don du Fonds d'assistance technique (FAT) de 4,07 millions d'euros; un don du Fonds africain de développement (FAD) de 20,49 millions d'euros et un prêt FAD

de 6,06 millions d'euros. Pour la Guinée Bissau, le Conseil d'administration de la Banque a approuvé un don du FAT de 1,78 millions d'euros et un don FAD de 16,77 millions d'euros.

Par ailleurs, la Guinée et la Guinée Bissau ont bénéficié respectivement d'un don de la Facilité d'investissement pour l'Afrique (FIAf) de 20,38 millions d'euros et 9,62 millions d'euros. (1 € = 655,957 FCFA)

« Cette route Boké-Québo est très importante pour les deux pays, et fait partie du corridor routier Transafricain N°7 Dakar-Lagos », a souligné le directeur général adjoint pour l'Afrique de l'Ouest, Serge-Marie N'Guessan.

Ces interventions du Groupe de la Banque produiront entre autres résultats, l'accroissement des échanges commerciaux entre les deux pays, de 60,46 tonnes de marchandises à 2000 tonnes de 2017 à 2025;

Le martyr de Jamal Khashoggi

MMAN - Le quotidien Al-Araby Al-Jadeed, basé à Londres, a récemment publié une caricature du dessinateur jordanienEmad Hajjaj, montrant un homme sans visage portant un keffieh rouge et blanc. Le mouvement qu'il a imprimé à son vêtement a fait s'envoler des feuillets manuscrits sur un fond sombre, évoquant un tour de magie. Dans le bas du dessin, la main d'un autre homme, vêtu d'un chemisier blanc, s'élève et semble avoir lâché son stylo-plume pour saisir quelque chose qui pourrait le sauver. La légende du dessin est « La disparition du journaliste saoudien Jamal Khashoggi ».

La caricature nomme la victime, mais pas l'auteur du crime. A vrai dire, tout Arabe - en fait quasiment tout le monde - sait exactement qui est responsable de la disparition de Khashoggi: le prince héritier d'Arabie saoudite, Mohammed ben Salman. Le fait qu'un dessinateur renommé soit contrait de masquer l'identité du coupable en dit long sur la peur ressentie par les journalistes indépendants dans le monde arabe. La disparition de Khashoggi n'a fait qu'intensifier leurs appréhensions.

Les pays arabes ont depuis longtemps l'habitude de récompenser les journalistes qui suivent la ligne officielle et de punir ceux qui, comme Khashoggi, osent dire leurs quatre vérités au pouvoir en place. Depuis l'échec des révolutions du Printemps arabe - la Tunisie étant l'exception - les citoyens de la région ont été confrontés au choix difficile entre des régimes dominés par les islamistes radicaux et des régimes militaires. Toutes les tentatives faites pour mettre en place des alternatives démocratiques ont été systématiquement réprimées.

Discréditer, contraindre, ou simplement réduire au silence les journalistes indépendants est une composante fondamentale de cette répression. Les gouvernements autocratiques ont adopté des lois et des réglementations qui les mettent à l'abri, eux et leur entourage, des critiques ou de révélations de la part des médias indépendants. Seuls les journalistes à leur solde - qui chantent les louanges des dirigeants et critiquent les opposants au régime - sont légitimes ; tous les autres sont des ennemis de l'État.

Cette attitude n'est pas le propre des dictatures. Même aux États-Unis - longtemps admirés pour la robuste liberté de la presse, protégée par le premier Amendement de la constitution américaine, et un journalisme d'investigation tenace, à l'origine de la destitution d'un président - l'administration Trump et le président lui-même ne cessent de dénigrer les journalistes indépendants, les qualifiant de traîtres, d'agents à la solde de l'étranger et de propagateurs de « fake news ».

L'intention de Trump est peut-être simplement de pacifier sa base électorale conservatrice et d'éviter d'avoir à rendre compte de ses innombrables erreurs et méfaits. Mais ses attaques contre la presse américaine, et son silence au suiet d'offensives contre la presse ailleurs dans le monde, ont beaucoup fait pour enhardir les auteurs de violations de la liberté de la presse où que ce soit.

Cela n'aide bien sûr en rien que ces contrevenants à la liberté de la presse - dont l'Arabie saoudite figurent parmi les plus proches alliés des États-Unis. Même des pays qui ne sont pas des proches alliées des États-Unis - comme la Birmanie, où deux journalistes de l'agence Reuter ont été condamnés à sept ans de prison - ne font pas l'objet de sanctions de la part des États-Unis.

Les journalistes indépendants ont un objectif: découvrir la vérité et la diffuser le plus largement possible. Lorsque les gouvernements répriment impunément ces journalistes et que d'autres abjurent leur engagement supposé envers les droits humains fondamentaux pour des raisons politiques ou partisanes, la vérité reste occultée, avec de graves conséquences.

Je connaissais Khashoggi depuis de longues années, à la fois aux plans professionnel et personnel. Il était un patriote saoudien qui n'était pas opposé au mode de gouvernance de son pays. Il avait bien sûr critiqué certaines de ses actions, dont la guerre inhumaine au Yémen et la manière dont les dirigeants saoudiens traitent les opposants. Mais ses arguments étaient toujours fondés sur des faits. Lui-même n'était pas un dissident ou un rebelle, mais un monarchiste qui souhaitait que son pays soit plus progressiste et tolérant. Il semble qu'il ait maintenant payé le prix ultime pour ce vœu d'ouverture et de réforme.

Pour les défenseurs arabes de la liberté, le chemin à parcourir sera long et semé d'embûches. En s'appuyant sur les sacrifices de véritables héros et de vrais démocrates, des journalistes et dessinateurs comme Hajjaj continueront à dire la vérité à ceux qui détiennent le pouvoir, en luttant pour les droits humains fondamentaux tels que la liberté de la presse. Il est toutefois inacceptable qu'ils doivent livrer bataille sans le soutien de ceux qui prétendent les protéger.



n Indian national, Ashok Kumar Sivaram, who was deported from Ghana a year ago, for alleged forgery of company's document is said to be heading the ongoing fiber optic cable transmission project here, amidst rising eyebrows.

According to Ghanaian Court documents, case number D2/73/18, Kumar Sivaram was deported after he was found to have forged the signature of Sachin Nambeer, the original owner of Jai Mai Communications or JMC at the Ghana Registrar General's office along with a local Ghanaian national, George Dankwa Otempong to reregister the company placing him as a 50 percent shareholder while Mr. Nambeer was away in India.

There are looming questions as to how Mr. Savaram surfaced in Liberia as implementer of the LIBTELCO fiber optic cables, which was originally awarded to CSquare, a company hired by LIBTELCO.

The connection of the fiber cable is expected to improve internet connectivity here at a faster speed, but the hiring of



a man who is said to have been allegedly involved into forgery and presenting of fake documents is raising security concern.

Reports from Ghana indicate that Sivaram did not only forged his boss's signature to re-register the company but he was also involve in another scam. Report say as part of effort to solidify his local backing, he married a

Ghanaian, while he was still legally married to the sister of Sachin Nambeer, the original head of JMC.

That move by Sivaram also landed him in trouble with local Ghanaian authority, who described his marriage to the Ghanaian as fake, and therefore saw his marriage certificate as fake.

Sivaram game plan for marrying the Ghanaian while he was still marry to Nambeer's sister was to obtained a Ghanaian citizenship, at least local reports and documents suggests.

Sachin's arranged marriage to the Ghanaian was exposed after he applied for his Ghanaian citizenship. His letter of application was questioned by the Ghana Immigration Service or GIS.

"But under our law in Ghana, you have to divorce first before you remarry. He did not do so. He later apply for Ghanaian citizenship. When the authorities saw it, they arrested him," one source with knowledge of the case said.

Sachin was deported from Ghana in June of last year, according to documents and reports from Ghana.

When a member of our team of investigators contacted the offices of CSquare on Tuesday October 16, 2018, for comment, a Ghanaian national who only identified himself as the HR (Human Resource) Officer declined to comment referring the paper to his lawyer.

One of the lawyers he referred our team to for comment told one of the journalists: "I am not aware of this. But please call me tomorrow. I will check with the

law firm on this because we have people who work on contracts for various companies. I will be prepared to speak on that."

Sivaram's deportation is not a secret in Ghana as several Ghanaian media including Joy news and the Ghanaian Daily Graphic.

In one of the reports, his deportation was tied to the fact that he lied the GIS using a fake marriage certificate to support his application for a permanent residence permit and this led to his repatriation in June last year following an order issued by the Interior Minister in May 2017.

Weah extends tariff suspension on rice

President George Manneh Weah has issued Executive Order #93, extending tariff suspension on rice in a bid to keep the nation's staple affordable on the Liberian market.

An Executive Mansion release issued Tuesday, 16 October says Executive Order #93 takes immediate effect.

It extends Executive Order No. 87 earlier promulgated by Government to suspend tariff on the nation's staple in alleviating unnecessary burden on ordinary Liberians.

The issuance of the Executive Order follows an assessment and evaluation by Government to determine the causes of increase in the prices

of various essential commodities and to initiate measures to ameliorate the situation.

"Now therefore," the Executive Order asserts, "the Government of Liberia in its desire to continue to bring relief to the public, hereby [issues] Executive Order No. 93, suspending the import tariff on rice as classified under tariff Nos. 1006.30.00 (in packing of more than 5kg or in bulk); 1006.30.00 (in packing of at least 5kg); and 1006.40.00 (broken rice) under the Revenue Code of Liberia Act 2000 with immediate effect."

President Weah uses the Executive Order to stress the need for exigent measures to ease economic burdens on Liberian citizens and residents, enabling them to access the staple food at all times and with ease.

These measures follow former President Ellen Johnson Sirleaf's Executive Orders Nos. 11, 19, 45, 61, 70, 80 and 87 suspending import tariffs on rice in the interest of the public.--Press release




