

# Kenyan policeman sentenced to death in rare officer conviction

enya's High Court has sentenced a senior for the murder of a detainee one of two cases resulting in rare officer convictions.

In a separate case, five senior police officers were found responsible for the death of a six-month-old baby hit over the head by riot police.

Kenya's police have previously faced accusations of impunity over killings.

Nahashon Mutua received a death sentence for fatally beating detainee Martin Koome with a metal bar in 2013.

Mutua was the officer in charge at a police station in the capital, Nairobi, when Koome was brought in following a domestic fight.

The officer had tried to frame an inmate for the murder but he was convicted in December and sentenced to death on Thursday.

Kenyans would have expected before: brutal beatings, torture and even broad daylight killings, some caught

the outcome. Policemen in Kenya have got away with it on camera.

The state stubbornly refuses to acknowledge it as a widespread problem; dismissing the cases as individual bad apples. But all the hard work of human rights groups, public pressure and the six-year-old Independent Police Oversight Authority (Ipoa) is beginning to bear

More officers are getting charged and prosecutors are beginning to win cases. The civilian-led Ipoa is getting plaudits for holding police officers accountable, and many Kenyans hope this new trend will be a deterrent.

Amnesty International says justice has prevailed against extraiudicial killings, but maintains it does not support the death penalty, which is still part of Kenyan law.

Why was Martin Koome arrested and what happened?

Chief Inspector Mutua was the officer in charge of Ruaraka police station when a suspect, Martin Koome Manyara, was brought in following a domestic brawl, back in December 2013.

Neighbours who heard the incident reported the matter to the police.

During the case, the court heard how Mutua had tried covering up the murder several times, including faking a report, freeing suspects present during the night of the incident and even charging one cellmate, Kelvin Odhiambo, with the murder of Koome.

It was Mr Odhiambo who sought the help of the oversight authority who eventually uncovered Mutua's behaviour. Charges against Mr Odhiambo were dropped and he turned state witness.-BBC



# Last day of campaigning in Nigeria before polling

igeria's presidential candidates wrapped up their election campaigns on Thursday, making a final pitch to voters before Africa's most populous country heads into the polls.

Two days before election day, President Muhammadu Buhari headed to his home state of Katsina in the northwest, while his main challenger, Atiku Abubakar, returned to his base in Adamawa, in the northeast.

Both were due to address supporters at their final rallies before voting in their villages on Saturday.

Buhari, 76, is seeking a second, four-year term of office but is facing a strong challenge from Abubakar, 72, who has campaigned largely against the president's record in office.

There has been little or no reliable opinion polling but

observers expect a close race. In 2015, results were announced some 48 hours after polls closed.

In what he called a "stateof-the-nation address", Abubakar said Buhari had failed to address insecurity, led a one-sided anti-corruption campaign and weakened the economy.

"Nigeria cannot survive another four years of this misdirection and maladministration," he said, declaring that Buhari's reelection would spell "disaster" for Nigeria.

Despite his age, Abubakar, a former vice-president representing the Peoples Democratic Party, has portrayed himself as a probusiness, modern and techsavvy candidate.

In particular he has appealed to the 18-35 age group that make up just over half of the 84 million registered voters, including by publishing a manifesto entirely in emojis.

Buhari is "better left to take a long rest (to) attend properly to his health", he added, referring to the president's illness that saw him spend

ozens of gold panners in Zimbabwe are feared to have drowned after heavy rains flooded two mines.

# Avert further death in Nimba

THE CURRENT DEATH toll from the Kartee Gold Mines in Gboanipea, Lower Nimba County is not only unfortunate, but very scaring. In total, some 60 poverty-stricken persons, including foreign nationals have reportedly died in desperation, scavenging for gold in caves beneath the earth.

THE CHILLING TALES came to public fold last week when about 45 illicit miners were trapped under the earth where they have been digging for gold at the Kartee Gold Mines in Gboanipea, about 10 kilometers from Tappita District in Nimba.

AT LEAST FIVE bodies were recovered on Tuesday, 12 February and one survivor rescued. But 35 others are still entrapped with no serious rescue team on the ground to save lives, nearly one week running into the aftermath of the incident.

THE GOVERNMENT IS yet to organize a disaster team to the mines to rescue the remaining trapped illicit miners and put in place mechanism to avert a reoccurrence of the ugly situation.

THE NATIONAL DISASTER Commission is quoted as saying it is not aware of the landslide at the Kartee Gold Mines in Gboanipea that has affected nearly 60 of our fellow compatriots. News from the county says 15 persons had suffered similar fate earlier at the same mine.

NIMBA COUNTY SUPERINTENDENT Dorr Cooper is quoted by the BBC as saying about 100,000 illicit miners have intruded the mines, some of them armed. Why hasn't he called in the police to condone the area?

HE NOTES THAT there is lawlessness around the site. But local authorities on the ground have failed to ensure law and order, leaving illicit miners to have their way at the expense of lives. Chiefs and elders are left with no alternative but to call in country devils to halt further intrusion.

**HOWEVER, WE THINK** it's about time the Government of Liberia thru the Ministries of Internal Affairs and Mines and Energy along with other state apparatus act to avert loss of more lives.

WE CALL FOR immediate deployment of the police Emergency Response Unity (ERU) and other riot units to contain the lawlessness at the Kartee Gold Mines. We believe the government is not supportive of illicit miners trying to create a state within a state.

THE TIME IS now. Government should not wait for more lives to be lost in Nimba before moving in, as they would be a miscarriage of key responsibilities under the Constitution - to protect lives and property, and maintain law and order.

# **Europe, Please Wake Up**

The first step to defending Europe from its enemies, both internal and external, is to recognize the magnitude of the threat they present. The second is to awaken the sleeping pro-European majority and mobilize it to defend the values on which the EU was founded.

UNICH - Europe is sleepwalking into oblivion, and the people of Europe need to wake up before it is too late. If they don't, the European Union will go the way of the Soviet Union in 1991. Neither our leaders nor ordinary citizens seem to understand that we are experiencing a revolutionary moment, that the range of possibilities is very broad, and that the eventual outcome is thus highly uncertain.

Most of us assume that the future will more or less resemble the present, but this is not necessarily so. In a long and eventful life, I have witnessed many periods of what I call radical disequilibrium. We are living in such a period today.

The next inflection point will be the elections for the European Parliament in May 2019. Unfortunately, anti-European forces will enjoy a competitive advantage in the balloting. There are several reasons for this, including the outdated party system that prevails in most European countries, the practical impossibility of treaty change, and the lack of legal tools for disciplining member states that violate the principles on which the European Union was founded. The EU can impose the acquis communautaire (the body of European Union law) on applicant countries, but lacks sufficient capacity to enforce member states' compliance.

The antiquated party system hampers those who want to preserve the values on which the EU was founded, but helps those who want to replace those values with something radically different. This is true in individual countries and even more so in trans-European alliances.

The party system of individual states reflects the divisions that mattered in the nineteenth and twentieth centuries, such as the conflict between capital and labor. But the cleavage that matters most today is between pro- and anti-European forces.4

The EU's dominant country is Germany, and the dominant political alliance in Germany - between the Christian Democratic Union (CDU) and the Bavaria-based Christian Social Union (CSU) - has become unsustainable. The alliance worked as long as there was no significant party in Bavaria to the right of the CSU. That changed with the rise of the extremist Alternative für Deutschland (AfD). In last September's länder elections, the CSU's result was its worst in over six decades, and the AfD entered the Bavarian Parliament for the first time

The AfD's rise removed the raison d'être of the CDU-CSU alliance. But that alliance cannot be broken up without triggering new elections that neither Germany nor Europe can afford. As it is, the current ruling coalition cannot be as robustly pro-European as it would be without the AfD threatening its right flank.

The situation is far from hopeless. The German Greens have emerged as the only consistently pro-European party in the country, and they continue rising in opinion polls, whereas the AfD seems to have reached its highpoint (except in the former East Germany). But now CDU/CSU voters are represented by a party whose commitment to European values is ambivalent.2

In the United Kingdom, too, an antiquated party structure prevents the popular will from finding

proper expression. Both Labour and the Conservatives are internally divided, but their leaders, Jeremy Corbyn and Theresa May, respectively, are so determined to deliver Brexit that they have agreed to cooperate to attain it. The situation is so complicated that most Britons just want to get it over with, although it will be the defining event for the country for decades to come.

But the collusion between Corbyn and May has aroused opposition in both parties, which in the case of Labour is bordering on rebellion. The day after Corbyn and May met, May announced a program to aid impoverished pro-Brexit Labour constituencies in the north of England. Corbyn is now accused of betraying the pledge he made at Labour's September 2018 party conference to back a second Brexit referendum if holding an election is not possible.

The public is also becoming aware of the dire consequences of Brexit. The chances that May's deal will be rejected on February 14 are growing by the day. That could set in motion a groundswell of support for a referendum or, even better, for revoking Britain's Article 50 notification.

Italy finds itself in a similar predicament. The EU made a fatal mistake in 2017 by strictly enforcing the Dublin Agreement, which unfairly burdens countries like Italy where migrants first enter the EU. This drove Italy's predominantly pro-European and pro-immigration electorate into the arms of the anti-European League party and Five Star Movement in 2018. The previously dominant Democratic Party is in disarray. As a result, the significant portion of the electorate that remains pro-European has no party to vote for. There is, however, an attempt underway to organize a united pro-European list. A similar reordering of party systems is happening in France, Poland, Sweden, and probably elsewhere.1


When it comes to trans-European alliances, the situation is even worse. National parties at least have some roots in the past, but the trans-European alliances are entirely dictated by party leaders' self-interest. The European People's Party (EPP) is the worst offender. The EPP is almost entirely devoid of principles, as demonstrated by its willingness to permit the continued membership of Hungarian Prime Minister Viktor Orbán's Fidesz in order to preserve its majority and control the allocation of top jobs in the EU. Anti-European forces may look good in comparison: at least they have some principles, even if they are odious.

It is difficult to see how the pro-European parties can emerge victorious from the election in May unless they put Europe's interests ahead of their own. One can still make a case for preserving the EU in order radically to reinvent it. But that would require a change of heart in the EU. The current leadership is reminiscent of the politburo when the Soviet Union collapsed - continuing to issue ukazes as if they were still relevant.

Otherwise, the dream of a united Europe could become the nightmare of the twenty-first century.

AMBRIDGE - Is the world becoming increasingly prosperous? It would be hard to answer "yes" right now, at least so far as the leading high-income ◆economies are concerned. Yet the longstanding bellwether of economic progress - inflation-adjusted GDP - has been growing across most of the OECD since 2010, suggesting that everything is fine.

Some 80 years after GDP was introduced, nearly everyone (apart from the indicator's stewards) has concluded that it is no longer a useful measure of economic progress. But there is no consensus yet on a possible replacement. Reaching agreement on an alternative will require a new concept of prosperity and a new way to measure whether living standards are improving.

There are several potential alternatives. One influential approach, pioneered by the Massachusetts Institute of Technology's Erik Brynjolfsson and his co-authors, is to ask people how much they value free digital goods such as online search and social media, and then add the result to the conventional measurement of GDP. Their research indicates that the average person in the United States would need \$17,530 per year to compensate for lack of access to online search, \$8,414 for email, and so on.

These are large numbers relative to the US median per capita income of just over \$31,000, indicating that the economic-welfare benefits of zero-money-price digital goods are high. This approach therefore captures some meaningful improvements in people's lives that are currently excluded from GDP. But to generate a meaningful economic-welfare metric, the same technique should be applied to other important components of wellbeing not captured by GDP, such as the natural environment, leisure, and unpaid work in the home.

Another alternative, supported by a large and growing body of research in economics and psychology, is direct measurement of wellbeing or happiness. Surveys of reported levels of wellbeing are now available for many countries, and the idea of cutting to the chase by using this as the prosperity metric has strong advocates. But this option has several drawbacks, including the fact that indicators of wellbeing change little over time. Happiness surveys in rich countries, for example, typically show a score of six or seven on a 0-10 scale.

One way to make such indicators more directly relevant to policy would be to track the ways people use their time and attach wellbeing measures to each. For example, people like leisure and especially digital media, may or may not enjoy their work, and hate commuting. This approach holds an obvious attraction in a largely services-based economy where the major input is time to produce and time to consume, and where digital technology is clearly changing the way many people allocate their time. After all, who wakes up thinking about what to spend rather than what to do?

These two options are rooted in the utilitarian philosophy that the goal of policy is the greatest happiness for the greatest number of people at any moment. This accounts for the focus on income or expenditure in the existing GDP framework, and the resulting paradoxes such as the way a natural disaster can increase GDP. It also underlies the emphasis on directly tracking wellbeing in the moment.

A third possibility for a new prosperity metric is to return to the origins of statistics, from the Domesday Book to William Petty, and measure wealth rather than income. Embracing such a balance-sheet approach would immediately bring sustainability into the calculation of economic progress by revealing when future prosperity is being compromised for that of today.

Measuring people's access to assets also draws on an ethical tradition, associated with the Nobel laureate economist Amartya Sen, which emphasizes people's agency and ability to lead the kind of life they value. What matters here is access to human capital (health and skills), social capital (human relationships and networks), and infrastructure. The World Bank has emphasized the measurement of wealth, and the calculation of these "missing capitals" is moving up the research and statistical

It is both revealing and encouraging that the issue of economic measurement has prompted such vigorous and exciting research. But, in addition to devising a new indicator of prosperity, there is the question of how to implement the shift. Official statistics are similar to a technical standard. It's hard for anyone to move from one framework to another without a lot of other people doing so at the same time.

Dissatisfaction with the prevailing GDP approach is therefore insufficient; a sufficiently large coalition has to agree to an alternative framework. Any successor to GDP also must be easily implementable, because statisticians will have to set out detailed definitions and methods, and collect the data.

Finally, and perhaps most important, there needs to be a public conversation about what is happening. Although very few people have the faintest idea about what GDP is or even what the acronym stands for, it is a single number that has gained the entrenched status that comes from long and frequent use. Its successor will need to be compelling and tell a persuasive story, consistent with experience, of what is happening in our economies. GDP may be toppling from its throne, but there is a long way to go before another composite indicator is crowned in its place.

# Rangers arrest protestors with knives

orest Rangers here have arrested two protestors carrying knives during a protest at the Forestry Development Authority in Paynesville outside Monrovia.

The two protestors, both males, were among a group of aggrieved citizens from Grand Bassa County who had converged on the FDA Head Office in Paynesville outside Monrovia to demand the resignation of the head for

community forest in Grand Bassa, Madam Getrude Karvayan.

They were apprehended with the harp objects, while attempting to enter the conference hall of the FDA, where the leadership of the protesting Bassa citizens had been invited by the Management to dialogue on their grievances.

Rangers immediately handcuffed the men and turned them over along with the knives to the Managing Director of the FDA, C. Mike Doryen and his officials, including the leadership of the protestors.

One of the individual is about 40, while the other is about 20. According to them, they decided traveling with the knives because of the time they left their residences to join their colleagues at the FDA compound for the protest demonstration.

According to them, they had gone with no negative intention of harming anyone, describing their arrest as very unfortunate.

However, while standing in the crowd, one the guys broke down in tears, begging the FDA authorities, who were already seated in the conference hall with the protestors, for mercy.

Managing Director C. Mike Doryen pardoned them, but strongly warned them not to ever repeat such behavior, as a reoccurrence could warrant prosecution.

The knives were subsequently confiscated by the forest rangers, who took them out of the conference hall where discussion between the FDA Management and the protestors had been scheduled. -Editing by Jonathan Browne


Tension erupted when Nimba County District #5 Rep.

# Tenure bill debate ends in deadlock

he Chambers of the Liberian Senate became tensed and breathtaking as members of that august body went into a heated and uncontrollable debate over a report from the Senate Judiciary Committee on the Tenure and Autonomous Agencies Bill.

It all started Thursday, 14 February when Presiding Officer, Senate Pro-tempore Albert Chie called for the reading of the Tenure and Autonomous Agencies Bill report for its possible passage.

But senators Conmany Wesseh of River Gee, Oscar Cooper of Margibi, J. Milton Teahjay of Sinoe, Daniel Naatehn of Gbarpolu and Matthew Jay of River Gee Counties could not allow the members of the Judiciary Committee to sail through with their presentation.

Opening the argument, Sinoe County Sen. Milton Teahjay said the report failed to provide the necessary information to inform the Senate.

Teahjay maintains that the committee failed to follow the corridor of open mind of handling the bill and the report did not speak to the

unanswered questions.

Also adding his voice to debate, Maryland County Senator Gble-bo Brown says the report is 'fake' and that the crafters' sole intent is to please President George Manneh Weah and [not] for the country's sake.

Referencing Article 89 of the 1986 Constitution and the Comprehensive Peace Accord signed in Accra, Ghana, Senator Brown says the establishment of these agencies were called for.

He argues that the call to establish these tenured positions was not former President Ellen Johnson -Sirleaf, as being insinuated by the committee.

Article 89 of the Liberian Constitution mandates the establishment of autonomous public commissions including the the Civil Service Commission; Elections Commission; and General Auditing Commission.

Further Article 89 states that the Legislature shall enact laws for the governance of these Commissions and create other agencies as may be necessary for the effective operation of Government.

Due to the continuous building of tensions among senators, presiding officer, Senator Peter Coleman who had taken over from the Pro -Tempore Chie, cut the debate and granted a motion that the debate be continued next Tuesday, 19 February.--Edited by Winston W. Parley

ournalists accredited to the Executive Mansion under the banner Executive Mansion Press Corps have expressed deep regrets over a recent tragic accident when an intruding vehicle hit President George Manneh Weah's motorcade, killing two persons.

The fatalities on Sunday, 10

from private and state media houses, and the Ministry of State's driver who operates the press jeep were badly injured, while an employee of the Ministry of State Gabriel Wilson and a lady in the intruding vehicle Victoria Wlue were killed.

In their statement released under the park of the University of Liberia Thursday, Gabriel Nyanti Wilson, commonly called Executive Horn, and an occupant of the intruding vehicle, Madam Victoria Wlue.

The Executive Mansion Press Corps adds that the incident also left several others severely injured.

# LWSC needs \$100m to replace faulty pipe

he Managing Director of the Liberia Water & Sewer Corporation (LWSC) Duannah Kamara is calling on development partners to come to the aid of the entity in replacing a faulty

Speaking Thursday, 14 February, Mr. Kamara said LWSC needs US\$100 million to replace the faulty pipe.

During a regular press briefing at the Ministry of Information on Capitol Hill, Mr. Kamara recalls that the faulty pipe was built in 1966 and commissioned in 1968 to provide service to 400,000 people.

Due to growing population here, he the LWSC boss asserts that the pipe is now supplying an estimated 1.6 million people.

He also complains that the pipe is very old and has more pressure on it due to the increased number of people that are currently benefiting from the LWSC service.



Meanwhile, Mr. Kamara blames the recent shortage of water in Monrovia and its environs on the damaged pipe.

He says the water shortage is not as a result of government bureaucracy as being speculated in the public domain.

Additionally, Mr. Kamara mentions that the LWSC technical team in the shortest possible time had the pipe repaired and the corporation is still carrying on other maintenance work.

# #Stop prioritizing foreign Liberian businesses!#

"As I'm speaking to you at the moment, the LWSC is now being involved into active operation. This implies that people are now pumping water," he says.

According to him, considering the situation the pipe is facing, it can't effectively provide service to the people of Montserrado County without experiencing further problem.

He laments that his entity losses 77% of its annual revenue generation to leakages and water theft.

"People who are connected to our line illegally took advantage of the water supply shortage by packaging and selling our water to us expensive," Kamara laments.

He notes that when those who are stealing water are being requested to pay taxes, they cry and blow the issue out of proportion.

He says the issue of fighting water theft is a serious challenge, concluding that the LWSC has dispatched a team in the field to carry on inspection.--Edited by Winston W. Parley

« Mortalité maternelle trop élevée au Libéria », s'inquiète la banque mondiale

a représentante de la Banque mondiale au ∎Libéria, Mme Larisa Leshchenko, se dit alarmée par les taux de la mortalité maternelle et des grossesses précoces chez les adolescentes au Libéria. Selon elle, trop de mères meurent et trop de jeunes filles n'ont pas la chance de passer leur enfance comme il le faut.

S'exprimant lors d'un atelier réunissant plusieurs parties prenantes le mercredi 13 février à Paynesville, Mme Leshchenko a déclaré que le taux de mortalité maternelle et le taux de grossesse chez les adolescentes au Libéria sont parmi les plus élevés en Afrique de l'Ouest et dans le monde.

L'atelier a été organisé à l'hôtel Golden Gate par le ministère de la Santé en partenariat avec la Banque mondiale. Il avait pour objectif de remédier aux contraintes institutionnelles pour obtenir les résultats escomptés en matière de santé au Libéria.

Mme Leshchenko a noté



qu'il ressort des résultats obtenus en matière de santé au Libéria qu'il reste beaucoup à faire. Pour rappel, l'indice du capital humain publié en septembre 2018 classait le Libéria au rand 153e sur 157 pays.

Le Libéria a enregistré plusieurs défis majeurs dont la humaines, l'approvisionnement en médicaments et le système de gestion des médicaments, la prise en compte de la voix des citoyens dans la gouvernance de la santé et l'amélioration de la transparence à différents niveaux du système.

« Quoique que plusieurs gestion des ressources solutions techniques

continuent d'être mises en œuvre, notre expérience suggère que celles-ci devront être soutenues par les réformes des institutions et des organisations de gouvernance », a déclaré l'émissaire de la banque mondiale. Elle a réitéré l'engagement de la Banque mondiale de poursuivre son partenariat avec le gouvernement libérien pour renforcer les capacités de prestation de service de santé pour la gestion durable des ressources disponibles.



## L'Europe doit absolument se réveiller

UNICH - Avançant à l'aveugle, l'Europe est en passe de tomber dans l'oubli. Les Européens doivent se réveiller avant qu'il ne soit trop tard. À défaut, l'Union européenne connaîtra le sort de l'Union soviétique. Ni nos dirigeants, ni les citoyens ordinaires ne semblent réaliser combien nous vivons une période révolutionnaire, aux retombées potentielles multiples, et combien l'issue finale est par conséquent hautement incertaine.

La plupart d'entre nous présumons que l'avenir ressemblera plus ou moins au présent. Or, ce ne sera pas nécessairement le cas. Au cours d'une existence longue et riche en événements, j'ai été le témoin de nombreuses périodes marquées par ce que j'appelle le déséquilibre majeur.

Le prochain point d'inflexion résidera dans les élections au Parlement européen de mai 2019. Il faut malheureusement s'attendre à ce que les forces antieuropéennes bénéficient d'un avantage comparatif dans les urnes. Parmi les raisons qui l'expliquent, interviennent l'obsolescence du système des partis qui prévaut dans la plupart des pays européens, l'impossibilité pratique d'un changement de traité, ainsi que le manque d'outils juridiques permettant de discipliner ceux des États membres qui enfreignent les principes sur lesquelles l'Union européenne a été fondée. L'UE peut certes imposer l'acquis communautaire (le corpus des lois de l'Union européenne) aux pays candidats, mais elle n'est pas suffisamment en capacité de contraindre les États membres à respecter les règles.

Dépassé, le système des partis entrave ceux qui souhaitent préserver les valeurs fondatrices de l'UE, tandis qu'il favorise ceux qui souhaitent remplacer ces valeurs par quelque chose de radicalement différent. Ceci se vérifie au niveau des États dans leur individualité, et encore davantage dans les alliances transeuropéennes.

Le système des partis appliqué dans les États individuels reflète des divisions qui valaient principalement aux XIXe et XXe siècles, telles que l'opposition entre le capital et le travail. C'est aujourd'hui le clivage entre pro-européens et antieuropéens qui importe le plus.

Le pays dominant de l'UE n'est autre que l'Allemagne, gouvernée par une coalition politique réunissant Union chrétienne-démocrate (CDU) et Union chrétienne-sociale en Bavière (CSU) - qui n'est désormais plus viable. Cette alliance fonctionnait tant qu'il n'existait aucun parti important en Bavière situé à droite de la CSU. Ceci a changé avec la montée en puissance du parti extrémiste Alternative für Deutschland (AfD). À l'issue des dernières élections de septembre dans les Länders, la CSU a enregistré son pire score en plus de soixante ans, tandis que l'AfD est entré pour la première fois au Parlement de

L'ascension de l'AfD a supprimé toute raison d'être de l'alliance CDU-CSU. Or, cette coalition ne peut être rompue sans le déclenchement de nouvelles élections, que ne peuvent se permettre ni l'Allemagne, ni l'Europe. Ainsi, l'actuelle coalition au pouvoir ne peut se montrer aussi ouvertement proeuropéenne qu'elle le ferait si l'AfD ne menaçait pas son flanc droit.

La situation est toutefois loin d'être désespérée. Les Écologistes allemands se démarquent comme le seul parti constamment pro-européen du pays, et ils continuent de progresser dans les sondages d'opinion, tandis que l'AfD semble avoir atteint son pic (excepté dans l'ancienne Allemagne de l'Est). Les électeurs de la coalition CDU/CSU sont néanmoins représentés aujourd'hui par un parti à l'engagement ambivalent autour des valeurs européennes.

Au Royaume-Uni également, un système des partis

obsolète empêche la volonté populaire de s'exprimer pleinement. Travaillistes et Conservateurs sont divisés en interne, mais leurs dirigeants respectifs, Jeremy Corbyn et Theresa May, se montrent si déterminés à faire aboutir le Brexit qu'ils ont consenti à coopérer pour y parvenir. La situation est si complexe que la plupart des Britanniques souhaitent tout simplement en finir, alors même que l'issue sera déterminante pour leur pays, et pour plusieurs décennies.

Le rapprochement entre Corbyn et May suscite néanmoins une opposition au sein des deux partis, qui dans le cas des Travaillistes frôle l'insurrection. Le lendemain de la rencontre entre Corbyn et May, la Première ministre a annoncé un programme d'aide aux circonscriptions travaillistes pro-Brexit appauvries du nord de l'Angleterre. Corbyn est désormais accusé d'avoir trahi la promesse qu'il avait formulée lors de la conférence du Parti travailliste de septembre 2018, consistant à soutenir un second référendum sur le Brexit en cas d'impossibilité d'organiser une élection.

L'opinion publique prend par ailleurs conscience des conséquences très défavorables du Brexit. La probabilité d'un rejet de l'accord proposé par May le 14 février augmente de jour en jour. Ceci pourrait amorcer une lame de fond en soutien d'un référendum, voire, mieux encore, pour la révocation de la notification de l'Article 50 par la Grande-Bretagne.

L'Italie connaît une difficile situation comparable. L'UE a commis une erreur fatale en 2017, en exécutant strictement l'Accord de Dublin, qui pèse d'un poids injuste sur des pays comme l'Italie, où pénètrent dans un premier temps les migrants pour entrer dans l'UE. Ceci a poussé en 2018 un électorat à dominante proeuropéenne et pro-immigration dans les bras de la Ligue du Nord et du Mouvement 5 étoiles, partis opposés à l'Europe. Auparavant dominant, le Parti démocrate se retrouve dans le désarroi. Résultat, une part significative de l'électorat, qui demeure favorable à l'Europe, ne dispose d'aucun parti pour lequel voter. Une tentative est néanmoins en cours pour l'organisation d'une liste pro-européenne unie. Une réorganisation similaire du système des partis s'opère actuellement en France, en Pologne, en Suède, et probablement ailleurs.

S'agissant des coalitions transeuropéennes, la situation est encore plus difficile. Tandis que les partis nationaux possèdent au moins certaines racines du passé, les alliances transeuropéennes sont entièrement dictées par les intérêts personnels des dirigeants de parti. La Parti populaire européen (PPE) se révèle à cet égard le plus critiquable. Le PPE est pour l'essentiel dépourvu de principes, comme l'illustre sa volonté d'autoriser qu'en demeure membre le parti Fidesz du Premier ministre hongrois Viktor Orbán, afin de préserver sa majorité et son contrôle sur la répartition des meilleurs postes dans l'UE. Les forces anti-européennes apparaîtraient presque louables en comparaison : elles au moins ont certains principes, malgré des conceptions odieuses.

Difficile d'imaginer comment les partis pro-européens pourraient sortir victorieux des élections du mois de mai, à moins qu'ils fassent primer les intérêts de l'Europe sur les leurs. Il demeure possible d'appeler à la préservation de l'UE, pour mieux la réinventer en profondeur. Ceci exigerait toutefois un changement de mentalité dans l'UE. Le leadership actuel rappelle en effet le politburo au moment de l'effondrement de l'Union soviétique - continuant d'émettre des oukases, comme s'ils avaient encore une signification.

La première étape dans la défense de l'Europe face à ses ennemis, intérieurs et extérieurs, exige de reconnaître l'ampleur de la menace qu'ils représentent. La seconde consiste à réveiller la majorité pro-européenne dormante, ainsi qu'à la mobiliser pour défendre les valeurs fondatrices de l'UE. Sans quoi le rêve d'une Europe unie pourrait devenir le cauchemar du XXIe siècle.

L'arrivée au pouvoir de George Weah le 22 janvier 2018, a suscité un immense espoir au Liberia. Classée parmi les pays les plus pauvres du monde, la nation ouest-africaine espère se remettre de plusieurs années de guerre civile et d'une épidémie dévastatrice d'Ebola. Mais l'obtention d'un financement demeure à ce jour l'un des plus grands défis du chef de l'Etat.

Ministry will consolidate ties with artists particularly, the Imperial Castle, a group made of Liberian reggae artists and a charitable volunteer mission organization ALAD, which focus is to put Liberia first in its activities.

he Liberian Senate failed to commence impeachment trial against Associate Justice Kabineh M. Ja'neh as planned on Thursday, 14 February due to a motion filed by Justice Ja'neh demanding the recusal of the presiding, Chief Justice Francis S. Korkpor, Sr. from the trial.


Article 43 of the Liberian Constitution gives the Chief Justice the power to preside whenever the President, Vice President or an Associate Justice is to be tried.


But Justice Ja'neh's contention is that Chief Justice Korkpor and three other justices signed a ruling which gives a green light for his (Ja'neh's) impeachment.

The Senate opened the impeachment trial Thursday after majority justices of the Supreme Court inclusive of Chief Justice Korkpor denied two separate petitions filed by Justice Ja'neh and four senators to prohibit his impeachment trial due to alleged violation of the Constitution.

Justice Ja'neh was involved in a property case with one Madam Annie Yancy Constance and the Supreme Court ruled in his favor.

But lawmakers claimed that





Associate Justice Ja'neh allegedly manipulated the Supreme Court, headed by Chief Justice Korkpor and ensured that no exception was made for the active negligence of Cllr. Lawrence Yeakula ... and Constance's appeal was dismissed.

The lawmakers alleged that on the basis of Justice Ja'neh's manipulation of the Supreme Court, he was allowed to keep such a valuable property for which he had paid such small amount.

The lawmakers alleged that

the injustice in the Constance case constitutes another gross breach of duty committed by Justice Ja'neh.

But Ja'neh says Chief Justice Korkpor signed the very ruling and herefore he cannot preside over an impeachment that is drawn on the basis of a ruling that he (the Chief Justice) signed.

Justice Ja'neh says Chief Justice Korkpor ruled on 30 November 2018 that a Justice is required to recuse himself/herself ... where the Justice is on record to have

taken a position with respect to a particular case brought to the Supreme Court.

These issues raised by Ja'neh have to be addressed before the impeachment proceedings at the Senate can continue.

Speaking at the Senate Thursday, Chief Justice Korkpor says no impeachment proceeding has taken place in Liberia in the form of a full blown trial before the Senate, noting that maybe this one [the case with Justice Ja'neh] will.

He says Article 43 of the Constitution provides in part that the power to prepare a bill of impeachment is vested solely in the House of Representatives while the power to try all impeachments is vested in the Senate.

According to him, when the President, Vice President or an Associate Justice is to be tried,

the Chief Justice shall preside.

He recalls that on November 15, 2018, the House of Representatives presented to the House of Senate a Bill of Impeachment for the impeachment of Justice Ja'neh.

Chief Justice Korkpor notes that the trial will be guided by the Constitution and by the statutory laws, and the urge to be fair and to do justice to all at all times.

He says though the Senate is not a courtroom, he will ensure that the calm and serenity that prevail in courtrooms during trials prevail at the Senate, insisting on order and timeliness.

But Senate President Pro Tempore Albert Chie differs, saying impeachment trials all over the world are political matters and not judicial, saying that is why they are conducted in political areas like the Senate and not the court.

Chie warns that the judicial officers shouldn't turn the Senate into a courthouse with legal battles.

Pro Tempore Chie adds that the Constitution guarantees the right of any accused to the Principle of Due Process, saying the impeachment trial is in the hands of the Senate and the Senate alone.

"This Senate reviewed legislative rules of procedures on impeachment and made important amendment ensuring that two thirds of the entire membership of the Senate convicts or acquits instead of a simple majority in the existing rule," he says.--Edited by Winston W. Parley

The LTA adds that JamCell's connectivity will serve as a pre 5G platform for cellular services and anticipated smart city applications.

anchester United paid Jose Mourinho and his staff £19.6m in compensation following his sacking in December.

United revealed the figures in their second quarter financial results.

Mourinho was sacked after a run of poor results, culminating in a 3-1 defeat by Liverpool, that left them 11 points off fourth place in the Premier League.

Caretaker manager Ole Gunnar Solskjaer won 10 of his first 11 games before Tuesday's 2-0 Champions League last-16 first-leg defeat by Paris St-Germain.


Within the financial results, which were released to the New York Stock Exchange, it said: "Exceptional items for the quarter were £19.6m, relating to compensation to the former manager and certain members of the coaching staff for loss of office."

Mourinho, 55, took over in May 2016 and led United to League Cup and Europa League titles. In January 2018 he signed a contract extension until 2020 with the option of an extra year.

United executive vicechairman Ed Woodward says Solskjaer's appointment, along with that of Sir Alex Ferguson's former coach Mike Phelan as his assistant has "had a positive impact throughout the club".

'Ole has made a fantastic start reviving performance of team," Woodward said.

Woodward says he thinks United, who have reached the fifth round of the FA Cup and are now fourth in the Premier League, above Chelsea and Arsenal, will now have "a strong finish to the season".
