he UN says it has received reports that guards fired on migrants who tried to flee air strikes on a detention centre near Libya's capital Tripoli on Tuesday.

The UN says it believes at least 53 migrants died and 130 were hurt in the air strikes on the Tajouracentre.

UN High Commissioner for Human Rights Michelle Bachelet has said the air strikes could constitute a war crime.

The government and an opposing militia have blamed each other for the attack.

Thousands of migrants trying to reach Europe, many of them sub-Saharan Africans, are being held in Libyan detention camps. Dozens who set off from Libya were feared dead as a boat capsized off Tunisia on Wednesday.

Libya has been torn by violence and division since long-time ruler Muammar Gaddafi was deposed and killed in 2011.

A recent upsurge in violence began in April when the self-styled Libyan National Army (LNA), commanded by Gen KhalifaHaftar, launched an offensive against the UN- backed Government of National Accord (GNA), led by PM Fayez al-Sarraj.

The latest situation overview from the UN Office for the Coordination of Humanitarian Affairs raised the number of reported deaths at the centre to 53, with six children among those

killed and bodies still being pulled from the rubble.

"There are reports that following the first impact, some refugees and migrants were fired upon by guards as they tried to escape," it states, without giving any further details.

A UN mission visited the camp on Wednesday and helped evacuate the injured but said there had been "no general relocation of the remaining refugees and migrants" and that some 500

fter fleeing air strikes people faced "the same degree of vulnerability and exposure to violence".

> The report added: "Humanitarian actors call for the immediate release of refugees and migrants from detention centres and for relocation to safe shelter."

> The Libya Observer quoted Interior Minister FathiBashagha as saying the government was now considering closing all detention centres and releasing all migrants.-BBC

Ebola check points 'set on fire' in Uganda

ganda's Daily Monitor newspaper reports that health workers are "living in fear" after tents at two Ebola screening points were set on fire on Wednesday.

Health workers have been battling to stop further contagion with a number of precautions, including border screening points and deploying medical monitors to 22 high-risk districts to spot and manage any cases they find.

DR Congo security forces 'fire on protesting miners'

ctivists in the Democratic Republic of Congo say security forces have fired on miners who were protesting against being evicted from a copper and cobalt mine run by the British-Swiss multinational Glencore.

Activists say shots were fired at the miners after they marched to the governor's office and pillaged shops in the southern town of Kolwezi.

It is unclear whether live rounds or rubber bullets were used. The illegal miners were forcibly evicted from the Glencore mine after they missed a deadline set by the government for them to leave.

The decision to evict the men came after more than 40 miners were killed in a landslide last month.

Glencore estimates that about 2,000 illegal miners enter the mine every day. In a

statement it said that it hoped that security forces would "exercise restraint and operate in accordance with... international human rights standards". Activists say evicting them will do nothing to alleviate the poverty that forces people into illegal mining. The DR Congo produces more than half the world's cobalt, a key component in batteries for mobile phones and other devices.-BBC

EDITORIAL **Playing with agriculture** that feeds us

JUST WHAT IS the Weah administration's policy on agriculture, if there is any, still remains a dream, running into two years since the government was inaugurated.

AGRICULTURE IS THE bedrock of any nation, but it seems that Liberia, which has an agro-based economy, is putting her feet in her mouth when it comes to food.

WHILE PRESIDENT GEORGE Manneh Weah and his Pro-Poor government are busy on capital-intensive investment such as roads, the nation's 4.5 million people go to bed hungry each day or undernourished due to inadequate food.

AS WE WRITE the Ministry of Agriculture in Gardnersville outside Monrovia is virtually empty as the Minister there, Dr. Mogana Flomo, was booted out over the weekend along with the Director-General for the Central Agricultural Research Institute (CARI) in Bong County, Dr. Marcus Jones.

IN HIS SECOND Annual Message in January this year, President Weah promised to give the agriculture sector the same focus he gives to road construction, but six months after, this vital sector still lies dormant with nothing else but mere policy statement on the books.

IN A ROUNDTABLE with officials of the Ministry and partners in February, the President reiterated the correlation between agriculture productions and economic boom on one hand, and poverty alleviation and national security on the other.

HE TOOK THAT message to Israel subsequently and the Israeli government has promised to assist Liberia in the area of training to boost capacity so that Liberians would return to the soil with renewed vigor and technological knowledge.

WE URGE THE government to go a step further in its expressed commitment to agriculture by taking practical actions in opening government farms and putting young agricultural graduates from our various universities to work. This is the surest way to proceed.

WE BELIEVE IF this strategy is heeded, in the next two years, Liberia would be a different story all together, for we would lay the foundation that could leap us to self-

The US Is Still Needed in Syria

By rushing out of Syria now, the Trump administration is ceding the field to Russia, Turkey, and Iran, all but guaranteeing another regional conflagration in the near future. By leading a new diplomatic effort to end the conflict and begin reconstruction, Trump could both extricate the US from the conflict and help stabilize the region.

between the United States and Iran, the bloodshed in Syria is escalating once again. Syrian President Bashar al-Assad's regime has intensified its onslaught against the remaining opposition stronghold in Idlib Province, which is home to some three million people, including many who have been internally displaced. To avoid a new humanitarian nightmare and another mass exodus of refugees, the US must renew its peacemaking efforts.

Since a US-backed coalition of (mostly) Kurdish forces succeeded in dismantling the Islamic State's (ISIS) territorial caliphate, the US has begun walking away from Syria. Late last year, US President Donald Trump announced the withdrawal of US troops there, effectively ceding negotiations over the country's future to Russia, Iran, and Turkey.

It is now clear that Trump jumped the gun. The renewed fighting in Idlib is a potent reminder that Syria remains a tinderbox. Almost onethird of the country is controlled by a Kurdishled militia that Turkey regards as a mortal enemy. Owing to America's support of the Kurds and Turkey's decision to purchase Russian anti-aircraft missiles, US-Turkish relations are near a breaking point. Meanwhile, Russia has orchestrated its return to the region by backing the Assad regime, and Iran has established a Syrian foothold of its own, enhancing its regional influence and increasing the prospect of war with Israel.

Instead of ignoring these risks, the US needs to get back in the game of shaping Syria's future. As a first step, it should launch a new contact group that includes Turkey, Russia, the European Union, and the United Nations. The initiative should have three critical objectives, the first of which is to pressure the Assad regime to end the violence and accept a decentralized state in exchange for international help with reconstruction. To end the conflict, the regime must abandon its stand down.

To start the process, the EU, backed by the UN, should take the lead on overseeing the return of refugees, raising the needed resources, and implementing a program of post-conflict reconstruction.

> The contact group's second goal should be to strike a deal with Syria's main Kurdish party, the Democratic Union Party (PYD). In exchange for regional autonomy within a decentralized Syrian state, the PYD would end its alignment with the Kurdistan Workers' Party (PKK), which has been waging a separatist terror campaign inside Turkey for decades. Provided that the PYD has broken ties with the PKK, the contact group should then spearhead a stabilization plan for the Kurdish region of Syria.

> The US, for its part, has an obligation to secure the political rights of Syria's Kurds, who led the fight against ISIS. But it also must repair its relationship with Turkey. The only way it can do both is to broker a rapprochement between Turkey and the PYD. To that end, the US should honor its pledge to reclaim heavy weapons that it previously transferred to the Kurds, and press the PYD to restore local control to the communities it occupied during the campaign against ISIS.

> The US also needs to help keep Kurdish fighters away from the Turkish border, which could be accomplished with a safe zone in northern Syria - a proposal that is currently under discussion in Ankara and Washington. The Turkish government's recent re-engagement in direct dialogue with the PYD leadership is an encouraging sign.

The contact group's third objective should be to reduce, if not eliminate. Iranian influence in Syria. With its forces and proxies on the ground, not to mention its considerable leverage over the Syrian government, Iran can stir up trouble not only in Syria, but also in Iraq, Lebanon, and Israel. Simply establishing a new contact group would reduce Iran's diplomatic clout by barring it from the main forum for negotiating Syria's offensive in Idlib, and the opposition groups future. Beyond that, the group should also make clustered there must agree to disarm and the delivery of reconstruction assistance contingent upon Assad distancing himself from the Iranians.

OUR NEIGHBORS IN Ivory Coast and Guinea, as well as Ghana, Burkina Faso, Nigeria and elsewhere in the regime are doing just that. Food prices would continue to increase in our market as long as we rely on imported rice to feed the population, because we don't control productions from abroad.



The political framework for peace and stability in Syria will require a new constitution that provides for a significant measure of regional devolution, while preserving the Syrian government's monopoly over the use of force. Allowing a potpourri of autonomous militias to remain in operation would almost certainly lead to a failed state.

For the international community, marshaling the reconstruction assistance that would accompany this political compact should be a top geopolitical and humanitarian priority. Failure to rebuild Syria's war-torn communities and restore the state's capacity to deliver essential services would leave the

Trump is right to want out of Syria. But to extricate itself from the conflict, the US must first initiate a new diplomatic peacemaking effort. If Trump walks away prematurely, Syria will be left chronically unstable, and thus vulnerable to a revival of radicalism. Moreover, America's break with Turkey will have passed the point of no return, Russia will have an unchecked proxy in the Middle East, and Iran will be empowered to foment chaos across the region. The conditions would be ripe for a renewed conflict that drags the US back into the region at an even higher cost. The choice is an easy one.

The Liberia Feminist Forum, #WeAreUnprotected Campaign, women's rights organizations, and allies of diverse social movements commend the Liberian House of Representatives for the passage of the Domestic Violence (DV) Bill. We recognize your exercise of accountability to the citizens of Liberia and most importantly, the acknowledgment of women's rights as a fundamental right and protection from domestic violence. It also highlights the fact that the government is responding to the advocacy efforts of its citizens affected by a crisis of rights violations in private and public spaces. Against the background of being on the right side of history and being accountable to the people of Liberia, we are hopeful that the House of Senate will fully concur with the House's Bill for the full passage for the protection and fulfillment of the rights of women, young people, children and marginalized groups to be free from domestic violence in Liberia.

We celebrate and recognize the collective work, and years of mobilizing and activism by Liberian women rights organizations, feminist and social movements, other civil society and community based organizations, student activists, survivors, the media, especially the Female Journalist Association of Liberia and marginalized persons affected by the scourge of domestic violence across Liberia. The Bill is a culmination of this struggle that we must win. Liberia must win.

The Domestic Violence Bill is a critical legal instrument that will ensure women, young people, children and marginalized persons are protected from sexual, physical, economic, verbal and psychological abuse and all other forms of violence that affect their health, wellbeing, integrity and rights. The Domestic Violence Bill will provide survivors and their families with mechanisms for redress, reintegration, and psychosocial support. The Bill will also accord the Liberian Government an opportunity to strengthen the justice system to uphold the dignity of survivors and ensure that justice can be accessed and delivered in a responsive, effective and timely manner. The finalization of the Domestic Violence Bill will highlight the Liberian Government adherence and obligation to associated regional and continental instruments it has ratified.

We would finally like to register that whilst the Bill aims to address all forms of the violence, the exclusion of Female Genital Mutilation (FGM) limits its ability to comprehensively address the impact of FGM on bodily integrity, sexual and reproductive rights and education of women and girls that are subjected to this practice in majority of counties in Liberia. The exclusion of FGM in the bill reduces the government's ability to act on Articles 11 and 20 of the Liberian Constitution.. It reduces our obligation to the Maputo Protocol and other international instruments. We look forward to Government's engagement and finalization of an anti-FGM law, through the National Legislature.

h e Executive Governor of the Central Bank of Liberia (CBL), Mr. Nathaniel R. Patray, III has underscored the importance of financial inclusion to economic growth and poverty alleviation.

Executive Governor Patray said financial inclusion plays a critical role in reducing poverty because access to population.

Although the statistics on financial inclusion appeared gloomy, The CBL Executive Governor expressed confidence that a coordinated National Financial Inclusion Strategy (NFIS) could reverse the trend.

He said the 2019 - 2024 Strategy, which is about to be

financial services helps individuals, families, and businesses to invest in income-generating activities and save for the future.

Despite this, Mr. Patray said only 36% of Liberians access financial services, including bank accounts and mobile money and, worse still, only 28% of women and 27% of the poorest 40% of the launched, builds on the results of the National Strategy, that expired in 2018 and the existing FSDIP as well as the Government's Pro Poor Agenda for Prosperity and Development.

Also speaking during the NFIS Stakeholder Validation Workshop, was Dr. Nicholas Smith, a World Bank Financial Sector Specialist who heads the World Bank Technical support Team that is supporting the Government to develop the current National Financial Inclusion Strategy.

He also stressed the importance of financial inclusion, which he said was all about having a bank account, access to loans and the use of mobile money. He said financial inclusion enables people to save for retirement, invest in their business, save for a new purchase and insure against risk and was therefore critical to national development.

With the final NFIS Stakeholder Validation Workshop now out of the way, the stage is set for the launch of this all-important policy document and its implementation through the concerted actions of all stakeholders.

rand Cape Mount County Senator defendant H. Varney G. Sherman confirms here that he communicated with British mining firm Sable Mining, telling prosecutors that "we exchanged emails" on what "we were doing" for them as their lawyers.

Sen. Sherman, one of Liberia's top lawyers faced cross examination with prosecutors Thursday, 4 July for his alleged role into claims that through his law offices his client Sable Mining bribed Liberian officials including lawmakers during former President Ellen Johnson -Sirleaf's regime to change a concession law to favor the company.

Among several things, the prosecution says it is relying on some documentary evidences including spreadsheets and alleged email exchanges between defendant Sherman and the company, but the accused has since denounced the evidences submitted by the State as doctored and unauthentic.

Government drew the indictment against the defendants following a report by U.K. - based watchdog group Global Witness in 2016 titled: "The Deceivers," claiming that Sable Mining paid bribes to Liberian officials totaling US\$950,000 to insert Section 75 in the Public Procurement and Concession Commission (PPCC) Act, providing for "non bidding" process.

Sable Mining had interest in the Iron Ore deposits of

But during his cross examination Thursday, Sen. Sherman insists that these emails that Global Witness says were leaked to it were hacked and doctored emails.

But he laments that unfortunately Liberia has no such law, narrating how the country's evidence law has not been developed to address technology issues.

He continues that because the defendants challenged the emails as hacked and doctored emails, the Special get Mr. Heine Jan Van Niekerk to come to Liberia to confirm that he and Cllr. Sherman had exchanged the alleged fake emails.

Sherman tells the Court that "genuine emails" have been tampered with, and indicates further that when Mr. Niekerk refused [to come to Liberia], the Task Force created an affidavit, the authenticity which the defendant challenges.

Sherman sounds astonished by how he got speedily indicted on May 24, 2016 just after Global Witness' report that contained the allegations was published on May 11, 2016.

According to him his indictment was obtained based on the testimony of two witnesses including Mr.

He narrates further that on June 6 that year, the second indictment against him was obtained, followed by the third indictment in January 2017.

However Sherman claims in his testimony that there is no evidence to corroborate the special presidential task force's report which he argues is "really a repetition" of the Global Witness Report.

Additionally Sherman tells the Court that there is no computer forensic studying of these emails that he maintains were hacked and doctored.

Following the defendant's testimony, State lawyer Cllr. Wesseh A. Wesseh announced that prosecution will produce rebuttals against defendant Sherman's testimony.

TN Liberia Music Award (MLMA) organizers gave out the biggest April fool here to artists, the Liberia Music Industry and so many loyal fans in and out of Liberia who participated in the recent award ceremony when in fact, there were no awards.

After a successful fight to bring the Liberia Music Award (LMA) home from the United States of America where some local artists had faced

difficulty in participating, the management finally brought the award to Liberia and got one of the country's giant GSM Companies heading sponsorship, changing the name from LMA to MTN Liberia Music Award (MLMA).

Prior to the award ceremony held at the Executive Pavilion in Monrovia in December, 2018, the head for MLMA Liberia, Joseph Teah announced in a press conference that the award held in Liberia was



different from all previous ones. Giving some attractions

that made the one here different from the rest, he noted that artists who won awards took home empty frames or mere papers, but will be escorted with some cash to appreciate their effort, as it's done in other country.

However, since December 22, 2018 till now, there has not been a single cent given to the many winners, who walked away with awards during the ceremony, which has sparked huge noise both between organizers, promoters, bloggers and the artists.

Culture & Entertainment also gathers that the MLMA-Liberia Officer-In-Charge made the pronouncement as a mere bluff, noting that he didn't consult the USA team before making such declaration to the public, which is causing serious embracement for the organization.

A source from US team reveals that during the contract with Lonestar/MTN



for sponsorship, the organizers requested for US\$65,000 but the company refused on grounds that said amount was very exorbitant.

Our source continues that Lonestar/MTN committed itself to giving the organizers US\$25,000, which was too little to include fees for award winners, disclosing that an amount of US\$11,000 was given to run the ceremony.

The source adds that the USA team now sees the MLMA-

Liberia O-I-C Joseph Teah as a serious embracement, mentioning that after the first US\$11,000 was given to Mr. Teah to carry on the show, the money was allegedly misapplied, causing serious problem for the organization.

Meanwhile, the source reveals the USA team is preparing a letter to be delivered to lawyers of MLMA and subsequently hold a news conference, but didn't state what the letter is all about.

Let's make the top a place where we can get rich (Not Fame). We are done finally; don't hunt what you can't kill." CIC also posted on his social media page that the case has not closed yet and it was early for other people to start celebrating. The artist's post continues that the case has been transferred from the Paynesville Magisterial Court on grounds that it borders on slander and damages, which the Paynesville Magisterial lacks jurisdiction to prosecute. He says therefore, the case will be furthered at the Circuit Court of Monrovia, meaning it was too early for anyone to celebrate.

By E. J. Nathaniel Daygbor rand Kru County Representative Cllr. J. FonatiKoffa and Senator Varney G. Sherman of Grand Cape Mount County are locked in words of war here, over the ongoing Sable Mining case, as the former described the latter's testimony as "tarry of falsehood."

The Grand Kru Lawmaker once headed a Special President Task Force that was constituted by former president Ellen Johnson Sirleaf to probe a Global Witness investigative report titled, The Deceivers, which links several Liberian officials, including Senator Sherman of taking bribe totaling US\$950,000.00 to change the concession law of Liberia in favor of the British firm, Sable Mining to win a bidding process.

Following preliminary findings, the former Sirleaf administration subsequently indicted and charged several former and current officials, including Cllr. Sherman and ex-Speaker Alex Tyler with multiple crimes such as bribery, economic sabotage, criminal conspiracy, criminal

solicitation and criminal facilitation, respectively.

Now, Rep. Koffa has strongly criticized the unprecedented manner in which the Criminal Court " C" at the Temple of Justice is allowing the indicted Sable Mining defendant Senator Varney Sherman to proceed in ongoing crossexamination.

Addressing a news conference in his office at the

Capitol Thursday, July 04, he says it is incomprehensible to allow a defendant parade himself before the court in an action of "showman", without being cross-examined.

"For three days now, Defendant Senator, Cllr. Varney Sherman has been in a tarry sparring falsehood in an attempt to seek public sentiments in the ongoing Sable Mining prosecution. Cllr.

Sherman during those three days made unsubstantiated comments against the high earned reputation of members of the Special Presidential Taskforce tasked with investigating the Global Witness, Sable Mining bribery allegations report linking former and current government officials of government to receiving bribe to award a concession agreement, particularly the Wologizi Mountain range, in Lofa County, observes Cllr. Koffa, who currently heads the House Judiciary Committee.

According to him, he wonders why would Cllr. Sherman be sparring lies and misinformation of the activities and performance of the Special Presidential Taskforce he (Sherman) said, the 'Presidential Taskforce was nothing but a setup to witch hunt and a money spending team.'

He argues that contrary to Cllr. Sherman's accusation, his (Sherman's) indictment along with others grew out of a 'Global Witness report', to which none of the members on the special task force or in the Government of Liberia knew about except Cllr. Sherman.

"We will not permit the lies and deception of Cllr. Sherman's to undermine the credibility of persons with credible credentials to be dented. This case grew up of a Global Witness report alleging systematic allegations of bribery on now defendants, including Cllr. Varney Sherman. We never knew about this Sable Mining Case until it was duly reported but contrary to claims now that we are which hunting him, Cllr. Sherman knew, so then, how can he says the special task force was about to witch hunting him and others? This is complete deception."

He continues: We are aware that Cllr. Varney Sherman was contacted by British media long before this matter came about through Global Witness, and he refused to comment to the matter. So why is he labeling members of the Special Presidential Taskforce who are only determined to rescue the image of our country by bringing to justice those persons and individuals intending to avert the

economic benefits of the entire country for personal gains."

Commenting on claims that the special presidential taskforce spent US\$4.5 million so far in bringing the defendants to justice, Cllr. Koffa says contrary to these assertions, the Taskforce spent US\$1.1 million to begin recovering government stolen money and properties, and the process leading to bringing to Justice of now-indicted Cllr. Varney Sherman and others. including former House Speaker Alex Tyler.

"Factual evidence to the involvement of Cllr. Sherman and others were obtained from Cllr. Varney Sherman own email server by Yahoo, his bank accounts showing cancelled checks and new payment checks to him and his comptroller, the BBC report, the British Guardian Newspaper publication, including the Sable Mining Company own files. So tell me, where is the witch-hunt for Cllr. Varney Sherman"? Koffa asks.

Senator Sherman, who is the defendant, is protesting against the exclusion of British mining firm Sable Mining and Andrew Grooves from the economic sabotage trial of top Liberian officials who were allegedly bribed by the company to change concession laws.

"It is not required for a person to be a [rocket] scientist to conclude both the giver of the bribe and receiver are guilty," Sherman testified Wednesday, 3 July in the economic sabotage trial for alleged US\$950,000 bribe offered by Sable Mining for favorable concession laws.

He believes that the trial is "merely a political witch hunt and a vendetta" submitted by former President Ellen Johnson - Sirleaf, having nolleprosequi (dropped case against) the company and Mr. Grooves who allegedly bribed the defendants in the case.

The defendant, also a lawyer, is one of several top Liberian officials accused by prosecution in the bribery case, with claim particularly against defendant Sherman that as lawyer for the British mining firm, he allegedly inserted Section 75 in the Public Procurement and Concession Commission (PPCC) Act regarding non - bidding process favoring Sable Mining. -Editing by Jonathan Browne

Senate rejects CBL nominees

n a rare legislative decision since the ∎inception of the Coalition for Democratic Change (CDC) - led government, the Senate Committee on Banking and Finance has rejected three persons nominated by President George Manneh Weah to occupy certain positions at the Central Bank of Liberia (CBL).

The Committee chaired by Grand Gedeh County Sen. Marshall Dennis said Thursday, 4 July that Mr. Richard A. Dolley, Mr. Timothy Thomas and Mr. James B.

Dennis are not qualified to serve as members of the CBL's Board of Governors.

Their appearance before the Senate Committee followed their recent appointment by President Weah.

The Committee has further asked the plenary of the Senate to reject the presidential appointees.

The Committee's report says Mr. Dolley and Mr. Dennis have served on the management team of the CBL and even up to the position of Deputy Governors.

The Committee further notes that judging from a report by a presidential investigative team that points to long term lack of proper internal control system at the CBL.

According to the Committee's observation, two of the nominees have no knowledge in developing policies to mitigate any problem of internal control at the CBL.

Further, the Committee report signed by its chairman Marshall Dennis and approved by majority of its members reveals that Mr. Timothy Thomas' testimony at the hearing proves that he has no idea of the country's current economic problems.

Given the observations expressed by the Committee, it came to a conclusion that none of the three nominees are convincing in terms of proactiveness and robustness to take head on the [creeping] threat that the economic status of the country posses to its citizens in this contemporary dispensation. The Committee therefore recommends that the Senate Plenary unanimously reject the three nominees to the CBL Board of Governors because they all lack the needed experiences, institutional knowledge and up - to - date economic management competences to resuscitate

NEC cites technical reasons

he National Elections Commission (NEC) has indefinitely postponed the conduct of the Montserrado County Senatorial and District #15 Representative by - elections for the second time, citing "technical and operational reasons."

The decision announced Thursday evening, 4 July comes just four days to the conduct of the two by elections that were due to be held on July 8 after they were first rescheduled from July 2.

"The Commission says the postponement is strictly on the basis of technical and operational reasons. The NEC also emphasizes that the postponement is motivated by professional considerations," the Commission announces.

The Senatorial and Representative by - elections are caused by the deaths of Sen. Geraldine Doe - Sheriff following prolonged illness and District #15 Rep. Adolph Lawrence in a fatal car crash along the Roberts International Airport (RIA) highway.

The Commission had indicated that it needed US\$2.5m for the conduct of the elections, but it is not certain if all of the amount required by the Commission was made available by the cash strapped regime of President George Manneh Weah.

By June 18 the NEC reported that Government had provided US\$1.5m out of the US\$2.5m required, subsequently announcing the first postponement of the by elections.

Four days to the conduct of the rescheduled polls, the Commission again revealed on Thursday that pre-packed kits have not arrived into the country and have made the by -


