

Lesotho PM to be charged with murdering his wife

esotho's Prime Minister Thomas ■Thabane, 80, is to be charged with the murder of his estranged wife Lipolelo Thabane, police have said.

Mr Thabane announced he would be stepping down in July because of old age, without commenting about the case. His current wife Maesaiah Thabane has already been charged with the murder.

He would be the first African leader to be charged with a domestic murder while in office, in a case that has shocked the tiny mountain kingdom.Lipolelo, 58, was shot dead two days before Mr Thabane became prime minister in 2017.

At the time, he described her killing as "senseless" but police now accuse him of being involved in her killing.

"The prime minister is going to be charged with the



murder," Deputy Commissioner of Police Paseka Mokete was quoted by Reuters news agency as saying.

"The police are preparing directives and he will probably be charged tomorrow [Friday]," he added. What does the prime minister say?

Mr Thabane said on state radio that he had served the nation "diligently" and he would retire at the end of July, Reuters reports.

"I've worked for a peaceful and stable Lesotho. Today... at my age, I have lost most of my energy," he was quoted as

The ruling All Basotho Convention had given him a deadline of Thursday to resign.Lesotho's prime minister is not going down without a fight - his party, the All Basotho Convention (ABC) and its leadership, were expecting him to accept an ultimatum to step down ahead of the opening of parliament on Friday but he has refused.

But it now looks highly unlikely that he will be appearing at parliament on Friday as planned.

It's a desperate time for Mr Thabane, who has lost favour with his allies in this coalition

government. He is now seen as a sinking ship and they do not want to go down with him.

The prime minister is running out of time and room to manoeuvre - the country's police want him charged and hauled before a court, all by the end of this week.

His arrest will not only be a great humiliation to the prime minister but could also plunge the country in a constitutional crisis - it's not every day that a sitting leader is charged with a

Lipolelo was gunned down at close range on the side of a dirt road while returning to her home in a small village on the outskirts of the capital, Maseru.

Pregnant behind bars with a 2-year-old kid

lif Aydin, 31, is one of the educators arrested in Turkey over the past three years. She was two-months pregnant when she was sent to prison in the western province of Gebze on May 25, 2018. She also had two kids, 6 and 3 vears old at that time.

She couldn t leave behind her younger child, Musab; thus, she brought him along to prison. They did not provide a separate bed for her son in the eight person ward . The pregnant woman stayed by sharing the same

bed with his son in prison for months .

The pro Kurdish People 's Democratic Party (HDP) 's deputy Ömer Faruk Gergerlioglu, a prominent human rights activist, has been fighting for her release from

Turkish law forbids the arrest of pregnant women; however, this ban has not been applied for suspects from the Gulen movement and of Kurdish origin.

Gergerlioglu filed a complaint on July 1, 2018, with the Supreme Council of Judges

and Prosecutors (HSYK) against the judge and prosecutor who gave the arrest decision for Elif Aydin. A response from HSYK to his complaint came 1.5 years later. They have not investigated it so far.

"By this decision, HSYK has become an accomplice to this crime," Gergerlioglu said.

Elif Aydin, on the other hand, is trying to be the voice of other arrested pregnant women by revealing what she had been through.

Aydin: "I fell downstairs twice"

"I was the director of a private student residence. That was the only accusation leveled against me. My husband had stayed in prison for a year over links to the Gulen movement. They arrested me nine months after he was released from jail. I left my older child behind and took Musab in prison with me. And I was pregnant with my third child. We all three were trying to sleep in the same bed.

"I fell downstairs twice and was taken to the hospital. My kid, Musab, also fell downstairs several times, and his face and eyes got hurt. The ward was an eight-person ward, but there were times also where nine people had been staying in our ward. The prison is tough for a

Ethiopian 18th Century crown returns home

n 18th Century Ethiopian crown has been returned home after being hidden in a Dutch flat for more than 20 years.

Ethiopian Sirak Asfaw, who fled to the Netherlands in the late 1970s, found the crown in 1998 in the suitcase of a visitor and realised it was stolen.

The management consultant protected it until he alerted a historian and Dutch police of his discovery last year.

crown".Mr Sirak left his home country in 1978 to escape the political repression of the Communist government, or Derg, which had come to power in 1974. The regime unleashed a wave of violence known as the Red Terror, which killed hundreds of thousands and forced many to leave.

The former refugee used to host Ethiopians who had left the country in his Rotterdam flat throughout the 1980s and 1990s. "Friends, refugees,



On Thursday, Ethiopia's Prime Minister Abiv Ahmed received the crown, thought to be one of just 20 in existence.The crown has depictions of Jesus Christ, God and the Holy Spirit, as well as Jesus' disciples, and was probably given to a church by the powerful warlord Welde Sellase hundreds of years ago.

In a tweet, Mr Abiy said he was grateful to Mr Sirak and the Dutch government for the return of the "precious whoever," he said. It was one of these visitors staying at his home in 1998 who was carrying the crown in his bag.

"Most people don't really care about this cultural heritage. I'm loyal to Ethiopia," he told the BBC in an interview last year.

Mr Sirak confronted the man and insisted the crown was not leaving unless it could be returned to its home.



EDITORIAL

Our hearts bleed for Journalist Miller !

LIBERIAN JOURNALISTS CURRENTLY mourn the sudden passing of one of their very best, Koboi Zenu Miller of OK FM 99.5on Saturday, 14 February after an cruel encounter with state security forces during a national county sports meet in January at the Samuel Kanyon Doe Sports Complex in Paynesville.

A PROFICIENT BROADCASTER, talk show host and sports commentator, the late Zenu had gone to commentate or cover the match between Grand Kru and Nimba counties when he reportedly encountered ruthless officers of the elite presidential guard, Executive Protective Service who beat him on 26 January 2020, leaving him to complain of chest pains up to his abrupt demise.

"I WAS ATTACKED tonight at the SKD ["Samuel Kanyon Doe" Stadium] by EPS [Executive Protective Service] officers in the full view of the EPS director. Gosh!!!", Zenu had posted subsequently on his Facebook page following the incident.

WHAT LEVEL OF investigated was conducted by the EPS following the alleged flogging is not clear but Zenu departed this world in pain, abandoning his loving family and relatives, friends and professional colleagues. He reportedly died at the ELWA Hospital in Paynesville.

THOUGH THE REAL cause of death may be established later, we demand a thorough investigation from the government, especially, authorities of the EPS to ascertain what transpired on 26 January that led to the brutal flogging of the deceased and his subsequent death.

NOTWITHSTANDING, THIS IS how much we know about security brutalities resulting to injuries and deaths under the Weah administration: On January 6, armed police dispersed peaceful protesters with teargas and water canisters, arresting at least 26 on the grounds of the Capitol where they had converged to demand answers from the government to earlier petitions, while on Tuesday, 15 October 2019 police teargased protesting students in the streets of Monrovia, demanding their teachers to return to the classroom. Then on November 7, 2019 police shot and killed a teenager and wounded two others in Kingsville, Montserrado County while dispersing angry residents, who had erected a roadblock to demand the death of a juvenile. A year later, a police commander had chased a motorcyclist and shot him at point blank before shooting himself in his hand, portraying that he was attack. These are among some of the many excesses by state security forces against the civilian population over the period.

THAT THE LATE Journalist Miller wrote on his Facebook following his beating by EPS officers the incident happened in the presence of the director of the institution, Trokon Roberts, is of grave concern and should be investigated. How the EPS chief could allegedly allowed such inhumane behavior occurred in his presence without intervening?

EVEN AFTER THE incident, there was no official condemnation or comment because attacks against journalists in Liberia have become a norm. From time to time, journalists have been manhandled and their gadgets destroyed by state security officers without proper redress. This has to stop! These are patriotic citizens providing selfless contributions to the Motherland. They should be accorded due courtesies and respect.

ZENU DID NOT deserve to have died the way he departed - at the cruel hands of security officers protecting the President. This is why the authorities should conduct an investigation characterized by an autopsy to unearth nothing else but the whole truth.

THE JOURNALISM PROFESSION, the Press Union of Liberia and the entire country have lost one of the best species of ours while serving in the line of duty at the time he was needed more. Our hearts bleed for his early departure in a manner that is so despicable.

China's Great Leap into Epidemic

The COVID-19 outbreak in China is not the first public-health emergency enabled by the absence of freedom of speech in China, and it is far from the worst. Between 1958 and 1962, the inability to criticize bad policy led to a famine that killed an estimated 36 million Chinese.

based ophthalmologist, Li Wenliang, noticed something strange in a few patients. They seemed to have contracted an unfamiliar virus that resembled severe acute respiratory syndrome (SARS), which hobbled China nearly a generation ago. A few days later, after Li had sent a warning message to several doctors in a group chat, the 34-year-old doctor was summoned by the police, who forced him to sign a letter confessing to "making false comments" that had "disrupted the social order." Li is now dead, a victim of the very sounded the alarm.

Li's death - together with further revelations of China's efforts to silence COVID-19 whistleblowers - has sparked global outrage, and rightly so. Had the government been more concerned about protecting public health than suppressing unflattering information, it may have been able to prevent the virus from spreading. So far, COVID-19 has infected more than 74,000 in China alone, with over 2,000 dead.

And yet this is not the first time that the denial of freedom of speech has been linked to a deadly public health emergency in China. When the SARS epidemic began in 2002, the Chinese authorities also initially attempted to cover it up.

Fortunately, Hu Shuli - the founder and managing editor of Caijing, a business weekly exposed officials' machinations relatively quickly. After learning that patients in Beijing had mysterious fevers, she sent journalists to hospitals to interview physicians. Caijing's reporting helped force China's leaders to acknowledge SARS publicly - the first step toward bringing the virus under control. Still, by the time SARS was contained, the virus had spread to more than 8,000 people worldwide and killed almost 800.

It also played a significant role in enabling the devastation caused by Mao Zedong's Great Leap Forward - the greatest calamity China has faced since the Communist Party took power in 1949.

In 1958, Mao decided that, in order to achieve rapid industrialization, villagers should be forcibly herded into communes, where they would perform industrial tasks that elsewhere would have relied on machines and factories. For example, millions were tasked with producing steel in small backyard furnaces, often by melting down farming implements.

By diverting labor into highly inefficient smallscale industry, the Great Leap Forward gutted agricultural production, resulting in severe food shortages, which persisted even after the initiative was ended in 1960. According to the Chinese journalist Yang Jisheng - whose

Protecting Mao's reputation was the top priority, and, given China's extreme international isolation at the time, the outside world would not find out unless the Chinese told them.

> Suppression of the truth about the Great Leap Forward persists to this day, with party officials preferring to downplay the tragedy by portraying it as the result of bad weather conditions. Yang's book still cannot be published in mainland China.

> The link between famine and freedom of speech is not limited to China. As the Indian philosopher and Nobel laureate economist Amartya Sen noted some two decades ago, "no famine has ever taken place in the history of the world in a functioning democracy." Leaders who depend on the support of voters with the freedom to criticize public policies are generally unlikely to uphold policies that cause those voters to starve.

> This has not been the case in, say, Zimbabwe, where about half the population - some 7.7 million people - currently face food insecurity, according to the World Food Program. Unprecedented levels of malnutrition beset eight of Zimbabwe's 59 districts.

Zimbabwe has long been known as "the breadbasket of Africa," thanks to its relatively mild climate. But climate change is taking its But repression of free speech in China has an toll. Making matters worse, decades of economic even more disturbing public-health pedigree. mismanagement by Robert Mugabe - who dispensed with democratic accountability during his 37-year-long rule, which ended when the military forced him to resign in 2017 - have produced runaway inflation, high unemployment, fuel shortages, and prolonged power outages. All of this has worsened Zimbabweans' plight significantly.

> Freedom of expression is about far more than direct political dissent or tolerance of ideas, acts, or images that we find offensive. As Sen wrote in 1990, "one set of freedoms - to criticize, to publish, to vote - are causally linked with other types of freedoms," such as "the freedom to escape starvation and famine mortality." To that list we should add "the freedom to avoid death by COVID-19."

The purpose of the Description of Services is to provide concise details of each service area for which USAID wishes to identify relevant private sector actors. It is also intended to inform parties who may be interested in the RFI as to what quality of capability the RFI seeks to identify in the Supply Chain Industry.

- 1. Warehouse Co-Management The RFI seeks to identify firms capable of providing modern warehouse mentoring service to existing warehouse management team while co-managing the Central Medicine Store (CMS) for at least two years, after which they should have trained and enabled the current management team to independently and efficiently manage the Central Medicine Store(CMS). The CMS, located in Caldwell, Montserrado County is a 55M X 68M, 12M high government owned fully equipped multi-million-dollar modern health commodity warehouse manned by a staff of fifty(50). It has at least eight (8) management and operations offices, three (3) cold rooms and storage racks totaling two thousand five hundred and fifty-three (2553) units. UNDP/OHCHR Launch Rehabilitation Programme at Monrovia Central Prison

he United Nations Development Programme (UNDP) in partnership with theOffice of the High Commissioner for Human Rights (OHCHR) has launched a rehabilitation project at the Monrovia Central Prison (MCP).

Under the UNDP/OHCHR Joint Rule of Law programme,

the project is funded by the Governments of Sweden and Ireland and has procured 44 pieces of tailoring machines and other assorted materials for soap making expected to be used to train 133 inmates and 11 correction officers as instructors.

The launching ceremony was performed Wednesday 19



February 2020 by the Minister of Justice, Counselor Musa Dean, who urged the inmates to take advantage of the opportunity to learn new skills that will be beneficial to them.

Counselor Dean described rehabilitation as a challenging enterprise with limited resources adding that, punishment for a crime requires one to serve a jail term where rehabilitation becomes a necessity.

"Tracking the impact of such program encourages investment in employing or empowering the ex-convicts with seed money," Justice Minister added.

The Minister acknowledged the congestion of the Monrovia prison which holds 1,260 inmates against its holding capacity of 324 inmates.

He recognized the work of the fast track court at the prison and the continued support from UNDP and donor partners in the operationalization of specialized courts in parts of the Country.

"This project has a duration of three years, and it's expected to be completed and dedicated like we indicated on July 26, 2023," he says.

Mr. Nyenpan indicates that mobilization of financing for this project was initiated and concluded by President Weah's government.

Justice Minister Dean appealed for assistance from development partners to assist in constructing of a new corrections facility at a 40acre land which the Bureau of corrections and rehabilitation owns

The idea behind the construction is engage inmates in farming activities where they can produce their own food.

The Swedish government representative Ms. Elizabeth Harleman emphasized that the programme was critical and encouraged its establishment in all facilities nation-wide.

She pledged Sweden's commitment to increasing access to justice.

Harleman welcomed the government's commitment to reduce the rate of pre-trial detention from 63% to 20% which according to her, is a good target.

She noted that many people are on pre-trial detention and have stayed for long periods

without facing trial. "This continues to undermine justice, and, in some instances, there are no

separate rooms for male and female inmates," she reiterated.

Elizabeth Harleman further acknowledged the efforts being made by civil society organizations in reducing pretrial detainees.

AT the same time, Ireland's Representative in Liberia, Ms. Rachel Fitzpatrick in her remarks said, that her government is engaged in supporting rehabilitation programme in prisons as a new area of focus.

She noted that it provides a greater opportunity for inmates to be self-sufficient upon release.

Earlier, the Chief Technical Advisor for the UNDP/OHCHR Rule of Law Joint programme Rowland Cole, noted that Correction institutions worldwide are normally forgotten in terms of funding and this puts a lot of pressure on the entire criminal justice chain.

Cole added that rehabilitation of inmates is most critical in reducing the

MCA-L and Public Works Ministry Commit to improving Liberia's

road network through maintenance support

Millennium Challenge Account-Liberia (MCA-L) and the Ministry of Public Works (MPW) have committed to coordinating their efforts to strengthen Liberia's capacity to provide routine maintenance of paved and unpaved primary roads.

The two entities signed an Implementing Entity Agreement, providing for the MCA-L and the U.S.-based **Volpe National Transportation** Systems Center to fund necessary support to strengthen MPW's capacity to sustainably manage its road maintenance programs through effective use of a US\$1 million proposed Road Asset Management System (RAMS).

Prior to this agreement, MCA-L and Volpe had already provided support to MPW for data collection activities (traffic counts, road inventory, and condition surveys) and trained 15 staff (including 4 females) from MPW and the National Road Fund (NRF) to use a datadriven computer software for road maintenance, known as HDM-4.

Some of these individuals became trainers and led the team that developed the country's five-year Road Maintenance Plan, which is updated every fiscal year for collaboration with their NRF counterparts to prepare the



Annual Road Maintenance Expenditure Programs in strict accordance with the National Road Fund Act of 2016.

Through this new agreement, RAMS will integrate with HDM-4 and the various software systems currently used by MPW to provide a userfriendly database for data collection, planning, execution, and other maintenance-related functions for managing Liberia's entire road network.

As part of the support, MCA-L will also provide institutional strengthening and capacity building, including new Gender and Social Inclusion and Monitoring and Evaluation units at MPW, as well as a consultant for NRF to study the Road User Charges that generate revenues for the Road Fund.

MPW will dedicate staff

(trained in HDM-4) to support MCA-L with the procurement and implementation of RAMS, and be solely responsible for administering and maintaining the system to ensure sustainability well beyond the end of the compact in 2021.

MCA-L CEO MonieCaptan said his organization would remain fully engaged with the Government of Liberia to achieve MCA-L's goal of stimulating economic growth through poverty reduction by improving the country's road network.

"The compact support is helping Liberia build a datadriven system to inform road maintenance in the country," he said.

"Routine maintenance of Liberia's roadways produce better roads, which can have far-reaching dividends for Liberians and the Liberian economy. With better roads, drivers will reduce travel time. the cost for transport, and vehicle repair. With better roads, farmers can get their products to the market

quickly, students can get to

school on time, patients can get to health posts on time, and police can arrive at crime scenes on time."

Improving Liberia's road infrastructure is one of the two key projects of the Millennium Challenge Corporation compact between the U.S. and Liberian governments because improved roads will stimulatetrade and commerce, which will help businesses grow with sustainable increases in their profit margins.

About MCA-L: In October 2015, the Government of the United States of America, through its development agency, Millennium Challenge Corporation, provided a grant of US\$257 million to Liberia. MCA-L is an independent, legal, and autonomous agency of the Government of Liberia created by the legislature to administer the compact projects, which address the lack of access to reliable and affordable electricity and inadequate road infrastructure.

woman with a child. It was summer, fortunately, when I was jailed, so we could spend most of our time in the yard. When it became colder, we had to stay inside."


"There was no hygiene in prison. Musab's eyes caught an infection. He hit his head on the bunk beds many times. He fell off the bunk bed, and he hurt his head and mouth. I was pregnant and was seeing all these (Musab had been through) so, I grew depressed.

"Many pregnant women were arrested like me. And,

this is still going on. There are no special arrangements or facilities in place for pregnant women and children in prison. Life is quite hard in prison."

Elle a révélé que le gouvernement a identifié un système pétrolier qui fonctionne à merveille, ce qui est un signe de la présence des hydrocarbures dans les eaux maritimes du Libéria. Elle s'est dite confiante qu'avec du travail de fond dans ce processus, l'on découvrira une quantité importante.Quant au sousministre de l'Énergie, des Terres, des Mines et de l'Énergie, il a fait remarquer que la participation des citoyens dans ce processus est un élément indispensable à la réussite, d'où l'importance de donner la priorité à l'intérêt du peuple et du pays dans son ensemble. Il a exhorté la LPRA et la NOCAL à poursuivre ces réunions.

Le vice-président des services techniques de NOCAL, le Dr Lester Tenny, a pour sa part dénoncé le fait que l'image du secteur pétrolier a été ternie par une série de controverses dans le passé. Il a insisté sur la nécessité de gérer de façon optimale l'information qui est aussi importante que les résultats, car le secteur pétrolier est très sensible. Il s'est aussi dit confiant que le Libéria possède du pétrole. «Le Libéria a du pétrole, les indications sont là, il suffit de chercher pour le découvrir. »

La NOCAL, selon lui, continuera à fournir une assistance financière dans la mesure du possible aux régulateurs, il est toutefois important que le ministère des Finances soutienne également financièrement le processus, car pour atteindre ses objectifs, le régulateur a besoin d'un soutien financier suffisant. Il a averti que si le régulateur ne dispose pas de moyens financiers suffisants, le travail risque de retarder.

Le député Vicent Willie, représentant du district4 du comté de Grand Bassa, qui préside le Comité législatif sur les ressources naturelles, a déclaré que l'Assemblée législative est disposée à aider le processus de quelque manière que ce soit, pourvu que les régulateurs se conforment à la loi, en particulier la nouvelle loi amendée sur le pétrole.

Le grand bond en avant de la Chine dans l'épidémie

connaissance du nouveau coronavirus qui a déclenché une panique mondiale, un ophtalmologiste basé à Wuhan, Li Wenliang, a remarqué quelque chose d'étrange chez certains patients. Ils semblaient avoir contracté un virus inconnu qui ressemblait au syndrome respiratoire aigu sévère (SRAS), qui a touché la Chine il y a près d'une génération. Quelques jours plus tard, après que Li ait envoyé un message d'avertissement à plusieurs médecins lors d'une discussion de groupe, le médecin de 34 ans a été convoqué par la police, qui l'a forcé à signer une lettre pour avouer « avoir fait de faux commentaires » qui avaient « perturbé l'ordre social ». Li est à présent décédé, victime de ce même virus - maintenant appelé COVID-19 - pour lequel il avait sonné l'alarme.

La mort de Li - ainsi que d'autres révélations sur les efforts de la Chine pour faire taire les dénonciateurs du COVID-19 - ont déclenché une indignation mondiale, à juste titre. Si le gouvernement s'était inquiété davantage de protéger la santé publique plutôt que de supprimer des informations peu flatteuses, il aurait pu empêcher la propagation du virus. Jusqu'à présent, le COVID-19 a infecté plus de 74 000 personnes rien qu'en Chine, faisant plus de 2 000 morts.

Ce n'est pourtant pas la première fois que le déni de liberté d'expression est lié à une urgence meurtrière en matière de santé publique en Chine. Lorsque l'épidémie de SRAS a commencé en 2002, les autorités chinoises ont également tenté d'étouffer l'affaire.

Heureusement, Hu Shuli - fondatrice et rédactrice en chef de Caijing, un hebdomadaire d'affaires - a exposé relativement rapidement les machinations des fonctionnaires. Après avoir appris que des patients de Pékin avaient des fièvres mystérieuses, elle a envoyé des journalistes dans les hôpitaux pour interroger les médecins. Les reportages de Caijing ont forcé les dirigeants chinois à reconnaître publiquement le SRAS - la première étape vers le contrôle du virus. Pourtant, avant que le SRAS n'ait été contenu, le virus s'était propagé à plus de 8 000 personnes dans le monde, tuant ainsi près de 800 personnes.

Mais la répression de la liberté d'expression en Chine a un pedigree encore plus troublant en matière de santé publique. Elle a également joué un rôle important dans la dévastation causée par le Grand Bond en avant de Mao Zedong - la plus grande catastrophe que la Chine ait connue depuis que le Parti communiste a pris le pouvoir en 1949.

En 1958, Mao a décidé que, pour parvenir à une industrialisation rapide, les villageois devraient être contraints de se rassembler dans les communes, pour y effectuer des tâches industrielles qui, ailleurs, pouvaient s'effectuer sur des machines et dans des usines. Par exemple, des millions de personnes ont été chargées de produire de l'acier dans de petits hauts fourneaux de cours de ferme, souvent en fondant des outils agricoles.

En détournant la main-d'œuvre vers une industrie à petite échelle très inefficace, le Grand Bond en avant a ravagé la production agricole, entraînant de graves pénuries alimentaires, qui ont persisté même après la fin de l'initiative en 1960. Selon le journaliste chinois Yang Jisheng, dont le compte rendu digne de foi sur la famine qui en a résulté,

Comme pour le COVID-19, des informations vitales sur les conséquences calamiteuses du Grand Bond en avant ont été réfrénées dès le début. Au début, les responsables du gouvernement central n'étaient pas au courant de la catastrophe qui se déroulait dans les campagnes, en raison de la réticence des autorités locales à relayer des informations qui auraient pu être jugées comme autant de critiques à l'encontre de Mao.

Mais même lorsque les principaux dirigeants chinois ont appris la famine, ils ont passé le problème sous silence, plutôt que de faire appel à une aide extérieure. La protection de la réputation de Mao était la priorité absolue, et compte tenu de l'isolement international extrême de la Chine à l'époque, le monde extérieur ne découvrirait rien à moins que les Chinois n'en parlent.

La répression de la vérité sur le Grand Bond en avant persiste jusqu'à ce jour, les responsables du parti préférant minimiser la tragédie en la dépeignant comme le résultat de mauvaises conditions météorologiques. Le livre de Yang ne peut toujours pas être publié en Chine continentale.

Le lien entre la famine et la liberté d'expression ne se limite pas à la Chine. Comme l'a souligné le philosophe et prix Nobel d'économie indien Amartya Sen il y a près de deux décennies, « aucune famine n'a jamais eu lieu dans l'histoire du monde dans une démocratie qui fonctionne ». Il est généralement peu probable que les dirigeants qui dépendent du soutien des électeurs qui ont la liberté de critiquer les politiques publiques, soutiennent des politiques qui font affamer ces électeurs.

Cela n'a pas été le cas au Zimbabwe, où environ la moitié de la population (environ 7,7 millions de personnes) est actuellement confrontée à l'insécurité alimentaire, selon le Programme alimentaire mondial. Des niveaux de malnutrition sans précédent assaillent huit des 59 districts du Zimbabwe.

Le Zimbabwe est depuis longtemps connu sous le nom de « grenier à blé de l'Afrique », grâce à son climat relativement doux. Mais le changement climatique se fait sentir. Pire encore, plusieurs décennies de mauvaise gestion économique par Robert Mugabe - qui s'est dispensé de la responsabilité démocratique au cours de ses 37 ans au pouvoir et qui a vu son régime prendre fin lorsque l'armée l'a forcé à démissionner en 2017 - ont produit une inflation galopante, un chômage élevé, des pénuries de carburant et des pannes d'électricité prolongées. Tout cela a considérablement aggravé la situation des Zimbabwéens.

La liberté d'expression va bien plus loin que la dissidence politique directe ou la tolérance des idées, des actes ou des images que nous estimons offensantes. Comme Sen l'a écrit en 1990, « un ensemble de libertés - critiquer, publier, voter - est lié de manière causale à d'autres types de libertés » telles que « la liberté d'échapper à la famine et à la mortalité liée à la famine ». À cette liste, nous devrions ajouter « la liberté d'éviter la mort par le COVID-19 ».

« Je m'exprime mieux

affranchis arrivés des Etats-Unis ont asservi leurs frères qu'ils ont trouvés sur place.

« J'ai des oncles et des tantes qui ne parlent pas anglais. Nous ne devons pas permettre aux gens de nous diviser. Si quelqu'un est allé comme esclave et est revenu, nous avons tous payé le prix », a-t-il ajouté, avant de conclure que les politiciens qui se disent plus autochtones n'ont même pas de maison dans leurs villages.



usinessman turned politician Benoni Urey on Wednesday February 19, denied allegations that he used the Bureau of Maritime money to buy arms and ammunition for jailed former President Charles Taylor during the country's brutal civil war.

"I Benoni Urey will never buy arms and ammunition to kill my people," he roared during a press conference here. He described the long held speculation as total rumor saying people are in the habits of saying things they know nothing about.

Mr. Urey served as Maritime Commissioner under former President Taylor and has been accused of bankrolling the war through the maritime fund.

He is currently the political leader of the All Liberian Party or ALP, a party which is part of an Alliance of four political parties that seek to unseat President George Weah in 2023.

He was placed on sanction



and travel bans for many years but was later removed following series of investigations that found him posing less of a threat to the peace of Liberia.

"When I left Maritime, I was audited and investigated for

almost 15 years by Homeland Security (United States) and they found nothing on me" a self-feeling vindicated Urey explained.

Mr. Urey said what he remembered was the purchasing of two ex-military

helicopters for use by the police and the Presidential Security force Special Security Service or SSS now referred to as the Executive Protection Service or EPS.

He explain how

"I got a letter from the Finance Minister authorizing me to instruct the Agent (Liberia Shipping and Corporate Registry or LISCR) to transfer USD630, 000 to buy two helicopters MI-3 for the use of the police and SSS-François Massaquoi died in one. They were Ex-military helicopters.

When I got the instruction, I wrote my Comptroller and I said by directive of the President through the Finance Minister, you are hereby instructed to instruct the Agent to transfer this amount. So when this guy (Homeland Security Agent) came he asked me-Mr. Urey did you ever

transferred money to buy arms and ammunition I said no, He said what about e-military helicopter, I said yes. The guy pulled out the letter and said, yes its true, I thought you would have lied and I said what is there to lie about."

Meanwhile, Urey said he left 30 million in Maritime's account when the late Charles Gyude Bryant took over during the interim government arrangement after Taylor was forced into exile.

He said former president Taylor at one point in time requested the money and he refused. He said the 30m included profit accrued from USD305, 000 investment in EMULSAT, a satellite use for shipping navigation device at the time. RIA highway expansion to complete in 3 years

resident George Manneh Weah has broken grounds for the commencement of works for the expansion and reconstruction of the Roberts International Airport (RIA) highway road project to widen the road which he laments has claimed lives of thousands of unfortunate passengers in the 70 years of its existence.

"The RIA Highway has been a death-trap since it was built in the 1940s, during World War Two," President Weah said during the groundbreaking ceremony on Thursday, 20 February in Unification Town, just near RIA.

The 45km road project estimated by Public Works

officials at about US\$95m is expected to transform the current two - lane road to a modern four - lane major highway from ELWA to RIA.

President Weah notes that the RIA highway is the most convenient route for movement of people, goods and services to and from six of Liberia's 15 counties including Margibi, Grand Bassa, River Cess, Sinoe, Grand Kru and Maryland.

Additionally, he says some of these counties are hosts to several multinational corporations such as FireStone and Golden Veroleum.

"Let me take this occasion to remind you that road connectivity is a core pillar of my Administration, and it is the function of the Pro - Poor Agenda for Prosperity and Development," he continues.

He informs Liberians at the dedication that his government's infrastructural development programs have the strong support of international development

partners, expressing appreciation to the partners for the support and assuring them of utilizing resources put at government's disposal for their intended purposes.

According to President Weah, Liberians have given him lots of names as a result of his developmental programs, including "Country Giant," Talk and Do," and Feminist - in - Chief," adding that he has been given a new name called "Bad Road Medicine."

"They now call me Bad Road Medicine," President Weah says, adding that he is "very proud of this new title, which depicts me as the antidote to bad roads, and I will do my very best during the rest of my tenure to deserve it."

Earlier, Public Works Minister Mobutu Nyenpan said by breaking grounds for the ELWA - RIA Highway road project, the people of Liberia can be assured that comes July 26 2023,

Swiss prosecutors charge Al-Khelaifi in FIFA bribery case



he president of the Paris Saint-Germain soccer club was indicted Thursday as part of a five-year bribery and corruption investigation linked to FIFA.

Nasser al-Khelaifi, a Qatari who also runs the Doha-based broadcaster BelN Media Group, was charged in Switzerland in connection to a bribery investigation linked to World Cup television rights. Swiss federal

prosecutors also charged former FIFA secretary general Jerome Valcke with bribery. A unidentified third person was also charged.

Al-Khelaifi was implicated for allowing Valcke to use a luxury villa on the Italian island of Sardinia rent free in 2014 and 2015. At the time, Valcke had some influence over FIFA broadcast deals, including an extension of BeIN's Middle East rights for the 2026 and 2030 World Cups.

The office of Switzerland's attorney general filed an indictment charging Al-Khelaifi with inciting Valcke "to commit aggravated criminal mismanagement."

It is not clear if Al-Khelaifi will be arrested, or what kind of sentence or fine he could face.

As president of Qatariowned PSG, Al-Khelaifi is among the most significant officials in modern soccer targeted in sprawling FIFA investigations by American and Swiss federal agencies. A close friend of the ruling Emir in Qatar, Al-Khelaifi has run French champion PSG for eight years while overseeing the purchase of star players Neymar and Kylian Mbappé. His influence in European soccer rose when he joined the UEFA executive committee last year.

Despite Thursday's indictment, Al-Khelaifi no longer faces an accusation of bribery in a criminal proceeding opened three years ago.

Barcelona attacker Lionel Messi isn't surprised by Cristiano Ronaldo's recent Serie A scoring streak for Juventus as he praised the striker's ability to find the back of the net.

Ronaldo has scored in 11 straight league games for his Italian club despite turning 35 this month and has an impressive 24 goals to his name this season.

Messi, meanwhile, has gone four matches without a

goal but has contributed six assists in his three most recent appearances for the Catalans.

Messi himself has struck 14 times across just 19 La Liga games this season for Barcelona as he also shows he still has an eye for goal at the age of 32.

Former teammate Carles Puyol recently backed the Argentina attacker to play on until he's 38, with Messi himself admitting he's feeling good despite his advancing age.
