alawı has made wearing masks mandatory in public places in an effort to curb a surge in COVID-19 cases.

The Presidential Task Force on COVID-19 said the rule went into effect Friday night, and those who do not adhere to it will pay a fine of about \$15. Some rights activists, however, say the government should have first distributed free masks to make the rule justifiable.

The mandate on face coverings is among various measures Malawi has taken to try to contain the COVID-19 surge. Other steps include barring traffic police from touching a driver's license or any other documents.

All markets, shops and businesses that are in close proximity to hospitals have been ordered to close.

The government also has banned public gatherings, such as weddings, parties and bridal showers.

The restrictions come as Malawi continues to confirm increasing cases of COVID-19, with an average of 100 cases

had registered 4,575 coronavirus cases with 137 deaths.

Health rights campaigners commend the measures but say they raise more questions than answers.

George Jobe, executive director of the Malawi Health Equity Network, said that "as we are hearing that the masks will be compulsory, the question will be: What will follow if someone fails to pay prescribed fees?"

Jobe also said the rules have failed to address whether the government will provide free masks to people who cannot afford to buy them.

about 70% of Malawi's population lives below the international poverty line of \$1.90 per day.

Hilda Kalonga, a subsistence farmer in the Thyolo district in southern Malawi, told VOA she has not worn a mask since Malawi registered its first three COVID-19 cases April 2.

"I cannot manage to buy a mask because I cannot get money to buy one," she said. "It would make sense should the government start distributing masks for free before it made the wearing of

John Phuka, chairperson of the Presidential Task Force on COVID-19, told VOA on Saturday that the government already had signed a memorandum of understanding with local mask manufacturers to start distributing free masks to those who cannot afford them.

Phuka said those flouting the rule would pay a fine of about \$15.

In the meantime, Phuka said, law enforcement officers have been given permission to use "reasonable force" to enforce compliance.VOA

Volunteers race to keep oil spill away from Mauritius

olunteers in Mauritius are scrambling to create cordons to keep leaking oil from a tanker away from the island.

The MV Wakashio, believed to have been carrying 4,000 tonnes of oil, ran aground on a coral reef off the Indian Ocean island on 25 July.

Locals are making absorbent barriers of straw stuffed into fabric sacks in an attempt to contain and

absorb the oil.

Mauritius is home to worldrenowned coral reefs, and tourism is a crucial part of its economy.

Images posted online by local media show volunteers collecting straw from fields and filling sacks to make barriers.Others have been making their own tubes with tights and hair to add to the effort and some have been cleaning up the island's beaches.

Their actions go against an order from the government asking people to leave the clean-up to local authorities.

"People have realised that they need to take things into their hands. We are here to protect our fauna and flora," environmental activist Ashok Subron told AFP news agency. Mitsui OSK Lines, the operator of the ship, said it had tried to place its own containment booms around the vessel but had not been successful owing to rough seas. Helicopters are attempting to move some of the fuel and diesel off the ship.It is thought that the ship, registered in Panama, had some 4,000 tonnes of fuel aboard when it ran aground. All crew were evacuated. At least 1,000 tonnes of oil is thought to have leaked into the waters surrounding the i S l а n d nation.Environmentalists are concerned about the impact on the country's ecosystem.

Trump's Hypocrisy on China

US Secretary of State Mike Pompeo recently called Richard Nixon's opening to China almost 50 years ago a failure, and went on to declare a virtual cold war against the Chinese. But Trump's blustering unilateralism and contempt for democratically elected leaders have left the US unable to forge the alliances Pompeo rightly says it needs.

EW YORK - In a speech last month at the Richard Nixon Presidential Library and Museum, US Secretary of State Mike Pompeo declared politely that Nixon had been wrong about China. Opening up to the People's Republic, in the hope that its Maoist dictatorship, moderated by a warm international embrace, would become freer at home and more cooperative abroad, has ended in failure.

In fact, Nixon never sought to democratize China - he needed Mao's help to end the Vietnam War and gain leverage over the Soviet Union.

Still, Pompeo's indictment was long. China is less free now than it was in the 1980s, he claimed. It steals Western industrial secrets, sends government agents masquerading as students, stifles criticism with threats, locks up ethnic minorities and dissidents in concentration camps, blackmails countries into buying Chinese technology used to spy on the United States, and so on. "The free world must triumph over the new tyranny," Pompeo declared. "We, the freedom-loving nations, must induce China to change..."

Could he be correct about this? Might US President Donald Trump's administration be on the right side of history at least in this respect? Does China represent an existential threat to the "free world"?

If so, the Trump administration has been remarkably hypocritical. Trump himself has called Chinese President Xi Jinping his good friend on several occasions, and patently refused to criticize him for ignoring human rights, locking up political prisoners, or undermining the rule of law in Hong Kong.

But the administration's hypocrisy does not This is far worse than hypocrisy. It is a direct threat necessarily mean that Pompeo was wrong about China. The gist of what he said is true. The Communist Party of China (CPC) maintains a dictatorship at home and is often hostile to democracies abroad.

is too powerful, economic interests are too important, and the risks of turning a cold war into a hot one are too formidable. Only the Chinese can possibly break the CPC's monopoly on power in their country. To advocate "regime change" by external force would be insane.

China's vast wealth means that it can also afford to bully governments into buying Chinese technology, despite security concerns. This is hardly unique, of course. All big powers use their clout to compel others to fall into line. The US did so during the Cold War, and has sometimes done so since, to the detriment of the democratic freedoms of others. But at least the US has not been, on the whole, ideologically hostile to those freedoms, in the way that Chinese leaders are.

The question is what to do about it. How to defend what is left of the free world against the predatory strategies of a very rich and powerful dictatorship? Pompeo is right to stress the importance of solidarity. The way to organize the protection of common interests is to establish international organizations to safeguard and enforce common rules and laws. That is what the United Nations has been for, and the World Trade Organization, the World Health Organization, and also the EU.

These organizations are often deeply flawed. And the hope that asking dictatorships to join them will make those regimes less oppressive is often misplaced. China has used its WTO membership to defy the rules for its own benefit. The WHO, too, has been too willing to accede to China's demands. And the UN Human Rights Council, for example, has damaged its own mission by having some very unsavory regimes as members.

But that is no reason to abandon or ignore these institutions. Trump's "America First" policy and his instinctive affinity with dictators, including Xi, is destroying the very solidarity that Pompeo says the free world needs.

A bloody century of foreign invasions does not excuse bellicose Chinese nationalism, but it helps to explain China's touchiness. Jeering references to the "Kung flu" and wild accusations that all overseas Chinese students are government spies offends even the many Chinese who still draw hope from societies freer than their own. Inflaming Chinese national sentiment is the worst possible way to temper the behavior of China's leaders.

THEY UNDERSCORED THAT such action will send a clear signal that threats and violence have no place in the democratic dispensation the people of Liberia have established for their country.

Bring the Zwedru's violence

perpetrators to book speedily

FOREIGN MISSIONS IN Liberia recently called on the Weah

administration to swiftly investigate the July 30 political violence in Zwedru, Grand Gedeh County in an objective and non-partisan

manner to bring all those culpable to justice.

THE UNITED NATIONS, ECOWAS, United States Embassy and the European Union in a joint statement issued in Monrovia expressed support for concern expressed by several Liberian groups specifically, the Inter-Religious Council, the Catholic Diocese of Cape Palmas, the Providence Baptist Church, the Grand Gedeh Legislative Caucus and other religious and political stakeholders, including President George Manneh Weah and his Government, over use of hate speech and mob violence, particularly recent violent attack against opposition politicians in Zwedru, Grand Gedeh County.

IT IS ALMOST two weeks since hundreds of stone-throwing youths believed to be from the youth league of the governing Congress for Democratic Change chapter in Zwedru City, Grand Gedeh County besieged a local entertainment center, B-2 Guesthouse in the city on Thursday, 30 July and prevented the Chairman of the Collaborating Political Parties (CPP) Alexander B. Cummings and Montserrado County District#10 Representative Yekeh Kolubah from stepping outside.

FOR MORE THAN five hours, angry youths joined by thugs armed with stones, sticks and cutlasses, attacked the guesthouse entertainment center, Hotel B-2 in the heart of Zwedru City, where Chairman Cummings, Representative Kolubah and members of their delegation lodged, threatening to lynch Rep. Kolubah for constantly ranting invectives at President George Manneh Weah, but Joint Security forces, led by troops of the Armed Forces of Liberia intervened, providing corridor for the opposition politicians to leave the county, known for its strong support for President Weah and his ruling Coalition for Democratic Change.

NEITHER THE RULING Coalition for Democratic Change nor the Government of Liberia condemned the violence immediately. It took President George Weah four days before he commented while attending worship at his own church, calling on his supporters not to engage in violence.

BUT WE JOIN the Foreign Missions in their call for speedy and impartial investigation to bring all those responsible before the law and allow justice to prevail. This would serve as deterrence to future attempt by any group to disrupt the current peace thru political violence.

WITH BARELY THREE months to midterm senatorial elections across Liberia on December 8, 2020, if the Zwedru's violence is swept under the rug like two previous bloody electoral violence in Montserrado County Electoral District#13 and District#15 respectively, it could send a very strong signal of what to expect in the pending polls.

WE DON'T WANT a continuous repeat of such attitude in our

political dispensation that has a propensity to reverse the gains achieved in restoring this country to democratic governance and stability with help of the international community.

WE BELIEVE IT is in this light that the Foreign Missions called on the Weah administration to investigate speedily with objectivity and bring the matter to close so that the government would not be suspected of complacency, and by extension, condoning violent acts.

The High Cost of a Strong Euro

Given their strong performance during the COVID-19 crisis, and their US counterparts' ongoing debacle, European leaders who have been pushing for a stronger global role for the euro may be about to get their wish. But it may not be long before they regret it.

BRUSSELS - Europe is experiencing a "good" crisis. Despite the damage wrought by the COVID-19 pandemic and ensuing recession, its response has minimized the damage and bolstered confidence in the economy. Yet even this positive news carries risks.

The European Union has done a much better job of curbing COVID-19 infections and fatalities than, say, the United States. Moreover, its economic-policy response has been much better than expected, with all member states taking strong action to entice firms not to lay off workers. As a result, unemployment has barely risen.

If the EU's economic recovery is as strong as currently seems likely, it should be easy for firms to restart production with the same workforce they had before the crisis. In the meantime, powerful discretionary fiscal measures are supporting demand.

Now, investors all over the world are taking a fresh look at the EU. Rather than dismissing the bloc as an economic and political basket case - a collection of slow-growth economies that can't seem to stop squabbling with one another - they are beginning to appreciate its slow but solid, generally science-based policymaking. The relatively low level of public debt in many countries also helps.

This does not mean that investors expect miracles from the EU economy. But it is doing far better than many. In the US, for one, unemployment has skyrocketed; GDP contracted by 9.5% in the second quarter of 2020 - 32.9% year on year - the economy's worst performance since 1947; and policymaking has become deeply partisan and erratic. As the proverb goes, in the land of the blind, the one-eyed man is king.

The EU's recently agreed €750 billion (\$886 billion) pandemic recovery fund - which includes the first large-scale issuance of European bonds - has bolstered its reputation further, by allaying concerns about the cohesion of the common currency. Risk spreads on the government bonds of countries like Italy, Spain, and Portugal have fallen - a development that should help them to weather the crisis.

But a key consequence of rising confidence in the EU - upward pressure on the euro's exchange rate - could offset the benefits of lower risk premia. The exchange rate tends to have a strong, immediate impact on growth in Europe. For example, the euro's relative strength at the end of 2017 contributed to a growth slowdown in the subsequent two years. Today, the currency is even stronger than in 2017: over the last few weeks, its weighted average exchange rate has increased by 5%, reaching a five-year high.

The problem lies in the fact that the eurozone is a very open economy, with exports of goods and services accounting for close to 30% of GDP. In the US, that figure stands at just 12% of GDP. Trade is also less important to the economy in Japan and China, implying that the eurozone is the most "globalized" of the world's four largest economies.

This combination of openness and export dependence means that the eurozone could be in serious trouble if the euro continues to rise. Those who push for a stronger international role for the euro should take note: while such a shift might be desirable from a geopolitical point of view, the economic implications are less cut and dried. For a highly open economy like the eurozone, they certainly include significant disadvantages.

The situation is somewhat different for the US, partily because of the dollar's global role. While a strong currency undermines export competitiveness and employment, the US economy's vulnerability to exchange-rate fluctuations is limited, because it is not as open.

Morgue Testing the US Economy

Owing to the lack of testing capacity, there is no way to know for sure just how bad the COVID-19 epidemic in the United States has become as a result of this summer's "Sunbelt second wave." But judging by the latest data on morbidity and unemployment-insurance claims, no one should bet on economic recovery in the third quarter.

BERKELEY - US national income and output in the first quarter of 2020 was 1.25% below what it had been in the fourth quarter of 2019, but still 9.5% above what it would be by the second quarter of this year. Now that US national income has plunged 12% below what it was at the start of the year, what should we expect for the third quarter?1

America could always turn out to be lucky; but betting on that would not be prudent. According to Austan Goolsbee and Chad Syverson of the University of Chicago Booth School of Business, it was voluntary self-protection, rather than legislated restrictions on activity, that drove most of the decline in consumer spending this spring. Moreover, they warn that, "If repealing lockdowns leads to a fast enough increase in COVID infections and deaths and a concomitant withdrawal of consumers from the marketplace," doing so "might ultimately end up harming business activity."

In fact, we have seen this summer that ending or scaling back lockdowns often does lead to a rapid increase in COVID-19 infections. A sound forecast for the US economy, then, must start by forecasting the future of the pandemic. Yet most of the charts, graphs, and tables concerning the virus and its impact are useless for forecasting purposes.

After all, confirmed COVID-19 deaths tell us only what the virus was doing a month ago, whereas anticipating the virus's trajectory requires knowledge about what it is doing now. Similarly, confirmed cases catch only those who have been tested, and one must wait days or even weeks to receive test results. To get a grip on the situation, the number of tests per confirmed case would need to be 5-10 times higher than it is.

How would the past few months have played out if effective testing infrastructure had been in place? My guess is that the true (not just the measured) number of weekly new cases increased 2.5-fold from mid-June to mid-July. Assuming that we can accurately infer true cases in mid-June by multiplying mid-July's weekly confirmed deaths by 150 (admittedly a big assumption), the cases per week rose from about 600,000 to about 1.5 million as the "Sunbelt second wave" hit.

Since then, the overall picture has been even less clear. As was the case in mid-July, one test in 12 still comes back positive, and there are 150-200 confirmed cases per million people. But we are testing no more now than we were then, and the reporting date of a typical test is now lagging substantially behind the administered data - in some cases by as long as three weeks.

If the US is lucky, the fear caused by the Sunbelt second wave will have led to more vigilance in social distancing and mask-wearing, allowing for the true number of new cases nationwide to stabilize at around 1.5 million per week. But if the country is unlucky, that number will have continued to grow to around 2.5 million per week.

Tragically, we simply will not know where we stand until we can count the bodies later this month. Only then can we determine whether COVID-19 deaths "merely" doubled (from 4,500 to 9,000 per week) between mid-June and mid-July, or continued surging well beyond that level.

America's widespread testing failure means that it is still flying blind. As such, nobody really knows what would happen if schools were reopened or indoor dining and choral music recitals resumed. The conservative commentator David Frum spent the spring in New York and is now in Toronto. "To walk around a city of 2.8 million with fewer than 5 cases a day feels like the onset of recovery," he recently tweeted.

As recent International Monetary Fund research shows, the overwhelming dominance of the US dollar in trade invoicing - the so-called Dominant Currency Paradigm - also makes a big difference.

Because most exporters worldwide invoice in dollars, their export prices remain relatively stable, even when their local currency's exchange rate vis-à-vis the dollar changes. As a result, neither these economies nor the US economy seems to benefit substantially from a depreciation of the local currency in the short term, or to suffer significantly from its appreciation.

Exporters from Europe are the exception: because they tend to invoice in euros, European exports become less competitive everywhere when the euro appreciates against the dollar. While a depreciation of the dollar does not help the US economy, it does hurt Europe. As for a depreciation of the euro, the main beneficiaries might be emerging economies, but only those that export industrial products. Commodity exporters just experience a decline in export earnings.

For years, EU policymakers have been pushing for a stronger global role for the euro. Given their positive response to the COVID-19 crisis, they might be about to get their wish. But it may not be long before they will realize that every rose has its thorns.

He's right. Canada, the European Union, and Japan are highly likely to see substantial economic recoveries this fall. The same cannot be said of the US. At best, there will be a mechanical bounce-back from the second to the third quarter, mostly because unemployment-insurance claims had fallen from a peak of 24 million to 17.5 million by the start of July. But, given that claims rose by one million from July 5-11 to July 12-18, there is every reason to fear that they have continued to climb in the ensuing weeks. We will soon have numbers for the first week of August. If claims have returned to the 20 million range and remain at that level heading into the fall, much of the mechanical bounce-back will have been reduced.

For the US to have any chance of a real economic recovery this year, it would need to focus on two overarching objectives. The first is to stop the spread of the virus, so that people no longer fear going out and spending. The second task is to put those who have lost their jobs in hospitality and other indoor high-human-contact occupations back to work, either providing online services or working in investment-goods sectors that do not require close contact with people.

It is in America's power to do these things, in principle. We have the resources, and as John Maynard Keynes once put it, "Anything we can actually do, we can afford."

"We have lost one of our best players! On occasions such as this one, when we gather on a national stage, I was always introduced by you, Munah. So, it is a sad day for me today, to come and speak and not be introduced by you," Mr. Weah said Saturday, 8 August in Monrovia.

He also describes Pelham-Youngblood as an outspoken and frank person, courageous, determined, and fearless, adding that she never backed down from anyone who would try to take advantage of her.





eports from the Liberian Senate adhoc committee investigating senate staffers' unpaid salaries, totalling about US\$557,000 say payroll for staffers appears to be a scam.

The committee is headed by Grand Gedeh County Senator, G. Alphonso Gaye.





The report, which was presented to plenary on Thursday, August 6, noted that the total workforce of 802 employees of the Senate appears to be too huge in relation to the responsibility of each department and work environment.

The committee however recommends that the Senate conducts an independent audit to determine the legitimacy of the payroll.

Giving full details of the report, Senator Gaye said the office of the Senate Secretariat has 33 employees, while Human Resource Department has 22 persons, protocol, 47, travel service 9, Finance Department, 22

persons and Internal Audit, 16 persons, respectively. Others are, budget department, 16 persons, procurement, 19, press department, 23 persons, legal office, 11 staff, while another legal session has 15 persons.

Sen. Gaye noted that there are Directors and Deputy Directors in Central Administration who earn more

salaries than other Directors and Deputies, adding that some directors earn more than the chief of office staffers of senators.

The Grand Gedeh County Senator explained that some directors in Administration earn US\$850, some US\$ 2,000, while some deputies earn US\$1,700 and others, US\$1,100, respectively.

Senator Gaye continued that some office managers earn more salary than chief of office staff, disclosing that office managers earn US\$995, while chief of office staff get US\$ 975.

He added that the committee discovered that some departments that have never had a motorcycle assigned to them have from one to four drivers assigned to them and those names are on the payroll.

Meanwhile, Senator Gaye has recommended that the Senate mobilizes additional resources, about US\$600,000 to be added to the staffers' salaries and that said amount should be paid to staffers

retroactively.

"Even if the said amount doesn't increase their salaries, let it restore their salaries that they had before the harmonization", he instructed.

The plenary of the Liberian Senate overwhelmingly voted on July 22, to probe Bomi County Senator Morris Saytumah, for his role in the handling of US\$557,000 or a little over half million United States Dollars allocated for senate staffers.

Staffers have been protesting here in demand of Liberian dollar component of their monthly salaries that have not been paid since July, 2019. -Editing by Jonathan Browne

espite facing a ruthless attack by ruling party Coalition for Democratic Change (CDC) supporters in Grand Gedeh County recently, opposition lawmaker Yekeh Kolubah of Montserrado County wants to contest in the December 2020 senatorial election in Grand Gedeh County on the **Collaborating Political Parties** (CPP) ticket.

A communication circulating on social media bears Yekeh Y. Kolubah as the author, and notifies the CPP of the Montserrado District 10 Representative's intent to Grand Gedeh County.

His declaration of intent to contest the senatorial election in Grand Gedeh County follows recent attack against him and Alternative National Congress (ANC) political leader Mr. Cummings who also chairs the CPP while they were on a tour in the southeast.

This paper has made efforts to contact Mr. Kolubah surrounding the communication, but to no avail.

Earlier last week, Mr. Kolubah said he had been charged with the responsibility to carry out the CPP's primaries due next week in the same county - Grand Gedeh.

Thugs invaded Mr. Cummings and Mr. Kolubah's lodging place in Zwedru city, Grand Gedeh County, stoning the B-2 Guest House that hosted the opposition officials and their vehicles, demanding that they leave the county.

Joint State Security forces failed to make any arrest for the violence that occurred in the county, and it took the intervention of the Armed Forces of Liberia (AFL) to disperse the disgruntled folks

Kolubah is a staunch critic of President George Manneh Weah and the CDC regime, and has vowed to extend his responses to the presidency in retaliation for being attacked by government officials and supporters of Mr. Weah.

Announcing his planned return to Grand Gedeh while the violent attack against him and Mr. Cummings still remained the top discussion here, Rep. Kolubah said the CPP initially did not have a candidate in the county, but he is returning there because the Collaboration had received three names from its county leadership.

Mr. Kolubah claims that those who carried out the attack are zogoes, a Liberian way of referring to wayward folks, adding that he has no problem with the people of Grand Gedeh because they are peaceful people.

"The Grand Gedeans are peaceful set of people. I got six children from Grand Gedeh. Six, not one. No, no, it was not the Grand Gedeans that chased me out. It was those criminals they took from the prison compound you know, that they brought," Mr. Kolubah alleges.

He accuses Grand Gedeh County Superintendent Kai Farley and Representative Zoe Pennoh of allegedly bringing the criminals out to carry on the rude attitude.

EW YORK - Dans un discours prononcé le mois dernier à la bibliothèque présidentielle Richard Nixon, le secrétaire d'État Mike Pompeo a respectueusement fait valoir que Nixon avait eu tort au sujet de la Chine. Pompeo considère en effet que l'ouverture vis-à-vis de la République populaire, censée voir la dictature maoïste se modérer via un réchauffement de ses relations internationales, pour ainsi devenir plus libre chez elle et plus coopérative à l'étranger, s'est finalement soldée par un échec.

En réalité, Nixon n'a jamais cherché à démocratiser la Chine - il avait besoin de l'aide de Mao pour mettre un terme à la guerre du Viêtnam, et prendre l'avantage sur l'Union soviétique.

Pompeo formule néanmoins une longue critique. La Chine serait aujourd'hui moins libre que dans les années 1980, affirme-t-il. Le pays déroberait des secrets industriels occidentaux, missionnerait des agents du gouvernement déguisés en étudiants, étoufferait toute opposition via des menaces, incarcérerait minorités ethniques et dissidents dans des camps de concentration, ferait du chantage à plusieurs pays pour qu'ils achètent des technologies chinoises permettant à Pékin d'espionner les États-Unis, et la liste se poursuit. « Le monde libre doit triompher sur la nouvelle tyrannie », poursuit-il. « Nous autres nations attachées à la liberté devons conduire la Chine à changer... ».

Pompeo a-t-il raison ? L'administration du président Donald Trump se situe-t-elle effectivement du bon côté de l'histoire sur cette question ? La Chine représente-t-elle une menace existentielle pour le « monde libre »?

Si tel est le cas, alors l'administration Trump fait preuve d'une hypocrisie spectaculaire. Trump luimême a souvent parlé de Xi Jinping comme d'un très bon ami, et clairement refusé de reprocher au président chinois sa négligence des droits de l'homme, l'enfermement de prisonniers politiques, ou encore la mis à mal de l'État de droit à Hong Kong.

Mais l'hypocrisie de Trump ne signifie pas nécessairement que Pompeo a tort concernant la Chine. Dans les grandes lignes, ce qu'affirme le secrétaire d'État est vrai. Le Parti communiste chinois (PCC) applique effectivement un régime dictatorial au niveau intérieur, et se montre souvent hostile à l'égard des démocraties étrangères.

Il existe bien entendu une limite dans ce que peut faire le « monde libre » pour changer la politique domestique chinoise, aussi condamnable soit-elle. La Chine est trop puissante, les intérêts économiques en jeu trop importants, et les risques de voir une guerre froide se changer en guerre ouverte trop significatifs. Les Chinois sont les seuls à pouvoir briser le monopole du PCC sur le pouvoir dans leur pays. Ce serait une folie pour une force extérieure que de promouvoir un « changement de régime ».

Les moyens financiers colossaux de la Chine lui permettent également de contraindre des gouvernements à acquérir des technologies chinoises, en dépit des préoccupations de sécurité. Cette situation n'est bien entendu pas exceptionnelle. Toutes les grandes puissances usent de leur poids pour en amener d'autres à rentrer dans le rang. Les États-Unis l'ont fait pendant la guerre froide, et à nouveau depuis, au détriment des libertés démocratiques d'autres pays. Pour autant, les États-Unis ne se sont jamais montrés dans l'ensemble idéologiquement hostiles aux libertés d'autrui comme le font les dirigeants chinois.

La question est de savoir quoi faire. Comment défendre ce qu'il reste du monde libre contre les stratégies prédatrices d'une dictature immensément riche et puissante ? Pompeo a raison de souligner ici l'importance de la solidarité. Organiser la protection des intérêts communs implique d'établir des organisations internationales qui préservent et appliquent des règles et lois communes. Telle est la vocation des Nations-Unis, de l'Organisation mondiale du commerce, de l'Organisation mondiale de la santé, ainsi que de l'Union européenne.

Ces organisations présentent souvent de profondes défaillances, et l'espoir selon lequel inviter des dictatures à les rejoindre pourrait rendre ces régimes moins oppressifs est souvent malavisé. La Chine a ainsi usé de son appartenance à l'OMC pour défier certaines règles dans son propre intérêt. L'OMS a pour sa part trop souvent accédé aux exigences chinoises. Le Conseil des droits de l'homme de l'ONU a quant à lui entaché sa propre mission en acceptant comme membres certaines régimes très peu recommandables.

Mais cela ne justifie pas que l'on abandonne ou ignore ces institutions. La politique trumpienne de « l'Amérique d'abord », ainsi que les affinités instinctives du président américains auprès de dictateurs parmi lesquels Xi, anéantissent précisément cette solidarité dont le monde libre a besoin selon Pompeo.

C'est encore bien pire que de l'hypocrisie. C'est une menace directe pour les démocraties du monde entier. L'unilatéralisme en rafales du président Trump, son mépris pour certains dirigeants démocratiquement élus, et le retrait américain de plusieurs institutions internationales, sont au moins aussi dommageables pour la liberté que les intimidations chinoises.

La protection de la liberté d'expression et des autres droits démocratiques face aux efforts chinois qui visent à les fragiliser ne doit pas pour autant signifier une rupture totale avec la Chine, et ne justifie pas que l'on insulte sa population. Si un siècle sanglant d'invasions étrangères n'excuse pas le nationalisme belliqueux de la Chine, il contribue toutefois à expliquer sa sensibilité. Les références moqueuses au « Kung flu », et les accusations gratuites selon lesquelles tous les étudiants chinois à l'étranger seraient des espions du gouvernement, offensent même les Chinois qui puisent encore de l'espoir dans des sociétés plus libres que la leur. Times, political contexts and social realities are rapidly changing and obviously Liberia's geographical political landscape as well as the electorates are obliged to come to term with thesedynamics as remaining oblivious to current realities will only accelerate backwardness; fuelmyopic political xenophobia and 'primordial sentiments'.

The attack on opposition leaders, Alex Cummings and YekehKolubah by some youth in GrandGedeh County is not only embarrassing but a bad precedence that opens a Pandora box on thecounty. When something of this nature happens, there are two fundamental ways to probe theunderlying reasons- one is by asking why did it happen and the next is who did this to destroythe county's hospitable image?

The formal question helps to elicit plausible underlying reasonsbeyond the euphoria generated while the latter facilitates a much broader probe to identify theperpetuators and their real motives. This is why I am wondering whose agenda are these youthpushing? As a native of the county, I am shocked and utterly embarrassed by such behavior, which threatens Liberia's fragile peace. It should be noted that anti-democratic behavior of thiskind undermines development and threatens stability.

Historically, Grand Gedeh County came to the spotlight of Liberia's politics in the 1980s,' when ason of the county, Master Sargent Samuel K. Doe, led a group of junior officers and overthrewPresident Tolbert's government. The pains and resentments linked to the violent removal andpublic execution of former government officials still linger in the hearts and minds of someLiberians.

Resentments toward Grand Gedeh County and people even intensified during and after the Liberian civil war such that the name Grand Gedeh County in the eyes of some issynonymous to violence and war.

While these perceptions are grossly misleading, it should be acknowledged that the role playedby some of my kinsmen contributed to the negative image of the county. On the other hand, Grand Gedeans also suffered inhume treatments from others because of their identity as Krahns.



Thus, no onewants a repeat of such painful history, hence we have to condemn the recent action by somemisguided youth who seem to not learn from the civil war.

Anti-democratic action by zealot youthful protesters in Grand Gedeh County only re-enforces theperception of a warlike folks and brings the county name to spotlight for the wrong reason. I havealways been proud of the level of tolerance in the county, whenever I visit. There are annotatedevidence that the third largest ethnic group in the county are folks from Nimba County.

Moreover, while conducting an assignment years back for an international organization on publicparticipation in concessions and natural resource governance, I was intrigued to notice thatunlike other counties where the youth vociferously advocated for their kinsmen to be givenpriority, when it comes to awarding jobs, in Grand Gedeh, there was relative openness and highlevel of tolerance to non-locals. I even spoke to a senior judiciary official who hailed from another county and he said "this is my second county and I do not want to take assignment anywhereelse but here".

placing all theireggs in one baskets but navigated the political landscape scrupulously in the interest of theircounties. Furthermore, President Weah in whose behalf the youth seemed to base their action, admitted that he has very good relationship with former President Sirleaf. Some even believethat Madam Sirleaf has major influence on President Weah, when it comes to making national decisions and appointments in government. So, one can even infer that Grand Gedeh County isnot out of the woods, if the dislike for Madam Sirleaf was a secondary driving force foroverwhelmingly voting for Weah's CDC. Also, considering the fact that nothing has changed in he county since the inception of the Weah's government, what is the rationale for such uncouthattitude? In whose interest are our young future leaders fighting?

In post war Liberia, previous and current presidents always appoint leaders for Grand GedehCounty who lack vision to transform the county. Social contract theory requires elected andappointed politicians to ably represent the collective interest of their folks and constituents butin the case of Grand Gedeh, national leadership imposes their cronies who are only committed to ensure that the county remains in abeyance. The action by the youth seems to be orchestrated by opportunist politicians who want to demonstrate that Grand Gedeh loves President Weah and the CDC more than any county. Granted for the sake of the argument, however politics is about interest but I do not see any trade off.

In other words, Grand Gedeans paid high price for the actions by few because of the 'Politics of ethnicity', which unfortunately comes with 'collective guilts' and bad consequences in Liberia, whenever the tie turns.

Consequently, primordial sentiments increased among Grand Gedeansnot because everybody from the county sanctioned the atrocities committed by some of theirkinsmen but due to the politics of collective guilt and associated consequences. Grand Gedeans are indeed tolerant, forgiving and very hospitable so one wonders where doessuch disgruntle behavior against Mr. Cummings and Representative Kolubah came from? Thewidely held narrative for the action is President George Weah is the 'play son' of the latePresident Samuel K. Doe and therefore anybody who openly hates President Weah will not beallowed in the county. The irony however is Grand Gedeh County has not made any significantprogress since the civil crisis ended largely due to such irrational thinking.

For twelfthconservative years, the county suffered unnecessary marginalization under President EllenJohnson Sirleaf administration because folks from the county perceived the former president asan enemy to the late president Doe.

The sad reality is other counties that even perceived formerpresident Sirleaf through such negative prism played their 'cards' wisely by not While I strongly dislike Representative YekehKolubah continuous outburst and invectives against the president and the presidency of ourcountry, the 'Country giant' knows how to handle Representative Kolubah better than GrandGedeh youth to damage the image of the county under the disguise of showing love.

It could be recalled that a similar situation involving Dr. Alaric Tokpah occurred where Dr. Tokpah rejected claims that he was COVID-19 positive after he had previously received certificate under the signature of Dr. Fallah informing him that he was negative.




