US cuts aid to Ethiopia over Nile dam row

he US is cutting aid to Ethiopia over a controversial mega dam being built on a tributary of the River Nile.

The move was triggered by Ethiopia's move to start filling the Grand Ethiopian Renaissance Dam before reaching agreement with Egypt and Sudan.

Egypt has long been opposed to any development on the Nile that could reduce the amount of water it receives.

Ethiopia says it needs the dam to provide a reliable electricity supply.

Once fully operational, the Grand Ethiopian Renaissance Dam (Gerd) will be the largest hydro-electric plant in Africa and provide power to up to 65 million Ethiopians.

While the US has not said openly how much aid will be cut, a US congressional source told Reuters news agency that "up to \$100m or so will be affected, of which \$26m is funding that expires at the end of the [financial year]".

The funding affected is

linked to nutrition, regional or border security, political competition and consensusbuilding, the official said. Funding for projects connected to HIV/Aids, migration and refugee assistance and the food for peace programme would be unaffected.

A US state department

official told Reuters Ethiopia's decision to start filling the dam while negotiations with Egypt and Sudan were under way had undermined confidence in the talks and was inconsistent with commitments Ethiopia had made.

"The United States

previously and repeatedly expressed its concern that commencing the filling of the Gerd before all necessary dam safety measures were implemented created serious risks,"

the official said. Ethiopia's ambassador to the US told the Financial Times he hoped the US would change its mind over the aid cut.


"We've asked them to reconsider and we're waiting. We hope 117 years of diplomatic relations will not be damaged because of an issue not related to the two countries," Fitsum Arega said.

Correspondents say the

move is likely to be seen as US President Donald Trump punishing Ethiopia after the country rejected US-led mediation with Egypt and Sudan.

The talks have stalled over various issues including demands by Egypt and Sudan that any deal should be legally binding and how to manage the dam during periods of drought.

The Gerd sits on the Blue Nile upstream of Egypt and has the potential to control the flow of water that the country receives. The Nile is Egypt's primary source of water for b o t h d r i n k i n g a n d agriculture.BBC



Civilians Accuse Military of Brutality in Cameroon's Anglophone Regions

ameroon's military has detained hundreds of people in the country's troubled northwest as they search for separatists following the killing of a police officer this week. Locals accuse the military of carrying out revenge attacks, including looting and burning shops, in

the English-speaking region -a charge the military denies.

Thirty-four-year old fish seller Ernestine Sahmo says she has decided to temporarily leave the English-speaking northwestern town of Bamenda due to what she says is military brutality.

Sahmo says she was forced out of her shop by armed

soldiers who detained 80 other women at a police station for three days.

"The military entered the whole market and was removing everybody," she said. "They will break into your store and then start brutalizing you, asking you to go out. They succeeded to remove everybody from the food market to the mobile police station. We were being asked to sit on the ground. Some women were collapsing. The way they terrorized us, we never knew we would come back alive." Sahmo says store owners' goods were either looted or torched by the military.

Last Monday, the government said separatist fighters in Bamenda killed a policeman in active service. The military was then deployed to hunt for the killers.

Residents said troops started arresting people indiscriminately, forcing some either to undress or to sit on the floor for several hours. Scared civilians escaped to neighboring villages and French-speaking towns including Mbouda and

Now we know the real chief feminist

LAST WEEK'S STONE throwing and running battle between anti-rape protesters and riot officers of the Liberia National Police that led to the coming into the street of ex-President Ellen Johnson Sirleaf to join protesters in solidarity over the increasing wave of rape across the country when in fact, President George Manneh Weah out-rightly refused to meet with the protesters despite their demand clearly indicates who is the real chief feminist for Liberia.

FOR THREE CONSECUTIVE days last week protesters, including little girls as old as five, six and seven years marched from the Monrovia suburb of Vamoma House to the Ministry of Foreign Affairs to present a petition to President Weah against endemic rape in the country. They had insisted to give the petition to the President himself, but Mr. Weah did not come out in spite of their demand.

AND SO WHEN it became very obvious that they won't see President Weah at his official office in the Ministry of Foreign Affairs, the protesters decided on the last day of their campaign to instead, go to Mr. Weah's residence in Rehab community along the Robertsfield highway outside Monrovia, but armed riot police brutally prevented them, save the appearance of former President Sirleaf, who met with the crowd predominantly women and young girls and expressed

HOW DISAPPOINTING IT has been that President George Weah, who some time ago, declared himself as Liberia's chief feminist, could not come out to meet women with bleeding hearts, lamenting over the wave of brutal abuse of their babies, daughters and sons sexually by evil men whose ages range from 20 to 50 and above.

BEING A WOMAN, mother and grandmother herself, MsSirleaf heard the wailing of protesters in the street and she came out to identify with them in their grieve over an act that is rapidly destroying future wives, mothers and husbands of the land, while the self-declared chief feminist [President Weah] sent emissaries upon emissaries with excuses that the President couldn't be there himself over a situation that has become very alarming in the country.

LIBERIANS NEED NOT to look any farther to know who the true chief feminist is for the country. We know that President Weah is a very busy leader or so he ought to be. But taking out at least 10 or 15 minutes of his busy schedules to have come to receive protesters' petition, especially when they had insisted so, would have worth the effort and demonstrated that the 'Father' and "Chief Feminist" of the Land is in empathy with their struggle to seek justice.

INSTEAD, WHAT THEY got were bruises, scars and allegedly broke limbs as a result of Police heavy-handedness to stifle and quiet their voices. What a paradox in a land that is supposedly presided over by a leader who presides himself as chief feminist! Is it mere title or does President Weah really care about issues that confront women of

BETWEEN EX-PRESIDENT SIRLEAF and President George Weah we can clearly see that it is not about self-title but demonstrated actions to match the title, for actions speak louder than words. By Thursday evening last week, Madam Sirleaf was on the BBC, acknowledging the endemic rape in the country and suggesting what could be or needs to be done to addressing the problem. That's the mark of a true leader.

ON THE CONTRARY, the current administration is politicizing everything and suspicious of everybody, even grieving women and girls protesting for their own lives in the streets. Who should provide them security, if not the government they elected at the ballot box? President Weah should know that he has a duty to ensure the peace, security and happiness of the people at all times.

MR. WEAH MISSED a great opportunity to demonstrate political leadership by his refusal to meet with protesting women and girls and receive their petition over a situation that is portraying Liberia negatively under his watch. We wonder whether the President understands the consequences of his reluctance or sheer inaction over a cruel crime such as rape and abuse of women and girls.

The Parties Must Go On

Amid the tawdry spectacle of the Republican Party behaving like a subsidiary of the Trump Organization, one shocking aspect stands out: the party has no platform. The GOP's transformation into an ideas-free cult of personality is bad news not just for US conservatives, but also for the American political system.

ERLIN - The recent Republican National Convention was scandalous for many reasons - from the misuse of the White House as a campaign prop (in violation of the Hatch Act and longstanding norms) and the brazen mendacity of its speakers, to the parade of Trump family members. Amid the tawdry spectacle of the GOP being transformed into a subsidiary of the Trump Organization, one shocking aspect stood out: the party offered no platform. The Republicans' only purpose, apparently, is "to enthusiastically support the President's America-first agenda."

On one level, eschewing a policy platform can be read as a smart strategy to insulate the party from Donald Trump the person. In the event that Trump is defeated in November, members of the GOP establishment can wash their hands of it, claiming that it was only an unpopular leader who lost; the party's longstanding principles remain sound.

But a more plausible interpretation is that the toxic mix of polarization and hyperpartisanship in America has reached a new level of concentration. Having been completely hollowed out, at least one of the country's main political parties no longer fulfills its basic democratic function.

That function requires parties not only to offer the electorate a choice, but also to determine how political battles will be waged. By appealing to some groups more than others, on some political fault lines over others, parties assemble coalitions that could have looked quite different had the emphasis been placed on various other equally salient issues.

The point of democracy is not to forge consensus on every issue, but rather to manage conflicting interests and commitments. But democracy can break down when parties or politicians openly demonize or deny the legitimacy of other contenders for power. Such tactics have long been the specialty of rightquestions of belonging. Hence, rather than engage with his opponents' arguments, Trump simply smears all critics as "un-American."

As the political scientists Jacob S. Hacker and Paul Pierson have shown, the GOP's propensity for culture warfare owes much to the fact that its economic-policy agenda is profoundly unpopular. Having cut taxes for the rich and failed utterly in the face of the COVID-19 pandemic, Trump and his party need to distract potential voters from material concerns.

This "plutocratic populism," Hacker and Pierson show, is the result of the GOP's complete inability to generate new policy ideas. Republicans have simply doubled down on tax cuts and mindless deregulation, while proving incapable of offering any coherent alternative to the 2010 Affordable Care Act ("Obamacare"), which they are always just

about to replace with "something terrific."

Just as the GOP has outsourced its identity to culture warriors on far-right television networks and websites, so has it handed off intellectual work to think tanks, most of which are more committed to their donors than to crafting broadly popular and effective policy proposals.

These are not just American problems, of course. Across the West, traditional parties have been challenged by upstarts that tend to hold no serious internal debates, let alone embrace democratic decision-making. In the Netherlands, the far-right populist Geert Wilders' party has just two official members: Wilders and a foundation of which he is the only member. Similarly, in the United Kingdom, the Brexit Party boasts more than 110,000 "paying supporters," but is in fact a limited liability company with four officers and just one registered "person with significant control": the ubiquitous Brexiteer and serial polarization entrepreneur Nigel Farage.

To be sure, political parties aren't debating societies. But they are supposed to produce new ideas and policy plans, which a one-man show or a family enterprise is unlikely to do. While parties need to represent certain principles that their members share, deciding on such principles will always be contentious, and upholding them does not happen automatically.

US President Lyndon Johnson once observed parties draw lines in the sand; and by focusing that, "What the man on the street wants is not a big debate on fundamental issues; he wants a little medical care, a rug on the floor, a picture on the wall." But as Johnson's Democratic Party learned the hard way, even "a little medical care" can become a matter of principled conflict.

Such contests are best hashed out not just with one's partisan adversaries but also in open, pluralistic internal debate. When disputes are settled in this fashion, the losers are more likely to accept defeat and remain loyal to the party. wing populists, who wage culture wars in an By contrast, mass acclamations of the kind the effort to reduce all political conflict to GOP staged for Trump often send some party members heading toward the exits.

> The hallmark of a well-functioning party is its ability to attract people with stable partisan commitments over time. Paradoxically, the party that allows members to offer criticism without being tarred as traitors ultimately instills deeper loyalty.

> The point is not to idealize intra-party participatory democracy. Yet there is a reason why the constitutions of Germany, Spain, and Portugal, for instance, prescribe internal party pluralism. By habituating people to democratic debate and forcing them to consider that the other side might have a valid point, this model embodies what has been lost in an age of polarization.




Grand Gedeh Bar wants review of Putu Mines agreement

he Grand Gedeh Bar Association (GGBA) Thursday petitioned members of the county's legislators to push for the review of the Putu Iron Ore Mineral Development Agreement, which was signed some 10-years ago.

The Bar's petition for a review is based on "Sections 31 Periodic Review" and "31.1 Profound Change in Circumstances" of the Agreement which state, "the Government on the one hand and the company on the other hand, shall meet once every five (5) years after the date hereof or earlier, if one party reasonably considers a Profound Change in Circumstances to have occurred, to establish whether or not a Profound Change in Circumstances has occurred. To the of a 25-year contract to be left in suspense with the state of clearly outlined social development projects and contributions to project affected counties and mandated environmental assessments uncertain," said Bar President P. Alphonsus Zeon, in a letter addressed to the Grand Gedeh County Legislative Caucus Chairman. Representative Alex Chersia Grant on August 31, 2020.

Rep. Cole claims glory for VP Taylor's project?

eports reaching this paper suggest that Bong County Representative Marvin Cole may be taking undue glory for a library project in the county which is reported to actually belong to Vice President Jewel Howard - Taylor.

In recent time Representative Cole made several public comments, claiming that he owns the library project, and not Vice President Jewel Howard-Taylor.

But an investigation conducted by our correspondent, it is unearthed that in 2019, Vice President Taylor made a special appeal to the Bong County Legislative Caucus and the local county administration seeking financial support for the construction of a public library in Bong County, which will be replicated in other counties.

After a series of consultations, our investigation gathers that an amount of US\$75,000 was later allotted for the project during the county council sitting.

But Representative Cole has been demanding the county administration to give him the money for the library on grounds that the vice president has allegedly mandated him to proceed with the project.

But a communication from the Office of the Vice President to the Project Management Committee (PMC) Chair of Bong County Stephen Mulbah dated 18 August 2020 clearly indicates that the vice president has at no time authorized Rep. Cole to proceed with the library project in Bong.

Copies of the communication which were also sent to Superintendent Esther Walker and the Bong Legislative Caucus asked the PMC to put hold on all processes leading to the library project until Vice President Taylor returns to the country.

VP Howard-Taylor is currently seeking medication in Ghana after being tested

positive for coronavirus.

Our correspondent further gathers that after several failed attempts by Rep. Cole to arm-twist the county administration to release the US\$75,000 to him, the lawmaker has complained Bong County Superintendent Esther Walker to the Minister of State for Presidential Affairs Nathaniel McGill to compel her and the PMC to release the money to Rep. Cole.

Our source furthers that after some conversations with Superintendent Walker, Minister McGill allegedly instructed that the funds allocated for the vice president's library project in Bong be given to Rep. Cole with immediate effect.

But reports reaching this paper indicate that Bong County Project Management Committee Chairman Stephen Mulbah has refused to sign the cheque to release the money to Rep. Cole because such an act is a violation of the Budget

Mr. Mulbah has not spoken to the media on the issue but Bong County Superintendent Esther Walker has told newsmen that she doesn't have the energy to speak to the issue.

Several Bong County citizens have also termed Representative Cole's action as dubious and they are calling on the county administration and the legislative caucus not to release the money to him.

The citizens say since the allocation was made to help the vice president in constructing a public library for the county, the county administration should ensure all the rightful procedures are followed and that the amount be disbursed to a creditable contractor to do the project.

They urge Minister Nathaniel McGill to respect the laws governing the usage of the County Development Funds and should desist from acts that would undermine transparency and accountability.--Edited by Winston W. Parley





Maintenant, nous connaissons la vraie féministe en chef

Les évènements de la semaine dernière ont montré clairement qui est la véritable féministe en chef du Libéria.

Pendant trois jours consécutifs, des manifestants essentiellement composés de petites filles de cinq, six et sept ans, ont marché de Vamoma House au ministère des Affaires étrangères pour présenter une pétition au président Weah contre le viol récurrent dans le pays. Ils voulaient remettre la pétition au Président lui-même, mais M. Weah ne s'est pas manifesté.

Et donc, vu le refus catégorique du président Weahde les rencontrer à son bureau officiel au ministère des Affaires étrangères, les manifestants ont décidé le dernier jour de leur marche de se rendre à sa résidence dans la communauté Rehabà l'extérieur de Monrovia, mais la police anti-émeute armée jusqu'aux dents leur a barré la route tout en les brutalisant. Mais la CDC estime que le sénateur Morais s'est distancé de la Coalition et ne lui aapporté aucun soutien, ainsi donc, il ne mérite pas d'être son candidat.

Par ailleurs, la CDC a annoncé la création d'un fonds fiduciaire pour répondre aux besoins des victimes de viol.

Le président Morlu, lors d'une conférence de presse au siège de la CDC mercredi, a révélé que des comptes avaient été ouverts auprès d'Afriland Bank Liberia Limited dans le seul but d'apporter un soutien financier aux victimes de viol.

Il s'estfélicité de la formation d'un groupe de travail interministériel sur la violence sexuelle basée sur le genre (SGBV), qui a été constitué par le président George M. Weah.

S'exprimant récemment, le président Weah a invité les trois pouvoirs de l'Etat - l'exécutif, le législatif, le judiciaire - et la société civile à conjuguer leurs efforts afin de mettre fin aux viols dans le pays.

Les partis politiques doivent survivre

BERLIN - La récente convention d'investiture du parti républicain, aux États-Unis, fut un scandale à plus d'un titre - du dévoiement de la Maison Blanche en support de propagande de la campagne (en violation de la loi Hatch de 1939 et des usages établis) et des mensonges éhontés proférés par les orateurs au défilé des membres de la famille Trump. Dans ce spectacle tape-à-l'œil d'un Grand Old Party transformé en succursale de la Trump Organization, une chose s'est avérée particulièrement choquante : le parti n'avait aucun programme. Le seul objectif des républicains était apparemment de « soutenir avec enthousiasme la vision du président pour l'Amérique d'abord ».

On peut considérer, d'une certaine façon, qu'éviter de communiquer un programme politique est une stratégie intelligente en vue d'isoler le parti de l'individu Donald Trump. S'il advenait que le président sortant perde les élections de novembre, la faute en incomberait alors à son impopularité, et la direction du GOP pourrait d'autant mieux s'en laver les mains ; les principes intangibles du parti demeureraient saufs.

Mais il est plus vraisemblable que le mélange toxique de polarisation et de division partisane qui caractérise aujourd'hui l'Amérique ait atteint là un nouveau sommet. Après avoir été complètement vidé de sa substance, l'un des principaux partis politiques du pays au moins est désormais incapable de remplir son rôle démocratique élémentaire.

Ce rôle requiert que les partis ne se contentent pas d'offrir un choix à l'électorat, mais décident aussi de la façon dont seront menés les combats politiques. En séduisant certains groupes plutôt que d'autres, les partis dessinent les limites de leur action ; en privilégiant sur d'autres certaines lignes de clivage, ils composent des coalitions qui arboreraient un visage très différent si l'accent avait été placé sur d'autres sujets également importants.

La raison d'être de la démocratie n'est pas de forger un consensus en toute matière, mais plutôt de gérer les intérêts et les volontés en conflit. La démocratie peut en revanche se déliter lorsque des partis ou des responsables politiques diabolisent ouvertement les autres prétendants au pouvoir ou leur nient toute légitimité. De telles manœuvres ont longtemps constitué la spécialité des populistes de droite, qui se sont livrés à des guerres culturelles en vue de réduire les conflits politiques à des questions d'appartenance. Partant, plutôt que de discuter les arguments de ses opposants, Trump vilipende leurs critiques au prétexte qu'elles sont « inaméricaines ».

Comme l'ont montré les professeurs et chercheurs en sciences politiques Jacob S. Hacker et Paul Pierson, la propension du GOP à mener des guerres culturelles doit beaucoup au fait que son programme de politique économique est profondément impopulaire. Ayant diminué les impôts des plus riches et totalement échoué face au Covid-19, Trump et son parti doivent distraire l'attention de leurs électeurs potentiels des questions matérielles.

Ce « populisme ploutocrate », démontrent Hacker et Pierson, résulte d'une inaptitude absolue à produire des idées politiques nouvelles. Les républicains n'ont fait que s'obstiner à réduire les impôts et à déréguler inconsidérément, s'avérant dans le même temps incapables d'offrir une option de rechange cohérente à la loi de 2010 sur les soins abordables (l'« Obamacare »), qu'ils sont toujours censés remplacer d'un jour à l'autre par « un truc formidable ».

De même que le GOP confie son identité à des soustraitants des guerres culturelles, actifs sur les sites Web et les chaînes câblées d'extrême-droite, il confie son travail intellectuel à des groupes de réflexion plus désireux de satisfaire leurs donateurs que de formuler des propositions politiques efficaces capables de rallier les suffrages.

Ces problèmes ne concernent évidemment pas que les Américains. Dans tout l'Occident, les partis traditionnels sont mis au défi par des parvenus qui ne s'embarrassent pas de débats internes, sans parler de souscrire à des procédures de décisions démocratiques. Aux Pays-Bas, le parti du populiste d'extrême-droite Geert Wilders n'a que deux adhérents officiels : Wilders lui-même et une fondation dont il est l'unique membre. Et il en va de même au Royaume-Uni, où le parti du Brexit revendique plus de 11 000 « soutiens payants », mais n'est en réalité qu'une société à responsabilité limitée, avec quatre administrateurs, un seul étant déclaré comme « personne dont l'autorité compte » : Nigel Farage, Brexiter omniprésent et entrepreneur en série de la polarisation politique.

Certes, les partis ne sont pas des cercles de débats contradictoires; ils sont néanmoins censés produire des idées nouvelles et des projets politiques, tâche dont il demeure peu probable que l'assument le spectacle d'un humoriste ou une quelconque entreprise familiale. Si les partis doivent représenter certains principes, que partagent leurs membres, les établir n'est jamais sans litiges, et leur respect ne survient pas automatiquement.

Lyndon B. Johnson, alors président des États-Unis, fit un jour remarquer que « ce que veut l'homme de la rue, ce n'est pas un grand débat sur les questions fondamentales ; il veut quelques soins médicaux, un tapis par terre, une photo au mur. » Mais comme devait l'apprendre à ses dépens le parti démocrate de Johnson, « quelques soins médicaux » peuvent devenir l'enjeu d'un conflit de principe.

Le sort de ces combats ne se décide pas seulement entre adversaires de partis différents ; les débats internes, ouverts, pluralistes, sont également nécessaires. Lorsque les différends sont réglés de cette façon, il est plus probable que les perdants acceptent leur défaite et demeurent fidèles au parti. En revanche, les acclamations des masses, comme celles que le GOP met en scène pour Trump, conduisent souvent vers la sortie certains membres du parti.

Le signe distinctif d'un parti en bonne santé est sa capacité à ramener dans ses rangs des gens dont l'engagement militant résiste au temps. Et ce sont paradoxalement les partis qui permettent à leurs membres de manifester leurs critiques sans être assimilés à des traîtres qui suscitent finalement les plus profondes fidélités.

Il ne s'agit pas ici d'idéaliser la démocratie participative au sein des partis. Il existe pourtant une raison pour laquelle les constitutions de l'Allemagne, de l'Espagne et du Portugal, par exemple, prescrivent le pluralisme dans les partis. En habituant les gens au débat démocratique et en les contraignant à considérer la validité du point de vue adverse, ce modèle incarne ce qui a précisément été perdu en une période d'intense polarisation politique.

La diaspora africaine en Chine :

C'était majoritairement des Européens, de Nord-Américains, d'Océaniens et certaines nationalités des pays voisins, entre autres la Corée du Sud et le Japon. En effet, compte tenu des opportunités commerciales et d'affaires qui s'offraient après cette fameuse ouverture de la Chine,

cet afflux migratoire était compréhensible. Ces hommes et femmes d'affaires en provenance des pays précédemment cités étaient plutôt en quête de ces opportunités commerciales que des candidats naturels à l'immigration économique au vrai sens du terme. Cependant, de nos jours, la donne migratoire a radicalement changé à cause notamment de la mondialisation croissante et le boom économique de l'empire du milieu. C'est ainsi l'immigration africaine croissante s'est ajouté aux flux migratoires habituels. Finalement, s'y est ajouté ce flux estudiantin au bénéfice de l'octroi des bourses aux étudiants étrangers par le gouvernement chinois et aussi l'importance et l'internationalisation du mandarin qui est devenu un élément.

Open Letter to Mrs. Davidetta Browne Lansannah

Chairperson, National Elections Commission (NEC) 9th Street, Monrovia, Liberia

Dear Mrs. Lansannah:

Permit me to congratulate you for your new job. I hope by the grace of God you are fine and doing well. I am also fine.

As a journalist and former workmate at the Liberia Broadcasting System, I was among wellwishers who celebrated you upon your appointment as Chairperson of the National Elections Commission (NEC) early this year. I am glad that a female media executive has been named to head the country's electoral body. I think that your preferment is also an honor for the journalism community. The job is no doubt tedious and tension pack. The need for all stakeholders' hands to be on the table in this process cannot be overlooked.

Following the Senate's approval, a month later, while looking through some local dailies, I came across an astonishing Editorial of the Monday, August 17, 2020 edition of Daily Observer Newspaper, caption: Gloomier by the day? Chairperson Lansannah is playing with Fire and She Must Beware! After reading the editorial, my initial reaction was wow, how come this professional colleague of mine has not lasted long in office, but she's being opposed by her staffers instead of being supported to succeed?

According to the Editorial, the standup between you and your staffers centered around the means of complying with the Supreme Court order to the NEC to clean up the 2017 Voter Roll the court had declared compromised. The Editorial said the NEC staffers' suggestion to conduct 'Stationary Voters Roll Update' (VR) has been overruled by you Madam Chair, and you are insisting that the VR Update be conducted by 'Mobile teams around the country'.

The paper said the experience gathered from the 2014 senatorial elections during which time the experiment with Mobile VR Update proved shockingly bad though it was conducted during the dry season when the country's roads were in better condition.

It said now with the rainy season at its peak, the NEC Chairperson's insistence on a Mobile VR process which she very well knows will be another fruitfulness exercise given the bad road conditions at this time of the year, is unwelcoming.

Stationary VR Update is a process where the VR team is set up at a particular location for the entire VR Update exercise, while VR Update by Mobile team is rotational i.e. for the team to work in one community or district for a specific period like for example a week or two and move to another community or district throughout the VR process.

The paper pointed out that with the failure of Mobile VR Update experiment in mind, it appears that the Chairperson is either being double-dealing and deceptive or she does not know or fully understand just what she is doing or is supposed to be doing.

If the paper's position on what appears to be serious disagreement between you and your support staff is something to go by, then it reminds me of what the Executive Director of the NAMO Partners for Democratic Development, Mr. Eddie Jarwolo told a local radio talk show host that cheating in electioneering process does not happen in one day.

According to him, it can start small and continues up to the election day. Perhaps the alleged slashing of the pending December 8, 2020 senatorial budget from US\$26 million to US\$13.5 million dollars which has been described by the commission as unrealistic, could be a well calculated attempt to deliberately delay the midterm elections under the pretense of the usual no money slogan.

I think that instead of hauling and pulling Madam Chair, as insinuated by the editorial, you should be seeking support and advice from experts on election aimed at resolving your staffers' opposition to the use of VR Update by Mobile teams. The way things are going, I believe that there is an urgent need to fast track the process leading to the success of the December poll. You have to be mindful because you have a long list of electoral arrears that are time-bound exercises that need to be held at a prescribed date in order to meet deadline.

I do hope that the commission's remaining re-scheduled electoral activities such as Voter Roll Update (VRU) will be completed on time in order to ensure smooth landing come December 8, 2020, since you have assured that all timelines are still intact, according to the Thursday, August 20, 2020 edition of the Inquirer Newspaper.

As you may be aware, a strong advocate for the impartiality of electoral authorities, has emphasized that regular and genuine elections through which the people have a real opportunity to choose their representatives freely, are now considered to be the cornerstone of democracy.

He further revealed that "an electoral roll of acceptable completeness and advocacy lies at the heart of the democratic process where the ability to vote depends on whether a voter's name is on the roll." (Free and Fair Elections, International Guy S. Goodwin-Gill, P. 47.)

Besides, Madam Chair, 17 years after the signing of the historic Accra Comprehensive Peace Agreement (CPA), on August 18, 2003, which marked the ending of 14 years of Liberian civil war, one of the drafter of the instrument, River Gee County Senator Commany B. Wesseh is cautioning Liberian to maintain the peace that we enjoyed today.

He reminded us that on that fateful day, Liberian leaders made a solemn and strong pledge to end the brutal civil war and also promised to never allow the country to go back to war with itself again and that Liberians would never allow the use of their territory for war against their neighbors.

In my candid opinion, Mrs. Lansannah, you as head of the country's election management body, have a crucial role to play in the maintenance of Liberia's fragile peace especially during these electoral seasons. One way you can do it, is to conscientiously adhere to the election laws without fear or favor.

You are already in the driver's seat Madam. Do your best in order to discourage the return of the ugly past. Another way I think that you can be successful in the process, is to ensure that election workers especially magistrates are trained and motivated to act impartially.

Thursday, August 20, 2020 edition of the Inquirer Newspaper reported that the Ruling Coalition

for Democratic Change (CDC) and the four Collaborating Political Parties (CPP) did not attend the NEC organized inter-party consultative committee (IPCC) political parties Code of Conduct (CoC) signing ceremony in Monrovia.

Part V of the CoC provides among things, that appointed officials who want to canvass or participate in an election must resign at least two years before elections; three years in the case of tenured officials. The CoC is also intended inter-alia, to hold accountable politicians that would come in conflict with the law especially when they are key players in the process.

Up to now, the NEC appears to be unwilling to determine the fate of the two parties in the wake of their refusal to comply with the NEC directive which implied their unwillingness to uphold democratic principles aimed at abiding by the Code of Conduct. This in my view Madam Chair, is unacceptable and unhealthy for the ensuing special senatorial and future regular elections in the country.

Remember Madam Chair that suspicion is dangerous. It can destroy friendship, relationship and a country; just by poisoning the minds of one group of people against another. Let's get it out of our national politics. For example, the brutal memories of the Presidential and Legislative elections of October 1985 in which Slain President Samuel Doe was accused of stealing the election, which according to political observers, served as one of the prime factors of the 1989 rebellion, which is still fresh in our minds.

I also want to draw your attention to the missteps of your predecessor, Cllr. Jerome George Korkoya, which led to some strange things happening at the commission under his watch during the 2017 elections that had the potential to have undermined the credibility of the entire exercise and create a political tension in the country at the disadvantage of the ordinary people.

Wednesday, July 5, 2017 edition of the Heritage Newspaper quoted the former Civic Educator of the NEC, Mr. Josiah F. Joeker, Jr. as saying that NEC ex-Chairman Korkoya's June 14, 2017 statement that citizens with valid voter cards would have voted on Election Day whether or not their names were on the roll, was inconsistent with the standard of maintaining a credible roll. He wondered how does one obtain a valid card when his or her information was not captured on the roll.

He said the profile of the voter is established by a credible voters roll, which confirms the validity of the voter card. He stated emphatically that without credible voters roll there will be no free and fair election.

Besides, this principle of maintaining a credible voters roll is also guaranteed by Article 77 (b) of the 1986 Constitution of Liberia mandating the commission to ensure that eligible voters are registered.Commenting on the issue further, Commissioner Jonathan K. Weedor indicated among other things that a reliable and credible Final Registration Roll is a cardinal requirement for every free, fair and transparent election.

From all indications, you are gradually being challenged by some politicians in Montrserrado County, who are engaged in pre-election campaign activities through petitioning ceremonies without the campaign being officially declared by your entity as required by law.

The gavel is already in your hand. You just need to use it within the confine of the law to regulate violators before things become shockingly bad to the point where the Commission may likely find it difficult to control.

As you the experts are quite aware, one of the pre-election activities of the NEC is to monitor elections guidelines and Code of Conduct for Representatives of Political Parties, Accredited Coalitions, and Alliances, and Independent Candidates at all times without fear or favor. If not, politicians may likely take advantage of the Commission's indifference to sideline the law in order to accommodate their vested interest.

For instance, Nimba County District 5 Representative. Hon. Samuel Korgai was on the OK FM morning rush recently raising serious issue about the billboards installed in various parts of Monrovia with inscriptions alongside President Weah's photograph calling on voters to vote "YES" for all the prepositions contained in the pending December 8, 2020 referendum which has already been objected to by some lawyers and civil society actors.

He said President Weah's call for the reduction of term for elected officials i.e. President from 6 to 5 years, Senator from 9 to 7 years, Representative from 6 to 5 years as well as his "YES" vote for dual citizenship, is a cleaver attempt by the President to secure his third term bid.

I am just wondering as to whether the office of the President is now responsible for civic voter education instead of the NEC and civil society. If the expressions on the lips of politicians and civil society actors are something to go by, then it appears that they are looking up to you to prevail on the office of the president to have the billboards removed.

I think Madam Chair that there is a need for your entity that is responsible to organize and conduct free, fair and transparent elections in this country, to provide clarity on Hon Korgai's assertion and set the record straight.

When you begin to check mail these people at the initial stage, they will regard you as head of the NEC with the gavel of authority to compel compliance. In addition, your action will also reduce the necessity for challenge, limit the possibilities of outright rejection of election results on the basis of cheating, as well as make transfer of power from losers to winners much easier and honorable.

To be frank with you, colleague, if you don't do it now, and God forbid the situation happens to become a recipe for political bitterness, Liberians at home, away from home, and the generation yet unborn may not easily forgive you, and the 21st century Liberian political history may not likely favor you. I am therefore suggesting that your conscience and the God that you serve be your guide in the conduct of your daily activities at the commission. Liberian people along with the world at large is washing you! Stay blessed, stay safe, have a nice day.

S/Court slaps Orange in the face

iberia's Supreme Court has ruled that the iberia Telecommunications Authority (LTA's) imposition of surcharges on data services and on - netvoice calls did not invade the Legislature's authority to levy tax, a slap in the face of GSM company Orange Liberia, which had continuously opposed the move.

Reading the Supreme Court's decision Thursday, 3 September, Associate Justice Yussif D. Kaba said it was not the intent of the Legislature to preclude the LTA from imposing surcharges on data services and on-net voice calls when it repealed and amended Sections 1165 (Mobile Telephone Usage) and 1022 (B) (2) of the Amended Revenue Code as Amended 2016.

On 25 February 2019, LTA caused the publication of its order captioned LTA Services and a Regulatory Fee on Telecommunication Goods and

examine Orange Liberia's concerns and decide what will best conduce to the purpose for which the Legislature enacted the Telecom Act of 2007.

In the Supreme Court's decision as read by Associate Justice Kaba, the court recounts requests for consultation made separately by service providers for LTA's intervention in addressing alleged anti- competitive practices in the mobile voice and data markets.

The Supreme Court notes that Orange Liberia noted in its inputs during the consultation that the "concept of unlimited, three day free calls" is at the core of its marketing strategy and if stopped, would destabilize the company and create significant risks on its leadership of the market, operations, revenues and taxes.

Besides, Orange had complained also that this would affect a vast number of its customers, and argued that it

stabilize telecommunications market, as the regulator, it could only act on those factors within its direct control, such as the service providers' cost price.

LTA further noted that it understands that the marketing gimmick of "unlimited calls" to be customers' unlimited minutes or megabytes at a defined cost within a specified period.

The regulatory agency therefore suggested that the service providers apply a cap to all such unlimited offers "under a price floor, and that the 'unlimited marketing offers' may continue as long as the appropriate caps are applied to ensure compliance with the price floors.

Having heard the case, the Supreme Court rules that the word "surcharge" as used in the LTA's order published on 25 February 2019 is construed within the context of an imposition of additional fees or charges on data services and on - net voice calls.

The court says this is under the authority of the Telecommunications Act of 2007, hence, the imposition of surcharges by the LTA did not invade the Legislature's authority to levy tax.

Further, it says that the trial judge who had earlier ruled in the case was not in error when he held that Orange Liberia did not allege sufficient legal grounds for the granting of its petition for judicial review.

It says further that the judge was not in error in ruling that LTA, acting under the Telecommunications Act of 2007 did not exceed its jurisdiction in the publication of its order.

"Wherefore and in view of the foregoing, the final judgment of the trial court is affirmed. The Clerk of this Court is ordered to send a mandate to the court below to resume jurisdiction over this case and give effect to this judgment. Costs are ruled against the appellant," the Supreme Court says.

When the case was called for hearing, Cllr. Jallah A. Barbu appeared for Orange Liberia and its CEO Mamadou Coulibaly, while Cllr. Jonathan T. Massaquoi and Osborn Diggs, LTA In-house Counsel, appeared for the LTA.



Services, and set forth the price floor for on - net voice at US\$0.0156 per minutes and US\$0.0218 per megabyte for data services.

The order also provides that after it comes into force on 15 April 2019, and on the sixth month anniversary of the order, there shall be automatically imposed a surcharge on the onnet voice of US\$0.008 per minute, and on the data services a surcharge of US\$0.0065 for each megabyte.

But following the publication of this order in 2019, the Supreme Court says Orange Liberia continued to engage the LTA by numerous letters, outlining its objection to the order.

However the Supreme Court rules that the purposes of establishing the LTA are to address concerns such as the ones raised by Orange Liberia.

It says that it is the LTA that has the requisite capacity, skills and technologies to would find it challenging to comply with a price floor.

Orange Liberia had further insisted that the reduction in the telecommunication market value by more than 33% between 2014 and 2017 was due to a combination of other facts, apart from a price war between service providers.

In response to the concerns raised by Orange Liberia, the Supreme Court notes that the LTA agreed that a combination of economic and other factors might have contributed to the telecommunications market's destabilization.

However, the Supreme Court says LTA noted that to rebalance the price structure and

bitter experience in legislative work here Tuesday when aggrieved staffers demanding unpaid salaries jeered and booed him at the Capitol in total disgrace.

Some of the aggrieved staffers shouted uncontrollably, "Chambers la rogue! Chambers la rogue!" Montserrado County Representative Jimmy Smith tried intervening, but his effort was like adding gas to fire, as the protesting staffers banged on the doors of the chambers.

The grounds of the Capitol on Tuesday this week became tense after aggrieved staffers of the House of Representatives stormed the entrance of the chambers of the House, demanding that their salaries and benefits allegedly cut without justifiable cause be returned immediately.

Staffers at the Legislature, including the House and the Senate have suffered cuts in salary and benefits after a salary harmonization scheme by the government.

In Section "13.2 Environmental Reports and Audits", the Agreement mandates the company to submit an environmental audit and assessment of the production areas under such


