

eyewitness Ahmed Nur was quoted by Reuters as saying.

"The operation is over now. Nine people, including four attackers, died and over 10 civilians were injured. There is no electricity," a police spokesman told reporters from the scene and via Facebook.

Prime Minister Mohamed Hussein Roble said in a statement that among those

killed was a former military general, Mohamed Nur Galal. The militants targeted the Afrik Hotel despite the fact that it is in a heavily guarded area near the city's main airport, the BBC's Bella Sheegow reported from Mogadishu. The hotel is known to be a gathering place for Somali government officials. A local police captain said a number of lawmakers and senior military officials were inside at the time of the attack.Footage on social media showed large plumes of smoke rising across the city



Nwabudike must go

IF THE NIGERIAN-BORN fraudster Cllr. A. Ndubuisi who sits at the Liberia Anti-Corruption Commission as chairperson after faking his Liberian citizenship thinks members of the Liberian Senate are on a floor show over his removal, he should rethink. Nwabudike should be told in no uncertain terms that he has no time in his favor and the only option is to quite immediately.

IT IS HIGHLY incomprehensible and disgraceful that the Weah administration would continue to keep a foreigner like Cllr. Nwabudike as head of the LACC, a position that is statutorily reserved exclusively for Liberian citizens. And President George Weah is fully aware but has adamantly kept a blind eye on the matter.

LAST WEEK, SENATORS on Capitol Hill debated why the Executive still keeps Cllr. Nwabudike at the LACC after he lied under oath about his Liberian citizenship despite his rejection by the senate during confirmation hearing from heading the National Elections Commission following nomination by the President.

RUMORS HAVE BEEN circulating in Monrovia that the Nigerian fraudster who used fake Liberian naturalization document and enrolled at the Louis Arthur Grimes School of Law at the University of Liberia as a Liberia citizen where he graduated from with a Law degree is expected to resign this week.

THE SENATE IS resolved in making sure that Nwabudike, who carries Liberian Passports with inconsistencies in his date of birth, does not continue to occupy such as important integrity institution like the LACC when his entire life is shrouded in cheat and dishonesty.

SENATOR CONMANY WESSEH of River Gee County during session last week noted that Cllr. Nwabudike managed his way criminally through all sectors of the Liberian government including the judiciary, executive and legislative branches and later duped the Liberia National Bar Association into being inducted as a member.

BUT THE LNBA has since expelled Nwabudike from its membership after his ugly deeds were uncovered and brought to the public. And so with both the Bar and the Senate having no confidence in this foreign con-artist, it makes no sense in keeping him in the Liberian government because he does not serve the interest of the Liberian people.

Biden's Grand Opening

With an economic rescue plan that is both ambitious and well targeted, US President Joe Biden and his team have demonstrated a clear understanding of the scale and range of action that the current situation requires. A broader reconstruction plan can and must come later; but crisis management remains the order of the day.

USTIN - In the space of less than three months, events have conspired to transform the American political scene. First, the COVID-19 pandemic defeated Donald Trump - not because public sentiment in this deeply polarized country changed, but rather because the virus forced open the gates of ballot access. Owing to a vast upsurge of early voting and mail-in ballots, the 2020 election's turnout surpassed that of 2016 by 20 million votes, and featured a greater share of the electorate than any US presidential election since 1900.

Second, thanks to ten years of local organizing by voting-rights activists led by Stacey Abrams, Georgia replaced both of its Republican senators with Democrats in the January 5 runoff elections, thus handing narrow control of the US Senate to President Joe Biden's Democratic Party.

Finally, Trump and some of his fellow Republicans incited a rabble to ransack the US Capitol. That catastrophic political miscalculation resulted in the death of five people (including a police officer), Trump's second impeachment, and the lasting disgrace of the defeated president's most aggressive would-be successors, Senators Josh Hawley of Missouri and Ted Cruz of Texas.

The moment was ripe for Biden to tell the country about his own economic plans. And when he spoke, it was with focus, precision, and a clear sense of the scale and range of action that the situation requires.

Biden has proposed a rescue plan that will advance a number of urgent objectives at once. His first priority is public health, a long-neglected issue that can be met in part by creating community vaccination centers and medical clinics, and by training and employing at least 100,000 new public-health workers in the basics of epidemic control. Essential elements of this plan will reach into low-income and minority communities, as well as into prisons and jails.

A second goal of the Biden plan is income support, which will take the form of extra cash for households below a certain threshold, extended and expanded unemployment insurance, emergency paid leave, grants to renters and small businesses, and tax credits for childcare costs.

Third, the Biden plan aims to stabilize federalism with some \$350 billion in support for state and local governments whose tax bases have imploded. Such funding is urgently needed to keep teachers, firefighters, police, and other essential public servants on the job - as is the additional \$20 billion that would go to keep public transit operating through the crisis.

Finally, the Biden plan has a fair-play element, proposing a long-overdue increase of the federal minimum wage to \$15 per hour, which would raise wages for some 30% of all American workers.

Biden has correctly billed his plan an "American

Rescue Plan," rather than as a "recovery" or "stimulus" program. If successful, the package will stem the pandemic, stave off a variety of social calamities, and prevent the collapse of state and local government services. Economic reconstruction is important; but it is a separate objective that can be advanced in a second package. Biden has made sure to acknowledge this point: once the rescue plan has been implemented, the reconstruction can begin, with an emphasis on infrastructure, energy, and climate policy.

Among other things, this second phase can be used to put America's advanced sectors back to work in the service of public purpose and social need.

This sequencing is crucial, because these sectors will not simply revive and return to their previous positions in the economy. Now that the pandemic has upended aerospace, commercial and retail construction, the energy sector, and much else, a wide array of skills and resources will need to be reallocated. A second-phase economic program can guide the way.

Most important, Biden's plan made no mention of Wall Street shibboleths about budget deficits or the national debt. It does not propose merely temporary measures that will be reversed later, nor does it appeal to economic forecasts to cover a gap between the program's outlays and results. Given the orthodox cast of Biden's economic team, this is especially encouraging to see. Having committed to an ambitious agenda at the outset, it will be somewhat more difficult for his people to backslide later on.

Still, three things that are missing from the Biden package will need to be taken up in due course. First, neither the public-health programs nor the infrastructure, energy, and climate initiatives will provide enough jobs to offset the losses in America's vast services sector. Following the inevitable decline of office and retail work and the disappearance of a wide range of in-person services that could not survive the pandemic, middle-class Americans have retreated into their suburban homes. It is already clear that, sooner or later, a guaranteed public or non-profit jobs program will need to be put on the table.

Second, in order to return to viability, many services and small businesses will need to move to new ownership and cost-sharing arrangements, which can best be achieved through cooperative structures with appropriate local oversight and financing. And similar arrangements will be needed to sustain the work of artists, actors, musicians, and writers. As in the New Deal, America's creative people need (and deserve) support that the commercial economy will not be able to provide.

Lastly, once the immediate crisis has passed, emergency measures to defer rent, mortgages, health bills, and student loans will need to be submitted to a system that can write down, cancel, or settle unpayable debts in a fair and orderly fashion.

This Decade's Growth Champions

Which countries will be the big economic success stories of the next ten years? South Korea is a safe pick, while Vietnam and Mexico also are poised to prosper, whereas India's divisive politics put that country out of the running for the time being.

THACA - With 2021 still young, and hope in the air thanks to new COVID-19 vaccines and a new occupant of the White House, we can finally stop covering our eyes in horror and peer furtively into the future. As the decade unfolds, which countries are likely to be the biggest economic success stories?

My bet is on South Korea, Vietnam, and Mexico, three countries at markedly different stages of development. South Korea is an advanced economy, while Vietnam is what the World Bank calls a lower middle-income economy, like India or Bangladesh. Mexico, an upper middle-income country like Colombia, Botswana, or Indonesia, is somewhere in between. I predict that each of these economies will outperform others in its cohort over the next ten years.

South Korea is the safest pick of the three. Beginning in the late 1970s, during the last years of Park Chung-hee's presidency, its economy gathered steam and sustained a two-decadelong growth run, before hitting the roadblocks thrown up by the 1997 East Asian financial crisis

Rich countries have less growth potential than poorer ones. But among rich countries, South Korea's prospects stand out - mainly because of its investment in human capital. With 3,319 patent applications per million population in 2019, South Korea is head and shoulders above other countries. Japan had the second-highest number, with 1,943, while China and the United States had 890 and 869, respectively. In April 2019, South Korea became the first country to launch a nationwide 5G campaign, and South Korean firms plan to capture 15% share of the global 5G market by 2026.

Moreover, South Korea has gone some distance toward solving a market failure that plagues all countries: teacher selection. As many studies, such as by Abhijit Banerjee and Andrew Newman, and Oded Galor and Joseph Zeira, have shown, schoolteachers are typically paid less than they should be, which I believe is because the effect of a good education cascades down to future generations. Good teachers are thus a bit like good climate policy: future generations benefit, but they have no influence over today's decisions.

South Korea has drawn some of its most talented people into teaching, and schoolteachers are among the country's richest people. The story of Cha Kil-yong, who earned \$8 million in one year teaching school mathematics online, has few parallels anywhere.

President Moon Jae-in's efforts to create a more equitable and inclusive society also augur well. Acts like moving the president's official residence from the palatial Blue House to a more ordinary government complex in downtown Seoul are symbolic but important gestures. My expectation is that South Korea's per capita income will overtake that of Japan within the next ten years.

Vietnam had a per capita income of just \$1,297 in 2010, when it was one of the world's three fastest-growing economies, along with India and China, both of which were richer. The country maintained its impressive growth rate since then, and its per capita income now exceeds India's.

This success story began in 1986, when the Communist Party of Vietnam's Sixth National Congress adopted the Doi Moi policy of moving away from a command economy to a more market-oriented model. In recent years, Vietnam has cut its tariff rates, opened its borders to trade and foreign investment, and invested heavily in human capital.

Vietnam's impressive management of the COVID-19 pandemic has given the economy an additional shot in the arm. The country's low crude mortality rate of 0.4 COVID-19 deaths per million people and 2.9% economic growth in 2020, a year when most economies shrank, are remarkable achievements. The steady inflows of foreign investment that Vietnam is now attracting could make it one of the world's leading manufacturing hubs.

Unlike Vietnam, Mexico is reeling under the pandemic, and President Andrés Manuel López Obrador (AMLO), the latest world leader to be infected, must take responsibility for some of the mismanagement. Nevertheless, since AMLO became president in 2018, there has been a resurgence of hope. He initiated what he called Mexico's "Fourth Transformation," a progressive economic agenda that aims to promote growth and remove some egregious elite privileges. To emphasize this, AMLO refused to live in the presidential mansion, Los Pinos, opting for a simpler residence.

Along with Vietnam, Mexico has the greatest potential to become a global manufacturing hub. The United States-Mexico-Canada Agreement (USMCA), which entered into force last year, can further these three economies' integration. In fact, with the US and Canada providing capital and advanced technology, and Mexico marshaling its ample labor force, the region could experience a major resurgence and outcompete China. Now that US President Joe Biden has taken office, trilateral relations should improve. All three countries will benefit, but Mexico will gain the most, because it has more scope for catch-up growth.

Finally, there is the puzzling case of India. Until a few years ago, the country's rapid growth of about 9% per year made it a major global economic success story. But the economy has since slumped, with falling growth from 2016 to 2020 - the longest slide since independence.

Yet, fundamentally, India is one of the strongest emerging economies. It has a world-class information-technology sector, a strong pharmaceutical industry, and a small segment of highly educated workers. The stumbling block is the country's divisive politics, which have eroded trust and caused the investment rate to fall steadily over the last few years.

If India can clean up its political act, it can be a global growth leader. But that is a big "if." At least for now, it puts India out of the running when it comes to picking this decade's likely economic winners.

Invitation for the Position of Auditor General of the Republic of Liberia

Background

Established by an Act of the National Legislature in 2014 ("the Act"), the General Auditing Commission (GAC) supports Legislative oversight of the management of public resources. As the independent constitutional external auditor of Liberia, the GAC serves the people of Liberia by conducting quality and timely financial, compliance and performance audits. Headed by the Auditor General of the Republic of Liberia, the GAC is mandated to periodically conduct professional audit of all government ministries and agencies, and reports audit results and recommendations to the Legislature with copies to the President.

According to Section 2.1.5, the Auditor General shall hold office for a term of seven (7) years and shall not be eligible for reappointment. Consequently, given the tenure of the current Auditor General is nearing expiration, the Government of Liberia, in compliance with Part 2, Section 2.1 of the ACT, is recruiting to fill the position of Auditor-General of the Republic of Liberia.

The Duties and Responsibilities of the Auditor General:

- a) The Auditor General shall be the auditor of the public accounts and public funds of the Republic of Liberia. Subject to sub-section (b) below, the Auditor General shall carry out such audits and inquiries as he/she considers necessary of public entities and funds owned or controlled by the Government to enable reporting as required by the General Auditing Commission Act of 2014.
- b) Notwithstanding the generality of sub-section (a) of this Section:
 - (i) the Auditor General shall carry out the annual audit of the Government's annual consolidated financial statements; and
 - (ii) the scope of audits by the Auditor General for the Judicial Branch of Government shall exclude matters relating to court decisions and for the Legislative Branch of Government shall exclude matters relating to the merits of legislation.
- c) The Auditor General shall have the right to determine which audits are to be carried out, to select the type of audit to be carried out, when to carry them out and report the findings.
- d) In the performance of his/her operational duties as set out in sub-section (c) above, the Auditor General shall not be subject to the direction or control of any person or authority.
- e) The Auditor General and the staff of the General Auditing Commission shall carry out audits, but shall not be involved, or seen to be involved, in any manner, in management's responsibilities of the organizations being audited

Qualification for Selection and Appointment

A person shall be appointed as Auditor General only if:

- (i) the person is a Liberian citizen;
- (ii) the person possesses at least one professional certification such as a CPA, CA, or ACCA from a recognized professional accountancy body;
- (iii) the person possesses at least a Bachelor degree in accounting, audit, business, finance or a related field;
- (iv) the person possesses a minimum of fifteen (15) years of relevant work experience, including an understanding of the role of a Supreme Audit Institution; and
- (v) the person is of a high moral character, with integrity and impartiality, and who has neither been convicted of any criminal offence nor judgement or been declared bankrupt, in any jurisdiction.







Nwabudike doit partir

Si le fraudeur nigérian Me A. Ndubuisi, qui siège à la Commission anti-corruption du Libéria en tant que président, après avoir frauduleusement obtenu la citoyenneté libérienne, pense que les membres du Sénat libérien se sont réunis pour jouer du théâtre à propos de sa destitution, il devrait repenser. Nwabudike devrait être informé en termes clairs de ce qu'il n'a pas le temps en sa faveur et que la seule option est de démissionner immédiatement.

Il est tout à fait incompréhensible et honteux que l'administration Weah continue de garder un étranger comme Me Nwabudike à la tête de la LACC, un poste statutairement réservé exclusivement aux citoyens libériens. Les débuts musclés de Biden

USTIN - En moins de trois mois, les événements ont conspiré pour transformer la scène politique américaine. Premièrement, la pandémie de la COVID-19 a vaincu Donald Trump - non pas parce que le sentiment du public dans ce pays profondément polarisé a changé, mais plutôt parce que le virus a forcé les portes d'accès aux urnes. En raison d'une forte recrudescence du vote anticipé et des bulletins de vote par correspondance, la participation aux élections de 2020 a dépassé de 20 millions de voix celle de 2016 et a été la plus importante, en pourcentage de l'électorat, de toutes les élections présidentielles américaines depuis 1900.

Deuxièmement, grâce à dix années d'organisation locale des militants en faveur du droit de vote dirigés par Stacey Abrams, la Géorgie a remplacé ses deux sénateurs républicains par des Démocrates lors du second tour des élections le 5 janvier, confiant ainsi le contrôle étroit du Sénat américain au Parti démocrate du président Joe Biden.

Enfin, Trump et certains de ses camarades républicains ont incité une foule à saccager le Capitole américain. Cette erreur de calcul politique catastrophique a entraîné la mort de cinq personnes (dont un policier), la deuxième mise en accusation de Trump et la disgrâce durable des successeurs les plus agressifs du président vaincu, les sénateurs Josh Hawley du Missouri et Ted Cruz du Texas.

Le moment était venu pour Biden de parler au pays de ses propres projets économiques. Et, quand il a parlé, c'était avec concentration, précision et une idée claire de l'ampleur et de la portée des actions exigées par la situation.

Biden a proposé un plan de sauvetage qui fera avancer un certain nombre d'objectifs urgents en même temps. Sa première priorité est la santé publique, un problème longtemps négligé, qui peut être résolu en partie grâce à la création de centres de vaccination communautaires et de cliniques médicales, ainsi qu'en formant et en employant au moins 100 000 nouveaux agents de santé publique pour s'occuper des bases de la lutte contre les épidémies. Les éléments essentiels de ce plan atteindront les minorités et les communautés à faible revenu, ainsi que les prisons et pénitentiaires.

Un deuxième objectif du plan Biden est le soutien du revenu, qui prendra la forme de liquidités supplémentaires pour les ménages en dessous d'un certain seuil, d'une assurance chômage étendue et élargie, de congés payés d'urgence, de subventions aux locataires et aux petites entreprises et de crédits d'impôt pour les frais de garde d'enfants.

Troisièmement, le plan Biden vise à stabiliser le fédéralisme avec quelques 350 milliards de dollars de soutien aux gouvernements des États et locaux, dont les assiettes fiscales ont implosé. Un tel financement est nécessaire de toute urgence pour éviter le licenciement d'enseignants, de pompiers, de policiers et d'autres fonctionnaires essentiels - tout comme les 20 milliards de dollars supplémentaires qui permettraient de maintenir le fonctionnement des transport en commun pendant la crise.

Enfin, le plan Biden contient un élément de fairplay, proposant une augmentation attendue

depuis longtemps du salaire minimum fédéral à 15 dollars de l'heure, ce qui augmenterait d'environ 30% les salaires de tous les travailleurs américains.

Biden a eu raison d'appeler son programme « American Rescue Plan (plan de sauvetage américain) », et non « plan de reprise » ou « plan de relance ». En cas de succès, le programme enrayera la pandémie, conjurera une série de calamités sociales et empêchera l'effondrement des services gouvernementaux et locaux. La reconstruction économique est importante ; mais c'est un objectif distinct qui peut être visé par un deuxième paquet de mesures. Biden s'est assuré de reconnaître ce point : une fois le plan de sauvetage mis en œuvre, la reconstruction pourra commencer, en mettant l'accent sur les infrastructures, l'énergie et la politique climatique.

Entre autres choses, cette deuxième phase peut être utilisée pour remettre au travail les secteurs avancés des Etats-Unis, au service de l'intérêt public et des besoins sociaux.

Cet enchaînement est crucial, car ces secteurs ne pourront pas simplement revenir à leurs positions antérieures dans l'économie. A présent que la pandémie a bouleversé la construction aérospatiale et commerciale, le secteur de l'énergie et bien d'autres choses, un large éventail de compétences et de ressources devra être réaffecté. Une deuxième phase de programme économique peut en indiquer la voie.

Plus important encore, le plan de Biden ne faisait aucune mention des principes de Wall Street concernant les déficits budgétaires ou la dette nationale. Il ne propose pas des mesures qui ne seraient que temporaires et appelées à être annulées ultérieurement, et ne fait pas non plus appel à des prévisions économiques pour combler un écart entre les dépenses et les résultats du programme. Compte tenu de la composition orthodoxe de l'équipe économique de Biden, cela est particulièrement encourageant à voir. S'étant engagé dès le départ envers un programme ambitieux, ce sera un peu plus difficile pour son entourage de reculer plus tard.

Pourtant, trois éléments manquent dans le package Biden et devront être incorporés en temps voulu. Premièrement, ni les programmes de santé publique, ni les initiatives dans les domaines des infrastructures, de l'énergie et du climat, ne fourniront suffisamment d'emplois pour compenser les pertes dans le vaste secteur americain des services. Suite au déclin inévitable du travail de bureau et de vente au détail, ainsi qu'à la disparition d'un large éventail de services en présentiel qui n'ont pas pu survivre à la pandémie, les Américains de la classe moyenne se sont repliés dans leurs maisons de banlieue. Il est déjà clair que, tôt ou tard, un programme d'emplois garantis publics ou à but non lucratif devra être mis sur la

Deuxièmement, pour retrouver leur viabilité, de nombreux services et petites entreprises devront modifier leurs accords de propriété et de partage des coûts. he Liberian Government has requested the Chief Judge of the Community Court of Justice Edward Amoako Asante to recuse himself from any and all cases brought before the Ecowas Court by any applicant or a state party, now or in the future for making alleged prejudicial comments against the interest of the administration.

State lawyers including Liberia's Solicitor General Cllr. Saymah Syrenius Cephus in a filling before the Community Court claim that Justice Asante made debasing comments against the Government of Liberia on the Voice of America (VOA), in which he accused the current Liberian Government of woefully "dismissing judges who will not dance to its tone."


Immediately following the Community Court's final

One of the cases which triggered Associate Justice Ja'neh's impeachment trial in Liberia related to a land dispute involving him and one Madam Annie Yancy Constance.

But Ja'neh's lawyers maintained that the claim that their client allegedly manipulated the Supreme Court to rule in his favor in the property case questioned the credibility of Chief Justice Francis S. Korkpor who served as the head of the Supreme Court and also signed the ruling.

The Liberian authorities insist that the statement of such a grave nature is neither the opinion of the court as contained in the case Kabineh Muhammad Ja'neh versus Republic of Liberia, nor part of the responsibility of a venerated iudge of the court.

Instead, the Liberian authorities indicate that the statement was perhaps triggered by personal or political considerations, gratuitous emotions exclusively designed, planned and unleashed against the Republic of Liberia by Justice Asante to satisfy a vested interest only known to him which is totally incompatible with the standard of judicial impartiality and neutrality.

"Movant/Respondent submits that Justice Asante has effectively incapacitated his own ability to preside over the Application for Judgment Review and should never preside over any matter to which the Republic of Liberia is a party now or in the future, because he has openly gambled and trampled underfoot the cool neutrality of the court and has convicted the Government of Liberia for "dismissing judges who will not dance to its tone" without any new application brought before the court," the Liberian government's complaint continues.

Going forward on the VOA, the Liberian government's complaint adds, Justice Asante also said "the Liberian Government has shown a certain posture that it does not actually respect the court's judgment."






"We are also involved in peacekeeping missions

Standards Laboratory has a total of 33 contractors whose role includes testing goods brought in by government, private businesses, and individuals.

He called on the National Legislature to give serious consideration to an Act currently before that august body that to establish the Liberia Standards Authority (LSA) as an autonomous institution.

He lamented that presently, the entity has no vehicle or motorbike to facilitate its daily operations which poses serious challenge.

He emphasized that due to the entity's current status, it has been unable to deploy staff at various border points and other areas in the country.

The NSL boss said if the Act to establish the Liberia

Standards Authority is hopefully passed by the National Legislature, the entity would have to employ additional workers because it needs at least 140 workers for its operations nationwide.

At the same time, several contractors of the NSL are calling on the government through the Ministry of Commerce (MOC) to regularize their status as permanent employees and pay them three months' salary arrears.

They expressed hope that the Ministry of Commerce would give immediate consideration to their plight by disbursing their wages, noting that they are going through serious constrains daily in reporting to work without pay. Editing by Jonathan Browne

FIGC opens inquiry into Ibrahimovic-Lukaku confrontation



Romelu Lukaku and Zlatan Ibrahimovic were booked following their exchange.

he Italian Football Federation (FIGC) has opened an inquiry into the clash between Zlatan Ibrahimovic and Romelu Lukaku in Inter's Coppa Italia win over Milan.

The former Manchester United team-mates were involved in a heated exchange in which Ibrahimovic appeared to tell the Belgian forward: "Go do your voodoo s***, you little donkey".

It was suggested Ibrahimovic was referring to comments made in 2018 by

Everton majority shareholder Farhad Moshiri, who said Lukaku had declined a contract extension because a "voodoo message" told him to move to Chelsea - a transfer that never transpired.

Some accused Ibrahimovic of racially abusing Lukaku, with the Swede responding by stating on Twitter: "In ZLATAN's world there is no place for RACISM." United midfielder Paul Pogba also tweeted to say his old teammate was "the last person I'd think of as racist".

Both players were booked

following the incident before Ibrahimovic picked up a second caution for a foul in the second half of the game.

As part of the inquest, match referee Paolo Valeri has been summoned to explain his decision to book both players in the aftermath.

A statement read: "This morning, FIGC attorney Giuseppe Chine opened an inquiry into the verbal dispute between Zlatan Ibrahimovic and Romelu Lukaku in the Coppa Italia quarter-final between Inter and Milan on January 26.

"As part of this inquest, Chine has decided to summon referee Paolo Valeri, who will. in the next few hours, be called upon to give his statement regarding the sanctions that were handed out to both players during the game."

Lukaku had cancelled out Ibrahimovic's opener in the tie at San Siro before Christian Eriksen sealed Inter's progression to the semi-finals with a stoppage-time freekick.

Speaking to Liverpool's official website, Davies admitted he was surprised to get the chance to join the current Premier League champions, but said he was desperate to make a good impression at Anfield.

He said: "I'm obviously delighted to be here. It's a huge opportunity.

"Obviously it came as a bit of a surprise when it first came but once you start to get your head around it, the opportunity that is in front of me is incredible.
