

## **Boyfriend charged for murder** of SA pregnant woman

he boyfriend of a South African woman, whose murder galvanised protests against violence against women in the country, has been charged with her murder at a court in Johannesburg.

Ntuthuko Ntokozo Shoba is accused of planning Tshegofatso Pule's murder and paying the killer.

The body of the pregnant 28-year-old was found hanging from a tree two years ago, with multiple stab wounds.Mr Shoba was not asked to enter a plea during his court appearance.

Last week, a Johannesburg court sentenced another man, Mzikayise Malephane, to 20 years in prison after he pleaded guilty to murdering Ms Pule.

In a plea agreement read out in court by his lawyer, Malephane, 31, said he had been offered 7,000 rand (£340; \$480) by Mr Shoba to carry out the killing but had

declined. The offer went up to 70,000 rand before he accepted, he said.Malephane told the court that Mr Shoba "did not want his wife to find out about

the unborn baby".Prosecutors have charged Mr Shoba, who was arrested last week, with murder, conspiracy to commit murder, and defeating the ends of justice.

The 32-year-old, whose legs were shackled, wore an all-black suit and shirt in his first court appearance on Monday, news site TimesLive reported.

Ms Pule's uncle Tumisang

Katake said that seeing Mr Shoba in court reopened "old wounds that were beginning to heal."He added that the family knew that Ms Pule was dating Mr Shoba, but did not know "what type of relationship they

According to the family she had gone to see Mr Shoba in his house in Florida on the West Rand district, 16km (nine miles) west of Johannesburg, in June 2019, after he invited her to go shopping for the unborn baby, news24 reports.

They got into an argument and he later called a taxi whose driver turned out to be Malephane.

On 5 June Ms Pule's body was found hanging from a tree in Roodepoort area in the West widely condemned and inspired the hashtag #JusticeForTshego on Twitter, the BBC's Pumza Fihlani reports from Johannesburg.

In a country with one of the highest levels of violence in the world, including high cases of femicide, Ms Pule's death distressed many, our reporter adds.

In response, President Cyril Ramaphosa released a statement denouncing genderbased violence, saying the pandemic had made it more dangerous for women because "violent men are taking advantage of the eased restrictions on movement to attack women and children".

As many as 51% of women in South Africa had experienced violence at the hands of someone they were in a



# The cost of not counting the dead

nly eight African countries out of more than 50 have a compulsory system to register deaths, a BBC investigation has found. This is not just a failure of the state to recognise individual tragedies but has enormous implications for the making of government policy. All but two countries in Europe -Albania and Monaco - have a universal death registration system, and in Asia, just over half, analysis of UN data shows. But in Africa it is only

Egypt, South Africa, Tunisia, Algeria, Cape Verde, São Tomé and Principe, Seychelles and Mauritius that have what are called functioning, compulsory and universal civil registration systems - known as CRVS systems - which record deaths.

All of the countries surveyed by the BBC, working with researchers from the UN's **Economic Commission for Africa** (UNECA), do have some sort of death registration.

But it is often on paper and not available in a shareable digitised form. The information may be used in a local area but cannot calculate mortality trends on a national level. In the wake of the Ebola epidemic, and now Covid-19, having an accurate picture of who is dying, from what and where, is crucial when it comes to allocating resources and funding.

This also has implications for tracking maternal and child mortality as there are children whose birth and untimely death go unrecorded.

This not only robs them of a "right to an identity", in the words of William Muhwava the head of demography at the UNECA based in Addis Ababa - it also means that lessons are not learnt.

"In order to help the living, we need to count the dead," UN Population Fund demographer Romesh Silva told the BBC. Those who are missed out on the registers are often the poorest and socially excluded, he adds, and the absence of information about their deaths means that measures to deal with the causes are sometimes not taken."Despite investments, CRVS systems

# Rwandan dissident killed

eading Rwandan opposition ∎politician Seif Bamporiki has been shot dead in South Africa, where he lived in exile.Mr Bamporiki was pulled from his vehicle in a township in Cape Town before being killed, police said.

Preliminary investigations showed he had been killed in a robbery, police said. But Mr Bamporiki's party, the Rwanda National Congress (RNC), said the motive was still unclear.

Rwanda has previously been accused of targeting dissidents in South Africa.

It has consistently denied the allegation.The RNC was formed in exile by opposition politicians who accuse President Paul Kagame's government of being authoritarian, and of being intolerant of dissent.

Mr Bamporiki ran a bed shop in Cape Town. He was making a delivery in Nyanga township on Sunday when he was shot after being confronted by two men, police said.

"The deceased was pulled from his vehicle and shot while the 50-year-old man

remain dysfunctional, forcing governments to rely on surveys... which by the time they are published are already outdated," says Irina Dincu, from the Centre of Excellence for CRVS systems. When it



who accompanied him managed to escape unharmed.

"The suspects who are yet to be arrested fled with the deceased's vehicle, and we have reason to believe that the motive for the murder was robbery," police added in a statement to the BBC.

RNC spokesman Etienne Mutabazi gave a different account, saying Mr Bamporiki was killed after a gunman fired a single shot through the window of the car. There was speculation on social media that Mr Bamporiki had been killed in a political hit, but Mr Mutabazi said he did not know whether this was the case. reports the BBC's Nomsa Maseko from South Africa's main city, Johannesburg. ### **Political tolerance is key** to peace and stability

IN HIS DEPARTING comments to the people of Grand Gedeh County on Saturday, February 20, 2021 at the Zwedru City Hall, President George Manneh Weah emphasized the need for political tolerance in the county in order to move ahead with economic development. He urged Grand Gedeans who voted for him overwhelmingly during the 2017 elections to tolerate opposition views in fostering a democratic culture in their midst.

THE CALL IS in direct reference to violence in Zwedru City, Grand Gedeh County on Thursday, 30 July 2020 when hundreds of thugs throwing stones and waving machetes prevented the leader of the opposition Alternative National Congress and former chairman of the Collaborating Political Parties (CPP) Alexander B. Cummings, and Montserrado County District#10 Representative Yekeh Kolubah from stepping out to address supporters in the county after a stopover from Maryland County.

THE OPPOSITION DELEGATION woke up to a nightmare on the 30th of July last year when angry youths, armed with stones, sticks and cutlasses, among others barricaded B-2 Motel in the heart of Zwedru City, where Mr. Cummings, Representative Kolubah and other members of their entourage lodged. The mobs threatened to lynch Rep. Kolubah for constantly ranting invectives at President George Manneh Weah.

THAT INCIDENT RECEIVED condemnation from the Grand Gedeh County Legislative Caucus and the international communication with calls for speedy investigation to bring the perpetrators to justice. Findings of investigation by the government are yet to be made public.

BUT PRESIDENT WEAH was very emphatic on Saturday when he told citizens of the county that despite their support for his administration, they should tolerate opposition politicians as guaranteed under the Constitution.

WE BELIEVE THE remark by the President is important in promoting diversity of opinions or contrary views as required by freedom of speech. Mr. Weah further stressed that there would be no development both in Grand Gedeh and the entire Liberia without peace, so peace and tolerance for one another should be upheld.

WE JOIN THE President in calling on citizens of that county to cherish tolerance and peace for the sake of national unity and economic progress. Development cannot thrive in chaos.

ADDITIONALLY, GRAND GEDEANS should be reminded in no uncertain terms that Liberia is not for any pacific President or administration. Rather, the democratic space, thru the Constitution allows a person to be elected at the ballot box to govern the state for a specific tenure.

NO MATTER WHO is elected President, that person automatically becomes leader for the entire Republic, which includes both his own supporters and the opposition. He may not be liked or loved by all of the citizens but tolerance requires that critical or contrary views are expressed without threats to those expressing such views.

IN FACT, CRITICAL views strengthen democracy and the government in power to govern well in the interest of all citizens, including the opposition. If a President succeeds in his administration, it is Liberia that gets the credit.

THIS IS THE message President Weah wants the people of Grand Gedeh County to run with: He appreciates so highly that they love him 100 percent, as demonstrated at the ballot box, but at the same time, others may express contrary views about his leadership. This should not give his supporters right to go after those people who criticize his government. History has proven time and again, that doing so is counterproductive.

## **The Draghi Power Triangle**

TANFORD - Mario Draghi's first speech as no replacement for the US troops in Europe. As Italy's prime minister made clear that his national unity government will not only signaled nothing less than a dramatic reconfiguration of European policymaking, with major consequences for Europe and the European Union's relations with Russia and the United States.

As prime minister, Draghi will be a member of the influential European Council; in fact, he should be one of its core leaders, along with his French and German counterparts, Emmanuel Macron and Angela Merkel. As Jörg Asmussen, a member of the European Central Bank's executive board when Draghi was ECB president, put it shortly before Draghi's installment, "European politics might shift into more of a triangle."

Asmussen was right. In his maiden speech to Italian lawmakers, Draghi stressed that Italy would "need to better structure and strengthen the strategic and essential relationship with France and Germany." Clearly, the reconfiguration of European politics will be a top priority for his government. "Without Italy, there is no Europe," Draghi said.

And there is no Europe without further EU integration. Taking aim not only at anti-euro Italian populists like Matteo Salvini, Draghi said, "Supporting this government means sharing the irreversibility of the choice of the euro," adding that it also "means sharing the prospect of an increasingly integrated European Union that will arrive at a common public budget capable of supporting countries in times of recession."

Draghi's ascension to the European stage alongside Macron and Merkel also implies closer EU-US relations. US President Joe Biden could not find a better ally in Europe. Italy's new government, Draghi vowed, will be "strongly pro-European and Atlanticist, in line with Italy's historical anchors." This marks a break with the foreign policy of Giuseppe Conte, the previous prime minister, who had aligned Italy more closely with China. Draghi is giving the transatlantic alliance a chance to Draghi can serve as Italy's prime minister until recover after four years of Donald Trump's

On NATO, Biden and Draghi think alike. Both favor keeping US troops in Europe, and both want a bigger German monetary contribution to the common defense budget. A more fundamental point is that the two see the US as the ultimate protector of Europe's independence.

> After all, Draghi's standing does not rest solely on his reputation in financial markets, where he is seen as someone who can lower Italian borrowing costs and boost Italian stock prices. He is a student of history, with strong democratic values and a strategic sense of the type that Europe badly needs to deal effectively with Putin and his ideological soulmates in Central Europe.

> Draghi's pro-Atlanticism clearly does not conflict with the prospects for a more united Europe. When he was president of the ECB, he did not save the euro merely to preserve Italy's membership in the common currency, as his northern detractors allege; he did it to save the European project itself. Likewise, he did not introduce quantitative easing simply to bail out Italian bonds; he did it to further north-south integration.

> Now he is championing the EU recovery fund, not only to help Italy and other southern countries overcome the economic consequences of the pandemic, but also to make permanent the most daring joint effort so far to integrate Europe's north and south. The next step in the process could be the introduction of a true eurobond. Draghi's support for such a joint debt instrument may well prove decisive.

> 2023, when new elections must be held. But he may decide not to serve past May 2022, if Charles Michel, the current president of the European Council, does not serve a second term. Given Draghi's focus on Europe's future, the opportunity to pursue the position would be tough for him to ignore. The conventional wisdom that Draghi will move on to the Italian presidency is overblown. There is no power in that job.

## **Texas Froze by Design**

USTIN - Harvard Kennedy School's William Hogan is credited with designing the Texas energy market. As Texans froze and their water pipes burst, he reportedly remarked that the state's energy market has functioned as designed.

Hogan is right, which says a lot about how some economists think.

For years, electric utilities were a stable, dull business. To counter the effects of monopoly, utility commissions set and stabilized prices, and companies got a rate of return on their investment that was (in principle) enough to cover construction, maintenance, and a fair profit.

But economists complained: utilities had an incentive to over-invest. The bigger their operations and the higher their total costs, the more they could extract from the ratesetters.

Electricity is the ultimate standard product, every jolt exactly like every other. Texas had a self-enclosed energy grid, cut off from interstate commerce and thus exempt from federal regulations. What better place, what better product, to prove the virtues of a competitive, deregulated system?

So, economists proposed a free market: let generating companies compete to deliver power to consumers through the common electrical grid. Freely chosen contracts would govern the terms and the price. Competition would maximize efficiency, and prices would reflect fuel costs and the smallest possible profit margin.

The state's role would be to manage the common power grid linking producers to consumers. In times of shortage, prices might rise, but those who did not wish to pay could flip their switches off.

In 2002, under Governor Rick Perry (later President Donald Trump's secretary of energy), Texas deregulated its electricity system and established a free market, managed by a nonprofit called the Electric Reliability Council of Texas (ERCOT), with roughly 70 providers. While a few cities - including Austin - kept their old-fashioned public power, they, too, were tied to the state system.

The problem is that electricity demand is inelastic: it doesn't respond much to price, but it does respond to weather. In times of extreme heat or cold, demand becomes even more inelastic. And, unlike in an ordinary market, supply must equal demand every minute of every day. If it doesn't, the entire system can fail.

The Texas system had three vulnerabilities. First, cut-throat competition to provide power in the cheapest possible way meant that machinery, wells, meters, pipes, and windmills were not insulated against extreme cold - rare but not unknown here. Second, while wholesale prices were free to fluctuate, retail prices depended on whatever contract the consumer had signed. Third, prices would rise the most at moments when demand for power was greatest - and would not fall.

The new system did work most of the time. Prices rose and fell. Customers who didn't sign long-term contracts faced some risk. One provider, called Griddy, had a special model: for a \$9.99 monthly membership fee, you could get your power at the wholesale price. Most of the time, that was cheap.

But people don't need electricity "most of the time"; they need it all the time. And, at least by 2011, when Texas experienced a short, severe freeze, the state's leaders knew that the system was radically unstable in extreme weather. The system's architects knew it as well, whatever they say now.

Yet Texas politicians did nothing. Texas energy providers, a rich source of campaign donations, didn't want to be required to invest in weatherization that was not needed most of the time. In 2020, even voluntary inspections were suspended, owing to COVID-19.

Enter the deep freeze of 2021. Water vapor in the natural gas froze at the wells, in pipes, and at generating plants. Non-weatherized windmills went offline, but they were a small part of the story. Because the Texas grid is disconnected from the rest of the country, no reserves could be imported; and, given the cold everywhere, none would have been available anyway. In the small hours of February 15, demand so outstripped supply that the entire grid reportedly came within minutes of a meltdown.

As this happened, the price mechanism failed completely. Wholesale prices rose a hundredfold - but retail prices, under contract, did not rise that much, except for customers of Griddy, who got socked with bills for thousands of dollars a day. Demand rose as supply collapsed.

ERCOT was forced to cut power, which might have been tolerable, had it happened on a rolling basis across neighborhoods throughout the state. But this was impossible: you can't cut power to hospitals, fire stations, and other critical facilities, or to high-rise apartments reliant on elevators. So, lights stayed on in some areas, and stayed off - for days - in others.

Freezing water was the next phase of the calamity. Pipes burst, and the water supply could not keep up with demand. Across Texas, water pressure fell or failed. Hospitals could not generate steam, and therefore heat, and some had to be evacuated. All of this, Hogan accurately tells us, was according to design.

Power is now coming back in Texas; water supplies will take some extra days. Food is scarce, and damaged homes will take months to repair. Millions of Texans have suffered the effects of a design, invented by economists, aided by a myth, that served the fossil fuel industry and the politicians it funds. One of these politicians, US Senator Ted Cruz, acted in perfect keeping with the system's free-market logic by decamping to Cancún.

#### Invitation for the Position of Auditor General of Liberia

#### **Background**

Established by an Act of the National Legislature in 2014 ("the Act"), the General Auditing Commission (GAC) supports Legislative oversight of the management of public resources. As the independent constitutional external auditor of Liberia, the GAC serves the people of Liberia by conducting quality and timely financial, compliance and performance audits. Headed by the Auditor General of the Republic of Liberia, the GAC is mandated to periodically conduct professional audit of all government ministries and agencies, and reports audit results and recommendations to the Legislature with copies to the President.

According to Section 2.1.5, the Auditor General shall hold office for a term of seven (7) years and shall not be eligible for reappointment. Consequently, given the tenure of the current Auditor General is nearing expiration, the Government of Liberia, in compliance with Part 2, Section 2.1 of the ACT, is recruiting to fill the positi<mark>on</mark> of Auditor-General of the Republic of Lib<mark>er</mark>ia.

#### The Duties and Responsibilities of the Auditor General:

- a) The Auditor General shall be the auditor of the public accounts and public funds of the Republic of Liberia. Subject to sub-section (b) below, the Auditor General shall carry out such audits and inquiries as he/she considers necessary of public entities and funds owned or controlled by the Government to enable reporting as required by the General Auditing Commission Act of 2014. Notwithstanding the generality of Section (a) above:
  - The Auditor-General shall carry out the annual audit of the Government's annual consolidated financial statements and
  - The scope of audits by the Auditor General for the Judicial Branch of Government shall exclude matters relating to court decisions and for the Legislative Branch of Government shall exclude matters relating to the merits of legislation.
- The Auditor General shall have the right to determine which audits are to be carried out, to select the type of audit to be carried out, when to carry them out and report the findings.
- In the performance of his/her operational duties as set out in sub-section (c) above, the Auditor General shall not be subject to the direction or control of any person or authority.
- The Auditor General and the staff of the General Auditing Commission shall carry out audits, but shall not be involved, or seen to be involved, in any manner, in management's responsibilities of the organizations being audited

#### **Basic Qualification for Selection and Appointment**

A person shall be appointed as Auditor General only if:

- the person is a Liberian citizen;
- the person possesses at least one professional certification such as a CPA, CA, or ACCA from a recognized professional accountancy body;
- (iii) the person possesses at least a Bachelor degree in accounting, audit, business, finance or a related field:
- the person possesses a minimum of fifteen (15) years of relevant work experience, including an understanding of the role of a Supreme Audit Institution; and
- (v) the person is of a high moral character, with integrity and impartiality, and who has neither been convicted of any criminal offence nor judgement or been declared bankrupt, in any jurisdiction.

#### Core Competencies Required for the Auditor General:

#### Behavioral

- a) Integrity;
- Objectivity;
- Professional competence and due care;
- Confidentiality;
- Professional behavior;
- Ability to work with others; and

- (a) Financial Statement, Compliance, Performance and Information Technology Audits;
- (b) Public Financial Management Act and Regulation of 2009 of Liberia as amended in 2019;
- (c) Public Procurement and Concessions Commission Act of 2005 as amended in 2010;
- (d) Revenue Code of Liberia of 2000 as amended in 2011;
- (e) INTOSAI Standards:
- International Public Sector Accounting Standards (IPSAS); and
- (g) IFAC Standards.

- (a) Information technology systems for financial accounting and reporting, including relevant current issues and developments;
- (b) Principles and practices for evaluating financial accounting and reporting systems, including evaluating controls and assessing risk;
- (c) Computer-assisted auditing packages and techniques; and
- (d) Have an understanding of the LICPA Act and Regulations.

Accordingly, the National Elections Commission is requested therefore to conduct the Grand Gedeh County by-election within 90 days to fill the vacancy in the National Legislature.

he publisher of The New Republic Newspaper has called on the Central Bank of Liberia to investigate Palm Insurance Corporation (PIC) for alleged unprofessional and unethical practices in the country, especially against its customers.

In a letter of complaint filed to the Central bank of Liberia, Mr. Alphonso Toweh wrote that the Insurance company allegedly failed to underwrite a liability for one of his vehicles which was involved in an accident this

In a preliminary investigation carried out at PIC office, all documents and receipts requested by the insurance corporation from Mr. Toweh to authenticate his claim were correct. Later, the corporation realized that there were inconsistencies in the documents processed in their office which led to them holding an emergency internal meeting with the staff.

This is the second time for PIC to carry out incorrect preparation of documents. Early this month, PIC issued a Tricycle document to Mr. Toweh instead of Toyota Pickup. After discovery, it was immediately



According to the month. corporation, its new policy has a clause which does not allow it to incur liability for any vehicle if a client owes.

"According to PIC, it has a revised policy which supersedes what was given to me last year; and [it] expires end of February, 2021. The earlier policy given to Mr. Toweh expires February this year but does not have any such clause. Palm said, it has a new policy which copy was not given to the publisher," the letter stated.

"As a supervisory body, I would appreciate were you to intervene into this matter in the shortest possible time," the letter addressed to Central Bank Executive Governor, J. Aloysius Tarlue, stated.



will be located.


The structure is very wide in size to accommodate huge number of worshippers going for prayers.

### La tolérance politique est la clé de la paix et de la stabilité

Dans son message de départ du comté de Grand Gedeh le samedi 20 février 2021, le président George MannehWeah a souligné la nécessité d'une tolérance politique dans le comté afin de sauvegarder la paix sociale et relancer l'économique. Il a exhorté les habitants de Grands Gedehqui ont voté massivement pour lui lors des élections de 2017 à tolérer les opinions de l'opposition et à favoriser la culture démocratique.

L'appel fait directement référence à la violence qui avait éclaté dans la ville de Zwedru, dans le comté de Grand Gedeh, le jeudi 30 juillet 2020, lorsque des centaines de voyous s'étaient mis à lapider le leader de l'Alternative National Congress et ancien président de la coalition des principaux partis de l'opposition.Ce jour-là, Alexander B. Ce jour fatidique du 30 juillet était pour la délégation de l'opposition qui s'était rendue dans cette partie du pays un véritable cauchemar. Cummings, le représentant Kolubah et d'autres) avait élu domicile, au cœur de la ville de Zwedru. #### Draghi et le triangle de pouvoir européen

TANFORD - Dans son premier discours au poste de Premier ministre de l'Italie, Mario Draghi a Clairement fait savoir que son gouvernement d'unité nationale entendait travailler non seulement sur la politique intérieure et les réformes en Italie, mais également sur l'Europe. Draghi annonce en effet une importante reconfiguration de l'élaboration des politiques européennes, avec des conséquences majeures pour les relations de l'Europe et de l'Union européenne avec la Russie et les États-Unis.

En tant que Premier ministre, Draghi sera membre du très influent Conseil européen ; il en sera d'ailleurs l'un des membres clés, aux côtés de ses homologue français et allemand, Emmanuel Macron et Angela Merkel. Comme l'a exprimé Jörg Asmussen, membre du comité exécutif de la Banque centrale européenne pendant la présidence Draghi, Asmussen ayant eu cette formule peu avant l'installation de Draghi, « La politique européenne pourrait bien évoluer vers un triangle de pouvoir ».

Asmussen avait vu juste. Dans son premier discours devant les parlementaires italiens, Draghi a insisté pour dire que l'Italie avait « besoin d'une meilleure structure, ainsi que d'un renforcement de sa relation stratégique essentielle avec la France et l'Allemagne ». Manifestement, la reconfiguration de la politique européenne constituera une priorité majeure de son gouvernement. « Sans l'Italie, il n'y a pas d'Europe », a-t-il ajouté.

Et il n'y a pas d'Europe sans poursuite de l'intégration de l'UE. Ciblant notamment les populistes italiens opposés à l'euro, tels que Matteo Salvini, Draghi a déclaré « Soutenir ce gouvernement signifie partager le choix irréversible de l'euro ». Cela signifie également « partager la perspective d'une Union européenne de plus en plus intégrée, qui parviendra à un budget public commun susceptible de soutenir les États en périodes de récession ».

L'accession de Draghi à la scène européenne aux côtés de Macron et Merkel implique également des relations plus étroites entre l'UE et les États-Unis. Le président américain Joe Biden n'aurait pas pu trouver meilleur allié en Europe. Le nouveau gouvernement italien, a promis Draghi, sera « résolument pro-européen et atlantiste, en phase avec les ancrages historique de l'Italie ». Ceci marque une rupture par rapport à la politique étrangère de Giuseppe Conte, son prédécesseur à la tête du gouvernement, qui avait privilégié un rapprochement de l'Italie avec la Chine. Draghi donne à l'alliance transatlantique une chance de se rétablir, après quatre ans de détérioration pourrait bien se révéler décisif. stratégique sous Donald Trump.

Biden et Draghi sont par ailleurs en accord sur la question de l'OTAN. Tous deux préconisent le maintien de troupes américaines en Europe, et tous deux souhaitent une plus grande contribution monétaire de l'Allemagne au budget commun de défense. Plus fondamentalement encore, tous deux considèrent les États-Unis comme le garant ultime de l'indépendance de l'Europe.

Les sentiments atlantiste et pro-américain présents chez Draghi sont trop profonds pour que celui-ci soutienne l'élan actuel - impulsé par Macron, avec l'approbation d'une grande partie de l'élite - en direction d'une plus grande « autonomie stratégique » de l'UE. Draghi s'inscrivant toutefois en accord avec Macron sur bien d'autres sujets, il aplanira sans doute leurs divergences sur cette question délicate.

Pour autant, la position de Draghi est ferme concernant la sécurité européenne - dans un avenir relativement proche, il ne peut y avoir de substitut à la présence de troupes américaines en Europe. L'influence de Trump s'estompant actuellement aux États-Unis, il en ira certainement de même pour les craintes européennes autour de la fiabilité de la garantie de sécurité américaine, ce qui devrait atténuer l'idée d'un nécessaire renforcement de « l'autonomie stratégique ».

La confiance profonde de Draghi dans l'atlantisme devrait par ailleurs renforcer celle du Conseil européen tout entier, lequel pourrait alors faire office de force de contrepoids et de modération vis-à-vis de Merkel, qui a parfois placé les intérêts d'affaires de l'Allemagne auprès de la Russie avant les relations transatlantiques et la sécurité européenne. Plus Draghi exercera d'influence dans le triangle de pouvoir européen - son poids face à Merkel semblant nettement confirmé par son mandat à la BCE - plus l'UE se montrera ferme avec le président russe Vladimir Poutine, ainsi qu'avec les autocrates locaux d'Europe tels que Viktor Orbán en Hongrie et Jaroslaw Kaczynski en Pologne.

La stature de Draghi ne repose en effet pas seulement sur sa réputation auprès des marchés financiers, où il est considéré comme quelqu'un de capable d'abaisser les coûts d'emprunt italiens et de dynamiser le cours des actions italiennes. Il est également un amateur d'histoire, fort de solides valeurs démocratiques et d'un sens stratégique dont l'Europe a cruellement besoin pour faire face efficacement à Poutine et ses semblables idéologiques d'Europe centrale.

L'atlantisme de Draghi ne s'inscrit absolument pas en contradiction avec la perspective d'une Europe plus unie. À la présidence de la BCE, il n'a pas sauvé l'euro dans le simple but de préserver l'appartenance de l'Italie à la monnaie commune, comme les prétendent ses détracteurs du nord ; il l'a fait pour sauver le projet européen lui-même. De la même manière, il n'a pas introduit l'assouplissement quantitatif pour sauver les seules obligations italiennes, mais bien pour renforcer l'intégration nord-sud.

Il défend aujourd'hui le fonds de relance de l'UE, pas seulement pour aider l'Italie et d'autres États du sud à surmonter les conséquences économiques de la pandémie, mais pour rendre permanents les audacieux efforts conjoints fournis jusqu'à présent pour intégrer le nord et le sud de l'Europe. Dans cette démarche, la prochaine étape consistera à mettre en place une véritable euro-obligation. Le soutien de Draghi en appui d'un tel instrument de dette conjoint

Draghi peut en principe rester Premier ministre de l'Italie jusqu'en 2023, lorsque de nouvelles élections devront avoir lieu. Il pourrait toutefois décider de ne pas exercer au-delà de mai 2022, si Charles Michel, actuel président du Conseil européen, ne briguait pas un second mandat. Sachant l'attachement de Draghi pour le futur de l'Europe, l'opportunité d'un tel poste serait pour lui difficile à laisser passer. L'idée très répandue selon laquelle Draghi aspirerait à la présidence de l'Italie est erronée, dans la mesure où ce poste ne confère aucun pouvoir.

Même si l'économie italienne risque de constituer le talon d'Achille d'un Draghi qui pourrait devoir consacrer tout son temps et son capital politique à la lutte pour les réformes nécessaires, son défi national et son défi européen sont en fin de compte étroitement liés. Mais seule la disponibilité de plus de 200 milliards € de fonds de relance à répartir au niveau national vient atténuer ce risque de voir l'économie italienne le conduire à sa perte.



# o room for corrupt individu

onservative Liberian politician and chairman of the newly established People's Liberation Party Wilmot Paye, says the opposition environment is not a waiting room for corrupt individuals to regroup or conspire to unseat another group.

He argues that after all, there is no evidence in history that consummate tribalists and conventional politicians who reject truth and do not promote integrity but fear those who stand up against dishonesty within their own organizations have the spine to lead transformation in any


"You cannot give what you do not have. Integrity does [not] change its character or nature, no matter what. While it exposes the ills and evils done by others, it distances itself from that which is committed under its nose. No political party,

ideas, practical and predictable approaches to tackling the problems of corruption, nepotism, sectionalism and tribalism.

"I know that you are all tired of promises that do not match current attitude, conduct, action and character. The question is not whether one administration will end in 2023 with the election of another. Let the debate rather be about how different Liberia's governance system will be after 2023. We must never settle for anything below this."

The former Unity Party stalwart says when Liberia is liberated; the current monetary uncertainties will vanish, and the Central Bank of Liberia will cease from being a channel for looting donor and public funds, while commercial banks will be trusted, and depositors will use the banking system without the fear that they will be robbed.

"When we liberate Liberia, then Justices of the Supreme Court and Judges of subordinate courts will dispense justice



Meanwhile, the head of Liberia's newest political party Dr. Daniel E. Cassell says, the PLP seeks to become the alternative political institution that would liberate Liberians from economic degradation, education paralysis, health immobility and agriculture decadence through inclusive and democratic participation of all citizens regardless of county, tribe or social status.

It may be recalled that scores of children who were reportedly sleeping in their campus building along with a senior staff of the Islamic school were killed in a fire, attracting visit of President George M. Weah and scores of other high profile individuals.

President Weah at the time assured that the brunt school building and mosque will have rebuilt with help from the Government of Liberia. -Editing by Jonathan Browne

alliance or coalition, however "good" the intentions may be, can present itself as a viable alternative if it fails and/or refuses to hold its own members and leaders accountable for their evil deeds and conduct," Paye continues.
