irls among the nearly 300 who were kidnapped from a school in northwestern Nigeria have been describing their ordeal following their release.

"Most of us got injured," one of the schoolgirls told the BBC, adding that gunmen threatened to shoot them.

The girls were abducted by unidentified assailants from their boarding school in Jangebe, Zamfara state, on Friday and taken to a forest, police said. The state's governor said on Tuesday that the 279 girls had been freed.

Such kidnappings are carried out for ransom and are common in the north of the country.On Tuesday, dozens of the girls were seen gathered at a government building in Zamfara after they were taken there in a fleet of mini-buses.Speaking to the BBC, one of the schoolgirls said that some of those kidnapped had found it difficult to continue walking when instructed to do so by the gunmen because of their injuries.

"They said they [would] shoot anybody who did not continue to walk," she said. "We walked across a river and they hid us and let us sleep under shrubs in a forest."Another of the girls, aged 15, said that some of her classmates found it difficult "walking in the stones and thorns" and had to be carried."They started hitting us with guns so that we [would] move," she told Reuters news

agency, adding: "While they were beating them with guns, some of them were crying and moving at the same time."Some of the fathers who had arrived to see their daughters for the first time since their abduction told reporters they were "very happy" at the news of their release.

The group's release was secured through negotiations

and the abductors, authorities in Zamfara state told the BBC.Local authorities said that an earlier figure provided by police of 317 for the number of girls kidnapped was not accurate.One official told Reuters that the discrepancy was because of the fact that some girls had fled shortly after being abducted.

Nigeria's President Muhammadu Buhari said he felt "overwhelming joy" at the news of the girls' release. "[I am] pleased that their ordeal has come to a happy end without any incident," he said.

The governor of Zamfara state, Bello Matawalle, tweeted that it "gladdens my heart to announce the release of the abducted students".

"This follows the scaling of several hurdles laid against our efforts," he added. "I enjoin all well-meaning Nigerians to rejoice with us as our daughters are now safe." Mr Matawalle has denied paving for the girls to be released, but last week President Buhari admitted state governments had paid kidnappers "with money and vehicles" in the past and urged them to review the policy. The 2014 kidnap of 276 schoolgirls in the north-eastern town of Chibok by Islamist militants Boko Haram brought global attention to the scourge of raids on schools in Nigeria, but a surge in recent attacks is suspected to be the work of criminal gangs. The raid in Zamfara state was the region's second kidnapping in recent weeks. Some 27 students were kidnapped from a boarding school in Kagara in the northcentral state of Niger last month before they were released on 17 February. BBC



SHAMELESSLY, HERE IS the Justice Minister Frank Musa, trying to defend Cllr. Syrenius Cephus before the Liberian Senate on his letter to the NEC, asking the Commission not to certificate the Senator-elect, Samukai because he (Samukai) was convicted by the court.

AND SO LAST week, both the Solicitor General Cephus and the Attorney General Dean on one hand, and the Liberian Senate on the other, had been pulling and hauling over the certification of the Senator-elect with the Senate instructing the two officials to withdraw the communication sent to NEC.

The Green Shoots of COVID Solidarity

XFORD - In a recent letter to her G20 colleagues, US Secretary of the Treasury Janet Yellen argued that a truly global COVID-19 vaccination program "is the strongest stimulus we can provide to the global economy." With rich countries vaccinating their populations while low-income countries have yet to receive even paidfor vaccine doses, the world seems a long way from that goal. But the first shoots of solidarity are beginning to appear, and leaders must strengthen cooperation to nurture them.

Such an approach is essential, because reopening the global economy requires containing the coronavirus everywhere. One recent study estimates that, even if advanced economies reach optimal vaccination levels by mid-2021, they could nonetheless suffer economic losses of up to \$4.5 trillion this year if developing countries' vaccine rollouts continue to lag far behind. Open economies such as European Union member states, Switzerland, the United Kingdom, and the United States would be most at risk, and output losses in sectors such as construction, textiles, retail, and automobiles could exceed 5%.

Uncoordinated vaccine distribution also poses grave health risks. Leaving poorer and needier countries out of the supply chain has resulted in the deaths of numerous desperately needed African frontline nurses and health workers. When Guinea declared an Ebola outbreak in February, the world relied on the country's own health-care workers to roll out a containment and vaccination campaign. Without such workers, the world is more vulnerable to future pandemics: in 2014, for example, a single case of Ebola in the US caused nationwide panic when it spread to the nurses treating the patient.

But ensuring a speedy global vaccine rollout is proving difficult. The COVID-19 Vaccine Global Access (COVAX) Facility, established by three international health agencies to speed up vaccine production and distribution, needs more money. Otherwise, poorer countries will be forced to divert scarce budget resources or slow down vaccination programs against other diseases such as polio, measles, and meningitis.

More funding is also needed for the Access to COVID-19 Tools (ACT) Accelerator, which the World Health Organization and other partners created to develop tests, treatments, and vaccines to fight the disease. According to one estimate, a \$10 billion US contribution to this initiative would safeguard up to \$1.34 trillion in domestic output, giving America a more than hundred-fold return on its investment. Yellen's letter to the G20 recognizes this logic, and the group agreed on February 26 that granting equitable access to safe COVID-19 vaccines, diagnostics, and therapeutics for all countries "is a top priority."

But money is not the most immediate obstacle. African countries that have borrowed to purchase vaccines have discovered that there are no doses for them to buy. Although COVAX has concluded some deals for developing countries, by March 1 it had delivered only a few hundred thousand doses to Ghana and Côte d'Ivoire. A first shipment reached Nigeria on March 2. And Guinea has administered a total of 55 doses to date.

Some blame intellectual-property (IP) protections for developing countries' lack of vaccine access. In late 2020, India and South Africa, as well as some NGOs, urged the World Trade Organization to waive current IP rules related to COVID-19, but the US, EU, and UK opposed the idea. Governments will debate the issue at the World Trade Organization in early March.

But patents are not (yet) the problem. The US pharmaceutical firm Moderna, which has developed an approved COVID-19 vaccine, has said that, while the pandemic continues, it will not enforce its coronavirus-related patents against those making vaccines intended to combat it. And AstraZeneca says that "for the duration of the coronavirus pandemic," it will proceed "with only the costs of production and distribution being covered."

Yet, these short-term arrangements will soon need attention. The voluntary licensing regime preferred by the UK and other rich countries may well be inadequate. At the least, policymakers should be considering non-exclusive licenses and technology transfer, as John-Arne Røttingen, who chairs the WHO Solidarity Trial of COVID-19 treatments, has proposed.

This still leaves two more immediate obstacles. First, there are manufacturing challenges related to increasing production speed. Each vaccine is different and relies on biological and chemical processes of variable efficacy that are sometimes difficult to scale up. And vaccine production requires intensive supervision and quality control. But these problems will ease as manufacturing improves and more vaccines - including a newly approved one from Johnson & Johnson - come on stream.

What Could Cause a US-China Warp AMBRIDGE - When China's foreign minister, Wang Yi, recently called for a reset

of bilateral relations with the United States, a White House spokesperson replied that the US saw the relationship as one of strong competition that required a position of strength. It is clear that President Joe Biden's administration is not simply reversing Trump's policies.

Some analysts, citing Thucydides' attribution of the Peloponnesian War to Sparta's fear of a rising Athens, believe the US-China relationship is entering a period of conflict pitting an established hegemon against an increasingly powerful challenger.

I am not that pessimistic. In my view, economic and ecological interdependence reduces the probability of a real cold war, much less a hot one, because both countries have an incentive to cooperate in a number of areas. At the same time, miscalculation is always possible, and some see the danger of "sleepwalking" into catastrophe, as happened with World War I.

History is replete with cases of misperception about changing power balances. For example, when President Richard Nixon visited China in 1972, he wanted to balance what he saw as a growing Soviet threat to a declining America. But what Nixon interpreted as decline was really the return to normal of America's artificially high share of global output after World War II.

Nixon proclaimed multipolarity, but what followed was the end of the Soviet Union and America's unipolar moment two decades later. Today, some Chinese analysts underestimate America's resilience and predict Chinese dominance, but this, too, could turn out to be a dangerous miscalculation.

It is equally dangerous for Americans to over- or underestimate Chinese power, and the US contains groups with economic and political incentives to do both. Measured in dollars, China's economy is about two-thirds the size of the US economy, but many economists expect China to surpass the US sometime in the 2030s, depending on what one assumes about Chinese and American growth rates.

Will American leaders acknowledge this change in a way that permits a constructive relationship, or will they succumb to fear? Will Chinese leaders take more risks, or will Chinese and Americans learn to cooperate in producing global public goods under a changing distribution of power?

Recall that Thucydides attributed the war that ripped apart the ancient Greek world to two causes: the rise of a new power, and the fear that this created in the established power. The second cause is as important as the first. The US and China must avoid exaggerated fears that could create a new cold or hot war.

Even if China surpasses the US to become the world's largest economy, national income is not the only measure of geopolitical power. China ranks well behind the US in soft power, and US military expenditure is nearly four times that of China. While Chinese military capabilities have been increasing in recent years, analysts who look carefully at the military balance conclude that China will not, say, be able to exclude the US from the Western Pacific.

On the other hand, the US was once the world's largest trading economy and its largest bilateral lender. Today, nearly 100 countries count China as their largest trading partner, compared to 57 for the US. China plans to lend more than \$1 trillion for infrastructure projects with its Belt and Road Initiative over the next decade, while the US has cut back aid. China will gain economic power from the sheer size of its market as well as its overseas investments and development assistance. China's overall power relative to the US is likely to increase.

Nonetheless, balances of power are hard to judge. The US will retain some long-term power advantages that contrast with areas of Chinese vulnerability.

The other big problem is vaccine nationalism. Wealthy countries have stockpiled more COVID-19 vaccine doses than they need, and other governments also are competing to prove that they are procuring adequate supplies for their own citizens.

Two Brazilian research institutes had planned to produce millions of doses of the AstraZeneca-Oxford and Chinese Sinovac vaccines, but have been hampered by unexplained delays in shipments of vital ingredients from China. And the Serum Institute of India, the world's largest vaccine manufacturer, was aiming to make more than 300 million doses available to 145 countries through COVAX in the first half of 2021, before the Indian government recently ordered it to meet domestic needs first.

Still, some encouraging signs of vaccine solidarity are emerging. Forty-seven countries, as well as the African Union, which has 55 member states, have made or been offered COVID-19 vaccine deals with China, India, or Russia. India has shipped nearly 6.8 million free doses around the world, China has pledged around 3.9 million, and Israel is offering 100,000.

UK Prime Minister Boris Johnson has pledged to donate most of his country's surplus doses

One is geography. The US is surrounded by oceans and neighbors that are likely to remain friendly. China has borders with 14 countries, and territorial disputes with India, Japan, and Vietnam set limits on its hard and soft power.

Energy is another area where America has an advantage. A decade ago, the US was dependent on imported energy, but the shale revolution transformed North America from an energy importer to exporter. At the same time, China became more dependent on energy imports from the Middle East, which it must transport along sea routes that highlight its problematic relations with India.

The US also has demographic advantages. It is the only major developed country that is projected to hold its global ranking (third) in terms of population. While the rate of US population growth has slowed in recent years, it will not turn negative, as in Russia, Europe, and Japan. China, meanwhile, rightly fears "growing old before it grows rich." India will soon overtake it as the most populous country, and its labor force peaked in 2015.


America also remains at the forefront in key technologies (bio, nano, information) that are central to twenty-first-century economic growth. China is investing heavily in research and development, and competes well in some fields. But 15 of the world's top 20 research universities are in the US; none is in China.

Section 75 (3) also empowers the EPA to by notice, impose any restrictions, as it considers necessary for the protection of the wetland from the



La tolérance politique est la clé de la paix et de la stabilité

Dans son message de départ du comté de Grand Gedeh le samedi 20 février 2021, le président George MannehWeah a souligné la nécessité d'une tolérance politique dans le comté afin de sauvegarder la paix sociale et relancer l'économique. Il a exhorté les habitants de Grands Gedeh qui ont voté massivement pour lui lors des élections de 2017 à tolérer les opinions de l'opposition et favoriser la culture démocratique.

Reconstruire ensemble

ERLIN - L'être humain est une créature La seule façon de rétablir la confiance et de d'habitudes. Nous avons tendance à imaginer un avenir très semblable au passé et nous nous raccrochons donc à des approches, perspectives et outils familiers, alors même que le monde change. Cependant, en cette période de profonde transformation sociale, politique et économique, nous devons veiller à ne pas laisser nos habitudes nous égarer.

D'un point de vue historique, les périodes de transformation radicale - comme celle qui a suivi l'effondrement de l'Union soviétique et la dissolution du Pacte de Varsovie au début des années 1990 - n'ont pas rendu les sociétés collectivement plus clairvoyantes, ni même plus circonspectes. Au contraire, elles ont généralement engendré la présomption que la vie quotidienne resterait, pour l'essentiel, telle qu'elle avait toujours été - ou du moins, qu'il y aurait un retour à la « normale ».

Cette tendance s'est manifestée avec la crise du Covid-19, souvent perçue comme une perturbation, certes dramatique, mais temporaire. En réalité, la pandémie est un moment charnière - et il n'est pas le seul auguel nous sommes aujourd'hui confrontés : la révolution numérique et l'impérieuse nécessité d'une décarbonisation rapide ont des répercussions tout aussi importantes.

Face à ces trois grandes ruptures historiques, pouvons-nous vraiment nous attendre à un retour à l'ancienne « normalité » ? Ou devons-nous plutôt escompter une conjoncture légèrement différente ? Et si l'avenir ne ressemblait en rien au passé ? Sommes-nous équipés pour relever les défis qu'elles présentent?

Tout permet d'en douter. Déjà, les institutions politiques traditionnelles - et en premier lieu, l'État-nation - sont en train de vaciller. Elles ont éprouvé les plus grandes difficultés à remédier aux périls du numérique, par exemple en cherchant à mettre au pas les géants du web. Et elles se sont révélées mal outillées pour gérer à la fois l'envergure mondiale de la pandémie et sa dimension psychologique, en particulier le caractère abstrait qu'elle revêt pour un grand nombre de personnes.

Le Covid-19 est invisible à l'œil nu. À moins d'être soi-même malade, de prendre soin de malades ou d'être endeuillé par la perte d'un être cher, il peut être difficile de saisir pleinement l'ampleur de la menace - et d'accepter les modifications des modes de vie imposées par la réponse à la pandémie.

stabiliser les sociétés est d'apporter une réponse efficiente à la crise. Et compte tenu de la nature mondiale des défis à relever, cela ne sera pas possible sans une coopération de grande ampleur, facilitée par des institutions efficaces.

Pourtant, jusqu'à présent, le monde a persisté dans ses vieilles habitudes, se prêtant au jeu de rivalités nationales bornées au lieu de mettre au point des solutions originales, tournées vers l'avenir. Ce constat s'applique particulièrement à la course aux vaccins.

Compter sur l'État-nation pour juguler la pandémie revient à tenter d'abattre un avion de chasse avec un mousquet. Et si on compare la crise du coronavirus à un avion de chasse, alors le changement climatique est un missile nucléaire. En échouant à construire des systèmes capables de faire face à des menaces d'une telle ampleur - y compris les inévitables pandémies futures l'humanité met en péril son existence même.

Assurément, l'appel du président américain Biden à « reconstruire en mieux » après la pandémie implique une certaine prise de conscience quant à la nécessité d'un changement systémique. Toutefois, la transformation nécessaire va bien audelà de la construction de nouvelles infrastructures et de la mobilisation des investissements privés dans un pays donné. Nous devons réorienter - à vrai dire, réinventer - la politique internationale, afin que les pays puissent coopérer bien plus efficacement à la création d'un monde meilleur.

L'Accord de Paris sur le climat de 2015 était un pas important dans cette direction. Les États-nations font partie intégrante de ce processus : ils ont négocié l'accord et sont responsables de la détermination de leurs propres contributions à la réalisation des objectifs de l'accord. Mais ils doivent également fonctionner au sein d'un cadre unique commun pour réaliser des objectifs qui n'ont rien à voir avec le renforcement de leur puissance géopolitique ou économique relative.

Senate passes Supplemental **Budget at US\$24m**

embers of the Liberian Senate overwhelmingly passed the Supplementary Budget at US\$24.3 million.

The senate, during its regular session sitting Tuesday, March 2, at the US\$9 million was identified from revenue generating entities as domestic revenue.

US\$1.5 million was identified as External Revenue Grant from the United Kingdom and that the US\$10.5 million submitted to the Senate by the House of Representatives, US\$3.9 million is proposed as appropriation for the Public Sector Investment Programs with emphasis on roads infrastructure, health,



Capitol Building voted for the passage and its onward submission to the Executive Mansion for signing into law by President George Manneh Weah.

The supplementary budget was earlier submitted at US\$10.5 million, but later the amount hit US\$24.3 million following an addition of US\$13 million intended for the clearance of Liberia Bank for Development and Investment debt owed by the government.

With approval of the senate, a revenue envelop of

That additional proposal was submitted by the Ministry of Finance and Development Planning in the amount of US\$13.8 million be appropriated for the settlement and offset portion of Liberian government debt to LBDI. This amount resulted from Revenue in Transit reconciled by the Ministry of Finance and Development

Planning and LBDI, and that the total budget of US\$24.3 million be passed by the Liberian Legislature as the supplemental budget."

Further, the Conference Committees proposed passage: "An Act to approve the Supplemental Budget for the Fiscal Period Beginning July 1, 2020 and ending June 30, 2021, providing for the expenditure of the Government of the Republic of Liberia in the tone of US\$24.3 million be approved; that upon the passage, the Ministry of Finance and Development Planning (MPDP) provides a schedule of the PSIP to the relevant committees for monitoring and accountability and that upon passage, MPDP provides the total liabilities owes LBDI after the payment of US\$13.8 million to serve as a guide to payments.

he National Elections Commissions (NEC) may ignore a communication send to it by the Minister of Justice (MOJ) Cllr. Frank Musa Dean requesting that body not to confirmed and certificate Lofa County Senator-elect J. Brownie Samukai because he (Samukai) has been found guilty of criminal charges.

The NEC Board of Commissioners on Tuesday March 2, ordered its Certification Committee, under the Political Affairs Section, to officially arrange and workout all modalities for the certification Ceremony

In a statement issued following the NEC Board of Commissioners sitting, the Board instructed its Certification Committee to arrange for the certification and James as first complainants and Kesselly and Peter as Second Complainants all of Lofa County. But the Highest Court said they had no standings to challenge the results as they were not Political Parties and Candidates.

The NEC Board also heard a motion to dismiss the appeal taken by defeated Maryland County Senator H Dan Marias paving the way for the certification of James Biney.

Lawyers representing Sen. H. Dan Marias led by Cllr. Wilfred Sayer after representations by both the Complainant and Respondent, first made a submission and informed the Administrative Court that they interposed no objection to the motion to dismiss the appeal and expressed no interest to continue the case against Biney,

The decision follows the reading of the mandate of the Supreme Court, which among other things confirmed the election of the embattled former defense minister as the winner of the 8 December 2020 Special Senatorial Elections in Lofa County.

The Chairperson of the BOC Davidetta Browne Lansanah in the ruling said after the complainant listened to the soundness of the motion to dismiss and interposes no objection to the motion to dismiss, the Administrative Court granted the motion to dismiss as pray for by the Complainant. The Chairperson then suspended the Lofa and Maryland counties elections dispute cases as a matter of law.

Prior to the NECs decision, a group calling itself Citizens Movement in Solidarity with Brownie Samukai staged a peaceful protest at the premises of NEC demanding the commission to certificate Mr. Samukai.

The protesters widely made of students activists hailing from Lofa County, also paraded the street chanting slogan such as "Certificate Samukai now and NEC stop playing politics with Samukai".

Most of the protesters who appeared at the NEC with the notion that the Lofa County Senator elect would had been officially certificated by NEC appeared disappointed when the commission ordered its Certification Committee to arrange another date for the certification.

Most of the protesters who were dressed up in jean trousers, white T-Shirts with red and blue berets on their heads, asserted that the NEC was heading for trouble due to its failure to certificate the Lofa County Senator elect.

For his part, the lawyer of Mr. Samukai Cllr. Augustine Fayah accused the government of playing politics with the certification of his client by dragging Samukai's confirmation.

Cllr. Fayah disclosed that the action by the government is also intended to deny Mr. Samukai the opportunity to begin official work as Senator elect of Lofa County.

He warned the government to stop playing politics with the Lofa County Senator elect to enable him join his colleagues at the National Legislature to do the Liberian people business.

There was no arrest made by the police and no injury reported during the protest on Tuesday, 3 March.

Mr. Samukai was charged by the Government of Liberia (GOL) of misapplication of over USD 1 million-money belonging to soldiers of the Armed Forces of Liberia (AFL) along with two other high profiled former officials of the Ministry of National Defense during the Ellen Johnson-Sirleaf regime. The trio were convicted of criminally conspiring to siphon the money. They were asked to restitute with first installment over the period of six months or face jail sentences.

address through the law," he said.

He added that he will submit a bill seeking to amend the Alien a Nationality Law of Liberia, which according to him, creates confusion that needs clarities for Liberians to still enjoy citizenship.

During the argument at the time, Dillon said that the referendum should not be held because of its untimeliness, only to see just two months after, the Montserrado County lawmaker is submitting a bill for dual citizenship.

Dillon said, he currently enjoys support of Liberians globally on the decision of amending the Citizen-Alien laws of Liberia and that he's lobbying with his colleagues citizenship.

This Proposition is significant because many Liberians believe that article 28 prohibits dual citizenship under all circumstances. However, the Proposition restricts those with dual citizenship from occupying certain positions in the Government of Liberia.

It states that those with dual citizenship "shall not qualify for elected national or public service positions...", unless they renounce the other citizenship. These restricted positions include Chief Justice and Associate Justice of the Supreme Court, ministers and deputy ministers, heads of autonomous commissions, agencies and non-academic research and scientific



for a smooth passage.

He explained that under the law, the rights of being a Liberian cannot be taken away by any means unless through the laws.

Senator Dillon builds his argument on the Jalloh case of September 2019, the Legislature adopted a Joint Resolution ("The Resolution") proposing a constitutional referendum to amend various articles of the Liberian Constitution. Proposition One of the Resolution ("The Proposition") seeks to amend article 28 of the Constitution, repeal (by implication) section 22.1 of the Alien and Nationality Law, and grant all Liberians the right to acquire another nationality without losing their Liberian

institutions, ambassadors, chief of staff and deputy chief of staff of the Armed Forces of Liberia.

The Constitution does not prohibit dual citizenship in all instances. Rather, article 28 of the Constitution only imposes a restriction on one category of Liberians from obtaining dual citizenship. The Proposition will resolve this by expanding the right to dual citizenship to all Liberians, and by implication, repeal section 22.1 of ANL, if the referendum is successful. While expanding the right of dual citizenship, the Proposition imposes an uneven burden on Liberians with dual citizenship by barring them from participating in "...elected national or public service positions..."

The mandate of the Supreme Court signed by its Clerk Sam Momolu also instructed the Elections Commission to resume jurisdiction of the Lofa County appeal case of elections irregularities.

NEC Chair Davidetta Browne Lansanah said having resumed jurisdiction of the matter, the Certification Committee, led by the Political Affairs Office is instructed to work out all modalities of the time and date for certification of J. Browne Samukai as Senator of Lofa County and suspended the matter.

The case grew out of the action of elections irregularities filed by Ahmed

"Me Darious Dillon of Grand Bassa, born and schooled in Bassa and later moved out of the country and to return I must apply for visa to come to Liberia is something that we must


It was under the Consulship of this Consul General that Madam Paramjit Kaur Dhaliwal aka Marpu Pearl Dhaliwal was
