

The Nigerian minister haunted by his extremist views

igeria's presidency says it "stands behind" an embattled minister facing calls for his resignation after extreme Islamist views he held in the past recently came to light.

Isa Pantami, minister of communications and digital economy, and also a renowned Muslim cleric, expressed views sympathetic to groups such as al-Qaeda and Boko Haram.

In one sermon from the 2000s he said he considered al-Qaeda founder, Osama Bin Laden, a better Muslim than himself, and in another, he said he was happy when infidels were massacred.

Recordings of him expressing these views began circulating on social media last week, leading to calls for his resignation or sacking by President Muhammadu Buhari.

But in its first reaction since the saga began, presidential spokesman Garba Shehu said the minister was being "subject[ed] to a 'cancel campaign'".

"In the 2000s, the minister was a man in his twenties; next year he will be 50. Time has passed, and people and their opinions - often rightly change", the statement said.

The minister also attempted to renounce his past views at the weekend, telling a local newspaper that some of the comments were based on his

"understanding of religious issues at the time" and that he has changed several positions "based on new evidence and maturity".

But that has not stopped calls for his sacking or resignation with many using the #PantamiMustGo hashtag on Twitter to express concerns over his access to sensitive data as the minister

of communications.

He has also been defended under the #PantamiMustStay hashtag as the issue exposed the religious and ethnic lines in this multi-ethnic country.

What exactly did Mr Pantami say?

There has been a steady stream of new evidence of the views he held in the past and the latest are documents that appeared online on Wednesday.

The documents are purportedly from a 2010 meeting he chaired at the Jama'atu Nasril Islam (JNI), a top Islamic body, where it was agreed that Christians should be prohibited from building churches in city centres across northern Nigeria, which has a majority Muslim population although millions of Christians also live there. Audio and video recordings have also

emerged of Mr Pantami's fiery prayers and sermons at different stages of his career as an imam. In one sermon after there had been a deadly religious conflict and tensions were still high in Shendam, Plateau state, he volunteered to lead Muslims back to their homes, saying that he was willing to die in the process. In a 2006 speech, Mr Pantami publicly offered his condolences after the death of al-Qaeda's leader in Iraq, Abu Musab al-Zarqawi.

In one audio clip, where he talks about the Nigerian army's war against Boko Haram, he appears to be on the verge of tears as he passionately describes the militants as "our Muslim brothers" who did not deserve to be "killed like pigs". In another audio recording, he declares he is always happy when infidels are massacred. He has not denied the authenticity of these texts, audio and video clips.BBC

uman rights groups in Zimbabwe say the government has frequently violated people's basic rights since the start of the COVID-19 pandemic. The groups presented their findings at a partially virtual meeting with officials in the capital Thursday.

At the meeting, rights groups presented a report they call "The Impact of COVID-19 on Socio-Economic Rights." The report

chronicles how Zimbabwe's government has violated human rights since COVID-19 lockdowns started in March 2020. Calvin Fambirai, executive director of Zimbabwe Association of Doctors for Human Rights, was one of the speakers. He said the COVID-19 pandemic highlighted the gap in medical care between the haves and have-nots in the country.

"The haves were able to secure that equipment and the

hospitals whose pricing was far beyond the majority of poor Zimbabweans. The right to health is also another component that relates to torture and inhumane and degrading treatment," said Fambirai.

On a number of occasions, Zimbabwe's doctors and nurses have gone on strike, demanding adequate protective equipment and decent salaries during the? coronavirus? pandemic. N aome Chakanya, a researcher at the Labor and Economic Development Research Institute of Zimbabwe, said the government must increase salaries of all its employees to motivate them.

"If the government is not doing a good service in terms of providing living wages, it is also increasing its own burden in terms of filling the gap of decent work deficit by providing social protection. So, it is in the best interest of the government to ensure that the majority of workers in the public sector enjoy decent work," said Chakanya.

Weah's challenge to officials!

OFFICIALS OF THE Weah administration seem to be living deceitful lives with their people, disappointing the President each time he tours the country. Recently in Grand Cape County President Weah frowned at Senator Varney Sherman and other lawmakers of the county for not having a home or a place to host official delegation in the county they represent.

NOW IN GRAND Bassa County, President Weah was not just disappointed but physically upset with county officials. including superintendent and lawmakers, who were elegantly attired, for hosting him in an unkept town hall during a meeting with citizens. The President faced the unpleasant experience as he ended the third leg of his nationwide tour.

MR. WEAH: "LOOK at this, look at this, look at this, look around you, look at this and look at us, look at us (describing how splendidly dressed up they were as compared to the infrastructure they were sitting in and the environment). Sometimes, we should have consceince and be ashamed of oursleves. This place doesn't represent anything. You can't be repsenting people and bring the President and the entire government here. It is not possible."

MOVING HIS EYES around the hall in which the town hall meeting was being held, he lamented that the place was not fit for such gathering and that even their own dress code contradicted everything.

OFFICIALS OUGHT TO know that reality always contradicts pretense or false life. The fact of the matter is that the Presidents's nationwide did not come as a surprise. It had been planned for 2020, but was postponed because of COVID-19 and other official engagements.

EVEN PRIOR TO the start of the exercise this year, it was formally announced. So we are also surprised that county superintendents and their lawmakers would not prepared adequately to host the President and his entourage. Are Grand Bassa County Superintendent Janjay Vakpah, Senator Nyonblee Kangar Lawrence and her colleague lawmakers from the county saying they couldn't find paint in Buchanan, the provincial capital to give the town hall a facelift for President Weah's meeting with citizens? Quiet disappointing!

LAWMAKERS SHOULD NOT only focus on personal projects in their constituents but also the county they represent, especially, when the President is paying an official visit. He should be received and hosted in line with the esteem ascribes to the Presidency.

LEADERS SHOULD DESIST from dressing up and parading themselves in public shamelessly while the towns, villages, counties and people they represent remain in appalling conditions. This is not leadership but sheer hypocrecy!

FROM RIVER GEE, Grand Cape Mount to Grand Bassa, the story is the same: Neglect and poorly managed infrastructure that does not properly portray the places they represent as leaders. Nevertheless, members of the Liberian Legislature preside over the national budget every year and apportion the national cake, even allotting themselves bigger shares.

IT'S TIME THEY change their leader style by placing the people and places they represent above personal interest to demonstrate the true leadership they ought to be.

Europe Needs a New Fiscal Framework

ARIS - In the mid-1980s, only seven fashion. countries had fiscal rules. In 2015, when the International Monetary Fund last counted, 96 did. Most had provisions limiting public debt, budget deficits, or both, and some had additional rules on public expenditures.

This circumscription of fiscal discretion was partly a response to traumatic experiences such as Latin America's "lost decade" following the debt crises of the 1980s; the painful adjustment suffered by countries caught off-guard by rising interest rates in the early 1990s; and the European sovereign-debt crisis of 2010-12. But the adoption of fiscal rules also owed something to growing distrust of fiscal activism.

In 2000, John B. Taylor of Stanford University captured the spirit of the time when he wrote that it is "best to let fiscal policy have its main countercyclical impact through the automatic stabilizers" - in other words, to put it on automatic pilot. The consensus then was that monetary policy is a nimbler and more effective policy tool, because the key decisions are made by an independent central bank and implemented with the stroke of a pen.

Nowhere are fiscal rules as detailed and prescriptive as in the European Union, whose budgetary rulebook is nearly 100 pages. There are good reasons for this. Because euro members share a currency, they cannot inflate away their individual debt burdens. As Paul De Grauwe of the London School of Economics has observed, they are in a position similar to countries that borrow in a foreign currency. Yet excessive public debt results in pressure on partner countries to come to the rescue to avoid severe financial fallout from debt restructuring or, worse, an exit from the currency union. This is what happened with Greece in the 2010s. So there is a real motive for preventing fiscal irresponsibility.

But there are also bad reasons for having codified budgetary behavior so extensively. Germany is traditionally wary of stabilization policy (though not in response to the 2008 financial crisis or the pandemic), and smaller northern European countries are even more fiscally gun-shy. In addition, member states lack mutual trust. As a result, they have piled

But times have changed. For 12 years now, interest rates have been pinned near zero, making a mockery of claims touting monetary policy's effectiveness. Instead of protecting the central bank from fiscal vagaries, the priority in such an environment is to ensure that monetary and fiscal policy function in tandem. Breaking a taboo, Isabel Schnabel, a member of the European Central Bank's Executive Board, has stressed that today's situation requires unconventional monetary policies and unconventional fiscal policies, which should complement one another to protect the economy from large downturns. As outlined in a recent Geneva Report, the longforgotten concept of a policy mix is back in

In parallel, concerns about sovereign solvency have greatly diminished. As former IMF chief economist Olivier Blanchard notes, there is no such thing as an unsustainable debt as long as the interest rate remains below the growth rate. In many countries, this has now been the case for a decade; and even in the United States, where bond rates have recently increased, the margin remains wide.

Recognizing the implications of these debt dynamics, US President Joe Biden's administration has lost no time pursuing its fiscal agenda. Whereas the post-2008 US stimulus was too timid, the recently adopted \$1.9 trillion fiscal package, coming on top of trillions of dollars in spending enacted last year under Donald Trump, amounts to massive overkill.

The question now is what Europe will do. In March 2020, it wisely availed itself of an escape clause in its fiscal rulebook, allowing member states "to temporarily depart from the normal budgetary requirements." This exception will likely remain in place for 2022 but, pandemic permitting, will end in 2023. In the meantime, the debate will focus on whether the rules should be reformed before they are reinstated, and - more fundamentally - whether fiscal initiatives should be regarded as a problem or as a solution.

The case for comprehensive reform was strong before the pandemic and has now become overwhelming. The current rules were built for a world that no longer exists. They are opaque, excessively constraining, and reliant on numerical targets that do not make sense in a low-interest-rate environment. Moreover, they are no longer credible. With a debt-to-GDP ratio approaching 160% this year, Italy can scarcely be expected to hit the EU's debt-to-GDP limit of

Make no mistake: in a monetary union, fiscal responsibility is crucial. The question is not whether member states should be given high standards to meet, but how this should be done. Reformers want to retain the commitment to fiscal discipline but change the yardstick for assessing actual behavior. Others, worried that this commitment would not survive a renegotiation, prefer to tinker on the margin. up a tangle of rules so complex that people in But sticking to an obsolete commandment out of Brussels joke that only one person in the whole fear of being unable to define a better one is a European Commission actually understands it formula for undermining trust in the rules altogether.

> If there is any silver lining to the COVID-19 crisis, it is that we have been forced to rethink rules that have survived on inertia. Short of the radical reform advocated by some, it is possible to design a fiscal framework that creates more space for fiscal discretion but preserves the essential commitment to responsibility. The first step is to accept that all countries cannot be expected to achieve the same goal. The second is to acknowledge that fiscal discipline must be based on principles and buttressed by welldesigned institutions, rather than by rigid numerical targets.

Should President Weah continue to be apprehensive over CDC's massive senatorial defeat, or simply ignore it completely?

Political Hot-Fire asks: "Should President Weah continue to be apprehensive over CDC's massive senatorial defeat, or simply ignore it completely?

The writer is aware that CDC's Stewarts would refer to him as being stupid or has no sense of direction. But the fact of the matter is that the senatorial results are self-evident of president Weah's systematic declining football popularity that took him to the majestyhigh of the Liberian politics, where he now served as President and Commander-In-Chief of the Armed Forces of Liberia.

However, President Weah's well-deserved football popularity was not the only factor that gave him the Presidency. Two other political parties stood with the CDC to capture the government in the form of a coalition led by Alex Tyler (Liberia People Democratic Party (LPDP); and the National Patriotic Party under Jewel Howard Taylor. These two parties helped to enforce CDC's overwhelming success through its "Coalition for Democratic Change."

But the political foundation of LPDP and NPP in the coalition is seemingly cracking at a disproportionate level, which should by and large make Pres. Weah apprehensive due to the just-ended CDC massive senatorial defeat which is a political referendum on Pres. Weah's if he chooses to run for 2nd term in 2023.

Pres. Weah should also be apprehensive for three reasons: First, either the coalition base did not support any of his senatorial candidates, or the coalition members simply refused to vote for them either the coalition leadership was simply unhappy over the limited political pie Pres. Weah has to offer them and keep the most lucrative jobs for CDC partisans.

Second, President Weah may have turned his blind eyes on everything they agreed on or he simply doesn't respect the power of the coalition anymore. Third, either President Weah is now overconfident at this time in his presidency after mastering and understanding the Presidency, or he no longer needs any type of political expertise going into the 2023 election.

But the writings are very clear on the wall. The parties that make up the coalition are the same parties that may undermine the CDC in the 2023 elections for three reasons: First, they may feel Pres. Weah used them for his political aggrandizement at their peril. Second, they may also feel that President Weah dumped them and deceived them by denying them lucrative jobs.

Third, the coalition parties would feel that they have nothing to lose, but Pres. Weah has all to lose, because if the CDC is yearning for 2nd term in 2023, with or without any coalition which in my mind is very dangerous tactics, that could possibly be the end of CDC political existence. But the LPDP and the NPP are not sleeping as well. They could be in search of another political opportunity to build a much stronger coalition that may inevitably endanger Pres. Weah chances in 2023.

Other CDC partisans think that Pre. Weah has a very strong political popularity from his football career days which is still active to earn him the 2023 presidential victory whether coalition or no coalition parties. Three reasons account for the President's confidence come 2023. First, Pres. Weah did employ an array of election Commissioners that can easily twist their hands in the direction of President Weah in the 2023 presidential election and make him the winner. Second, Pres. Weah did employ all the election Commissioners who should also return similar favor in kind by making him the winner in the 2023 election. Third, African governments are very notorious when it comes to cheating and nothing can ever happen to them.

Aside from the coalition fallen apart due to Pres. Weah's own political maneuvering capabilities, the ruling CDC has its own bad political odors heading into the 2023 Presidential election could also affect Pres. Weah directly. Many level headed Liberians in CDC led-government are often ashamed to associate themselves in public with the CDC party officials who are just violence oriented according to one inside source familiar with the CDC inner working. These are some of the rationales while Pres. Weah has to be apprehensive in the 2023 election for 2nd term.

My people:

I know many of you are worried about some of the things going on in the country. I am too. The so-called mysterious deaths of Liberians is troubling. The other day, I returned to Monrovia to news of another "mysterious death". The man's name was Mr. Anthony Johnson. From the pictures we have seen, it is hard not to believe that Mr. Johnson was killed. Please remember his family in your prayers.

Under this government, the "mysterious deaths" are plenty! We have to ask ourselves; how many times are we going to be expressing sympathies to families for the mysterious deaths of their loved ones? How can anyone in our country feel safe when the government cannot explain how people are disappearing and dying?

I know there are plenty things that are wrong with our country. To be fair, this government did not do all the things that are wrong with our country. They met some of the wrong things there. But they have spoiled the wrong things even more. And they are showing us everyday that either they are not able to fix it, or don't even know how to fix it. For sure, they are not even letting themselves try to fix it.

14-year-old student takes | Brown cautions marijuana to school

ourteen years old Student Melvin Brooks was caught early Thursday morning, April 29, 2021 smoking marijuana in an abandoned building near his school campus. Student Brooks is a 7th Grader at the JS Pratt High School in Harper, Electoral Distinct#1, Maryland County.

Township Commissioner Mr. Jonathan Harmer, narrates that the minor was caught in the unwholesome act along with a friend, who he didn't identify.

Commissioner Harmer says while on his way to work

teenagers in the county, so there is a need for national government to act effectively in order to arrest those who normally traffic harmful substances in Liberia that are destroying the youth of the nation gradually.

Commissioner Harmer notes although there are straight laws on the books to deter perpetrators from engaging into such unlawful act, but they are yet still happening.

He says with the increase in the number of youths getting involved in such harmful situation, government needs to be more practical, robust and take drastic actions or decisions to prevent such from happening,

"It is so embarrassing this morning to see my student being caught right-handed in such unlawful act especially, with his age and class."

He said in line with the Student's Handbook on campus, the administration will institute appropriate punishment befitting Student Melvin's offense and also threatened expulsion if he (Melvin) failed to bring his parents on campus.

Meanwhile, Student Melvin Brooks, who spoke to this paper early Thursday morning, confirmed the act and apologized to his parents and the school.

The minor disclosed this is not his first time taking the substance, disclosing that his elder brother introduced him to it at age 12 in 2019 in J. Las Cuz Community in Harper, Maryland County where he currently resides.


Melvin continued that he usually buys a parcel of marijuana for 50 Liberian Dollars from a male dealer in his community, take it to his brother and they smoke.

Though he didn't disclosed name of the trafficker to enable the Liberia Drugs Enforcement Agency make arrest, the JS Pratt High School in Harper had suspended three students before for similar bad habit.

The issue of students smoking harmful drugs is worrisome and alarming, as was highlighted recently during the third phase of President Weah's nationwide tour and engagement with citizens in Margibi, Grand Bassa and Rivercess counties.

The President challenged Liberians to be good citizens by exposing and reporting such practices to relevant authorities of government for prompt intervention.





L'Europe doit redéfinir son cadre budgétaire

ARIS - Seuls six pays disposaient de règles budgétaires au milieu des années 1980. Au dernier comptage du Fonds monétaire international, en 2015, ils étaient 96. La plupart s'étaient dotés de dispositions visant à limiter la dette publique, le déficit budgétaire, ou les deux, et certains de règles additionnelles d'encadrement des dépenses publiques.

Cette volonté d'endiguer pouvoir discrétionnaire a certainement été l'effet d'expériences traumatisantes : la "décennie perdue" en Amérique latine qui a suivi une série de crises de la dette dans les années 1980, l'ajustement douloureux subi par les pays pris au dépourvu par la hausse des taux d'intérêt au début des années 1990, ou la crise européenne des dettes souveraines de 2010-2012.

Mais l'attrait pour les règles provient également d'une méfiance à l'égard de l'activisme budgétaire. En 2000, John Taylor, de l'université de Stanford, a bien saisi l'esprit du temps lorsqu'il a écrit qu'il était "préférable de laisser la politique budgétaire jouer son rôle contra-cyclique principalement par le biais des stabilisateurs automatiques", en d'autres termes, de la mettre en pilotage automatique. Le consensus de l'époque était que la politique monétaire est un outil plus agile et plus efficace, car les décisions sont prises par une banque centrale indépendante et mises en œuvre d'un simple trait de plume.

Ces règles ne sont nulle part aussi détaillées et prescriptives que dans l'Union européenne, dont le règlement budgétaire compte près de 100 pages. Il y a de bonnes raisons à cela. Parce qu'ils partagent leur monnaie avec d'autres, les membres de l'euro ne peuvent pas réduire le poids de leur dette en jouant sur l'inflation. Comme l'a fait remarquer avec perspicacité Paul De Grauwe, de la London School of Economics, c'est comme si ces États empruntaient dans une monnaie étrangère. Or une dette publique excessive pousse les pays partenaires à venir à la rescousse plutôt que de devoir faire face aux retombées financières de la restructuration de la dette ou, pire, de la sortie de l'union monétaire. C'est ce qui s'est passé avec la Grèce dans les années 2010. La raison d'être d'une prévention de l'irresponsabilité budgétaire est incontestable.

Mais la codification extensive du comportement budgétaire provient aussi de mauvaises raisons. L'Allemagne est traditionnellement méfiante à l'égard de politiques de stabilisation (ce qui ne l'a pas empêché de réagir vigoureusement à la crise financière, puis à la crise sanitaire), et les petits pays d'Europe du Nord le sont encore plus. En outre, les États membres de l'UE ne se font pas confiance. Ils ont donc empilé les réglementations, au point que la plaisanterie à Bruxelles est qu'une seule personne au siège de la Commission européenne maîtrise la complexité qui en découle.

Les temps ont cependant changé. Depuis douze ans, les taux d'intérêt monétaires sont bloqués à un niveau proche de zéro, ce qui discrédite la célèbre efficacité de la politique monétaire. Plutôt que de protéger la banque centrale d'éventuels divagations budgétaires, la priorité dans un tel environnement est de faire en sorte que politique monétaire et la politique budgétaire puissent fonctionner en tandem. Brisant un tabou, Isabel Schnabel, membre du Directoire de la Banque centrale européenne, a souligné que la situation exigeait à la fois des politiques monétaires et budgétaires nonconventionnelles, et qu'elles devaient se compléter l'une-l'autre en vue protéger l'économie contre des épisodes récessifs importants. Comme l'expose un récent rapport de Genève, le concept longtemps oublié de policy mix est de nouveau d'actualité.

Parallèlement, les inquiétudes concernant la solvabilité des États se sont fortement atténuées. Comme l'a souligné Olivier Blanchard, l'ancien économiste en chef du FMI, aucune dette n'est insoutenable tant que le taux d'intérêt reste inférieur au taux de croissance. Telle est la situation depuis une décennie et même aux États-Unis, où les taux obligataires ont augmenté, cette condition reste largement remplie.

Le président Biden n'a pas perdu de temps pour en tirer les conclusions. Alors que le plan de relance lancé en 2009 en réponse à la crise financière était trop timide, son paquet de 1900 milliards de dollars, qui vient s'ajouter au programme de relance de Donald Trump, représente un puissant - sans doute même excessif - coup d'accélérateur.

Les regards se tournent désormais vers l'Europe. En mars 2020, elle a judicieusement activé une clause de sauvegarde de son cadre budgétaire. Celle-ci restera certainement en place en 2022, mais prendra fin en 2023 si la pandémie le permet. Un débat s'est engagé à la faveur de cette parenthèse pour savoir si les règles doivent être réformées avant d'être rétablies et, plus fondamentalement, si les initiatives budgétaires doivent être considérées comme un problème ou plutôt comme une solution.

Les arguments en faveur d'une réforme d'ensemble étaient puissants dès avant la crise sanitaire. Ils sont désormais incontournables. Les règles actuelles ont été conçues pour un monde qui n'existe plus. Elles sont opaques, limitent excessivement l'action budgétaire et reposent sur des objectifs numériques qui n'ont aucun sens dans un contexte de faibles taux d'intérêts. De plus, elles sont inapplicables : on ne peut pas demander à l'Italie, dont la dette devrait approcher 160 % du PIB cette année, de viser un ratio dette/PIB

Il ne faut pas se tromper : la responsabilité budgétaire est indispensable à une union monétaire. La question n'est pas de savoir s'il faut fixer aux États des normes exigeantes à respecter et les tenir responsables de leurs performances, mais de savoir comment le faire. Les réformateurs veulent conserver l'engagement en faveur de la discipline budgétaire mais changer le critère d'évaluation des comportements des États. D'autres préfèrent retoucher le Pacte de stabilité à la marge, car ils craignent que cet engagement ne survive pas à une renégociation. S'en tenir à un commandement dont la raison d'être a été perdue par crainte de ne pouvoir en définir un plus raisonnable, c'est cependant la meilleure façon de miner la confiance dans les règles.

La vertu de la crise sanitaire est qu'elle oblige à repenser ce qui fonctionnait par simple inertie. Sans aller jusqu'à la réforme radicale proposée par certains, il est possible de concevoir un cadre budgétaire qui préserve l'engagement essentiel en faveur de la responsabilité budgétaire, mais laisse plus de place aux choix discrétionnaires. Cela exige d'abord d'accepter que les pays ne peuvent pas tous se voir assigner le même objectif. Ensuite, cela implique une discipline budgétaire fondée sur des principes et soutenue par des institutions bien conçues, plutôt que par des objectifs numériques rigides.

L'Union européenne n'a pas hésité à concevoir des réponses sans tabou à la crise sanitaire. En s'engageant dans une réforme complète de son cadre budgétaire, elle montrerait qu'elle est suffisamment forte pour repenser la politique économique dans le contexte post-pandémique. Elle devrait ouvrir le débat sans attendre, dans la perspective d'un plan d'action d'ici un an.

s twin starting points: Today is your birthday; you departed this life on 20 November 2019. Reflecting upon your courageous fight for a corruption-free Liberia under the rule of Law, it is of deep concern to me how your venerated legacy is being exploited and poorly treated by some of our friends.





Liberian military commandant disrobed

he Armed Forces of Liberia (AFL) High Command has relieved Lieutenant Colonel Nyankun E. Williams of his post as Commandant of the Armed Forces Training Command (AFTC) on allegation of rape.

In a press release issued Thursday, 29 April by the Ministry of Defense, the authorities say the AFL High Command has forwarded Lieutenant Colonel Williams to the Military Police to face investigation.

The Military Police will conclude its investigation on 10

May 2021, and submit its findings to the AFL High Command for further actions, the release says.

On 26 April 2021, Sergeant Obento Roberts, presently serving the United Nations Peacekeeping Missions in Mali, formally complained against Lieutenant Colonel Nyankun E. Williams of allegedly having sexual intercourse with his (Roberts') 16 years old daughter.

Meanwhile, the Defense Ministry says Sergeant Obento Roberts has been recalled from the peacekeeping mission to aid the Military Police in the investigation.

The AFL High Command assures the public that all recommendations emanating from the investigation will be fully executed.

At the same time the AFL is assuring the public that it remains a "Force for Good," and will not tolerate any act that has the propensity to undermine the integrity of the Armed Forces of Liberia.-

5 **Super League club executives resign from Premier League roles**

ive high-profile club executives have resigned from their roles on Premier League subcommittees following the European Super League debacle.

Stats Perform News understands Manchester United executive vice-chairman Ed Woodward and Liverpool chairman Tom Werner have stepped down from the club broadcast advisory group, while Chelsea chairman Bruce Buck has left

the audit and remuneration committee.

Arsenal chief executive Vinai Venkatesham and his Manchester City counterpart Ferran Soriano have both resigned from the club strategic advisory group.

The moves came to light just 11 days after these clubs, and Tottenham, declared on April 18 they would be joining a new Super League competition, which faced scorn before it was formally announced after news leaked out in the preceding bours



It provoked fury, with the 'closed-shop' element of the proposed new competition set to see six of the Premier League's biggest clubs guaranteed riches far beyond those available to their domestic rivals.

Within 48 hours, the project had collapsed as the Premier League clubs withdrew, but by showing they had been willing to join in the new league, and doing so without consulting others that may be affected, domestic rivals were left incensed.
