



# Fact-checking claims about food aid for Tigray

ith conflict continuing in Ethiopia's Tigray region and nearby areas, the government has made a series of claims about the problems in accessing much-needed food supplies.

We have checked some of these claims against what we know about the aid situation in Tigray. At the moment, there's no firm evidence to support this claim about the Tigray People's Liberation Front (TPLF).

The TPLF itself has told the BBC that the government was "coming up with all kinds of excuses" to obstruct the movement of aid supplies into Tigray.

We know the conflict has intensified and spread beyond Tigray, and that land routes into Tigray from the Amhara region were closed.

And there are security issues affecting the one remaining route via the Afar region, which starts from the regional capital Semera, and goes northwards into Tigray at Abala.Road access through the Amhara region was blocked by militias who support the Ethiopian government, rather than by Tigray forces.

The UN has referred to an incident at a checkpoint in the Afar region on 28 July on the way to Tigray, where two trucks were said to have been stopped and looted by civilians.

But it's not clear who was involved, and whether Tigray rebel forces were in that area at the time. The UN said that in late July, there'd been various reasons for delays, including the need for permission from the Ethiopian authorities, as well as numerous checkpoints along the route to Tigray. In a more recent statement on 11 August, the UN humanitarian affairs co-ordinating office said humanitarian access had "significantly improved", with an estimated 75% of the area accessible. But it also said the flow of humanitarian supplies into the region remained

"insufficient".

We asked UN agencies if have not received a response.

In any case, the World Food Programme says it needs to send at least 6,000 tonnes of food a week during August, which means 100 trucks going into Tigray every single day. The Ethiopian government said that flights into Tigray would be allowed from early July - after being banned in June.



WE HAVE LEARNT reliably that the suspended manager of the Port of Buchanan in Grand Bassa County Charles McArthur Gull and Chief Statistician Amara Kamara currently facing investigation for diverting over US\$300,000.00 of port fund to a private account have absconded. How this happened we are not interested but one thing that should be clear is they did not act alone.

### **Apocalypse or Cooperation?**

the glaring message of the perfect storm of COVID-19 and climate change that has now broken. The pandemic is unlikely to end for years, as the novel coronavirus mutates into increasingly transmissible, drug-resistant variants. And the climate catastrophe is no longer "impending" but playing out in real time.

The latest report by the Intergovernmental Panel on Climate Change - whose assessments predate the extreme climate events of the past year tells us that some drastic adverse climatic changes are now irreversible. These will affect every region, as the recent heatwaves, wildfires, and floods demonstrate. They will also severely damage many natural species, and adversely affect the possibilities for and conditions of human life.

level (even if above the 2015 Paris climate agreement goal of 1.5°C) will require a massive effort, involving sharp economic-policy reversals in every country. Major changes in the global legal and economic architecture will be essential.

For its part, the pandemic has devastated employment and livelihoods, pushing hundreds of millions of people, mostly in the developing world, into poverty and hunger. The International Labour Organization's World Employment and Social Outlook Trends 2021 shows the extent of the damage in grinding detail. In 2020, the pandemic caused the loss of nearly 9% of total global working hours, equivalent to 255 million full-time jobs. This trend has continued in 2021, with working-hour losses equivalent to 140 million full-time jobs in the first quarter and 127 million jobs in the second quarter.

On current trends, projected employment growth will be insufficient to make up for these losses. So, even in 2022, total employment will be lower than in 2019 by the equivalent of at least 23 million full-time jobs. This is despite relatively that labor-market deterioration in other, mostly poorer, regions will be even sharper and more intense. Moreover, the "new" jobs associated with recovery from the pandemic will be predominantly low-paying and poor quality.

Meanwhile, economic inequality between and within countries has reached levels that were unimaginable in the already extremely unequal pre-pandemic world. While many people face substantial income losses, declining access to tiny minority of the extremely wealthy and a few large corporations have grabbed even more income and wealth, thereby multiplying their assets.

Today's new forms of conspicuous consumption such as the world's richest man, Jeff Bezos, recently spending \$5.5 billion for a four-minute ride around suborbital space - are literally out of this world. This amount could instead have funded the COVID-19 Vaccine Global Access (COVAX) facility to provide vaccines to two billion people in poor countries, who are currently unlikely to get them in the next two years.

This state of affairs obviously cannot continue for long without major social tensions and civil unrest. Indeed, the perfect storm we are beginning to experience will soon include much more social and political instability. Rather than

EW DELHI - The Apocalypse is now. That is spurring a progressive and transformative agenda, this could descend into ethnic, racial, and other forms of conflicts, violence, and chaos.

> This nightmarish scenario can still be averted with substantially increased international cooperation on a few key issues. On climate, governments could collectively declare that they will cut carbon dioxide and other greenhouse-gas emissions more sharply in order to reach net zero in a decade, rather than several decades.

> Rich countries with high legacy emissions should obviously make the deepest cuts and transfer green technologies to the developing world without conditions, enabling the latter also to decarbonize rapidly. Funds for climate adaptation are now essential, and proposed global public investment can enable swift action on this.

Keeping future global warming to a manageable To control the still-raging pandemic, it is imperative to redistribute available vaccine doses immediately, and remove legal constraints on widening production through compulsory licenses. In addition, the pharmaceutical firms that benefited from large COVID-19 vaccinedevelopment subsidies must share their technology with other producers to increase supply, as the World Health Organization Council on the Economics of Health for All has recommended. Building resilient and decentralized manufacturing capacity, including in the public sector, will be vital in order to deal effectively with future pandemics and other health crises.

> As for economic policy, global tax cooperation is a no-brainer. Simple rules that would make multinational companies pay the same rate of tax as purely domestic firms, and ensure that the revenues are shared fairly between countries, would reduce inequality and provide fiscally constrained developing economies with muchneeded resources.

Likewise, an international sovereign-debt resolution mechanism would reduce many developing countries' fiscal burdens, freeing up strong job growth in the United States, meaning space for urgent spending. Regulating highly mobile cross-border finance, reining in creditrating agencies, and introducing conditions that make finance respond to social needs also will require international regulatory cooperation.

Unfortunately, the current state of global politics means this necessary and feasible agenda is unlikely to be realized. Leaders of major countries have so far displayed a pathetic lack of ambition. Instead, they have paid lip service to these existential challenges, while remaining basic needs, acute deprivation, and hunger, a subservient to private capital and vested interests, and all too willing to play to national and local galleries.

> The attitude of G7 governments, which are more obsessed with China's rise than with preserving our increasingly fragile world, has been especially depressing. Their COVID-19 vaccine nationalism is short-sighted and obscene, while their rigid attachment to intellectual-property rights allows private firms to restrict knowledge and production in order to maximize their profits. These stances have reduced trust and hampered international cooperation to tackle the pandemic.

> Humanity still has a chance to step back from the brink. Will it do so, or will future species wonder why we chose to participate actively in our own destruction?

#### The Tusk Effect

ARSAW - In July, Donald Tusk, the former European Council president who previously served as Poland's prime minister from 2007 to 2014, returned to Polish politics. Many voters remember him as the politician who raised the country's retirement age - a policy that was reversed in 2017 by the Law and Justice Party (PiS). In fact, the PiS has blamed Tusk for pretty much everything that is wrong in Poland.

Other paranoid accusations leveled against Tusk include that he collaborated with Russian President Vladimir Putin in 2010 to arrange the plane crash that killed President Lech Kaczynski, the identical twin brother of PiS leader Jaroslaw Kaczynski, and that he is, in fact, a German backed by Chancellor Angela Merkel.

But Tusk is a consummate pragmatist. He admits that he made some serious mistakes during his tenure as prime minister. He now believes that people should be able to choose whether they want to retire earlier or get a larger pension for retiring later. He is less economically liberal than he was before, conceding that the state should be more active in redistribution. Like the rest of the Polish political class, he acknowledges that the PiS government's many generous social programs are popular. There will be no returning to the neoliberalism that dominated Poland after 1989, in the era of then-Finance Minister Leszek Balcerowicz's "shock therapy."

Tusk's return has had an electrifying effect. His party, Civic Platform, immediately regained the lead among the opposition, with its support rising from 16.9 to 27.3 in the space of a month. Moreover, an analysis of the polls shows that he has won over as many as one million new voters for the opposition. As one commentator put it, Tusk has rolled in like a tank to challenge the infantrymen of PiS and the other opposition parties.

The atmosphere within Civic Platform has also changed. The party's previously comatose politicians have woken up. Tusk is traveling the country and meeting activists, local government officials, and ordinary people. At press conferences, he answers even hostile questions, including from PiS-aligned media outlets. Not allowing himself to be provoked, he both admits to past mistakes and offers sharp ripostes - a style that contrasts starkly with Kaczynski, who never takes questions at press conferences.

Tusk's strategy is to serve as a kind of father of the opposition. He not only avoids disputes, but also praises other opposition leaders effusively. He is not the kind of politician who wants to share power; but, for now, he is focused on defeating PiS. That goal comes with significant career risks. Although Kaczynski has a significant resource advantage (presiding over the state budget, public media, state-owned companies, and European funds), losing to him nonetheless would be a grave embarrassment for Tusk.

Tusk's return has also intensified Kaczynski's war on Poland's independent media. To limit the opposition's electoral prospects, PiS has tried to pull the plug on the country's largest private television station, TVN, and its news channel, TVN24. Because the station is owned by the US company Discovery (which is in the process of merging with another American firm, WarnerMedia, the parent company to CNN), PiS has introduced a law that would bar entities from outside the European Economic Area from controlling television entities operating on the basis of a license issued in Poland.

PiS pretends that it wants to protect Poland's media market from takeovers by other countries, such as Russia, China, or an Arab state. But, giving lie to this claim, the PiScontrolled National Broadcasting Council has been delaying the extension of TVN24's broadcasting license for 18 months, simply out of spite. The station now has fewer than 50 days left to secure a renewal.

Poland is thus spurning the country on which it most depends to maintain its own national security. The United States has repeatedly signaled its opposition to PiS's actions, with a bipartisan group of US senators warning in a recent joint letter that:

"These and other steps, which Poland - a NATO ally and close friend and partner of the United States - has recently taken, do not reflect the shared values that underpin our bilateral relationship. Any decision to implement these laws could have negative implications for defense, business, and trade relations. We urge the Polish government to pause before acting on any measure that would impact our longstanding relationship."

The message here is clear. If the law is enacted, Poland can forget about any large weapons contracts, an increased American military presence (beyond the 5,000 US soldiers who currently rotate through the country), or any state visits. Of course, that last point may well suit Kaczynski, who bet everything on Donald Trump remaining in power and now sees no reason to cooperate with US President Joe Biden's administration.

Still, there is opposition to the so-called "Lex TVN" even within the ruling camp, where a small group of deputies led by the conservative member of parliament Jaroslaw Gowin has pulled out of the PiS coalition government, opening the possibility of it falling soon.

Kaczynski appears willing to sacrifice the Polish-American alliance in an attempt to obliterate the opposition's electoral chances. He is even more desperate now that the country's COVID-19 vaccination campaign has stalled, setting the stage for a fourth pandemic wave and possibly another lockdown. Worse, anti-vaccination sentiment is rising within the right-wing electorate, including among PiS voters. That means the government cannot risk using coercion or discrimination against the unvaccinated to head off more infections.

On top of everything else, Poland is still in a dispute with the European Union over the independence of the judiciary, leaving it vulnerable to having its EU funding cut off. Lacking a stable parliamentary majority and facing the possibility of a fourth wave, PiS thus finds itself on a collision course with not only its own electorate, but also with the EU and the US.

Still, Tusk must pierce the ceiling of 25-30% support to overtake PiS in the polls. The coming months will show us how strong he is, and how weak Kaczynski may have become.

#### **Big Tech Flies Too Much**

UNAFUTI, TUVALU -Last year, Microsoft announced that it will be carbon-negative by 2030. "If we don't curb emissions, and temperatures continue to climb," the firm said on its official blog, "science tells us that the results will be catastrophic." Microsoft deserves credit for publicly discussing the climate crisis, being transparent about its own greenhouse-gas (GHG) emissions, and at least having some sort of plan to reduce them.

But the elephant in the room is that Microsoft is one of the top ten corporate buyers of commercial flights in the United States. Before the pandemic, in the financial year 2019, the firm's business travel alone accounted for 392,557 metric tons of GHG emissions.

That's far more than my entire Pacific island country emits in a year. Tuvalu is well known for its vulnerability to the effects of climate change. We contribute almost nothing to global GHG emissions, but their consequences affect us on a monthly or even daily basis.

Microsoft's high level of corporate air travel is not a good look for a company that talks big on climate, sustainability, and racial justice, especially one that literally has its own videoconferencing platform. Surely an advanced tech firm that claims to be "reimagining virtual collaboration for the future of work" should practice what it preaches, crank up Microsoft Teams, and fly less.

But Microsoft is hardly an outlier among tech firms. Five of the ten largest buyers of corporate air travel in the US are technology companies: Amazon, IBM, Google, Apple, and Microsoft. These digital giants, along with the big consulting firms, are also among the top buyers of flights globally.

Although one might expect these big, growing companies' large number of employees to fly to many meetings, there are plenty of even bigger employers that fly less. Companies that tout technological innovation as the key to tackling climate change should be savvy enough to use video calls, rather than shuttle employees around the planet on airlines that before the pandemic burned 7-8 million barrels of oil per day - more than India.

In May last year, a paper in the journal Nature Climate Change found that the pause to aviation accounted for 10% of the decrease in global emissions during COVID-19 lockdowns. Given that only 4% of the global population took an international flight in 2018, and that half of all aviation emissions come from just 1% of the global population, this outsize impact shows not only how often the 1% fly, but also that flying is a function of privilege. And according to the International Air Transport Association, many, if not the majority, of frequent flyers are businesspeople.

Microsoft, which is so committed to business travel that it has its own priority check-in lane at Seattle-Tacoma International Airport, sits near the top of a highly unequal and skewed global carbon hierarchy. The wealthiest (and often the whitest) pollute the most, while those who emit the least - predominantly people of color, the socially vulnerable, and inhabitants of the Global South, including the Pacific - bear the costs.

Comparatively wealthy flyers must recognize their responsibility to those less fortunate, who deserve to live without fear of global warming's effects. Climate-vulnerable people want to maintain their homes and identities as citizens of their country, rather than being forced to migrate elsewhere.

If concern for equality and climate justice won't cure Big Tech's corporate flight addiction, maybe money will. The profits of Amazon and other large technology firms soared during last year's lockdowns, even when commercial flights were reduced to zero for many months.

Chief financial officers and accountants are therefore now wondering whether the expense of business flights makes any sense. Employees can hold more meetings in a day via videoconference, and business flyers say the pause in air travel either had no impact on their productivity, or actually improved it.

Bill Gates has predicted that business travel will decline by half after the pandemic. If that's the baseline, then what would a company truly committed to urgent climate action do?

With that question top of mind, a coalition of NGOs, activists, and Microsoft customers recently launched JustUseTeams.com, calling on Microsoft to take the lead and announce that it will permanently lock in all of its 2020 reduction in business flights. Once Microsoft shows some leadership on this issue, the campaign will expand to other tech firms. On the road to net-zero emissions, any step that advances that goal while saving a company millions of dollars a year should be considered low-hanging fruit.

Tech firms will claim that they have been trying to pluck it, but their actions are inadequate to the climate crisis we face. Microsoft, for example, is part of an initiative to promote sustainable fuels. But the airline industry has consistently failed to meet its own targets for scaling up such fuels, which still account for less than 0.1% of the sector's use.

Meanwhile, many Big Tech firms buy "carbon credits," and maintain that this somehow erases or "offsets" their own flight emissions. But this claim is losing whatever scientific credibility it once may have had. A recent investigation revealed that the most popular carbon-offset scheme used by airlines is based on a flawed system, in which so-called "phantom credits" are often sold on the promise to protect forest areas that were never at risk of being cut down. In reality, neither airlines nor their biggest corporate customers are in a position to claim that their flights are "carbon neutral."

Microsoft and other big technology companies therefore must commit to remain permanently at their 2020 flight levels. This is possible, necessary, and fair. It is also good business.

### Developing Liberia is a National Emergency: Reasons for Underdevelopment of Liberia

Liberia has remained underdeveloped even though she has vast natural resources (gold, diamonds, timbers, fertile soil for agriculture etc.). The county's leaders have for the better part of 174 years gone out begging for assistance. Our leaders have failed to maximize the potential we have of becoming a great nation. They wait instructions from power leaders and nations to tell them what is good. The country got political independence 174 years ago but yet she is an economic slave. She entered bigot concession agreements and gave the right of our resources to companies owned by former slave masters.

The former masters control the economy, hence dictate to politicians on what is good for their people. They make us believe that nothing good comes from Africa (foods, clothes, drinks, education etc.). These leaders spend over 50% of the national budgets to purchase foreign items thereby creating jobs in the former colonial masters' countries at detriment of theirs. The 'WHY' of this phenomenon has jaded my little mind and I have tried to answer the question.

Unlike Liberia, some countries in Africa are developing much faster than others. I once asked a friend this question and he said to me that many people in Africa, particularly government officials who should champion development do not allocate resources for programs/infrastructural development. He further said in many Africa cities, if one travelled and returned twenty years later, he would not see any change in the neighborhood where he left after years of absence. To prove or disprove him, I visited Soniwein, a small community behind AME University on Camp Johnson Road, where I once lived 50 years ago, and realized my friend was right.

The purpose of this article is to share my answer to the question 'Why' Liberia continues to remain underdeveloped. The answer to the 'why' has always been under our noses and yet we cannot see it. We have been blinded for over 100 years. To answer the question, I first want to ask many of our political actors and even our intellectuals if they have seen and read a book titled "Small is Beautiful" by Ernst FrederichShumaecher, published in 1973. In this book, the author identified the greatest enemies of development. He identified these enemies as Envy and Greed. The author said that these two human vices, if systematically cultivated, the inevitable result is nothing less than the collapse in human intelligence.

Political actors driven by these human vices lose the power to see things as they really are. And if a nation is infested by these vices, the political actors become increasingly incapable of solving the nation's most 'elementary' problems of everyday existence of the people. These vices make political actors live on ideas that conflict with the constitution and laws governing the country and the universe. Whenever a nation reaches this stage, conflict abounds, because the people will demand answers from their political leaders.

Hence it was not surprising to many people the events of 1979 Rice Riot, the 1980 Coup d'état, and the 1990 popular uprising that resulted in the killing of over 250,000 Liberians and the destruction of the very fabric of our society (health care, water and sanitation services, the energy sector, education, agriculture and basic infrastructures (roads and bridges).

When former masters realized that our leaders are covetous and greedy, they identified those leaders that are envious and greedy and used them to unseat progressive Leaders, who wanted and want to develop the country. The first Coup d'état in Liberia happened 150 years ago and it has continued. Even some of the civic crises and conflicts in Liberia are masterminded by the former masters for their interest.

Over the past 150 years, since the first military coup d'état many African countries have declined economically, socially, educationally and infrastructurally. However, some have bend back and are on course. For example, Ghana has recovered and has achieved her vision of 2020. In the case of Liberia, she has not. She has mortgaged her sea port, energy sector to the former colonial masters. Just investigate, who are the individuals behind the ATM Terminal contract and the LEC Management Contract.

In respect of infrastructure, before the military coup d'état, most of the road networks in Liberia were not paved, but even a sedan could be driven from Monrovia to Harper or Foyain under two days. Today, 41 years later, even 4x4 vehicles take more than a week to cover the distance to these cities. Things have gotten worse over the past sixteen years. These two human vices give birth to egocentricity and corruption. I will address each of these for the reading public to understand.

#### 1. Egocentricity

In many African countries the national budgetsare drafted to give worth to political actors. Just review the salaries and wages of these actors. The employees/compensations are often 50% plus of the national budgets and the lion share goes to the members of the parliament, the presidents and the ministers. Some countries have approved national budgets between US\$500 to 600 million and employees' compensations are US\$296.0 million (56.22%). There are No budget lines for programs and as a result the educational, agriculture, health and infrastructure sectors are in deplorable condition. In some countries the conditions are so bad that you might want to send you 'dog' for treatment in the clinic or heath center.

Even if the revenue envelope dropped from US\$600 million to US\$535 million these political actors do not adjust their salaries and wages, what is interesting is that they in fact increased the salaries and wages and sometimes introduced budget lines to get more money in their pockets. It is often the donor partners that raised

the Red Flag and because they want the donor partners to support the budget, they complied to whatever is recommended by the partners. Some Finance and Economic Development ministers sometimes claimed a budget surplus. But nobody sees the impact because salaries of the government employees continue to be delayed in the wake of the surplus.

I do not know how many of our political actors have this book by Robert Klyosaki and Sharon Lechter "Rich Dad Poor Dad". In the book, the authors suggested that whenever a person's financial situation changes, he/she needs to adjust his/her expenditures. It is only men and women of greed that fail to do this.

Many of the political actors in Liberia believe that their country is a middle-income country. This notion is false. It is time to face the truth. Only a few countries in Africa are working toward becoming a middle-income country and Liberia is not one of those countries. The Sirleaf Administration developed Vision 2030 (Making Liberia a Middle-Income). Country by 2030). The projected cost of achieving this vision was estimated to be US\$5.0 billion. If we as a country had aligned our national budget on some of the activities instead of developing new goals and vision, we would be moving in the right direction. This is what Ghana did to all succeeding governments after Jerry Rawling for the 2020 vision plan. Today, she is 90% there. Until African Leaders begin to continue what their predecessors started, many countries will continue to be underdeveloped.

#### 2. Corruption

Corruption has many definitions but for the purpose of this article, we will look at two definitions. Corruption as defined by the World Bank as a form of dishonesty or criminal offense which is undertaken by a person or organization that is entrusted with a position of authority, in order to acquire illicit benefit or abuse power for one's private gain. Another definition is the abuse of entrusted power for private gain. Both definitions apply to the abuse of power for private gain.

In Liberia those who are entrusted to allocate the resources for the development often allocate those resources for private gains. For example, such budget lines, Presidential Projects and Legislative Engagement, as well as the Legislative projects. These funds go directly to them. They are thereby putting money in their pockets and making them wealthy. If funds are allocated to such projects, how much is left for government projects? Absolutely little or nothing. During the days of Kwame Nkrumah, SekouToure, Tubman, Tolbert, Doe, Siaka Stevens etc., all the late presidents never allocated funds for presidential projects. This is new in Africa. This new act on the part of Political Leaders is not corruption but BROAD DAYLIGHT STEALING of the RESOURCES. Are the Legislators and the presidents of these countries beneficially? The answer is yes. Hence this is an act of corruption as by the World Bank's definition.

Corruption erodes trust, weakens democracy, hampers economic development and further exacerbates inequality, poverty, social division and environmental crisis. These budget lines put thousands of dollars in the pockets of these actors and no budget line for programs to uplift the ordinary citizens from poverty; hence, the citizens go to them begging for handouts. They become demigods/slave masters for the ordinary citizens.

These actors also allocate huge quantities of petroleum products to themselves. In some countries members of parliament/legislators allocate 500 gallons of petroleum products monthly (equivalent of US\$1,600.00). Some of them even said this quantity is small. In countries they received gifts to ratify concession agreements.

Example in 2006, the Legislators of Liberia received 103 pickup trucks from ArcelorMittal this company's concession agreement was under review by these lawmakers. Immediately upon the receipt of the pickup trucks, the concession agreement was ratified under 48 hours. This is corruption. It is alleged that all68 concession agreements entered into during Sirleaf's Administration, were embroidered with incentives for each ratification, and that is why sixty-six of the sixty-eight concession agreements did not meet international standards or best practices.

If those that have oversight are corrupted what hope is there a corrupt free government?

In the 1970s and 1980s corruption in the Legislature was not heard of. Maybe there was, but at low key. Corruption was mainly in the Executive Branch of the Government (Ministries and Autonomous Agencies). When the coup d'état occurred on April 12, 1980 in Liberia, the military leaders said they overthrew the Tolbert Government because of Rampant Corruption and Nepotism.

A year after the coup d'état, a United States Technical Advisor assigned to the Ministry of Finance wrote that during the Tolbert Administration the door of corruption was wide enough for a Volkswagen to drive through but under the Doe Administration it was wide for Helicopters to fly through. President Sirleaf labelled corruption as a Vampire. She once said "I did not give it to them, they took it"; reference to the benefits of the Legislators in the National budget. Under the Weah Administration, the corruption door is so wide that the largest Cruise Ship, the Harmony of the Sea can easily ship through. During the Doe Administration corruption was only rampant in the Executive; during the Sirleaf Administration corruption extended its tentacles in Legislature, and under the Weah Administration corruption has extended its tentacles in Judiciary for the first time in the history of Liberia. It is alleged that all three Branches of Government are deemed corrupt to the extent even the children can discern this national anomaly.

#### **Coast confirmed Ebola case**

ealth authorities in Ivory Coast have a case of the Ebola virus in the Cocoa rich West African country, with the victim being an 18 year-old Guinean national.

In a statement issued by the Ivorian Government on Saturday August 14, authorities at the Ministry of the CHU of Cocody, on a young girl aged 18, of Guinean nationality.

According to the statement, the young girl left Labé in Guinea for Abidjan by road. She arrived in Côte d'Ivoire on August 11 and was diagnosed and taken care of immediately by Ivorian health services on August 12, 2021 at 8



Health, Public Hygiene and Universal Health Coverage said they were informed by the Pasteur Institute of Côte d'Ivoire, of a POSITIVE case of Virus Disease EBOLA after the examination of a sample taken on August 13, 2021 in the medical emergencies of

Authorities said this was an isolated and imported case.

The patient is currently said to be in isolation and cared for at the treatment center for Highly Epidemic Diseases at the University Hospital of Treichville.

The authorities stated that Ivory Coast has vaccines against Ebola. Government will vaccinate target groups (front-line health personnel, immediate patient contact, security forces at points of entry, etc.).

It further stated that on receipt of the results of the analyzes on Saturday at 7 a.m., an emergency meeting of the health monitoring committee was held today at 10 a.m., chaired by the Minister in charge of Health and 'Public health.

The government has since reactivated its community surveillance of the Ebola response, organized followup of all identified contacts, creating awareness, prevention, diagnosis and management of confirmed cases; immediate vaccination of target groups; ensure compliance with guidelines for the diagnosis and management of hemorrhagic fevers and the continuation of strict compliance with the barrier measures enacted against COVID-19 which remain valid for Ebola virus disease.

The Ivorian authorities also noted that it has intensified cross-border collaboration with Guinea, and has implemented a standard procedures of the

#### Un déficit persistant de leadership dans le Libéria de Weah

L'absence d'un leadership proactif dans la structure gouvernementale nuit gravement à l'administration de George Weah qui est au pouvoir depuis près de quatre ans maintenant. La mauvaise gouvernance alimentée par la corruption, les violations constitutionnelles, le favoritisme politique et l'incompétence, entre autres, est visible partout, depuis le plus haut échelon du gouvernement jusqu'aux fonctionnaires subalternes.

Les récentes vagues de protestations de masse des citoyens lésés à travers le pays démontrent un manque total de leadership dans l'administration.

Les expériences désagréables ont montré leurs têtes laides d'abord à Grand Cape Mount, en particulier à Robertsport, où des citoyens lésés sont descendus dans la rue parce que leur sénateur élu, Simeon Taylor, n'a pas encore pris son siège au Sénat en raison de contestations judiciaires qui durent presque un an, leur privant ainsi une représentation, en dépit du fait d'avoir fait leur choix dans les urnes le 8 décembre 2020. Une manifestation similaire s'est produite à Lofa où les citoyens veulent que leur sénateur élu, J. Brownie Samukai, qui fait face à une bataille juridique, siège au Sénat.

À Margibi, des commerçants ont barricadé la rue parce qu'on veut les relocaliser de force. Monrovia a été témoin de deux manifestations violentes et sanglantes, ayant fait plusieurs blessés. Des étudiants de l'Université du Libéria dirigés par le Student Unification Party (SUP) protestaient contre les cours en ligne, un programme mis en place par l'administration. Mais ils ont été violemment dispersés par la police anti-émeute à l'aide de grenades lacrymogènes. Il y a eu plusieurs blessés parmi les étudiants.

Pas plus tard que la semaine dernière, des citoyens lésés, dont pour la plupart des malinkés, ont marché de la Japan Freeway au temple de la justice et au siège de la police nationale dans le centre-ville de Monrovia, réclamant la dépouille mortelle d'un des leurs, qui serait mort du fait de la brutalité policière.

Toutes ces réactions distinctes des citoyens se sont produites en raison de l'absence d'une chose : le leadership. De Lofa à Cape Mount en passant par Margibi et Montserrado, les dirigeants n'ont pas fait preuve de leadership pour rassurer les citoyens que leurs intérêts étaient protégés. À l'Université du Libéria et le long de la Japan Freeway, si les dirigeants avaient été proactifs, les citoyens ne seraient pas descendus dans la rue pour protester.

Il faut rappeler à ceux à qui l'on a confié le pouvoir qu'ils sont placés à ces postes pour régler les problèmes avant qu'ils ne tournent mal, une responsabilité élevée qu'ils ne devraient jamais minimiser, comme l'indiquent ces expériences désagréables.

Il est temps que les dirigeants, de la Présidence au cabinet, en passant par la police, la justice et le surintendant du comté, rassemblent leurs actions pour diriger comme les dirigeants qu'ils devraient être pour rendre notre société stable et unie. #### **Apocalypse ou coopération ?**

■ EW DELHI - L'Apocalypse, c'est maintenant. C'est le message éclatant de la véritable tempête de COVID-19 et de conséquences du changement climatique qui a maintenant éclaté. Il est peu probable que la pandémie se termine avant plusieurs années, car le nouveau coronavirus mute en variants de plus en plus transmissibles et résistants aux médicaments. Et la catastrophe climatique n'est plus « imminente » mais se joue en temps réel.

Le dernier rapport du Groupe d'experts intergouvernemental sur l'évolution du climat - dont les évaluations sont antérieures aux événements climatiques extrêmes de l'année dernière - nous dit que certains changements climatiques drastiques sont désormais irréversibles. Ceux-ci affecteront toutes les régions, comme le démontrent les récents incendies de forêt, vagues de chaleur et inondations. Ils endommageront également gravement de nombreuses espèces naturelles et affecteront négativement les possibilités et conditions de la vie humaine.

Maintenir le réchauffement climatique futur à un niveau gérable (même s'il dépasse l'objectif de 1,5°C de l'accord de Paris sur le climat de 2015) nécessitera un effort massif, impliquant de brusques inversions de politique économique dans chaque pays. Des changements majeurs dans l'architecture juridique et économique mondiale seront essentiels.

Pour sa part, la pandémie a dévasté l'emploi et les moyens de subsistance, plongeant des centaines de millions de personnes, principalement dans les pays en développement, dans la pauvreté et la faim. Les Tendances de l'emploi et des perspectives sociales dans le monde 2021 de l'Organisation internationale du Travail montrent l'étendue des dégâts dans les moindres détails. En 2020, la pandémie a causé la perte de près de 9 % du total des heures de travail dans le monde, soit l'équivalent de 255 millions d'emplois à temps plein. au sein des pays ont atteint des niveaux inimaginables dans le monde pré-pandémique, déjà extrêmement inégalitaire. Ce scénario cauchemardesque peut encore être évité grâce à une coopération internationale substantiellement accrue sur quelques questions clés. Concernant le climat, les gouvernements pourraient déclarer collectivement qu'ils réduiront plus fortement les émissions de dioxyde de carbone et d'autres gaz à effet de serre afin d'atteindre le zéro net en une décennie plutôt qu'en plusieurs décennies.

Les pays riches avec des émissions historiquement élevées devraient évidemment mettre en œuvre les réductions les plus drastiques et transférer les technologies vertes au monde en développement sans condition, permettant à ce dernier de se décarboner rapidement. Les fonds pour l'adaptation au climat sont désormais essentiels, et les investissements publics mondiaux proposés peuvent permettre une action rapide à cet égard.

Pour contrôler la pandémie qui fait toujours rage, il est impératif de redistribuer immédiatement les doses de vaccins disponibles et de lever les contraintes légales sur l'élargissement de la production par le biais de licences obligatoires. En outre, les entreprises pharmaceutiques qui ont bénéficié d'importantes subventions au développement de vaccins contre la COVID-19 doivent partager leur technologie avec d'autres producteurs pour augmenter l'offre, comme l'a recommandé le Conseil de l'Organisation mondiale de la santé sur l'économie de la santé pour tous. Le renforcement de capacités de fabrication résilientes et décentralisées, y compris dans le secteur public, sera essentiel pour faire face efficacement aux futures pandémies et autres crises sanitaires.

Quant à la politique économique, la coopération fiscale mondiale est une évidence. Also speaking, the head of the project, Yekeh Solunkbah said the project is having approximately about 500 workers from across the entire Salahyah District, Bong County. He added that the people who are working on the farm are paid on a daily basis and they are fed three times a day with full support from the farm owner, Dr. Whapoe.

Solunkbah revealed that the project has done much for the citizens of Bong County, helping them to solve other family problems with the little money they get from the farm as pay.

Further, Solunkbah disclosed that they have invested about LRD\$5 million on the farm for salaries and logistics, among others.

He praised Dr. Whapoe for having found passion in agriculture, particularly in growing Liberia's staple food rice, knowing that it has been part of the many plights of the people here.

For their part, the women, youth, elders and farm workers expressed excitement over the initiative and vowed to work with Dr. Whapoe.

According to them, as Dr. Whapoe has decided to address their challenges ranging from road, clinic, school and safe drinking water, they will help him in everything that he does, noting that God will continue to bless him for his kindness.

he travel ban placed on several government officials linked to corruption here appears to be belated, as this paper has learned that some of the suspects named on the travel restrictions' list had left the country earlier before the ban order was issued.

A source hinted this paper Sunday that Mr. Charles McArthur Gull who recently admitted to stealing US\$300,000 from the Buchanan Port coffers in Grand Bassa County along with his Chief Statistician Amara Kamara are believed to be in the United States.

#### How did it happened?

Sources told this paper that Gull and Kamara had been issuing invoices to Mittal Steel for payment from their operations at the Port of Buchanan using a fake UBA account instead of the Port's Account to divert the fund.

This paper gathered that the steel company had made three different payments on three invoices at US300, 000 on each payment into this account before noticing that the account to which these payments were being made did not match that of the Buchanan Ports account.

The source said US200, 000 of this amount was transferred through an individual bank

Cllr. Edward Martins told this paper on Sunday that the LACC has invited Gull to come at its offices to answer some questions but he has been dodgy. "Since we invited him (Gull) he has been dodging," he said.

He appeared surprised when told that Gull and his Chief Statistician Kamara-two of the suspects on the travel ban list issued over the weekend were already in the United States.

However, he was confident that if indeed the information about the two Buchanan Port suspects were true, a recent commitment from the US Embassy near Monrovia to support the LACC in its corruption fight could be tapped into to get the suspects extradited back home to face justice.

"We hope to work with the U.S Embassy to have them extradited because the U.S. Government has promised full support to us to fight corruption," Cllr. Martins said

So, we believe that once extradition proceedings are completed in the court, we will have them back in Liberia," he added.

He said the LACC is considering going beyond the suspects mentioned in here to include all those that have been mentioned or linked to audit reports that have somehow left the territorial space of the LACC will be brought back to face the law.

Cllr. Martins a former Montserrado County Attorney took over the LACC about three weeks ago. He explains that the issues of the allegations of misappropriation and misapplications of funds at the Liberia Airport Authority, Water and Sewer Corporation and the Port of Buchanan have been on his desk and that all those involved are undergoing investigations.

"We have started recovering some of the records for mismanagement and misappropriation. We can't conclude now (that is on the total amount involved) but we expect the Government of Liberia to aid us in getting the actual amount.

ire has destroyed the Charles Henry Rennie Hospital, popularly known as C. H. Rennie Hospital in Margibi County, leaving thousands of impoverished

The incident occurred at about 9:00 a.m. on Sunday, August 15, 2021, forcing hospital authorities to transfer in-patients to other health facilities in Kakata and Bong County.

No casualty has been reported but major components of the hospital, including the emergency response room, pharmacy, administrative offices and the records room are destroyed completely.

County Health Officer Dr. Augustine Fannieh, blames the incident on electrical fault. Hundreds of Margibians rushed on the scene in the Walker Farm Community where the hospital is located and made frantic efforts to off the fire

Wreh, whose district hosts the hospital, expresses serious frustration about the fire disaster and calls on residents of the county to remain calm as residents who cannot afford to authorities and relevant go to private hospitals stakeholders collaborate to find a way forward.

> Thousands of Margibians are expressing dismay over the incident, wondering where they will refer cases from other health centers in the county at minimum cost, as Du-Side Hospital in Harbel is privately owned and operated by Firestone Liberia Plantations.
