Meanwhile, the security cordon has grown bigger, along with the number of soldiers and police officers.

A man is overheard telling the workers to wait for a hearse to drive closer to the site instead of carrying the bodies to where the vehicle is parked.

Two bodies were retrieved from the rubble in the morning, but no-one has been found alive since Tuesday morning.Near the site, a woman waits anxiously, occasionally taking calls from friends and relatives. Her boss is amongst those missing. He was a contractor working at the building.



EDITORIAL Signs of an emerging death squad

THE WAVE OF suspicious killings in Monrovia and parts adjacent is both scaring and very disappointing, particularly under a civilian administration where security or law and order should be paramount. However, it seems that ghastly killings in homes every other week or month have become common in our society with the authority at the highest level remaining conspicuously silent.

OUR ATTENTION IS drawn to the suspicious death of three high profile personalities, two of them officials of government and a highly established private citizen in just over a month.

ON TUESDAY, NOVEMBER 2, 2021 the Government of Liberia announced the death of Liberia's Peace Ambassador Rev. William R. Tolbert, III, youngest son of slain President Dr. William R. Tolbert, Jr. According to the Ministry of Information, Rev. Tolbert was discovered dead at his residence in Monrovia on Sunday, October 31, in what the Liberia National Police described as a suspected homicide. The same day, female officer Maude Elliott of the Liberia Immigration Service (LIS) said to be in her 50s, was found brutally murdered at home in Brewerville, outside Monrovia.

EARLIER, IN SEPTEMBER this year, specifically September 22, 76-year-old John Hilary Tubman, a son of another former President, William V.S. Tubman, was reportedly found dead lying face down in a pool of blood with deep cuts to his neck and forehead with pillow placed over his head at his residence in Fiamah community, Monrovia.

INTERESTINGLY, THESE PERSONALITIES were alone in their respective homes when they were brutally killed. These are nothing else, but targeted murders that raise concern about something sinister being perpetrated and Police investigations should be able to establish.

THERE WERE OTHER mysterious deaths in and around the city prior to these three specific cases listed above. And from the trend of events, we can deduce that there is a pattern being unleashed by a probable death squad that is roaming and seeking its next target.

THE KILLINGS BEAR similar wounds that were inflicted in specific parts of the body, indicating there is a hired killer or a group of hired killers involved. Who are they working for is yet to be established but their targets may signal something.

ARE WE RETURNING to the days of the Charles Julu death squad under slain President Samuel Kanyon Doe? God forbid! But the writings on the wall spell bad omen for our beloved country.

SADLY HOWEVER, CIVIL Society, religious leaders and institutions including men and women of moral conscience in our society are silent about the unfolding development. Today, the late John Hilary Tubman, Officer Maude Elliott and Rev. William R. Tolbert, III, are the latest victims of this creeping

American Democracy and Soft Power

AMBRIDGE - At a recent meeting of and reform. trans-Atlantic foreign policy experts, a • European friend told the group that he used to worry about a decline in American hard power, but felt reassured. On the other hand, he now worried more about what was happening internally and how that would affect the soft power that underlies American foreign policy. Are his fears justified?

Smart political leaders have long understood that values can create power. If I can attract you and persuade you to want what I want, then I do not have to force you or pay you to do what I want. If the United States (or any country) represents values that others find attractive, it can economize on sticks and carrots. US soft power rests partly on American culture and foreign policies when they are attractive to others; but it also rests on our values and how we practice democracy at home.

As international polls show, President Donald Trump's term in office was not kind to American soft power. This was partly a reaction to Trump's nativist foreign policy, which shunned allies and multilateral institutions, as well as to his administration's incompetent response to the COVID-19 pandemic. But even more damaging to US soft power was Trump's effort to disrupt the orderly transition of political power after he lost the 2020 election. And on January 6, 2021, as Republican Senator Ben Sasse described the invasion of the US Capitol, "the world's greatest symbol of self-government was ransacked while the leader of the free world cowered behind his keyboard tweeting against his Vice President for fulfilling the duties of his oath to the Constitution."

America's allies and other countries were shocked, and America's attractiveness was diminished. Can US soft power recover?

It would not be the first time. The US has outcome was finally certified by Congress. serious problems, but it also has a capacity for resilience and reform that has rescued it in the past. In the 1960s, America's legacy of against the Vietnam War grew increasingly violent. Bombs exploded in universities and government buildings. The National Guard

Unlike hard-power assets (such as armed forces), many soft-power resources are separate from the government and attract others despite politics. Hollywood movies and popular music showcasing independent women or empowered minorities can attract others. So, too, does America's diverse and free press, the charitable work of its foundations, and the freedom of inquiry at its universities. America's firms, universities, foundations, churches, and protest movements develop soft power of their own, which may reinforce others' views of the country.

But while peaceful protests can generate soft power, the mob in and around the Capitol on January 6 was far from peaceful. The events of that day were a disturbing illustration of the way that Trump exacerbated political polarization, which he continues to do by making his myth of a stolen election a litmus test in the Republican Party.

To be sure, the US had experienced an increase in political polarization well before Trump was elected in 2016. Trump's innovation was to exploit and exacerbate nativist populism as a political weapon to take control of the GOP, cowing congressional Republicans with threats of a primary challenge from his supporters. Many still are too scared to oppose his lies about the 2020 election. Fortunately, in a federal system, many state officials and legislators stood up to Trump's efforts to intimidate them into "finding" votes. Some pessimists worry whether this can continue.

For those who are mourning the demise of American democracy, it is important to remember that unprecedented turnout in the 2020 election unseated a demagogue. And the outcome was upheld in more than 60 court cases overseen by an independent judiciary, including some of Trump's appointees. And the

This does not mean that all is well with American democracy. The Trump presidency racism fueled major urban riots, and protests eroded a range of democratic norms. Polarization persists, and most Republicans believe his lies about the election. Social media business models exacerbate the existing polarization by relying on algorithms that profit from eliciting user "engagement," and companies like Facebook and Google, under pressure from public opinion and Congressional hearings, are only slowly beginning to respond.

SOCIETY SHOULD SPEAK out now before it becomes too late. It is citizens' alienable right guarantee by our Constitution to peacefully assemble, protest and petition their representatives against anything that threaten their peace and happiness. If the current killings must stop, Liberians should rise up now!

Yet within a decade, Congress enacted a series of political human rights policies of Jimmy Carter, and the optimism of Ronald Reagan helped restore America's attractiveness.

Moreover, even when protesters marched through the world's streets condemning American policies in Vietnam, they were more likely to sing "We Shall Overcome" than the "Internationale." The anthem of the civil rights movement illustrated that America's power to attract rested not on its government's policy but in large part on its civil society and its capacity for self-criticism

reforms, and the honesty of Gerald Ford, the At the same time, American culture still has sources of resilience that pessimists in the past have underestimated. Press freedom, independent courts, and the right to peaceful protest are among the greatest sources of America's soft power. Even when mistaken government policies reduce America's attractiveness, its capacity for self-reflection and self-correction makes it attractive to others at a deeper level. As I told my skeptical European friend, values change with generations, and the younger generation is a source of hope.

Parents decry fees hike in public schools

Several parents in Pleebo, Electoral district#2, Maryland County have accused public school administrators in the district of hiking fees despite the Ministry of Education's policy on fees in public schools.

They specifically named administrators of the Pleebo High School, Sodoken High School, and Lab4 High School as allegedly being involved in the act.

Speaking to this paper on Tuesday, November 2, 2021, several parents lamented that it's unfortunate that the Ministry of Education that is responsible to regulate schools both public and private, would have public schools not upholding policy fees.

"We wonder what the Ministry is doing; if they say Pro-poor and allow a government school in the county to charge poor market women like us LRD7, 350 for our children's school fees, then why they are Pro-poor for na?" They asked.

They said the sudden increment in fees by these government schools despite the ministry's policy, totally contradicts government Pro-Poor monitoring team to the County to check on these people because we have talked for long period of time now but no better".

"We think what is happening in this county is different from other counties but if one or two school administrations are served letters of suspension, they will come to themselves.

We have receipts to this situation so no government school administration within this district will say what we are saying is false; they all know", they disclosed.

When this paper contacted the County Education Officer (CEO) for comment on these allegations, Tehneseo Brohdoyen, Sr. said, parents are contributing factors to the hike of fees in public schools.

He said despite complaints about public schools inflating fees, his office has not received any formal complaint.

CEO Brohdoyen said parents should have informed their education officers about those issues confronting them.

However, he warned school administrators to desist immediately if the claims by parent are true, while calling on parents to do formal letters of



agenda.

Student Patience Weah, an 11th grader at Pleebo High School said, she was shocked when the Registrar informed her that the fees have jumped from LRD3,000 to LRD7,350 complaint so that appropriate measures would be taken against school administrators involved in violating government policy.

The CEO also cautioned school administrators to observe the mandate

She noted that because of the information from the Ministry of Education that public schools' fees shouldn't exceed LRD3, 000, her parents gave her the said amount but she was shocked to have heard about the sudden increment in fees.

"When the registrar of my school (Pleebo High School) called LRD7,350 I felt he was joking, so I presented my LRD3,000 but he refused and threw it back to me", Student Patience narrated.

Jocab Hinneh, a 12th grader from Sodoken High School said, he has paid LRD6, 500 as fees, alleging that the situation is not the first, because last year, they paid almost similar amount.

The both students, including their parents said these government schools have been violating government policy for a long time.

"We hope the Ministry will send her

Pleebo City Mayor Wellington Kyen, promised to intervene on grounds that his citizens' interest remains his concern.

"We will visit the various district education officers to know what really happened", Mayor Kyen said.

The chair of the Parent-Teacher Association of Sodoken High School Mr. Dio Wah, promised to speak on the matter at a later date.

Despite the outcry about sudden increment of school fees, the price of a 25kg bag of rice has increased from L\$2,800 to L\$3,500, while a gallon of gasoline has been hiked from LRD800 to LRD1,200, resulting to a corresponding increase in transportation fares. -*Editing by Jonathan Browne*

Liberian INGO Forum Hosts Annual General Meeting November 2, 2021, Monrovia– Liberia

Distinguished Members of the Media, our Partners in Progress, Donors, and the Public.

On November 2, 2021, the Liberia International Non-Governmental Organization (LINGO) Forum, a network of more than 40International NGOs working across the Republic of Liberia convened a cross-section of members for its Annual General Meeting (AGM) in Monrovia. The theme of the 2021 AGM was "Collective Impact-Resilient Future" reflecting on the collective impact of INGOs over the past 10 years towards building a more resilient future for Liberia.

This was the first AGM since the COVID 19 Pandemic was confirmed in Liberia. Many new INGO Country Directors/Representatives have joined LINGO Forum in the last year. As such, the event provided a platform for members and invited guests to better understand the role of LINGO as a collective network supporting the Government of Liberia's development agenda. In addition, it was an opportunity to reflect, take stock of INGOs' contributions and to outline and look forward to the future of civil society presence in Liberia.

Augustine A. Allieu, Immediate Past Chair of LINGO and Country Direct of SOS Children's Hospital opened the event with a holistic overview of civil society's contribution to the social, economic, and political development of Liberia over the past 10 years. Civil society in Liberia has been a critical force in the movement for democratization and played a crucial role in national reconciliation and peace building to date he noted. He further stated that CSOs also participated and/or facilitated in setting the development agenda at all levels, including county and national levels, including the then Poverty Reduction Strategy and the current Propoor agenda, as well as the development of sector plans in education, health, agriculture, social protection, and other areas.

A panel on Maximizing Collective Impact facilitated by Madam Facia Harris, National Women's Rights advocate brought together representation from the United Nations, Bilateral partner such as USAID and the national Civil Society council. Speaking on



Convening of all the INGOS together in Liberia to maximize impact, avoid duplication and use resources more effectively including Joint planning, coordination and resources mobilization is certainly what we should be doing more of said Neils Scott, UN Resident Coordinator in Liberia. He noted that there is a need to move beyond the term implementing partner, organizations for example, LINGO Network has more to offer so let's develop the power of partnership to better promote and achieve the SDG targets. He also added that measuring the SDG does not come naturally to many countries. Even in the most developed countries, only 40-50% of indicators are being measured. We need planning tools and a more systematic way of working with government, development partners including INGOS in working towards achieving the SDGs he added.

Madam Loretta Pope-Kai, Chair of the National Civil Society Council charged LINGO to strengthen its coordination with and investments in the National CSO council members to build back better towards a more resilient Liberia. LINGO must ensure timely engagements of CSOs, effective partnerships beyond just coimplementation but involved in setting the agenda, shared program design and planning, monitoring and evaluation, joint resource mobilization and directly holding the government accountable to work closely with international partners on implementation and outcomes. She also noted that in terms of sustainability, CSO is the direct representation for the community; therefore, it is necessary to ensure active participation from all---the government, INGOS, CSO, Women and Youth led groups and the community at large. She concluded by calling for facilitated national dialogue with CSO and INGO and government to review the state of affairs towards building a more resilient future for Liberia.

The 2021 AGM wrapped up with a session on internal reflections facilitated by Madam Faith Akovi Cooper, Chair of LINGO. Members engaged in an interaction session highlighting LINGOS successes and gaps including highlighting critical incidences in Liberia in which LINGO positioned its support as a unified front on

humanitarian response. When Covid-19 gripped the world, it put to test our collective resilience to the global pandemic. The fight against COVID-19 required a collective effort with strategic partnerships at its core. By Patrick N. Mensah, Maryland County he Liberia National Police in Pleebo, Maryland County Electoral district#2 has arrested 27-year-old Henry Weah for attempting to murder a motorcyclist in the district.

According to Police preliminary investigation,

as Papa God in Zone 11, New Pleebo community before making his way to Ivory Coast on Monday.

Narrating his ordeal, Victim Samuel Dialeh, a commercial motorcyclist said, on Monday, November 1, 2021 while in traffic, Suspect Henry Weah stopped him around Big Market Road and hired his service to take him (Dialeh) to the Pleebo

Weah returned, he asked Samuel to taken him to the border through Barreken for a fare of LRD\$1,800.

Victim Dialeh explained that when he charged the suspect the amount, Samuel Weah asked him to show where gold is sold and also to take him to his oldest brother house in New Pleebo.

"When we got there, we met his oldest brother and the three (3) of us got on the bike and came to the parking around the big market road. We stopped again and he went to the shop to sell the gold but I don't know the total amount, but I saw the man giving him money."



he Liberia National Police (LNP) and the Armed Forces of Liberia (AFL) with complementary support from the Liberia Disaster Management Agency, National Fire Service and Liberia Red Cross Society on Wednesday, 3 November 2021 ended a one - day joint command post and practical demonstration on crowed control and dispersal in Monrovia.

The command post and practical demonstration of crowed control and dispersal exercise is intended to ensure mutual understanding of the role of all agencies during response to crisis situation in Liberia.

The practical demonstration of crowed

watched an election violence in the country of Siberia where a party won an election, but its rival party rejected the result and cried fraud.

The synopsis continued where the opposition party of Siberia political leaders and supporters engaged in a major protest and demonstration, something which prompted the joint security to come in and restore calm.

At the physical demonstration and practical crowd control dispersal exercise activities, the LNP was assisted by the AFL when the crowd was overwhelming.

Also they were followed by the Red Cross, Fire Service and Disaster Management Agency who provided support for the protesters to save lives and properties.

The joint security at the scene changed strategically and responded depending on the

election," said Minister Dickson.

Liberia's Army Chief of Staff Major General Prince C. Johnson, III, said the examples displayed were fruitful based upon the four separate intelligence unite that they have setup and trained to provide and handle information during election period.

General Johnson continued that they have the Operation Watch Over Vi, the Joint Technical Operation Center (JTOC) Watch Over Vi and Sector "B" Operation with the media sector that will provide the right information to the public during the election period when examples displayed and anticipated happened.

"The AFL will help but it will be the last to come in when the police can't make it. However, with the training and lesson thought, I'm confident to say that I trust the police in handling these issues across the country," General Johnson added.

Awar. "We have NEC commissioners that have integrity. We are part of this so that in challenging time we can know how to get to the joint security to restore peace and stability," Cllr. Awar noted. For his part, the National Security Advisor to the President Mr. Jefferson Kanmoh disclosed that the exercise has shown in term of internal security operation, which one of the security forces should take the lead and how it will be done, adding that there should be more support to the team for the work.

n the margins of the COP26 taking place in Glasgow, Scotland, Commissioner of Maritime, Eugene Lenn Nagbe participated in a seminar arranged by the Liberia Ship Owners Council Board where he assured Ship Owners of vessels under the registry of the Liberian government of a pragmatic regulation, passionate client-service and support for the tireless seafarers who move the global feet as well as ensuring security and safety in the maritime sector.

"The maritime industry must continuously evolve and improve, but in a harmonious manner that is operationally and



"Over the past 12 months the Liberian government has initiated high-level diplomatic dialogue on this issue. I am personally committed to championing Liberia's initiative to



Les libériens doivent honnêtement se féliciter de l'accord amendé de l'AML

Le gouvernement du Libéria et la direction d'ArcelorMittal Libéria (AML). l'un des plus grands géants mondiaux de l'acier, ont récemment signé une version modifiée de l'Accord de développement minier (MDA).

Dans le cadre de l'accord, l'AML investiraprès de 800 millions de dollars supplémentaires au Libéria. Mais avant même que la copie modifiée du MDA ne soit signée, les citoyens des zones opérationnelles de l'entreprise dans les comtés de Nimba et de Grand Bassa ont protesté contre l'accord. Il y a eu une action en justice et des actes de harcèlement physique et d'intimidation avec la présence d'un masque traditionnel dans les locaux de la compagnie minière à Nimba dont l'intention était de mettre fin à ses opérations.

Mais toutes ces actions contre l'accord sont-elles vraiment iustifiées sans avoir pris son temps pour faire la lecture de l'amendement du MDA? Ou est-ce à dire que les Libériens ne font plus confiance à leur propre gouvernement avec le président George Manneh Weah aux commandes en ce qui concerne leurs intérêts dans cette concession?

Le New Dawn a feuilleté les points saillants de l'accord modifié et pense que les citoyens ordinaires ont beaucoup à gagner en termes d'emploi, de fonds de développement social régional, de bourses d'études et de formation professionnelle, entre autres grâce à l'investissement de l'AML et du gouvernement lui-même qui renflouera ses caisses grâce à cet accord gagnantgagnant.

En tant que premier investisseur majeur sous l'administration Weah, l'engagement d'ArcelorMittal à investir 800 millions de dollars US montre clairement que la société aspire à raviver la confiance des investissements du secteur privé dans l'économie avec plus de 2000 nouveaux emplois qui devraient être créés pendant la phase de construction, et à mesure que les volumes de production augmenteront, ses équipes d'exploitation généreront également 1 000 nouveaux emplois supplémentaires, ciblant les Libériens.

Opposition divisée :Cummings et Boakai continuent de se tirer dessus médias interposés

Par Joseph S. Nye, Jr. La démocratie américaine et le pouvoir de convaincre

AMBRIDGE - Lors d'une récente réunion d'experts de politique étrangère au groupe qu'il s'inquiétait auparavant d'un déclin du pouvoir de contraindre américain, mais qu'il se sentait à présent rassuré. D'un autre côté, il s'inquiétait davantage à présent de ce qui se passe en interne et de la manière dont cela pourrait affecter le pouvoir de convaincre qui sous-tend la politique étrangère américaine. Ses craintes sontelles justifiées?

Les dirigeants politiques intelligents ont compris depuis longtemps que les valeurs peuvent créer du pouvoir. Si je peux vous attirer et vous persuader de vouloir ce que je veux, alors je n'ai pas à vous forcer ou à vous payer pour faire ce que je veux. Si les États-Unis (ou tout autre pays) représentent des valeurs que d'autres trouvent attrayantes, ils peuvent faire des économies sur leurs programmes d'encouragement et de répression. Le pouvoir de convaincre des États-Unis repose en partie sur la culture américaine et sur la politique étrangère lorsqu'elles sont attrayantes pour les autres ; mais il repose également sur nos valeurs et sur la manière dont nous pratiquons la démocratie chez nous.

Comme le montrent les sondages internationaux, le

d'attraction des États-Unis ne reposait pas sur la politique de leur gouvernement, mais en grande partie sur leur société civile et sur leur capacité à se critiquer et à se réformer.

Contrairement aux actifs militaires (comme les forces armées), de nombreuses ressources du pouvoir de convaincre sont séparées du gouvernement et attirent les autres en dépit de la politique. Les films hollywoodiens et la musique pop présentant des femmes indépendantes ou des minorités autonomes peuvent attirer d'autres personnes. Il en va de même de la liberté et de la diversité de la presse américaine, des œuvres caritatives de ses fondations et de la liberté de la recherche dans ses universités. Les entreprises, les universités, les fondations, les églises et les mouvements de protestation des États-Unis développent leur propre pouvoir de convaincre, ce qui peut renforcer le points de vue des autres sur le pays.

Mais si des manifestations pacifiques peuvent produire du pouvoir de convaincre, la foule dans et autour du Capitole le 6 janvier était loin d'être pacifique. Les événements de ce jour-là ont été une illustration inquiétante de la manière dont Trump a exacerbé la polarisation politique, ce qu'il continue de faire en faisant de son mythe d'une élection volée un test décisif au sein du Parti républicain.

Bien sûr, les États-Unis avaient connu une polarisation politique croissante bien avant l'élection de Trump en 2016. L'innovation de Trump a consisté à exploiter et à exacerber le populisme nationaliste comme arme politique pour prendre le contrôle du Parti républicain, en intimidant les Républicains du Congrès par des menaces de fortes représailles de la part de ses partisans. Beaucoup sont encore trop peureux pour s'opposer à ses mensonges relatifs aux élections de 2020. Heureusement, dans un système fédéral, de nombreux responsables et législateurs de l'État ont tenu tête aux efforts de Trump, censé les intimider en « trouvant » des voix. Certains pessimistes craignent que cela ne se poursuive.

Pour ceux qui déplorent la disparition de la démocratie américaine, il est important de se rappeler que la participation sans précédent aux élections de 2020 a défait un démagogue. Et le résultat a été confirmé dans plus de 60 affaires judiciaires supervisées par un système judiciaire indépendant, dont certaines personnes nommées par Trump. Et le résultat a finalement été certifié par le Congrès.

démocratie américaine. La présidence de Trump a mis a mal tout une serie de normes democratiques. La polarisation persiste et la plupart des Républicains croient en ses mensonges sur l'élection. Les modèles d'affaires des médias sociaux exacerbent la polarisation existante en s'appuyant sur des algorithmes qui tirent profit de l'incitation à « l'engagement » des utilisateurs. En outre, des entreprises comme Facebook et Google, sous la pression de l'opinion publique et des audiences du Congrès, commencent à peine à réagir.

Opposition divisée :Cummings et Boakai continuent

réunion du Comité consultatif national (CCN) laisse beaucoup à désirer, et au lieu de rétablir la confiance, elle semble approfondir la méfiance », a dit Cummings.

Il a révélé que quand il a reçu une proposition de Boakai le mercredi 27 octobre 2021 pour une réunion du CCNqui devrait se tenir le 29 octobre 2021, il lui a écrit pour demander l'ordre du jour car il ne l'avait pas reçu comme promis.

Il a fait savoir que quand l'ANC a finalement reçu l'ordre du jour, il a demandé que la réunion fût reportée en raison du fait d'avoir reçu l'ordre du jour si tardivement. Cette demande était basée, selon lui, sur le fait que le calendrier était inadéquat, car le Comité exécutif national de l'ANC ne pouvait pas discuter de l'ordre du jour proposé. Il etait egalement impossible de recevoir à temps une copie de la lettre qui avait été précédemment envoyée à l'équipe d'avocats. Cette lettre était indispensable car elle avait été incluse comme point à l'ordre du jour. « Par conséquent, nous espérions que cette affaire serait limitée à la salle de discussion du Conseil National, c'est-à-dire entre nous », a dit Cummings. « Sans faire mention du retard que vous avez accusé dans la soumission de l'ordre du jour, vous avez tenu à ternir mon image et celle de l'ANC. Vous nous accusez d'être responsables de l'incapacité du CNA à se réunir. Ceci, monsieur le président, est un mauvais départ et un début

malheureux pour votre mandat. Beaucoup avaient espéré quelque chose de différent », a-t-il dit.

« L'ANC et moi personnellement avons déjà été victimes d'abus excessifs de la part de la présidence de la CPP. Nous avons fait l'objet d'une campagne de désinformation imméritée et de diffamation. Notre espoir était qu'avec votre appel à la réconciliation, et l'assurance de votre expérience en matière de leadership, ces abus auraient pris fin et le public commencerait à voir la CPP comme une coalition de l'opposition qui se comporte de nouveau honorablement afin de rétablir la confiance nécessaire dans les rangs de ses membres ».

Dans un communiqué de presse qui date du 29 octobre 2021, Boakai a déclaré que la réunion du Conseil consultatif national s'est tenue au siège du CPP à Congo Town. Seuls les dirigeants du Parti de la liberté, du Parti de tous les libériens et du Parti de l'Unité étaient présents. L'ANC avait boycotté la réunion. « Malheureusement, il n'y avait absolument aucun représentant du Congrès national alternatif (ANC) à la réunion du CNA », a-t-il déclaré. Selon lui, conformément aux règles régissant les réunions du CPP, chaque parti devrait avoir au moins unreprésentant. Il a déclaré que par conséquent, les questions cardinales relatives au renforcement de la CPP et à la décision sur la résolution à l'amiable des problèmes du document-cadre ne pouvaient pas être discutées. Il a cependant dit espérer que l'ANC sera pleinement représenté à la prochaine réunion du CNA.

mandat du président Donald Trump n'était pas enclin à mettre en avant le pouvoir de convaincre américain. Cela était dû en partie à une réaction à la politique étrangère nationaliste de Trump, qui a évité ses alliés et ses institutions multilatérales, ainsi qu'à la réponse incompétente de son administration à la pandémie de COVID-19. Mais les efforts de Trump visant à perturber la passation de pouvoir pacifique du pouvoir politique après sa défaite aux élections de 2020 ont été encore plus dommageables envers le pouvoir de contraindre des États-Unis. Le 6 janvier 2021, comme l'a décrit le sénateur républicain Ben Sasse, l'invasion du Capitole des États-Unis a montré « le plus grand symbole de l'autonomie gouvernementale au monde mis à sac, tandis que le chef du monde libre se cachait derrière son clavier pour tweeter contre son vice-président qui exerçait son devoir en respectant le serment prêté à la Constitution. »

Les alliés de l'Amérique et d'autres pays ont été choqués et l'attrait de l'Amérique en a été amoindri. Le pouvoir de convaincre de l'Amérique peut-il s'en remettre?

Ce ne serait pas la première fois. Les États-Unis ont de sérieux problèmes, mais ils ont également une Cela ne veut pas dire que tout va bien pour la capacité de résilience et de réforme qui les a sauvés par le passe. Dans les annees 1960, l'heritage raciste américain a provoqué d'importantes émeutes urbaines et des manifestations contre la guerre du Vietnam se sont révélées de plus en plus violentes. Des bombes ont explosé dans les universités et dans des bâtiments publics. La Garde nationale a tué des étudiants qui manifestaient à Kent State University. Nous avons assisté aux assassinats de Martin Luther King Jr. et de deux Kennedy. Les démagogues populistes comme George Wallace ont attisé les feux de la haine. Pourtant, en l'espace d'une décennie, le Congrès a mis en place une série de réformes politiques et l'honnêteté de Gerald Ford, la politique des droits de l'homme de Jimmy carter, ainsi que l'optimisme de Ronald Reagan ont contribué à rétablir l'attrait de l'Amérique.

En outre, même lorsque les manifestants ont défilé dans les rues du monde entier pour condamner la politique américaine au Vietnam, ils ont eu tendance à chanter « We Shall Overcome » plutôt que « L'Internationale ». L'hymne du mouvement des droits civiques a montré que le pouvoir Dans le même temps, la culture américaine a encore des sources de résilience que les pessimistes ont sousestimées par le passé. La liberté de la presse, les tribunaux indépendants et le droit de manifester pacifiquement comptent parmi les plus grandes sources de la puissance de convaincre de l'Amérique. Même lorsque des politiques gouvernementales erronées réduisent l'attrait de l'Amérique, sa capacité d'auto-réflexion et d'auto-correction la rendent plus attrayante pour les autres à un niveau plus fondamental. Comme je l'ai dit à mon ami européen sceptique, les valeurs changent avec les générations et la jeune génération est une source d'espoir.

bout 30 lawmakers from the House of Representatives have co-signed a bill and submitted same before the House requesting the amendment or the repeal of parts of the country's Aliens and Nationality Law.

The bill requesting the amendment or repeal of some parts of the Aliens and Nationality Law of Liberia is headed by Montserrado County District #8 Representative, Acarous Moses Gray.

Rep. Gray in the letter before the House of the Aliens and Nationality Law of the Liberian Code of Law Revised, Vol. II."

Gray is the Chairman on the House's Committee on Executive. He and his co-signees believe that the amendment or repeal of certain parts of this law will satisfy the constitutional provision in Article 2 of the 1986 Liberian Constitution, which states, "... Any laws, treaties, statutes, decrees customs and regulations found to be inconsistent with it shall, to the extent of the inconsistency, be void and of no legal effect...'

"It is against this backdrop that I humbly submit to you, Honorable Speaker and Distinguished Colleagues, for legislative enactment consideration by way of amendment and or repealing of the existing law through a proposed Bill titled, "An Act to Amend Part III, Chapter 20, Section 20.1; Chapter 21, Sections 21.30, 21.31, 21.51 & 21.52 and Chapter 22, Sections 22.1, 22.1 & 22.4 of

by 30 other lawmakers as cosponsors including Deputy Speaker Jonathan Fonati Koffa, was submitted on Friday, October 29, and read on the House's floor on Tuesday, November 2nd. It was later forwarded to the Committee on Judiciary to report back to Plenary within one week.

Gray, an official of the ruling **Coalition for Democratic Change** (CDC) of President George Weah, is the "Chief Sponsor" of the Bill for the amendment.

The particular bill in question is also being back by the All-Liberian Conference on Dual

Citizenship (ALCOD), which includes the Union of Liberian Associations in the Americas (ULAA), European Federation of Liberian Associations (EFLA), Liberian Advocacy for Change (LAFC), Federation of Liberia Communities in Australia (FLCA), United Liberian Association of Ghana (ULAG), Liberian Association of Canada (LAC), and Conference of Liberian Organizations in Southwestern United States of America (CLOSUSA). ALCOD represents more than 500,000 Liberians living in the diaspora.

Rep. Gray's submission comes few days after it was published in the media that some diaspora Liberians, who became fed up with "lack of action and will", had called on Montserrado County Senator Abraham Darius Dillon to withdraw similar bill that he had submitted with his colleagues, in the Senate, for legislative enactment.

Meanwhile, members of ALCOD have extended their thanks and appreciation to President Weah, who had, among eight other proposals for amendment in the December 2020 Special Senatorial Election, included the dual citizenship proposal for amendment. "The President still continues to support our effort for dual citizenship today. It is our wish that he will support the Rep. Gray-sponsored bill."

The ALCOD members also thanked the Speaker and Members of the House for their support for dual citizenship. They have also thanked Senators Varney Sherman, Abraham Darius Dillon, who had submitted similar bills in the Senate for passage.

These diaspora-based Liberians hope that when the bill passes through the House, it will be concorded in the Senate.

ndian businessman and philanthropists Mr. Upjit Singh Sachedeva (Mr. Jeety) has used Liberia's Thanksgiving Day on 4 November 2021 and India's national festival, Diwali, to feed prisoners and donate 100 dozens of plates for inmates at the Monrovia Central Prison (MCP).

The inmates feeding exercise on Thursday, 4 November was part of Mr. Jeety and his Jeety Trading Corporation's inmates feeding

Mr Jeety said the last time he visited the Monrovia Central Prison, he observed that the plates in which inmates were served were broken.

Daykay town check point and the security checked us and we passed but reaching in the town under a palm tree I felt a sharp pain on my back and I stopped quickly but while stopping the suspect was still chopping me with a knife", he alleged.

'But when I came down from the bike we started fighting over the knife; he overpowered me so I started shouting until one man came to my rescue and brought me to the checkpoint, while I was bleeding", he lamented.

According to Police charge sheet, Suspect Weah has been charged with multiple crimes, ranging from robbery,

criminal conspiracy, criminal attempt to commit murder and aggravated assault, respectively.

The crime is in violation of Section 14.1, 15.32, 10.1 and 14.1 of the revised Penal Law of the Republic of Liberia hence, the Suspect Weah is being detained at the Pleebo prison, awaiting court trial.

Though the suspect denied the allegation and claimed it was the victim instead, who attempted to kill him, he spent a night behind bar before Police forwarded him to the Pleebo Magisterial Court.

Similar situation this year occurred in Pleebo on 20th March, when a suspect identified

as Moses Mlarmah allegedly murdered a motorcyclist. Angry protesters, including

commercial motorcyclists subsequently set ablaze the residence of Speaker Bhofal Chambers' and a prison compound, demanding speedy investigation into the gruesome murder of the cyclist.

The protesters threw stones and erected road blocks, demanding speedy investigation for the sudden death of the late Modeciou Nyemah, a commercial motorcyclist who was gruesomely murdered by Moses Mlarmah. -Editing by Jonathan Browne

he Ellen Johnson Sirleaf Presidential Center for Women and Development (EJS


Center) has announced the launch of the Have Her Back campaign - an exciting initiative to mobilize male leaders and
