Oscar Pistorius parole ocess to sta

outh African Paralympic athlete Oscar Pistorius, in prison for murdering his girlfriend Reeva Steenkamp, may soon meet her parents as part of the process leading to parole being considered, officials say.

He is eligible for possible release after having served half his sentence.

But he first has to take part in what is called "restorative justice".

Pistorius shot Steenkamp dead in 2013 saying he mistook her for a burglar at his home in the capital, Pretoria.

The 34-year-old fired four times through a locked toilet door.

In 2014, at the conclusion of a trial that was followed around the world, he was given a five-year term for manslaughter. But Pistorius was found guilty of murder on appeal in 2015 and the sentence was later increased to 13 years and five months. In a statement, South Africa's department of correctional

services said it was talking to the Steenkamp family about a possible meeting.

Outlining what needs to happen before parole is considered, the statement says that offenders must "acknowledge and take responsibility for their actions".

As part of the restorative justice process there has to be "an opportunity for parties to reconcile or an apology".

The Steenkamps' lawyer, Tania Koen, told national broadcaster SABC that they "would like to participate in the victim-offender dialogue"."June [Steenkamp, Reeva's mother] has always said that she has forgiven Oscar, however that doesn't mean that he mustn't pay for what he has done... Barry [Steenkamp, Reeva's father] battles with that a bit, but

that is something he will have to voice at the appropriate time," Ms Koen added.

"The wound, even though so much time has passed, is still very raw."

Being eligible for parole is not the same as being entitled to it and so it is not a forgone conclusion that he will be released, the lawyer said. The authorities will also have to consider a number of reports written by prison officials as well as other professionals.

There had also been some confusion over when the parole process could begin.

It was widely believed that it would not be until March 2023, but the Steenkamps were "very shocked and quite taken aback" that he was already eligible, Ms Koen said.

The BBC's Pumza Fihlani in Johannesburg says that if granted parole, Pistorius would serve the remainder of his sentence at home and need to report to prison officials regularly.

Prior to the murder, Pistorius had become well known as a Paralympic gold medallist. In 2012, he made history by becoming the first amputee sprinter to compete at the Olympics running on prosthetic "blades". His legs were amputated below the knee when he was 11 months old because he was born without fibula bones. BBC

whistleblower who testified at a state inquiry into massive corruption allegations has left the country fearing for his life."If I remained at home there was a good chance I'd be silenced, so I left," Athol Williams said.

A public inquiry investigating corruption during the presidency of Jacob Zuma has heard from multiple witnesses.

Zuma was convicted of contempt for refusing to appear

before the commission. He was jailed but then freed on medical parole. He faced numerous charges of corruption, which he denies.Mr Williams, a former ethics lecturer at the University of Cape Town, is among 278 witnesses who have testified at the public inquiry.

"Knowing that my government offers me no protection after I've acted in the public interest is a disturbing reality. I implicated 39 parties in my testimony so threats could come from many places," he said in a statement published on Sunday. He described hugging his family members in tears before boarding a flight out the country.

Mr Williams added that the killing in August of another whistle-bower, Babita Deokaran, who had exposed alleged corruption in a different scandal, convinced him that his protection was not guaranteed.



Signs of an emerging death squad !

THE WAVE OF suspicious killings in Monrovia and parts adjacent is both scaring and very disappointing, particularly under a civilian administration where security or law and order should be paramount. However, it seems that ghastly killings in homes every other week or month have become common in our society with the authority at the highest level remaining conspicuously silent.

OUR ATTENTION IS drawn to the suspicious death of three high profile personalities, two of them officials of government and a highly established private citizen in just over a month.

ON TUESDAY, NOVEMBER 2, 2021 the Government of Liberia announced the death of Liberia's Peace Ambassador Rev. William R. Tolbert, III, youngest son of slain President Dr. William R. Tolbert, Jr. According to the Ministry of Information, Rev. Tolbert was discovered dead at his residence in Monrovia on Sunday, October 31, in what the Liberia National Police described as a suspected homicide. The same day, female officer Maude Elliott of the Liberia Immigration Service (LIS) said to be in her 50s, was found brutally murdered at home in Brewerville, outside Monrovia.

EARLIER, IN SEPTEMBER this year, specifically September 22, 76-year-old John Hilary Tubman, a son of another former President, William V.S. Tubman, was reportedly found dead lying face down in a pool of blood with deep cuts to his neck and forehead with pillow placed over his head at his residence in Fiamah community, Monrovia.

INTERESTINGLY, THESE PERSONALITIES were alone in their respective homes when they were brutally killed. These are nothing else, but targeted murders that raise concern about something sinister being perpetrated and Police investigations should be able to establish.

THERE WERE OTHER mysterious deaths in and around the city prior to these three specific cases listed above. And from the trend of events, we can deduce that there is a pattern being unleashed by a probable death squad that is roaming and seeking its next target.

THE KILLINGS BEAR similar wounds that were inflicted in specific parts of the body, indicating there is a hired killer or a group of hired killers involved. Who are they working for is yet to be established but their targets may signal something.

ARE WE RETURNING to the days of the Charles Julu death squad under slain President Samuel Kanyon Doe? God forbid! But the writings on the wall spell bad omen for our beloved country.

SADLY HOWEVER, CIVIL Society, religious leaders and institutions including men and women of moral conscience in our society are silent about the unfolding development. Today, the late John Hilary Tubman, Officer Maude Elliott and Rev. William R. Tolbert, III, are the latest victims of this creeping evil in our country. We don't who's next.

SOCIETY SHOULD SPEAK out now before it becomes too late. It is citizens' alienable right guarantee by our Constitution to peacefully assemble, protest and petition their representatives against anything that threaten their peace and happiness. If the current killings must stop, Liberians should rise up now!

television celebrity, and possible presidential candidate Éric Zemmour is having great success with his extreme reactionary views. Zemmour has suggested that Muslims must choose between their religion and France, that the deportation of Muslim immigrants is feasible, and that non-French first names should be banned. He hates "cosmopolitans" and believes that liberalism is destroying French family life.

Zemmour has been sentenced twice already for racial discrimination and inciting hatred. His book, The French Suicide, published in 2014, sold more than a half-million copies in France. Polls suggest that he might get as much as 16% of the vote in next year's presidential election.

Zemmour's way of thinking stems from a tradition going back to the French Revolution of 1789. Catholic conservatives and right-wing intellectuals, who hated the secular republic that emerged from the revolution, have long fulminated against liberals, cosmopolitans, immigrants, and other enemies of their idea of a society based on ethnic purity, obedience to the church, and family values. They were almost invariably anti-Semitic. When Jewish army Captain Alfred Dreyfus was falsely accused of betraying his country in the notorious scandal of the 1890s, they were on the side of Dreyfus's accusers

Germany's invasion of France in 1940 gave reactionaries of this kind the chance to form a French puppet-government in Vichy. Zemmour has had kind things to say about the Vichy regime. He also has expressed some doubt about the innocence of Dreyfus.

None of these views would be surprising if they came from a far-right agitator like Jean-Marie Le Pen. But Zemmour is the son of Sephardic Jewish immigrants from Algeria who lived among the Muslim Berbers. Because of the French reluctance to make ethnic or religious distinctions between citizens, Zemmour's background is often ignored. But it might help to explain why he arrived at his extreme opinions.

person should not hold conservative views. about their countries. But nativism among Jews in the diaspora is exceedingly rare, for obvious reasons. (Israel is a somewhat different story.) Hostility to immigrants and insistence on national purity have never done Jews any good. > In France, such patriots would be mostly on the side of universal human rights and other French republican values. This would apply, for example, to the well-known philosopher Alain Finkielkraut, the son of a Polish father who survived Auschwitz. Finkielkraut fears the dangers of Islam no less than Zemmour, but he is not a nativist. The Islamic threat, in his view, is to the liberal, secular, republican ideas that Zemmour deplores.

> So, what drives Zemmour? How can a Jew become an anti-Dreyfusard, as it were? Perhaps the memories of the Nazi genocide and the Vichy regime's complicity have faded so much that even a Jewish intellectual can flirt with nativist reaction without any sense of shame or fear. Or maybe he believes that stirring up French hostility to Muslims will deflect potential aggression against Jews. Many French Jews, especially the mostly Sephardic Jews living in poor neighborhoods, live in genuine fear of Muslim anti-Semitism.

> Zemmour is an extreme assimilationist. He cannot stop talking about his ardent love of France. Again, there is nothing unusual about that. But his family roots among the Berbers are a complicating factor. Zemmour's attitudes are not unique to France, or to Sephardic Jews. In the Netherlands, for example, one thing some of the most fervent opponents of Muslim immigration have in common is a family history in Indonesia, the former Dutch East Indies.

> Geert Wilders, leader of the anti-immigrant Party for Freedom, is partly Eurasian. So are some other prominent figures in Dutch far-right politics who have an obsession with Islam. Racial hierarchies in the former colonies were complex. Eurasians in Indonesia, especially those with a Dutch education, were not just keen to be thought of as Europeans, but were fearful of being identified as Asians - let alone Muslims. Many Algerian Jews were just as eager to identify as French, and living among Muslims could easily result in hostility.

Muslims in Europe not only are resented, but some Eurasians in Holland or Jews in France are There is of course no reason why a Jewish terrified of being associated with them. > Zemmour's hostility to Muslims has made him popular with some French Jews who have been shocked by recent acts of Islamist violence including the murder of a rabbi and three children in Toulouse, the stabbing of an elderly Jewish woman in Paris, and other incidents.

been keen to assimilate and become But Zemmour also has given license to bigotry among Gentiles. Le Pen himself put this succinctly in a recent interview with Le Monde. Because Zemmour is a Jew, Le Pen said, nobody could accuse him of being a Nazi, and "that gives him great freedom." Twilight of the Kims?

Having failed to improve its economic prospects, North Korea is once again launching missiles and hoping that saber-rattling will lead to a loosening of international sanctions. But the United States and its allies are already familiar with this script and have decided to write a new one of their own.

TLANTA - Nearly three years after his failed bromance with Donald Trump, North Korean dictator Kim Jong-un is once again angling for US attention. North Korea has tested a new, high-tech missile and hinted that it may agree to restart talks with South Korea, where President Moon Jae-in desperately wants to resuscitate his moribund outreach to the North. But if Kim is expecting a positive reaction from US President Joe Biden, he shouldn't hold his breath. With issues like China and the rebuilding of US alliances topping Biden's agenda, overtures to Kim are unlikely.

Kim's dog-eared script is not helping his cause. The latest drama has unfolded all too predictably. In Act One, Kim Yo-jong, Kim's sister and the North's spokesperson on North-South affairs, averred that the regime might be interested in discussing a peace treaty with South Korea - an idea that Moon himself had proposed in September. She hastened to add, however, that South Korea will have to distance itself from US demands for nuclear disarmament and end joint military exercises with US forces.

The predictable saber-rattling came a few days later, in Act Two. Following the announcement that the regime had launched a new hypersonic missile and carried out a half-dozen other tests, Kim took to the podium (with his missilery in the background) to tout the North's "world class defense capability." Although the Biden administration had sent "signals that it is not hostile," he declared that the North has "no reason to believe it." By challenging US credibility, Kim was all but asking the United States to respond, ideally by following its Korean ally's lead and publicly throwing a bone his way.

But the newly slimmed-down Kim isn't the only one reusing an old script. Moon's offer to negotiate a peace treaty as a prelude to nuclear negotiations has been a perennial feature of North-South talks. As if following Kim Yo-jong's cue, Moon's Democratic Party followers duly played their part by calling for a suspension of military exercises and other preconditions for negotiations.

Yet, in seizing on the prospect of new nuclear talks, the political leadership in Seoul seems to have already forgotten what Kim said at North Korea's Eighth Party Congress in January: "We must develop tactical nuclear weapons that can be applied in different means in the modern war [sic]... and continue to push ahead with the production of super-large nuclear warheads."

As always, North Korea's blandishments and bluster are geared toward only one goal: to loosen the vice of nuclear-related economic sanctions. Despite making economic development his domestic priority five years ago, Kim has failed to improve basic living conditions in the country. Battered by floods, food shortages, and a pandemic-induced lockdown, his initiatives - market-based reforms, decentralized decision-making, and more social investment - have stalled, tanking trade and economic growth. Kim acknowledged as much at the party congress in January, emphasizing the need for "self-reliance" and explicitly sidelining reform.

Unfortunately for Kim, there is a new audience in the White House, and it is far tougher than the incumbents in Seoul. Speaking before a joint session of Congress in April, Biden made clear that Kim should not expect the kind of pre-emptive concessions that Trump offered at the summits in Singapore in 2018 and Hanoi in 2019. According to Biden, the US is prepared to talk anytime without preconditions about the peninsula's denuclearization, but there will be no mano-a-mano deal-making. As Biden's press secretary explained after his speech, "We have and will continue to consult with the Republic of Korea, Japan, and other allies at every step along the way."

Biden's priorities in Asia pose a big problem for Kim. In early October, CIA Director William Burns announced the creation of a new China Mission Center and then disclosed that the agency's North Korea mission center will be shut down. Although countries like North Korea and Iran will remain priorities, that work will be absorbed into the agency's regional divisions. According to a State Department official, US intelligence agencies "will continue to remain in close consultation and coordination with our South Korean allies on issues of mutual concern," especially North Korea.

For Kim, the implications of this reorganization are obvious. While Trump was willing to backhand longstanding US allies for the sake of his summitry theater, Biden insists on working closely with America's partners. The consequences of this change are already apparent across the region. In South Korea, conservative politicians campaigning for next year's presidential election are calling for greater pressure on the North and to repair ties with Japan, which have become badly frayed under Moon.

Similarly, in his first conversation with Biden as Japan's newly installed prime minister, Fumio Kishida emphasized the importance of allied cooperation. Reportedly singling out the threat from a nuclear-armed North Korea, he highlighted Japan's need for stronger missile and naval defenses.

Biden's overarching focus on China, North Korea's sole ally and source of economic support, also does not bode well for Kim. To be sure, the North Koreans have probably concluded, correctly, that a more fractious US-China relationship will make China less likely to twist their arms on the nuclear issue. Given today's tensions, it is highly unlikely that China would do the US any more favors in this regard.

But Chinese help with the North Korean nuclear issue has only ever been intermittent at best. Because China does not want Korean refugees flooding over its border or a US ally in control of the entire Korean Peninsula, it still has an interest in limiting Kim's provocations.

In any case, having China in his corner is probably the best that Kim can hope for in the next act of the drama. By bolstering US allies and deepening mutual cooperation, America's strategic commitment to Asia not only represents a bulwark against China's own military ambitions; it also changes the balance of forces surrounding the Korean Peninsula. Australia's investment in nuclear submarines and enhanced alliance relations with the US and the United Kingdom represent future capabilities that can focus on Pyongyang. And Kishida's Liberal Democrats back a boost in Japan's defense spending to 2% of GDP.

For its part, Pyongyang would do well to consider these and other forthcoming strategic changes affecting the Korean Peninsula. America's Asian partners, with their strong economies, world-class technology, and modern defense forces, are well prepared for the twenty-first century. Time is not on Kim's side.

How can PUL pull itself out of poverty?

he Press Union of Liberia like any other professional body in Liberia is suffering due to a lack of contemporary modern innovations. But PUL has no reason to suffer, perhaps critical leadership innovation is conspicuously missing from the strategy index of PUL since its inception on 30th September 1964 up to the present.

For PUL to strive positively it must transcend beyond regular due payment methods and come out with innovative long-range plans of action that will be more accountable and transparent, something to convince donors.

Excitingly, the \$100000 donation made to PUL by then Pres. Ellen Sirleaf (2008) wasn't for dinner and eating of chocolate and American sauces, it was for serious business for PUL to turn around and multiply a huge dividend which would have made Madam Sirleaf very proud to lobby more and more for the PUL, but instead the executives of PUL began to wear a big gold ring, Italian shoe, and American coat and tie and renting of huge SUV jeeps to entice others when in the true sense of the world the PUL is suffering beneath. Today, the \$100000 is now history and PUL is still at square one and Madam Sirleaf is grossly disappointed.

PUL is too old not to have accumulated huge assets in Liberia needless talks about its holistic connections with other giant media entities abroad-what is then PUL's actual problem as she continues to languish in acute financial poverty from one leadership to another? How can PUL hold the CDC-led government accountable for corruption when PUL is one of the leading children of corruption in the land?

It is very sad if not disappointing that the 57-year-old media institution has much to always talk about but little to show with no strategy, no innovation, no practical plan of action that will truly pull it out of financial to that bring lasting smiles to its over 500 members who are glaringly impoverished financially and materially. Interestingly, the birth year of PUL was the same year when the late President William Vacanarat Shadrach Tubman was inaugurated for a fifth term as President of Liberia.

This historical connotation should be key to PUL's birth for two reasons: First, Liberia was then a very dark republic that a smart entity like the PUL could have quickly stolen the show on development innovation. Second, a farsighted leadership can undertake more and more development in a very dark republic as quickly as possible than any other time in the history of a said entity like PUL. PUL, like other useful entities of the 50s and 60s, missed its opportunities to build a resourceful and rewarding future foundation that would have pulled its membership out of poverty in modern Liberia.

Mr. Gabriel I. H. Williams, a founding member who was then secretary-general of PUL in those dark days, failed to lay any productive foundation for PUL. As a chief administrator, he was either consumed or entrenched into business as usual or was simply complacent or he just didn't have the critical thoughts to get PUL to where it should have been-that is across the finished line into high core development initiatives.

PUL is not just any entity, it is a professional body. The Press is referred to as the "Fourth Estate" fourth in line of serious political tradition in line of societal functionaries next to the executive, the legislature, the judiciary and then comes the "Fourth Estate" defined as such with its array of functions and deliverables in Liberian society.

There are several possible strategies on how PUL can pull itself out of financial/material poverty. First, all PUL print newspapers should patronize a member or group of members that has printing facilities, rather than patronize foreign printing presses in Liberia. Second, PUL can get collateral that will help it get a loan of \$500.000 to invest in animal husbandry, by raising goats, cows, sheep, and chickens for sale on the Liberian market. PUL could also get ex-farmers from Zimbabwe, South Africa to help with the process.

Third, PUL could acquire 500000 acres of land, bring rice experts from Taiwan to guide its huge food production for Liberia, and have it sold at a much cheaper rate. Fourth, PUL could invest in mining gold and felling trees for charcoal that would supply Liberia. Fifth, PUL could use proceeds from the farm business to acquire an additional 800 acres of land and erect mini-estates for low-income Liberians including PUL members. PUL could also use its hugely acquired profits from the housing projects to establish a vibrant transportation system, by getting some old hands from Ghana and Ivory Coast to guide the process with their strategies and success stories. These are some of the ways and means by which PUL could easily be the richest entity in Liberia and help its members.

Lastly, PUL could lobby with its huge International media partners such as International Media Support (IMS), Committee to Protect Journalists (CPJ), International Federation of Journalists (IFJ), West African Journalists Association (WAJA), Catholic Justice and Peace Commission (JPC-Liberia), Carter Center (CC), International Alert (IA-UK), Center for Democratic Empowerment (CEDE), the Civil Rights Association of Liberian Lawyers (CRALL), Media Foundation for West Africa (MFWA), IREX, Media Rights Agenda, Open Society Initiative for West Africa (OSIWA), Panos Institute of West Africa, OSIWA and IREX to put before them some of these viable resourceful projects and proposals for funding.

Meanwhile, assigned Criminal Court "C" Judge T. Ciapha Carey has admonished his colleagues at the opening of the court that the challenges they face should not be reasons for them to engage into acts that undermine the integrity of the

Judge Carey also reminded his colleagues that the office of the Judge is to interpret the law and not to make law.

"The office of a judge is not to render advisory opinions but to hear cases and render judgment in the form of an opinion and as such, judgment must be impartial and independent," Judge Carey noted.

He said judgment should not be for sale or delayed. According to him, they will maintain the independence of the office of the judge.--Edited by Winston W. Parley





"The Financial Intelligence Unit of Liberia has noticed with disdain that some supervisory bodies are serving as enablers of non-compliant by these listed sectors," said Mr. Harris while addressing the Edward Wilmot Blyden Forum organized by the Press Union of Liberia (PUL) Friday, 5 November 2021 on Money Laundering and Terrorists Financing.

He said FIU has noticed that



Les libériens doivent honnêtement se féliciter de l'accord amendé de l'AMI

Le gouvernement du Libéria et la direction d'ArcelorMittal Libéria (AML), l'un des plus grands géants mondiaux de l'acier, ont récemment signé une version modifiée de l'Accord de développement minier (MDA).

Dans le cadre de l'accord, l'AML investiraprès de 800 millions de dollars supplémentaires au Libéria. Mais avant même que la copie modifiée du MDA ne soit signée, les citoyens des zones opérationnelles de l'entreprise dans les comtés de Nimba et de Grand Bassa ont protesté contre l'accord. Il y a eu une action en justice et des actes de harcèlement physique et d'intimidation avec la présence d'un masque traditionnel dans les locaux de la compagnie minière à Nimba dont l'intention était de mettre fin à ses opérations.

Mais toutes ces actions contre l'accord sont-elles vraiment justifiées sans avoir pris son temps pour faire la lecture de l'amendement du MDA? Ou est-ce à dire que les Libériens ne font plus confiance à leur propre gouvernement avec le président George Manneh Weah aux commandes en ce qui concerne leurs intérêts dans cette concession?

Le New Dawn a feuilleté les points saillants de l'accord modifié et pense que les citoyens ordinaires ont beaucoup à gagner en termes d'emploi, de fonds de développement social régional, de bourses d'études et de formation professionnelle, entre autres grâce à l'investissement de l'AML et du gouvernement lui-même qui renflouera ses caisses grâce à cet accord gagnant-

En tant que premier investisseur majeur sous l'administration Weah, l'engagement d'ArcelorMittal à investir 800 millions de dollars US montre clairement que la société aspire à raviver la confiance des investissements du secteur privé dans l'économie avec plus de 2000 nouveaux emplois qui devraient être créés pendant la phase de construction, et à mesure que les volumes de production augmenteront, ses équipes d'exploitation généreront également 1 000 nouveaux emplois supplémentaires, ciblant les Libériens.

Le projet d'expansion, en vertu de l'accord modifié, qui englobe les installations de traitement, ferroviaires et portuaires, promet de devenir l'un des plus grands projets miniers de toute l'Afrique de l'Ouest. Il comprendra la construction d'une nouvelle usine de concentration et une expansion substantielle des opérations minières. La premièreexpansion est prévue dès 2023 et pourrait atteindre 15 millions de tonnes par an. Ce qui pourrait stimuler le PIB.

L'accord qui est critiqué dans certains milieux devrait également renforcer la capacité du gouvernement du Libéria à répondre aux besoins d'autres utilisateurs, dont les mineurs guinéens, d'utiliser l'infrastructure libérienne pour leurs exportations. L'AML s'est engagé à conclure un accord multi-utilisateur avec le gouvernement du Libéria après la ratification de l'accord modifié.

Vu que l'économie mondiale est étouffée par la pandémie de COVID-19, les Libériens devraient faire preuve de patience et être optimistes quant à l'avenir plutôt que de chercher à jeter l'eau de bain avec le bébé. Nous avons besoin d'investissements étrangers directs pour développer notre économie et les entreprises qui sont déjà sur le terrain ne devraient pas être effrayées, comme cela a été le cas de Sime Darby dans les comtés de Bomi et de Grand Cape Mount. ArcelorMittal et le gouvernement du Libéria ont jugé nécessaire de procéder à un amendement depuis août 2016 avec l'ancienne administration Sirleaf. Cela démontre combien l'entreprise tient au partenariat avec le Libéria et au maintien des opérations à flot et son intention d'offrir des solutions gagnantgagnant telles que l'utilisation des usines de HFO qu'elle avait achetées en 2014 pour fournir de l'électricité dont le pays a si grandement besoin.

En tant que membre fondateur de l'ITIE du Libéria, ArcelorMittal Libéria a joué un rôle essentiel dans la déclaration de ses paiements au gouvernement, ce qui était essentiel pour les rapports de conformité de l'ITIE. En outre, AML a versé 3 millions de dollars US par an aux pays dans lesquels elle opère. À ce jour, l'entreprise a versé 45 millions de dollars pour cet engagement. En réponse aux plaintes des citoyens selon lesquelles les fonds ne bénéficiaient pas aux communautés affectées, AML a convaincu le gouvernement du Libéria pour que 20 % de ces fonds soient gérés directement par ces communautés. Ce programme a démarré en 2020.

Éric Zemmour et la revanche de Vichy

EW YORK - Le journaliste français, vedette de la télévision, et potentiel candidat à la présidentielle Éric Zemmour remporte un franc succès au travers de ses points de vue réactionnaires extrêmes. Il estime que les musulmans doivent faire un choix entre leur religion et la France, que la déportation d'immigrés musulmans est une possibilité, et que les prénoms autres que français doivent être interdits. Il ne cache pas sa haine des « cosmopolites », et considère que le libéralisme détruit la famille française.

Zemmour a déjà été condamné à deux reprises pour discrimination raciale et incitation à la haine. Son ouvrage de 2014 intitulé Le Suicide français s'est vendu à plus d'un demi-million d'exemplaires en France. D'après les sondages, il pourrait recueillir pas moins de 16 % des voix lors des élections présidentielles de l'an prochain.

Le mode de pensée de Zemmour est ancré dans une tradition qui remonte à la Révolution française de 1789. À l'époque, les catholiques conservateurs et intellectuels de droite, profondément hostiles à la république laïque née de la révolution, fulminaient déjà contre les libéraux, cosmopolites, immigrés et autres ennemis de leur conception, celle d'une société fondée sur la pureté ethnique, l'obéissance à l'Église, et les valeurs familiales. Ils étaient d'ailleurs presque toujours antisémites. Lorsque le capitaine juif Alfred Dreyfus fut accusé à tort d'avoir trahi son pays, célèbre scandale des années 1890, ils choisirent le camp des accusateurs.

L'invasion de la France par l'Allemagne en 1940 conféra à ce camp réactionnaire l'opportunité de former le gouvernement fantoche de Vichy, dont Zemmour a parfois dit du bien, lui qui a également exprimé certains doutes quant à l'innocence de Dreyfus.

Aucune de ces opinions ne serait surprenante si elle émanait d'un agitateur d'extrême droite comme Jean-Marie Le Pen. Seulement voilà, Zemmour est le fils d'immigrés juifs séfarades algériens, qui ont vécu parmi les musulmans berbères. Compte tenu de la réticence française à établir des distinctions ethniques ou religieuses entre les citoyens, le profil de Zemmour est souvent ignoré. Or, il contribue peut-être à expliquer pourquoi le candidat potentiel en est arrivé à des positions aussi extrêmes.

Il n'y a évidemment aucune raison qu'une personne juive ne formule pas des opinions conservatrices. De nombreux juifs font d'ailleurs preuve d'un patriotisme passionné quant à leur pays. Pour autant, le nativisme parmi les juifs de la diaspora est extrêmement rare, pour des raisons évidentes (Israël constituant un cas à part). L'hostilité aux immigrés et l'insistance sur la pureté nationale n'ont en effet jamais bénéficié aux juifs. C'est peut-être la principale raison pour laquelle les juifs américains, par exemple, à la différence d'autres minorités prospères telles que les Irlandais, les Italiens, et de plus en plus les Latinos, votent encore régulièrement pour les Démocrates.

Depuis bien longtemps, nombre de juifs de la diaspora s'assimilent et deviennent aisément indistinguables de la population majoritaire. Comme pour les autres minorités, c'est souvent une question de classes, une relative prospérité venant assouplir les liens religieux et culturels traditionnels. Les patriotes juifs français, britanniques ou américains même les pus ardents ont tendance à soutenir l'ouverture de leur société, ainsi qu'à s'opposer à l'intolérance vis-àvis des immigrés.

En France, ces patriotes se situeraient pour la plupart dans le camp des droits humains universels et autres valeurs républicaines françaises, ce qui s'appliquerait par exemple au célèbre philosophe Alain Finkielkraut, fils d'un Polonais qui a survécu à Auschwitz. Finkielkraut redoute autant que Zemmour les dangers de l'islam, mais il n'est pas pour autant nativiste. La menace islamique, selon lui, concerne les idées libérales, laïques et républicaines, que Zemmour déplore pour sa part.

Qu'est-ce qui anime alors Zemmour ? Comment un juif peut-il devenir pour ainsi dire antidreyfusard? Peut-être les souvenirs du génocide nazi et de la complicité du régime de Vichy se sont-ils tellement estompés que même un intellectuel juif puisse flirter avec un réactionnisme nativiste sans ressentir la moindre honte ou crainte. Ou peut-être pense-t-il qu'attiser une hostilité française contre les musulmans détournera les agressions potentielles loin des juifs. Beaucoup de juifs français, notamment les juifs principalement séfarades qui vivent dans des quartiers défavorisés, redoutent en effet réellement l'antisémitisme musulman.

Zemmour est un assimilationniste extrême. Il ne cesse de clamer son fervent amour pour la France. Ici encore, rien d'anormal. Ses racines familiales berbères viennent toutefois complexifier les choses. Les attitudes de Zemmour ne constituent pas une spécificité propre à la France ou aux juifs séfarades. Aux Pays-Bas, par exemple, les plus vifs opposants à l'immigration musulmane ont en commun une histoire familiale en Indonésie, autrefois Indes orientales néerlandaises.

Geert Wilders, chef du Parti pour la liberté, opposé à l'immigration, est en partie Eurasien, comme le sont plusieurs autres figures majeures de la droite néerlandaise, obsédées par l'islam. Les hiérarchies raciales au sein des anciennes colonies étaient complexes. Les Eurasiens d'Indonésie, notamment ceux d'éducation néerlandaise, ne souhaitaient pas être considérés comme des Européens, mais n'aimaient pas non plus être vus comme des Asiatiques - et encore moins comme des musulmans. De nombreux juifs algériens s'identifiaient au contraire comme Français, et leur existence parmi les musulmans pouvait rapidement conduire à l'hostilité.

Non seulement les musulmans d'Europe sont méprisés, mais certains Eurasiens des Pays-Bas ou juifs de France redoutent profondément d'être associés à eux. Le parallèle le plus proche réside peut-être dans l'attitude de certains juifs européens occidentaux assimilés avant la guerre, vis-à-vis des juifs pauvres d'Europe de l'Est. C'était néanmoins plus un question de snobisme que de haine, de même que les juifs ashkénazes n'étaient pas craints.

L'hostilité de Zemmour à l'égard des musulmans l'a rendu populaire chez certains juifs français en raison du choc ressenti par ces derniers face aux récents actes de violence islamistes - dont le meurtre d'un rabbin et de trois enfants à Toulouse, l'attaque au couteau d'une vieille dame juive à Paris, et plusieurs autres incidents.

Mais Zemmour banalise également l'intolérance chez les non juifs. Le Pen le dit lui-même rapidement dans une récente interview pour Le Monde. Zemmour étant juif, explique Le Pen, personne ne peut l'accuser d'être un nazi, et « cela lui donne une grande liberté ». Par extension, cela confère davantage de liberté à ceux qui pensent comme Le

Liberia Feminist Forum to convene this week

- Hold several outreach activities - including its annual Meet & Greet



he Liberia Feminist Forum (LFF) will this week host its 2021 convening on the theme: Intergenerational Dialogue on Feminist Movement Building: Trauma, Resistance, and Resilience for Feminist Movement in Liberia.

The Convening will bringtogether members of the Forum to hold deliberations on the Forum's work as well as its roles and contributions to national social, economic and development of Liberia, especially the advancement and realization of women's rights and quality.

LFF is a Feminism advocacy group that speaks against human rights violations perpetrated against women and girls, and minority groups with the quest of equality for everyone.

The LFF as part of its pre-convening activities held a 'Meet and greet' and open evening with young female college students, members of Civil Society Organizations, development partners and young women leaders from a diverse background.

The purpose of these activities is to acquaint the different participants with the workings of the LFF that will help broaden their understanding of the Forum, its values and principles.

At the Meet and Greet, and Open Evening Events, held separately, the LFF provided information on the work the Forum does, feminist movement building, intergenerational perspectives and resistance.

The gatherings also created an opportunity for young women to share experiences of their journeys and how they could become more effective and deliberate about challenging injustice and power dynamics that marginalize or silence women and girls.

According to Caroline Bowah, the gathering brings together people who are interested in learning, understanding and demystifying whatever thoughts and myths about feminism and allow for strategic engagements with stakeholders in different development sectors working on gender equality and women rights.

"We host these events so we can engage with the public and address concerns and questions they have about the work we do as the Liberian Feminist Forum," she said. Madam Bowah added that the Meet and Greet with young Liberian women convening as well as the Open Evening Event with development partners, Civil Society Organizations and other Allies in Liberia are pre convening activities that allows for agenda setting for it of the LFF 2021.

We will also go into an internal convening which is for the Liberia Feminist Forum members," she said.

Narrating the historic view of the LFF at the Meet & Greet, Ms. Aisha Kamara Kolubah said the Liberian Feminist Forum (LFF) was established in 2014, during the Ebola Crisis, starting with 25 Liberian

feminists with support for the forum - African Women Development Fund (AWDF), KvinnatilKvinna (KtK) and African feminists (Zimbabwe, Uganda and South Africa). "Sisters from Liberia attended the African Feminist Forum in Ghana when they came back African countries were given the mandate to have a country forum". The two Liberian co-creators are Caroline Bowah and Korto Reeves.

She recalled that setting up the movement was a struggle because many people do not feel comfortable associating with feminism in Liberia.

Currently, the LFF has 42 women who are members and has a horizontal leadership, meaning there is no head in the Forum.

"We have a horizontal structure of leadership. We don't have a head but we have a technical working group, people with different skills that run the day-to-day activities," she stated.

The fundamental purpose of the forum was to address the lack of critical feminist positioning/analysis on human rights issues. The LFF was organized to create a safe space for Liberian women promoting a grounded feminism perspective.

Presenting on 'Intergenerational Dialogue: Building Feminist Movement in Liberia, Ms. Naomi TulaySolanke called on the young girls to embrace inclusion and diversity to excel and create their space in the society. She emphasized the importance of collectiveness and solidarity in movement building.

"We need to get rid the - I didn't do it and so I am not going to be part of it".

According to her, the intergenerational conversations and sharing through collective actions and partnership is crucial to addressing the needs of young people, people living with disabilities, older people, and people with different sexual preferences.

Additionally, she said the Liberian Feminist Forum is concerned about the wellbeing of young women and girls. "We are concerned about the way we mentor young people making sure that they are guarded, young people are protected and young people's contributions and

voices are amplified.

Also, speaking on the resistance to Feminist Movement', Elizabeth G. Johnson said lack of understanding of feminism is the main challenge to the movement. She encourages the participants to be more robust to effectively advocate for a just and equal society using their agency and voice.

"Feminist movement is not a bread and butter. It is a political stand that you are taking, challenging unequal power relations that continue to marginalize women" she said.

According to Madam Johnson, religious beliefs, and traditional and cultural practices also serves as resistance to feminist movement building. "Even in your family they will call you names. You will be the outside child," she added. But importantly, it is prudent to always counter this resistance from an informed positioning because Feminism is about equality for everyone.

Also speaking was Korto Williams, co-founder of the LFF, she further noted that the establishment of the forum has helped to provide conceptual clarity on feminism and linkages to women participation in national development processes and reawaken the enthusiasm among Liberian women to movement.

Adding that the overall goal of the LFF seeks to advocate for the transformation of all social relations of power that exploit, oppress and marginalize any set of people. The fundamental purpose of the forum was to address the lack of critical feminist positioning/analysis on human rights issues. The LFF was organized to create a safe space for Liberian women promoting a grounded feminism perspective.

The LFF challenges patriarchal norms in the Liberian society which threaten the rights of women and LGBTI people.

Facia Harris also a founding member of the Liberia Feminist Forum stated that the LFF has contributed immensely to elevating the conversation of gender equality and women rights to the national agenda, adding that before 2014 - Feminism was not word boldly or comfortably mentioned in the country, it has taken lots of efforts to deepen the ongoing conversation even though Liberian women have been contributing to development work and fight for women rights in Liberia.

The establishment of the forum has helped to provide conceptual clarity on feminism and linkages to women participation in national development processes and reawaken the enthusiasm among Liberian women to movement.

The overall goal of the LFF seeks to advocate for the transformation of all social relations of power that exploit, oppress and marginalize any set of people.

Also, as part of its reconvening activities, the LFF will launch a series featuring the 100 women's stories documenting their and remarkable impact they are making at different levels of the Liberian society.

These are women from diverse social, cultural and economic backgrounds. They lead impactful lives within their communities at the local or national levels.

The stories capture their traditional and non-traditional leadership journeys of inspiring change and breaking through barriers unapologetically.


