he Gambia's President Adama Barrow has easily won re-election, authorities there said, in the first vote for decades held without long-term leader Yahya Jammeh.

President Barrow received around 53% of Saturday's vote, with nearest rival Ousainou Darboe on 28%.

Mr Darboe and two other candidates - Mama Kandeh and Essa Mbye Faal - issued a joint statement before the final result was declared, questioning the figures.

They said they were concerned at delays and that their party agents had raised a number of issues.

Kenyan politician pledges loans for newlyweds

in Kenya has promised loans of between \$4,400 (£3,300) and \$8,800 to all newlyweds should he be elected to the top seat in next year's general elections.

Machakos Governor Alfred Mutua, who was launching his presidential manifesto on Sunday, said the low-interest loan payable within 20 years will help families "start life with dignity".

"What is the effect of all this? Dignity for all of us, improvement of the living standards and quality of homes countrywide and no more mud houses," said Mr Mutua.He also said his government would encourage

presidential aspirant Mr Mutua said during the launch that was broadcast live on local television stations.

But this promise has drawn sharp criticism and ridicule from Kenyans online.

Nearly a dozen politicians have already begun campaigns to succeed incumbent President Uhuru Kenyatta, who is on the last months of his 10 years in office.

They include veteran opposition leader Raila Odinga and current Deputy President William Ruto, who are seen as the main contenders in the August 2022 polls.

The economy, youth joblessness and fighting corruption have emerged as key issues in the agendas of those seeking the presidency, but past elections have shown that Kenyans largely vote along ethnic tribes or coalitions rather than policy issues. BBC

summit, hundreds of financial institutions declared that they would put trillions of dollars to work to finance solutions to climate change. Yet a major barrier stands in the way: The world's financial system actually impedes the flow of finance to developing countries, creating a financial death trap for many.

Economic development depends on investments in three main kinds of capital: human capital (health and education), infrastructure (power, digital, transport, and urban), and businesses. Poorer countries have lower levels per person of each kind of capital, and therefore also have the potential to grow rapidly by investing in a balanced way across them. These days, that growth can and should be green and digital, avoiding the high-pollution growth of the past.

Global bond markets and banking systems should provide sufficient funds for the high-growth "catch-up" phase of sustainable development, yet this doesn't happen. The flow of funds from global bond markets and banks to developing countries remains small, costly to the borrowers, and unstable. Developing-country borrowers pay interest charges that are often 5-10% higher per year than the borrowing costs paid by rich countries.

Developing country borrowers as a group are regarded as high risk. The bond rating agencies assign lower ratings by mechanical formula to countries just because they are poor. Yet these perceived high risks are exaggerated, and often become a self-fulfilling prophecy.

When a government floats bonds to finance public investments, it generally counts on the ability to refinance some or all of the bonds as they fall due, provided that the long-term trajectory of its debt relative to government revenues is acceptable. If the government suddenly finds itself unable to refinance the debts falling due, it likely will be pushed into default - not out of bad faith or because of longterm insolvency, but for lack of cash on hand.

This is what happens to far too many developingcountry governments. International lenders (or rating agencies) come to believe, often for an arbitrary reason, that Country X has become uncreditworthy. This perception results in a "sudden stop" of new lending to the government. forced into a default, thus "justifying" the typically takes years or even decades.

Low- and lower-middle-income countries, by contrast, borrow in foreign currencies (mainly dollars and euros), pay exceptionally high interest rates, and suffer sudden stops.

> For example, Ghana's debt-to-GDP ratio (83.5%) is far lower than Greece's (206.7%) or Portugal's (130.8%), yet Moody's rates the creditworthiness of Ghana's government bonds at B3, several notches below those of Greece (Ba3) and Portugal (Baa2). Ghana pays around 9% on ten-year borrowing, whereas Greece and Portugal pay just 1.3% and 0.4%, respectively.

> The major credit-rating agencies (Fitch, Moody's, and S&P Global) assign investment-grade ratings to most rich countries and to many upper-middleincome countries, but assign sub-investment-grade ratings to nearly all lower-middle-income countries and to all low-income countries. Moody's, for example, currently assigns an investment grade to just two lower-middle-income countries (Indonesia and the Philippines).

> Trillions of dollars in pension, insurance, bank, and other investment funds are channeled by law, regulation, or internal practice away from subinvestment-grade securities. Once lost, an investment-grade sovereign rating is extremely hard to recover unless the government enjoys the backing of a major central bank. During the 2010s, 20 governments - including Barbados, Brazil, Greece, Tunisia, and Turkey - were downgraded to below-investment grade. Out of the five that have since recovered their investment-grade rating, four are in the EU (Hungary, Ireland, Portugal, and Slovenia), and none are in Latin America, Africa, or Asia (the fifth is Russia).

An overhaul of the global financial system is therefore urgent and long overdue. Developing countries with good growth prospects and vital development needs should be able to borrow Without access to refinancing, the government is reliably on decent market terms. ULFA REACHED THIS conclusion despite assurance from the Government of Liberia to increase faculties' salaries in what seems to be clearly belated.

HOWEVER, THE REAL victims of the current disengagement by the faculty are the more 10,000 struggling students of the University of Liberia, majority of whom cannot afford fees at private universities in the country, so are stock at the state-owned University with its huge capacity gap as result of inadequate funding.

THOSE STUDENTS HAVE no choice but to endure unnecessary interruptions in their academic programs because of poor administrative leadership and decisions.

FINANCE MINISTER SAMUEL Tweah frantically made a last minute's negotiation with ULFA officials last week prior to their disengagement, asking them to return to the classroom with a promise to take charge of the payroll.

BUT HIS PLEAD did not yield any positive fruit, as the faculties abandoned lectures, demanding unpaid salaries and demeaning disparities in their monthly income.

IT IS BECOMING a trend for the Minister of Finance and Developing Planning Tweah to allow situations to reach crisis proportion before attempting to intervene somehow unsuccessfully. The case with teachers of the Monrovia Consolidated School System is one instance.

FOR GOD SAKE, can't these protests be averted by early or pro-active interventions other than carrying water when fire has already razed an entire building to the ground, as it was done with the case of the UL Faculty?

WHEN POTENTIAL CONFLICT situations are allowed to reach points of disengagement, there are always

accompanying unintended consequences or what economists called externalities, which students at the University of Liberia are currently going thru largely as a result of poor planning or failure to plan. The faculty disengagement clearly has offset the academic calendar and left students with uncertainty over when they will write exams before the Christmas holiday.

Rich-country governments that borrow internationally in their own currencies do not face the same risk of a sudden stop, because their own central banks act as lenders of last resort. Lending to the United States government is considered safe in no small part because the Federal Reserve can buy Treasury bonds in the open market, ensuring in effect that the government can roll over debts falling due.

The same is true for eurozone countries, assuming that the European Central Bank acts as the lender of last resort. When the ECB briefly failed to play that role in the immediate aftermath of the 2008 financial crisis, several eurozone countries (including Greece, Ireland, and Portugal) temporarily lost access to

To help end the sudden stops, the G20 and the IMF should use their financial firepower to support a liquid secondary market in developing-country sovereign bonds. The Fed, ECB, and other key central banks should establish currency swap lines with central banks in low-income and lowermiddle-income countries. The World Bank and other development finance institutions also should greatly increase their grants and concessional loans to developing countries, especially the poorest. Last but not least, if rich countries and regions, including several US states, stopped sponsoring money laundering and tax havens, developing countries would have more revenues to fund investments in sustainable development.

A More Perfect Turkic Union?

Russia, China, and the West have so far said relatively little about the seven-member Organization of Turkic States. But with the Eurasian chessboard becoming increasingly pivotal as great-power competition heats up, they are unlikely to remain silent for long.

BISHKEK - I still have vivid memories of my first trip to Turkey in 1993. After the Soviet Union's collapse two years previously, we Kyrgyz gained access to a world we had hitherto only imagined. We all had Turkish relatives somewhere in the West with whom we had lost contact. And there was a similar emotional reaction on the Turkish side: Turkey was the first state to recognize the independence of my country and the other Soviet Central Asian republics.

So, when I arrived at Atatürk airport in Istanbul, I approached ordinary Turks and tried to speak with them. To my disappointment, we didn't understand each other. I realized that although many elements of our respective languages were similar, differences in pronunciation and the many Persian, Arabic, and Latin words that had become a part of modern Turkish prevented me from communicating freely with the people I met. Despite a shared culture and traditions, history had separated Turkic-speaking people not only geographically and linguistically but also in essence.

But a gradual cultural rapprochement has taken place in the 30 years since the ex-Soviet Turkic states gained independence, and major powers are increasingly taking note. The latest step came at a summit in Istanbul in November, when the seven members of the Cooperation Council of Turkic Speaking States - Azerbaijan, Kazakhstan, Kyrgyzstan, Turkey, and Uzbekistan, plus Hungary and Turkmenistan as observers - renamed themselves the Organization of Turkic States.

The OTS spans 6,149 kilometers (3,821 miles) from Hungary to Kyrgyzstan and has a combined population of over 170 million and an aggregate GDP of over \$1.3 trillion. In Istanbul, the assembled leaders proclaimed that an alliance based on deep roots, kinship, brotherhood, and political solidarity would guide cooperation in economic development, trade, and investment. The countries pledged to pay special attention to strengthening their cultural and humanitarian ties.

In the economic domain, OTS members will focus on improving the transport corridors between Central Asia, the Caucasus, and Turkey, which are the shortest and most economical routes connecting China and Europe. Here, the organization's geographic location may prove invaluable.

Likewise, potential future energy cooperation among OTS states is assuming considerable geopolitical weight. Four of the seven members - Kazakhstan, Uzbekistan, Turkmenistan, and Azerbaijan - have significant hydrocarbon reserves. And Turkey is positioning itself as a hub for delivering energy resources from Russia and the Caucasus to Europe.

It is no secret that Turkish President Recep Tayyip Erdogan wants to turn Turkey into a pivotal regional player. To realize this goal, the country could pursue one of three models: pan-Islamism, neo-Ottomanism, or pan-Turkism. With pan-Islamism, the Turks have serious competitors in Saudi Arabia and Iran. Neo-Ottomanism is untenable, because Turkey has lost its influence in its former European and Asian territories. But when it comes to pan-Turkism, the country has no rivals. For example, Turkey recently cemented its special relationship with Azerbaijan by actively supporting it in its 2020 war with Armenia over Nagorno-Karabakh.

So far, there is no sign that Turkey is seeking to dominate the Turkic world, and even if it wanted to, the Central Asian states have too much geopolitical room for maneuver. Because the region is now a playground for three global powers - Russia, China, and the United States - the Central Asians are able to play them off against each other.

All states build partnerships to promote their domestic and foreign priorities. And because the Central Asian countries value their multi-vector orientation, they will not put all of their diplomatic eggs in one basket. Instead, they will continue to cooperate with Russia for historical reasons, China for economic investment, and the US for security.

Erdogan, a realist at heart, no doubt understands this, and will not seek to reorient the other Turkic countries exclusively in Turkey's direction. He is playing for more regional influence, not necessarily exclusive leadership.

Russia seems to grasp this reality, and may even seek full OTS membership. Foreign Minister Sergey Lavrov has said previously that, "I see no problems with us joining this organization." And strengthening cooperation between the ex-Soviet Turkic states and Turkey may also strengthen Turkey's bilateral relationship with Russia. Some even speculate that Turkey, instead of trying to join a European Union that has barred its door, will instead opt for the Russia-led Eurasian Economic Union, joining Kazakhstan and Kyrgyzstan (Uzbekistan is an observer).

Pres. Weah: "Is US\$15.000 price tag to identify serial killers a real solution?"

Does Pres. Weah knows he's the head-of-state, commander-in-chief of the Armed Forces of Liberia? Does he know that when something serious is happening such as the mysterious killings of innocent Liberians in the land by unknown serial killers he should address the nation? Does he know that addressing his people on issues of importance is part and parcel of his presidential duties and obligations, rather than being tight-lipped on the issue? How will President Weah feel telling these grieving Liberians to vote for him in 2023? Does President Weah think these very grieving Liberians would vote for him again with all he has done by turning his blind eyes at their plight, at the time when they needed him most in protecting their lives and that of their loved ones, and he failed them?

President Weah should know that in politics, one good gesture deserves another good gesture in return. Grieving Liberians could pay Pres. Weah in the same token as he is doing now. Furthermore, the act of President Weah putting aside taxpayer money in the sum of US\$15, 000 to solve the serial killers' issue is a complete waste of taxpayer money. Those who may have advised Pres. For its part, China has been studiously silent on the new Turkic union. But the Global Times, a newspaper published under the auspices of the Communist Party of China, recently published a commentary about the OTS that may well have expressed the Chinese government's fears. "This organization," the newspaper said, "may trigger the rise of extreme nationalism, which could intensify ethnic conflicts and hit the regional stability and security."

Moreover, it added,

"There are also groundless sayings that Uyghur people in the Xinjiang Uyghur Autonomous Region are of the same ethnic group as Turks. [...] China should remain vigilant against the spread of pan-Turkism and pan-Islamism that the Organization of Turkic States may bring about."

The plight of the Uyghur minority, a Turkic ethnic group in Xinjiang province, is undeniably a sensitive issue for China. But if the OTS serves to reinforce and deepen regional economic ties and thus strengthen Chinese President Xi Jinping's Belt and Road Initiative, it is likely to turn a blind eye to what China does in Xinjiang.

The West, meanwhile, has so far said little about the OTS. But with the Eurasian chessboard becoming increasingly pivotal as great-power competition heats up, it is unlikely to remain silent for long.

Booting them out could be a very good idea.

youth and student civil society group called the Coalition of Youths & Students for Better Liberia (COYSBL), has expressed support for the US\$800 million ArcelorMittal Mineral Development Agreement (MDA) amendment between the company and the Government of Liberia.

The group marched to the Capitol Monday, 6 December 2021 to demand passage of the MDA. The Coalition said after scrutinizing the US\$800 million ArcelorMittal Mineral Development Agreement

Amendment on 10 September 2021.

Few days ago, President George Manneh Weah presented the US\$800 million extended ArcelorMittal deal to the Legislature for ratification.

Speaking on behalf of the youth and student coalition at the news conference, the group's Chairman Jeremiah Paye stated that their analysis of the ArcelorMittal MDA Amendment indicates that a ratification of the deal by the Legislature will greatly lead to increment in the company's tax portfolio and royalties and rise in its annual support to the National Budget.



Amendment, it is convinced that the Agreement "is in the supreme interest of the Liberian People."

The group then calls for its speedy ratification by the Legislature.

Their protest comes a few days after some citizens of Nimba protested at the same Capitol rejecting the ArcelorMittal deal.

He also claimed there will be a significant reduction in unemployment in Liberia, and an increase in the company's social contributions range to affected counties (Nimba, Grand Bassa& Bong), among others.

The group has boasted of several achievements of ArcelorMittal Liberia in the last 15 years, including the provision of direct and indirect jobs for over 5,000 Liberians. Mr. Paye said Liberians currently hold 66% of the senior management positions at ArcelorMittal Liberia. He said since 2006, ArcelorMittal Liberia has spent over USD\$38m on County & Social Development

He continued: "Community Development Fund (CDF) has been launched, ensuring that 20% of CSDF goes directly to affected communities for development."

He narrated that ArcelorMittal Liberia has been contributing US \$3.0 million annually for the three counties in which it operates (Nimba, Grand Bassa& Bong)," adding that "to date, the company has paid \$45 million towards this commitment.

"AML has made a US \$40 million commitment to fund the paving of Yekepa to Ganta Highway, after the people of Nimba complained that LAMCO had not built this highway during its decades in Liberia," he continued.

On the side of healthcare, Paye disclosed that ArcelorMittal has spent \$18 million to undertake major renovations of the existing health infrastructure and upgraded health facilities in its concession area and outside of its concession areas.

Across Liberia, he said, ArcelorMittal Liberia spent \$5.52 million to help the Government respond to EBOLA and COVID-19.

Speaking of the current US\$800 Million Agreement before the Legislature for ratification, Chairman Paye listed several benefits for Liberians that he said are contained the instrument.

He said taxes, royalties, CSDF, contributions to affected communities, and other contributions by the company as contained in the MDA will be significantly increased.

The group called on members of the Legislature to speedily ratify the ArcelorMittal Mineral Development Agreement Amendment so as to rekindle confidence for private investment in Liberia.



45-years-old man, Patrick Doepoh has been incarcerated by the Liberia National Police in Pleebo, Maryland County electoral district#2 for allegedly duping several parents, and walked away with LRD 278,000.

The suspect had been working with the International Bank (IB) Liberia (Little in Monrovia for many years.

According to the victims, the incident occurred between the period August and October 2021 in the heat of registration.

Narrating their ordeals separately to the head of the criminal investigation division of the Liberia National Police in Pleebo, Rev. J. FlahnNyemah, Sr., father of student Agnes K. Nyemah, a 7th grade student

the International Bank staff has caused him more expanses because the school is demanding the fees.

Philomena Sartee, another victim of the incident narrated that in November, during the morning hours, she went to the bank (IB) to register her daughter Jackie Musa with the slip and the amount of LRD10, 000 and when she got there, she stood in the queue, but while standing, she saw Suspect Patrick, whom she described as a kinsman and asked him to assist her with the registration process by depositing the fees.

"So I gave him the money and the slip and I left, the same day he went to the market and carried the return to me but to my surprise, the registrar of the St. Francis School told me that my daughter registration wasn't processed", she disclosed.

"I was shocked and couldn't believe it because I trusted him very much until when I went to

children Isaac Dweh, Jr, Lucy Wesseh, Francis Stall, and Esther Shannon, carrying a total amount of LRD30, 885.

She details that while standing in queue inside the bank, she saw Suspect Patrick Doepoh, who impersonated as an employee of the bank asked him to help her with the registration process.

"So I gave him my children slips and monies for the registration in order for me to save time for other work".

She continues that the next day Suspect Doepoh presented several bank slips with valid stamp on them but to her greatest surprise, the registrar from the school called, informing her that the children have not been registered.

Priscilla Sartial also mentioned that on October 8, 2021 during the morning hour, she went to the Bank to register her son Frederick Sartiah with the amount of LRD2, 000 but gave the bank slip to Ophelia, a cleaner in the bank to give it to Suspect Patrick Doepoh for processing.

"When I went back to get the slip the lady told me that she gave it to Suspect Patrick and he later brought the return slip to me and said it was processed but when I went to verify, I was told that my son didn't register", she explains.

Meanwhile, on Monday, November 28,201 Police arrested Suspect Patrick, who has allegedly admitted to commissioning the act.

"It is true that the students gave me their slips at the bank as I worked there as maintenance and supervisor for the friends of international Company, when I received those slips instead of processing them through the tellers I don't know what criminally came over me".

"I secretly entered into the Bank Manager's Office, took his stamp and I stamped them and pocket the money. I received up to about LRD 278,000 but didn't report it until I was caught by the bank manager", he confessed. He has been charged with theft of property and misappropriation of entrusted funds, consistent with Section 15.50 and 15.51 of the Revised Penal Law of Liberia, and has been forwarded to the Pleebo Magisterial Court for trial.





Presentation by Chinese Ambassador to Liberia H.E. Ren Yisheng at the meeting via video link with Liberian officials and media outlets representatives

(2 December 2021, 10:00hrs)

Distinguished representatives of Liberian academic circle and China-related associations.

Ladies and gentlemen.

Opening remarks А.

Good morning! Thank you all for accepting our invitation to this meeting via video link. I have with me Counselor Xu Kun, Deputy Chief of Mission, Mr. Li Jiang, Counselor for economic and commercial affairs and Mr. Li Zhaoxin, Director for political affairs together with other colleagues from our embassy.

At the outset, I would like to take this opportunity to express our sincere appreciation for your interest in and support to the economic and social development of China, and to the China-Africa and China-Liberia friendship and pragmatic cooperation.

Please allow me to give you some update on the following points, the 100th anniversary of the founding of the Communist Party of China(CPC) and the sixth plenary session of the CPC Central Committee, building a moderately prosperous society in an all-round way (including the 14th Five-year Plan and the decisive victory in the fight against poverty), China's ecosystem construction and environment protection, the achievements of Xinjiang and Taiwan question, China-Africa relations and FOCAC, China-Liberia relations and pragmatic cooperation. Then we will open floor for comments and questions.

в. CPC centenary celebration and the sixth plenary session of the CPC Central Committee

This year marks the 100th anniversary of the founding of the Communist Party of China(CPC). Over the past 100 years, the CPC has developed from only 50 plus members at its inception to more than 95 million members today and is the world's largest socialist ruling party. The CPC has led the Chinese people in winning victories of revolution, construction and reform. China has achieved an unprecedented great leap from continuous decline to a fundamental reversal of fate and continuous progress towards prosperity and strength.

For more than 70 years since the founding of the People's Republic of China(PRC), the CPC has led our people in creating "two miracles" that have attracted worldwide attention, namely the miracle of rapid economic development and the miracle of long-term social stability that are rare in the world. By spending decades' time only, China has completed the industrialization process that Western countries have traversed for hundreds of years. The creation of "two miracles" stems from the strong leadership of the CPC.

Since reform and opening up four decades ago, China's average annual GDP growth rate is 9.4% and the contribution rate of China's economic growth to world economic growth has reached about 18%. China has become the number one engine of world economic growth. Today, China is the world's largest manufacturing country, the largest trader in goods, the largest foreign exchange reserve country, and the second largest foreign direct investment destination and source country.

Building a community of shared future for humankind. The rapid rise of China not only benefits the Chinese people, greatly changes China, but also makes important contributions to the development and progress of human society. China firmly supports multilateralism and the United Nation's central role in international affairs. CPC Central Committee General Secretary Xi Jinping, also president of PRC, has put forward a series of initiatives such as the Belt and Road initiative(B&R) and Global Development Initiative (GDI) put forward at the General Debate of the 76th UN General Assembly, advocating the building of a community of shared future for humankind, calling for a change in the global governance system and the establishment of a new international justice and equity

General Secretary Xi Jinping delivered explanatory remarks on the draft Resolution on the Major Achievements and Historical Experience of the Party over the Past Century. It was highlighted at the latest session that the Party has had a glorious journey over the past hundred years. Since its founding in 1921, the Party has made seeking happiness for the Chinese people and rejuvenation for the Chinese nation its mission. Staying committed to communist ideals and socialist convictions, it united and led the Chinese people in working tirelessly to achieve national independence and the liberation of the people and then to make our country prosperous and strong and bring happiness to the people. The endeavors of the Party and the people over the past century represent the most magnificent chapter in the millennia-long history of the Chinese nation.

The 20th National Congress of the CPC comes at an important time when the CPC has embarked on a new journey to build a modern socialist country in all respects and to realize the Second Centenary Goal. It will be a highly important meeting and an event of great political significance for both the Party and the country.

C. Building a moderately prosperous society in all respects

In the past four decades or so, China's per capita GDP has increased 65 times. China has won the decisive victory of its battle against poverty and 770 million people have been lifted out of extreme poverty. China's victory over absolute poverty means that the most populous country in the world has achieved the poverty reduction goal of UN 2030 Sustainable Development Goal(SDG) 10 years ahead of schedule. We have achieved our first centenary goal of building a moderately prosperous society in all respects.

China has embarked on a new journey of realizing the dream of the great rejuvenation of the Chinese nation by marching towards the second centenary goal when we celebrate the 100th anniversary of the founding of PRC in 2049, which is to build a modernized socialist country in an all-round way.

Since early 2020, the world has encountered a sudden outbreak of COVID-19 pandemic. China took the lead in containing the pandemic, providing technical, anti-epidemic material and COVID vaccine assistance and support to more than 100 countries and international organization including the WHO. China also took the lead in resuming the work and production. Last year, China's annual GDP came in at 101.59 trillion yuan (15.68 trillion US dollars) in 2020 for the first time in history. accounting for about 17% of the world's total, and its contribution to global economic growth was as high as 35%. And China's per capita GDP exceeded 10,000 US dollars for two consecutive years.

This year marks the beginning of China's 14th Five Year Plan and the Long Range Objective through the Year 2035. This year, China's economic growth is expected to exceed 8%. Next year, there will be two major events for China. One is China will host the Winter Olympic Games in February. The other is the 20th National Congress of the CPC will be convened in the second half of the year. Some individuals in the USA have called for the so-called "diplomatic boycott" of the Beijing Winter Olympic Games. Politicizing sports has been an abnormal norm since the Cold War. Given the state of play of China-US relations, nobody would expect China to invite US leaders to the Games. The so-called boycott is no more than a self-invented, and politically convenient, excuse for Washington.

D. Ecosystem construction and Environment Protection

As put by President Xi Jinping, lucid water and lush mountains are invaluable assets. In recent years, China has carried out a series of fundamental, pioneering and long-term work, accelerated the promotion of the top-level design of ecological civilization and the construction of institutional systems, strengthened the construction of the rule of law, established and implemented the central environmental protection inspection system, and vigorously promoted green development. China has achieved remarkable results in tackling desertification, air, soil and water pollution, and in developing such clean and green energy as solar power and wind power.

According to the report released by FAO, China has increased an average of 1,937,000 hectares of forests every year in the past 10 years, with a growth rate of 0.93%, much higher than that of other countries.

So far, more than 140 countries including Liberia and over 30 international organizations have signed on B&R cooperation document. According to relevant World Bank reports, by 2030, the "Belt and Road Initiative" is expected to help 7.6 million people around the world get rid of extreme poverty and 32 million people out of moderate poverty. It will increase global trade by 6.2% and the trade of economies along the route by 9.7%, and global revenue by 2.9%.

The 19th Central Committee of the Communist Party of China convened its sixth plenary session in Beijing from November 8 to 11, 2021. At the session, the Central Committee heard and discussed the report on the work of the Political Bureau, presented by General Secretary Xi Jinping on behalf of the Political Bureau, and considered and adopted the Resolution on the Major Achievements and Historical Experience of the Party over the Past Century and the Resolution on the Convocation of the 20th National Congress of the Communist Party of China. Over the past 100 vears, the CPC has adopted three resolutions related to historical issues, in 1945. 1981 and 2021 respectively. They have analyzed the causes and drown conclusions on important historical events and figures, through which the whole Party come to a clear consensus and thus grow stronger in unity.

For many years, China has been carrying out projects to prevent and control desertification and return farmland to forests in the vast western and northern regions. In April this year, state media reported that the Maowusu Desert, one of China's four major sandy lands, was "about to disappear".

China is firmly committed to working together with other Parties to strengthen implementation of the Paris Agreement. As the largest developing country, China is making arduous and exceptional efforts to achieve the modernization goal by the middle of this century while realizing low-carbon and green development. China has promised to strive to peak carbon dioxide emissions by 2030 and achieve carbon neutrality by 2060.

Xinjiang-related issues and Taiwn question

For some time, out of prejudice, ignorance and even malice, a small number of politicians, media outlets, and scholars in some Western countries have spared no effort to fabricate the so-called human rights issues of Xinjiang by spreading such rumors and lies as "genocide", "forced labor", "re-education camps". These smearing attacks without a bottom line and a convincing basis seriously violate international law and the basic norms of international relations, and blatantly violate justice and conscience.

Facts prove that "genocide" is the biggest lie of the century. Over the past 40 years,

iberian Embassy official assigned to ∎the country's diplomatic mission in Abuja, Nigeria, has alleged that his seven year - old daughter has been raped right on the Embassy's premises by two perpetrators.

Mr. Nat Bayjay, Minister Counselor for Press and Public Affairs at the Liberian Embassy in Abuja, Nigeria says his daughter, aged just 7 at the time, was unfortunately sexually abused over a period of seven months by two different perpetrators.

He said in a press statement issued Monday, 6 December 2021 that he had to come public because all efforts he has applied diplomatically to get the attention of relevant authorities to particularly care for his daughter's welfare have only produced no response.

Mr. Bayjay, a Liberian journalist who has Public Affairs department, Mr. David Akoi, for comment. Mr. Pewee could not be reached via phone, while Mr. Akoi's numbers rang without an answer.

Throughout his press statement, Mr. Bayjay did not name those he alleged to be the perpetrators of the rape incident against his daughter.

He explained that after being raped at the Embassy by two of its residents, this barbaric act was confirmed by medical doctors and the Nigerian police after which he formally complained same to the Liberian Ministries of Foreign Affairs and Information.

Nat said as if that wasn't enough shock for the little baby and his entire family, his colleague whose wards committed such a heinous crime against the victim showed absolutely no remorse over the very unfortunate incident.

"The worst shock came when our Liberian Ambassador, mv own direct boss Professor Al-Hassan Conteh with whom I have



transitioned to public service, has lamented that the situation has made closure on such a traumatizing incident to be yet far off and continues to haunt his family.

"These two perpetrators

had very excellent and cordial professional and personal relationships, so terribly intervened in the matter in which he was unfortunately bent on protecting the perpetrators rather than the victim," Mr. Bayjay explained.

and Tourism which seconded me to the Embassy, the Honorable Minister of Foreign Affairs initially expressed his disappointment especially in the Ambassador's refusal to have him informed on the matter within three weeks of the incident," said Mr. Bayjay.

According to him, the Foreign Ministry sent a threeman investigative panel to Abuja.

Bayjay also alleged that the three - man panel's report was so tailored in protecting the role of the Ambassador whose mishandling of the situation got the Liberian Government to even commit already scarce financial resources to do an investigation of three officials of the Ministry of Foreign Affairs.

"I also want to use this time to state that the Ambassador Jarjar Kamara Report only amounted to nothing more than a diplomatic appeasement, all aimed at protecting Ambassador Conteh at the expense of us the victims," he alleged.

He claimed that the likes of Ambassador Jarjar Kamara are only concerned about protecting their own clique at the expense of any victimized situation.

While I'm in Monrovia for the past two months to pursue the justice aspect to this matter, Bayjay said he keeps getting calls from his family over his young daughter's declining health back in Abuja, causing the kid to miss out on school for several days.

He said for the past 8 months, he has been asking the Liberian Government to take full responsibility of catering to the child's wellbeing while pursuing justice.

But he said his request has been completely ignored right from when such an alarming matter finally came to his attention since April 17, 2021.

"As we are aware of the ong process of litigation, why can't cater to the welfare of this innocent child solely on humanitarian grounds? Why if this litigation lingers for a year, we the family [remain] the only one to be going through the financial stress of her health which is already in a poor state?" Bayjay ponders. He has launched an appeal to all female advocacy groups, including the Association of Female Lawyers Association of Liberia (AFELL) and the Female Journalists Association of Liberia (FeJaL) in standing up for his daughter.--Press release




