

Sudan's prime minister resigns after mass protests

udan's Prime Minister Abdalla Hamdok has resigned after another day of mass protests rocked the capital Khartoum. Thousands marched against a recent deal he had done to share power with the army, who staged a coup in October. Chanting "power to the people", protesters called for a return to full civilian rule. But military forces again responded with force, leaving two people dead.

Mr Hamdok's decision to guit leaves the army in full control.

It is another blow to Sudan's fragile attempts at a transition to democratic rule after a popular uprising led to the overthrow of Sudan's long-term authoritarian President Omar al-Bashir in 2019.

In a televised address, Mr Hamdok said the country was at a "dangerous turning point that threatens its whole survival".

He said he had tried his best to stop the country from

that "despite everything that has been done to reach a consensus... it has not happened". Civilian and military leaders had made an uneasy power-sharing agreement after

the army staged a coup on 25 October and initially placed Prime Minister Hamdok under house arrest.

Ivory-burning conservationist Richard Leakey dies successfully ran a number of

world-renowned Kenyan conservationist and fossil hunter has died aged 77.

His groundbreaking work contributed to the recognition of Africa as the birthplace of humankind.

He also spearheaded campaigns to stop poaching in Kenya, famously burning the country's stockpile of poached ivory. Kenyan

Leakey served in various positions in the Kenvan government including the National Museums of Kenya, the Kenya Wildlife Service and as head of the civil service.

"Besides his distinguished career in public service, Dr Leakey is celebrated for his prominent role in Kenya's civil

Leakey followed in his parents' footsteps in paleoanthropology - the practice of seeking to understand human evolution by studying fossils and ancient tools.

In his 20s, Leakey made his own important finds, and in two ground-breaking books (Origins and People of the Lake), he explained the emergence of Homo erectus, an ancestor of modern

His work contributed to the growing body of evidence that the earliest humans had lived on the African continent.

In 1981, he fronted a seven-part BBC television series called "The Making of Mankind", which made him a household name.

In the late 1980s, he switched careers to take over as head of Kenya's Wildlife Service at a time when poachers were wiping out the country's entire elephant and rhino populations.

He told his rangers to shoot poachers on sight and organised the spectacular public burning of a huge haul

man has been arrested after a large fire severely damaged the Houses of Parliament in the South African city of Cape Town. The suspect, who is not a parliamentary employee, will appear in court on Tuesday, facing charges of arson, housebreaking and theft, police said.

Firefighters worked for hours to extinguish the blaze.

President Cyril Ramaphosa called it a "terrible and devastating event", as he vowed parliament's work would continue. Footage from the scene on Sunday showed a plume of black smoke filling the sky, with huge flames coming out from the roof of the building.

Officials say the fire started on the third floor offices and quickly spread to the National Assembly (the parliament's lower house) chamber, reports the BBC's Nomsa Maseko in Cape Town.

The parliament is not currently in session because of the holidays, and no-one was injured.

However the building is home to thousands of treasures including historic books, photographs and important works of art. There is particular concern that the valuable Keiskamma Tapestry, which is 120m (394ft) long and documents South Africa's history, may have been damaged or destroyed.


Police say the suspect, who reportedly entered the building through a back window, is expected to be charged under the National Key Points Act, which protects sites of strategic importance.

Stop Scapegoating Care Workers

In the United States, the United Kingdom, and elsewhere, nursing home staff are increasingly being blamed for the pandemic's death toll. But accusing front-line care workers merely highlights - and compounds - the widespread failure of the public and policymakers to take their responsibilities seriously and behave accordingly.

ASHINGTON, DC - After a two-year pandemic, with the Omicron variant raging and uncertainty ahead, there is an understandable desire to blame someone for the appalling death toll from COVID-19. And in the United States, the United Kingdom, and elsewhere, fingers are increasingly being pointed at nursing home workers. As one recent prominent study puts it, "Nursing home staff are considered to be a source of severe acute respiratory syndrome coronavirus 2 (SARS-CoV-2) infection in nursing homes."

Such statements are not only unfair at the individual level; they are also the wrong way to think about how to avoid deaths in the future. It would be much better to face our broader social responsibilities, to consider other sources of viral spread such as hospitals and nursing home visitors, and to spend more resources building trust in public-health systems.

People live in nursing homes because they have no alternative, either because they are recovering from surgery (often, for many people over the age of 80, after a slip and fall), or because they have a long-term condition that requires continuous medical attention. Nursing home residents require daily care from trained nurses and other skilled personnel. This is always hard work, and when a pandemic arrives, it is also dangerous.

Most nursing home staff have gone to great lengths to protect themselves, their families, and the people they care for. But remember that, at the start of the pandemic, they could not even be provided with properly functioning masks. Nursing homes were also a low priority for receiving regular COVID-19 tests.

Even as these resource deficits have been addressed and wages have been increased (from initially low levels), many nursing homes remain short of staff. The people who go to work there every day should be lauded as heroes and provided with every protection imaginable, including help with safe commutes and safe living arrangements. Increasing their pay further would be an appropriate step in the right direction.

Visitors are extremely important to nursing home residents, and the near complete isolation requirements of 2020 were devastating in myriad ways. However, nursing homes need to be empowered to screen and restrict visitation when it is not safe for vulnerable residents. With Omicron driving case numbers to new heights, unvaccinated and COVID-positive visitors currently pose a severe threat to nursing homes.

Hospitals are the crown jewels of any health system, and countries have gone to great lengths - including with costly lockdowns - to keep them functioning. But hospitals are often held to a different (less demanding) standard than nursing homes for use of personal protective equipment and testing of employees, patients, and visitors. The extent of infection control, even in major hospitals, needs the same level of scrutiny as in nursing homes. Any well-functioning health system needs to ensure the safety of both types of facilities.

Obviously, we all want the pandemic to go away. The best way to achieve this is to increase the rate of vaccination and to ensure that the uptake of boosters, when appropriate, is as high as possible. Rates in the US state of Massachusetts are encouraging, including universal vaccination of nursing home staff and the country's highest rate for boosters.

Massachusetts nursing homes were fortunate to be included in a pilot COVID-19 testing initiative, run by the Broad Institute, as early as April 2020. This led to a greater understanding of asymptomatic spread and improved infection control across the state. By August 2020, universal testing protocols for nursing homes were in place, supported financially and logistically by the state's Department of Public Health.

Currently, all nursing home employees and contractors in Massachusetts must have a weekly PCR test, and when a case is detected, all staff and residents are tested every three days. The state's nursing homes are also supplied with, and encouraged to use, rapid antigen tests. And, in addition to universal vaccination, masking requirements protect staff and residents. As much as possible, these actions have helped to eliminate staff as the source of infection for residents.

But what about everyone else in the community? Nursing home workers, hospital staff, and family members who visit hospitals and nursing homes all contract the virus primarily from friends and family, with whom they interact indoors, particularly during meals.

Anyone who is not vaccinated is contributing to community spread and increasing the probability that the coronavirus will reach vulnerable people, either in a care home or elsewhere. Spreading the virus also has a significant economic impact as exposure and infection exacerbates labor shortages, including of health care workers in all areas. Indeed, the greatest current threat to vulnerable residents is lack of staff to care for them.

Misinformation and disinformation have confused people about the value and safety of vaccines, endangering the lives of nursing home workers and vulnerable people everywhere. Blaming those on the front line of care merely highlights - and compounds - the widespread failure of the public and policymakers to take their responsibilities seriously and behave accordingly.

Given these complex policy conditions, ECB President Christine Lagarde's careful approach appears to be as sound politically as it is economically.

Is the late Cllr. Brumskine weeping in his grave? **Funeral Announcement**

"The LP version of the Mandingo-Liberian party began a very strong crusade that later brought in thousands and thousands of Mandingos from Guinea, Lofa County, and Ganta to fortify the Mandingo-Liberians' wing of LP by recognizing the ANC political leader Cummings as the CPP standard-bearer who will, in turn, nominate Musa Bility as Vice Presidential Standard-bearer on the CPP ticket in the 2023 election. This dangerous maneuvering strategy eventually disables and paralyzes Nyonblee-Karnga-Lawrence and Dillion for seeking any political future political office in the LP now and/or in the future. The Bassa wing of the LP will be dismantled by this political plan thus making Nyoblee and Dillon useless party instruments. This is what the fight is all about according to our sources."

Phase II of the LP crisis is directly associated with the late founding father Cllr. Brumskine according to the same family sources. "Before his demise in 2019, the late Cllr. 

Man jailed for murder, rape of 13yr old girl

he Liberia National Police (LNP) has ■ investigated, charged and sent to court a 31 - year - old man identified as Abraham Wento for allegedly raping to death a 13 - year old girl in Boys Town, Lower Margibi County.

A police charge sheet released Monday, 3 January 2022 stated that defendant Abraham Wento has been forwarded to court for the crimes of rape, murder, felonious restraint and abuse of corpse.

"In view of the foregoing facts and circumstance, coupled with defendant Abraham Wento's voluntary statement of admission, this investigation has resolved to charge defendant Abraham Wento with the crimes of

murder, felonious restraint, and called the victim under the abuse of corpse," the police some work for him.

The police indicated that the crimes are in violation of Chapter 14, Sub-chapter "A," Section 14.1, 14.70, 14.51 and Chapter 18.12 Section of the Revised Penal Code of Liberia, pending court trial.

The police noted that on 11 December 2021 during the evening hours, the victim was sent by her guardian, Patricia Golo, into the community to buy peanut butter intended for cooking soup and rice.

Accordingly, the victim went to a neighbor's house to buy the peanut butter when she went missing. Police in Boys Town were said to commence a search for the victim.

According to police, defendant Wento purposely, knowingly and intentionally pretense of sending her to do

He allegedly sent the victim to pick up his phone which was in his room. Police said as soon as the victim entered the defendant's room, the accused allegedly followed her and choked her until she died.

The police investigation disclosed that on 13 December 2021 during the evening hours, the victim's lifeless body was discovered in a swamp behind Mr. George Yeagar's house by residents of the community.

The victim's body was examined and deposited at the John F. Kennedy Medical Hospital where a post mortem examination was conducted by the county coroner of Montserrado, police added.



La BCE et le retour à l'orthodoxie monétaire

TANFORD - En décembre, les principales banques centrales ont annoncé qu'elles allaient mettre fin au relâchement monétaire. Mais il y a une exception, la BCE (Banque centrale européenne) qui n'envisage pas d'augmenter les taux d'intérêt en 2022, et ceci malgré le risque inflationniste.

Par contre la Fed (la Réserve fédérale américaine) prévoit de relever son taux directeur à trois reprises cette année, tandis que la Banque d'Angleterre a déjà augmenté son principal taux directeur de 15 points de base. Par ailleurs, pour rester fidèle à sa promesse de ne pas augmenter ses taux avant d'avoir redressé son bilan, la Fed va accélérer la réduction progressive de ses achats d'actifs.

Pour autant, la BCE est-elle laxiste face à l'inflation et joue-t-elle le rôle de la colombe parmi les principales banques centrales du monde? Le plus grand tabloïd allemand, Bild, a-t-il raison de se moquer de Christine Lagarde, la présidente de la BCE, en la surnommant "Madame Inflation"?

Non, trois fois non! Bild reflète l'opinion allemande traditionnelle selon laquelle la BCE doit se préoccuper quasi exclusivement de l'inflation, mais ce point de vue est totalement dépassé dans l'Europe de 2022.

Lagarde sait que l'arrêt des mesures de relance monétaire après une crise est une opération délicate. Faisant grimper le coût du crédit et étouffant la reprise des pays membres surendettés comme l'Italie, l'Espagne et la Grèce, une hausse trop rapide des taux d'intérêt pourrait entraîner l'éclatement de la zone euro. Les économistes parlent de "risque de fragmentation". Cette fragmentation est un problème chronique pour la zone euro, car contrairement à la Fed et à la Banque d'Angleterre qui sont toutes deux soutenues par une autorité budgétaire unique, la BCE fonctionne avec 19 autorités budgétaires indépendantes.

C'est peut-être ce à quoi pensait Lagarde lors de sa conférence de presse de décembre, quand elle a expliqué qu'il fallait avancer graduellement vers une politique monétaire plus resserrée pour éviter une "transition brutale". Il n'est pas surprenant que cette déclaration ait provoqué une réponse glaciale du président sortant de la Bundesbank, Jens Weidmann, un partisan résolu de l'orthodoxie budgétaire. Le nouveau ministre allemand des Finances, Christian Lindner, penche dans le même sens. Il estime que la sensibilité de la BCE au coût des prêts aux pays membres surendettés pourrait la conduire à une lenteur excessive pour mettre fin aux mesures de relance.

D'une certaine manière Lindner a raison. Lagarde n'est pas pressée de resserrer la politique monétaire, car elle tient à préserver l'intégrité de l'union monétaire lors de la réduction des mesures de relance. Comme un médecin consciencieux, elle ne veut pas précipiter le sevrage d'un toxicomane accroché à un produit fortement addictif. Il ne faut pas s'y tromper, les mesures de relance de la BCE ont eu un effet majeur sur l'économie - au point qu'elle en est devenue dépendante.

Toujours avisée sur le plan politique, Lagarde sait que l'opinion publique ne régirait pas favorablement à une politique monétaire qui menace de fracturer la zone euro alors qu'elle a créé un fonds de relance de 750 milliards d'euros pour maintenir sa cohésion. Un arrêt trop brutal de la politique de relâchement monétaire serait dangereux tant sur le plan économique que politique.

La plus grand risque de fragmentation vient aujourd'hui de l'Italie, avec ses 2600 milliards d'euros de dette publique et une longue histoire d'instabilité politique. Cette situation appelle à la plus grande prudence. Jusqu'à présent les investisseurs semblent satisfaits du leadership de Mario Draghi, le Premier ministre italien. Mais ils craignent un retour de l'instabilité politique si ce dernier démissionne pour viser la présidence (essentiellement une fonction de représentation) après le départ imminent de Sergio Mattarella, le président actuel.

Les marchés financiers ont déjà tremblé à l'issue de la conférence de presse de fin d'année de Draghi en décembre, quand il a laissé entendre qu'il pourrait démissionner prochainement. Pourtant les investisseurs ne devraient pas s'inquiéter, car il est peu probable que Draghi devienne le prochain président italien. NEC Floyd unleashes "dogs" (Pt2)

ust at the time the National Elections Commission (NEC) Chairperson Davidetta Brown-Lansanah is still challenging the Liberia Anti-Corruptions Commission (LACC) investigative report in Court, sources have hinted this paper that two commissioners have begun battling for the top seat.

One of the two commissioners battling to take over from Madam Davidetta Brown-Lansanah should her dismissal request go through is Mr. Floyd O. Sayor, the Commissioner at the centered of the US\$2.8 million excess in the NEC budget memo.

Mr. Floyd Sayor has told the Frontpage Africa newspaper here that the memo was Davidetta Brown-Lansanah trying to bring him down with her instead of leaving as she has been asked

Commissioner Floyd Savor oversees the NEC data Center and was very instrumental in the acquisition of the Thermometers which he negotiated with the Tuma Company before drawing in his boss who is now facing conflict of interest charges.

Sources within the corridors of NEC told this paper that the actual amount of US\$182,000, was requested by Floyd Sayor as one with oversight over the **NEC Data Center.**

Floyd Sayor's connection with Tuma was flagged in the initial report by the Daily Observer, although it was alleged that he owe the company, a claim he truthfully denied.

According to the paper, Floyd Sayor, declined to speak on the transaction and rather chose to exonerate himself.

"I am not here to speak to the details pertaining to the transaction on the modern facial recognition and temperature testing machines, but what I have to say is that I have no link in ownership to Tuma Enterprises," Sayorwas quoted by the Oberver as saying.

He narrated to the paper "that being an IT expert and with his wealth of knowledge and experience as well as his long-standing service at the NEC, dating as far back as 2004, he has lots of connections with IT professionals and businesses in the country.

"I know the law. Under no condition, I will do it. I don't have any interest in owning an IT Company now. Maybe in the future, when I am no

longer at NEC, I may own one because I have to live by my education."

Sayor was head of the IT department at NEC when Jerome Kokoya was chairman of NEC and he spearheaded all data management activities all through 2017 and even before then.

During his tenure as head of the NEC data center, Floyd Sayor was accused by disputing political parties of manipulating the voters roll, which led to a Supreme Court ruling that it should be cleaned before the conduct of the run-off elections.

Last week in an attempt to hit

allegation, NEC had been embroiled with a conflict of interest saga with its chair Madam Davidetta Browne-Lansanah at the center, as the Liberia Anti-Corruption Commission (LACC) bashes on the electorial body in what appears to be a selective corruption fight.

In their write up in defense of Floyd Sayor, the so-called hire civil society group describe the New Dawn publication as false and misleading but yet went ahead to admit the existence of the internal memo.

Although Floyd Sayor declined to speak to this paper following multiple calls and messages on both his mobile number and WhatsApp, on Wednesday December 29, 2021, the so-called civil society group which has little or no legal existence and business registration were allegedly hired to do for him a damage control and while at the same time defaming the paper and NEC.

Prior to Floyd's US\$2.8 Million

But Mr. Cummings who has repeatedly dismissed this allegation told the BBC that at no time did him and others conspired to alter the said framework paper.

"We did not conspire or altered the framework document. The document was

alleged amended document queried as why he would want to alter a document that equally affects him as it does everybody else within the collaboration.

"This is why this is baseless. It is actually political. But we will when we actually receive the writ as a legal abiding citizen, we will make ourselves available to whatever the processes are as per our lawyers' recommendation.

Meanwhile, in the writ of arrest, the court commands its officers to arrest the living bodies of Mr. Alexander B. Cummings and others to be identified and have them brought before the Monrovia City Court at the Temple of Justice to answer to the crimes of forgery and criminal conspiracy.

The court said based upon the writ and complaints filed by the Republic of Liberia through the All Liberian Party, substantial allegations were made, noting that during the period of May 2020 and including July 2020, the defendants purposely connived, conspired and jointly altered the CPP framework document of the

The court noted further that the defendants deceived the private prosecutor and the public regarding the content and averments of the documents.

The court said the alleged act of the defendants being unlawful, wicked, criminal, illegal and intentional, it is in violation of Section 15.70 and 2 of the New Panel Law of Liberia. By Othello B. Garblah and Lincoln Peters

The Court subsequently issued the arrest order against Mr. Cummings Monday, 3 January
