The paradox of Pres. Weah's reconciliatory message

EDITORIAL

IN HIS 5TH Annual Message to the 54th Liberian Legislature on Monday, 24th January President George Manneh Weah rallied Liberians not to allow politics divine the nation to the extent of destroying it. But this is exactly the posture the President has adopted.

MR. WEAH IS allowing politics to blind his eyes to reality that this country is so divided to the extent that reasoning among Liberians as one people does not count anymore.

THE PRESIDENT DISAPPOINTINGLY led his entourage of ruling party officials to kick off celebration of Liberia's Bicentennial at the Providence Island in Monrovia without inviting the opposition bloc and the religious community, but blamed it on organizers of the program. Liberia's 200 years of existence as a country is not owned exclusively by a six-year administration but all citizens irrespective of social, economic, political and religious affiliation so they should be involved.

When President Weah constantly ignores cries of the people of Lofa for their Senator-elect, Brownie Samukai to take his seat in the Senate and restitute soldiers' money that he expended on official purpose, which has effectively denied that county from being fully represented under his administration then what does genuine reconciliation mean to this government?

OTHERS MAY ARGUE that the issue of Senator-elect Samukai is a rule of law matter that the President should stay clear of. Rightly so; but true reconciliation goes deeper than mere lip service especially, when citizens are on bended knees, begging for mercy.

THE ADMINISTRATION HIDES under the rule of law and go after perceived enemies, but looks the other way when endemic corruption is practiced from the highest office down to the National Port Authority, the Liberia Water and Sewer Corporation, Liberia Anti-Corruption Commission and other public entities under its watch because of nepotism and partisanship.

AS HEAD OF STATE, the President has neither called for a meeting with the opposition nor solicited their views and perspectives on matter of state. He seems more interested in throwing jibes and going to studio to produce music than uniting Liberians yet he is calling for unity.

FROM LOFA TO BONG and Nimba Counties citizens are aggrieved but they have no opportunity to sit in a town hall meeting with the Leader of the Land to express their grievances yet he asks Liberians to walk in peace continuously.

THE ROAD TO PEACE, reconciliation and unity is like a triangular path where all sides should come together to discuss, instead of the leader standing far away or sitting in his comfort zone and sending olive branch.

GENUINE RECONCILIATION requires an open mind, a listening heart and sincerity for national healing to take place. The talk should be matched by action.

Economic Sanctions Won't Bring Peace to Ethiopia

DDIS ABABA/CHICAGO - The recent decision by US President Joe Biden's administration to revoke Ethiopia's eligibility for the African Growth and Opportunity Act (AGOA) has revived the debate over the effectiveness of imposing economic sanctions on poor countries. The administration cited "gross violations of internationally recognized human rights" in the conflict in northern Ethiopia as the basis for the move. But it is unclear how Ethiopia's exclusion from the program will end the violations, especially given the involvement of multiple state and non-state actors in the conflict.

AGOA offers eligible countries in Sub-Saharan Africa duty-free access to the US market for selected products. Ethiopia stands to lose preferential access to a market segment worth \$240 million, which is equivalent to roughly 9% of the country's total exports. The loss will be felt most acutely by the apparel and leather industries, which employ around 200,000 people, most of whom are women.

In general, there is little theoretical support for using international economic sanctions to influence governments' domestic political behavior. What explanations there are derive from the Heckscher-Ohlin model of international trade, according to which a country benefits from exporting goods produced with its most abundant resources and importing goods that use resources that are scarce. If sanctions are imposed and trade is limited, the country's supply and demand balance will be disrupted and overall welfare will decline something political leaders would like to avoid.

Si personne ne remet en question qu'il fut sage d'emprunter pour répondre à une urgence de santé publique et à la menace d'une crise économique, ces lourdes dettes posent des problèmes de gestion. Les maigres ressources budgétaires qui pourraient sinon être allouées aux soins de santé, à l'éducation et aux infrastructures vont être aspirées par le service de la dette. Et le poids de celle-ci ira croissant à mesure que la Réserve fédérale des États-Unis durcira sa politique monétaire et que se raréfieront les capitaux à l'échelle mondiale, c'est-à-dire qu'augmenteront les pressions à la hausse sur les taux d'intérêt.

La dette publique n'est en outre qu'une partie du problème. Depuis l'apparition de la pandémie, les dettes des ménages et des entreprises non financières ont augmenté presque aussi vite que celles des États. Lorsque ces débiteurs s'avéreront À ce stade, cet argument ne relève que de l'hypothèse. socialisées et pèseront sur les bilans des finances publiques.

Un autre facteur devrait inciter au scepticisme concernant le consensus sur les marchés émergents : les risques de la promiscuité au travail poussent à l'accélération de l'automation dans les économies avancées. Comme la nécessité d'une étroite coordination occulomotrice entravait encore, voici peu, ce type d'évolution, l'exportation des industries manufacturières à forte concentration de maind'œuvre constitua longtemps la voie traditionnelle d'augmentation des revenus sur les marchés émergents et dans les pays en développement. Si ces industries ne demandent ni de lourds investissements ni une main-d'œuvre hautement qualifiée, elles ont le mérite de familiariser cette dernière avec la discipline de l'usine, de permettre la formation par l'apprentissage, d'acclimater les entreprises à la concurrence sur les marchés mondiaux et de rapporter des devises.

Il est à craindre que ces produits manufacturés soient très bientôt fabriqués par des robots et des imprimantes 3D, dans les pays mêmes où ils sont vendus. Une telle perspective renforce les inquiétudes déjà formées quant à la « désindustrialisation prématurée » des marchés émergents.

Concomitamment, les chaînes d'approvisionnement, dont l'importance pour les économies émergentes est cruciale, connaissent, du fait de la pandémie, des perturbations importantes, qui conduisent les entreprises à rechercher des facteurs de production plus proches. Les gouvernements des pays développés arguent quant à eux de leur sécurité économique pour justifier les incitations qu'ils mettent en place afin de rapatrier une partie de la production manufacturée.

Pour les marchés émergents, les effets négatifs ne sont pas sans ressembler à ceux de l'accélération de l'automation. Nombre de pays à revenu faible ou intermédiaire commencent par des tâches d'assemblage simples avant de s'engager dans des opérations de fabrication plus complexes. Les occasions de ce type se raréfieront si les économies développées assemblent plus de biens chez elles.

Le Mexique pourrait tirer profit des efforts consentis par les sociétés aux États-Unis pour contracter leurs chaînes d'approvisionnement. Les pays d'Europe de l'Est pourraient aussi bénéficier d'une dynamique analogue dans les pays de l'Union européenne. Mais l'Asie du Sud, l'Afrique et l'Amérique latine pourraient se trouver évincées.

Et surtout, il faut compter avec les conséquences du Covid-19 sur la formation du capital humain. Si ses effets sont partout négatifs, ils le sont encore plus sur les marchés émergents, où la bande passante à grande vitesse, nécessaire pour dispenser un enseignement à distance correct, est une denrée rare. Le rythme plus lent des vaccinations va se traduire par la prolongation des fermetures de classes dans les établissements d'enseignement et par la multiplication des absences. Selon une estimation de la Banque mondiale, la proportion d'enfants de dix ans ne sachant ni lire ni comprendre un texte simple passera dans les pays en développement de 53 % à 63 % du simple fait de la

L'objection la plus convaincante à ces prévisions pessimistes résiderait dans le dopage d'après-crise de l'économie mondiale, qui profiterait aux marchés émergents. La croissance de la productivité dans les économies avancées, qui marquait un ralentissement depuis plusieurs décennies, fut soutenue durant la pandémie, notamment aux États-Unis. Les évolutions technologiques et structurelles induites par la pandémie pourraient désormais entretenir cette accélération. Une croissance plus rapide dans les pays développés créerait ainsi une demande supplémentaire pour les exportations des marchés en développement.

insolvables, il est probable que les pertes seront La hausse récente de la productivité dans les économies avancées est entièrement imputable à des facteurs conjoncturels - pour les plus récents d'entre eux à l'utilisation plus intensive de leurs ressources par les entreprises au moment des rebonds qui ont suivi les dépressions enregistrées en 2020. Police send 2 murder suspects to court

he Crime Services Department (CSD) of the Liberia National Police in Maryland county has charged and forwarded to court two suspects in connection with the alleged murder of a 51-vear- old Peter Huggins, resident of Bunger Hill, Community East Harper in Maryland.

Suspects Alfred Sackor Mombou, age 34, and 19year-old Brown B. Dalieh, Jr,

were charged and sent to court substances in a mortar by on Tuesday, January 25, 2022, for allegedly beaten Peter Huggins, Jr. on January 19, 2022, resulting to his death.

Speaking to the Liberia National Police on Wednesday, January 19, 2022, the spouse (girlfriend) of the victim, Felecia George, narrated that at about 7:45 to 8:00PM, her boyfriend, the late Peter Huggins, Jr. was allegedly beaten with a mortar pestle in his chest and back.

A pestle is a simple tool used to pound ingredients or crushing and grinding them for cooking or other purposes.

Few days after the incident, Felecia said reported to the Police in Harper that her fiancé had suddenly died following his flogging.

She continued that the suspects and her boyfriend had a fist-fight after which he didn't recover until his demise.

Explaining also, 56-yearold eyewitness Samuel A. Williams, a retired sheriff of the Fourth Judicial Circuit court in Harper, told police investigators that on Wednesday, January 19, at about 8:00pm, while at his residence, he heard noise from the residence of the late Peter Huggins, so he and others community dwellers ran there to find out what was happening.

"When I got there, I saw the late Peter Huggins coming towards me, asking for help and it was the only thing he kept repeating. Because I know he is[was] mentally challenged so I started to convince him to go home but

Give zogoes attention

-Apostle Kromah tells gov't following 29 deaths at crusade

he General Overseer of the World of Life Outreach International Ministries Apostle Abraham Kromah who's three - day night - time crusade ended tragically with 29 deaths has called on the government here to pay key attention to drug abusers who are also known among Liberians as zogoes or disadvantaged youths.

Speaking late Wednesday night on his radio station, Vision FM 102.1, Pastor Kromah expressed deep sadness over the incident. saying he is broken and disappointed about those that lost their lives in a stampede that occurred when zogoes invaded a sports pitch where the crusade was held on Bushrod Island.

"Please, to the Government of Liberia, please do all you can within your power and give attention to those disadvantaged youths or "zogoes" in the street," said Pastor Kromah.

"Please do all you can to protect your citizens. Please, above all, try and get them off the street so that you can save the lives of your citizens.

Once again, I am deeply sorry, broken and disappointed about the loss of lives," he continued.

He said it was never his wish and thought for the crusade to be as it went, adding that he is broken and saddened by the deaths.

Pastor Kromah condemned the situation and the way in which his people died, but also prayed that the souls of the faithful rest in peace.

Liberian health authorities have confirmed the deaths of at least 29 persons following the stampede that occurred at the overcrowded crusade when Christian worshipers were reportedly invaded by drug abusers or street gangs armed with deadly instruments intended to incite fear, wage terror and steal from people.

The three-day night-time crusade was organized at the D. Twe Memorial High School soccer pitch in New Kru Town on Bushrod Island by the Word of Life Outreach Ministry senior pastor Apostle Abraham Kromah, popularly known as

A moment after the service climaxed during the night, the drug abusers attacked worshipers attending the service with machetes, knives and other deadly weapons and made away with the loot.

Instructors end go-slow at BWI

ollowing intervention from the Government of Liberia through the Civil Service Agency, the Ministries of Finance and Education and the BWI Administration, protesting teachers at the Booker Washington Institute (BWI) in Kakata, Margibi County have called off their go-slow on campus.

On Monday, January 24, 2022, academic instructors of the institute, who were supposed to commence administering mid-term exam, halted all academic activities in demand of increment of incentives.

The go-slow lasted up to Wednesday this week after the protesting instructors through their union met with representatives from the government behind closed doors.

The meeting was followed by a press release issued by the workers union, announcing a halt to the goslow.

The release partially reads: "The Booker Washington Institute Workers Union is pleased to inform students, parents and the general public that the "Goslow" action instituted by the academic instructors of BWI has been called off as of today, January 26, 2022."

The union says the

decision followed consultation with all stakeholders, including the BWI Administration on welfare of the staff and teaching faculty of the institution.

Meanwhile, the BWI Workers Union apologizes to students, parents and the public at large for the disruption of academic activities on campus for the entire week and promises to always use dialogue in resolving grievances, while reassuring to work hard in ensuring that BWI becomes a model center for Technical and Vocational Education Training (TVET) in Liberia.

To the amazement of students of BWI, their academic instructors refused to

administer exams on January 24 in demand of increment in salary and incentives.

Students were told to stay home for three days as of Monday, January 24th. But normal academic activities have been restored following intervention by the government.

Founded in 1929 and named in memory of the late renowned African-American Scholar Booker T. Washington, BWI has been one of the premiere vocational and technical institutions in Liberia that has immensely contributed to the country's h u m a n resource development. Editing by Jonathan Browne

one guy by the name of Sackor, the suspect, went to him and started to push him out of their yard and he (Alfred Sackor Mombou) went in his house for mortar pestle and hit him for the first time on his back and he started to leave the vard but Sackor followed him, beating him with the pestle so he came at my yard and fell down on his back, but Alfred Sackor Mombou kept knocking him with the mortar pestle in his chest", Witness Williams narrated to the Police.

He said while the deceased was lying helpless, another boy named T. Boy, came from the same direction of the two suspects, using stick to beat the late Huggins on his left foot until he got cut.

"So when it was too much despite I have tried to stop them, I told T. Boy and Sackor that if anything happens to the deceased (Peter Hugging) I will tell the police because the way they were beating him, thou it wasn't my one who was present, many people were there", he added.

Suspect Alfred Sackor Mombou explained that on Wednesday January 19, 2022 at about 7:30Pm, while in his yard along with other tenants, the deceased was passing by with one Oliver, but while going he (Huggins) stood and asked for help so one of the tenants known as Isaiah gave him 100 Liberian Dollars.

He said after receiving the money, the late Huggins still asked for help so one Dedesco Gweh interjected and inquired which kind of help?

He added that Dedesco then noticed that the victim's penis had already erected, so he asked him if he wanted woman to which the late Huggins allegedly responded yes, so Dedesco immediately pushed him out of the yard.

According to Suspect Sackor, when he was pushed out, the deceased didn't stop there, rather, he went to other apartments, allegedly harassing ladies who were in those apartments.

He continued that while in the process, a pregnant woman called Anita, was returning from the bathroom and the late Peter Huggins rushed to her and she fell to the ground that night, and allegedly he started to force himself on her so he (Sackor) quickly ran there to rescue the lady.

He said when he pushed the deceased aside and picked the pregnant woman up, the deceased took stick against him, but someone called his attention and it was how they tussled over the stick, before Mr. Samuel Williams intervened and told him (Sackor) to stop beating the deceased, but denied beating him.

"I was afraid of leaving the stick before the deceased in return hurt me, so I successfully took the stick from the deceased (Peter) and threw it down but Martha took the stick to the deceased's girlfriend, who later brought it as evidence", he explained.

Sackor added that the Police later went on the scene and asked them to take the pregnant woman to hospital, which they did, but noted that his friend or accomplice (Brown B. Dalieh, Jr) was arrested based on medical report from the J.J. Dossen Hospital in Harper that disclosed that the victim died from internal organ bleeding and trauma. However, while at the police station, the both suspects denied committing the alleged act of killing the later Peter Huggins despite engaging him in fist-fight.

The two suspects spent few nights behind bars before the Crime Services Department (CSD) of the Liberia National Police charged them with murder and forwarded them to the Magisterial Court on January 25, 2022, pending trial.

The crime is in violation of Section 14.1 of the new penal code of Liberia, which is above the jurisdiction of the Harper Magisterial Court, so the suspects are expected to be transferred to the Fourth Judicial Circuit Court for trial. *Editing by Jonathan Browne*

Regardrétrospectif 4 ans après

Le président George MannehWeah en est à la cinquième année de son administration, après avoir été élu en 2017 et prisfonction par la suite en 2018.

Il est monté à la présidence en tant que politicien populiste et icône internationale du football, gagnant lescœurs et l'admiration de la jeunesse libérienne, qui constitue 60% de la population du pays.

Mais quatre ans après, l'euphorie s'est évaporée et les attentes sont loin de devenir réalité, comme en témoignent les milliers de jeunes sans emploi qui errent quotidiennement dans les rues de Monrovia dans une économie qui tarde à montrer de l'espoir.

M. Weah a fait campagne sur le slogan « Change for Hope » que de nombreux habitants des bidonvilles, en particulier les ieunes du ghetto, pensaient être une opportunité de changer leur niveau de vie et d'améliorer leur sort.

Cependant, quatre ans après, de nombreux jeunes sont désabusés et ils ont exprimé leurs frustrations par des votes de protestation lors de l'élection sénatoriale partielle du 8 décembre 2020 en élisant une opposition à la place, en plein comté de Montserrado, autrefois surnommé le bastion du Congrès pour lechangement démocratique au pouvoir.

De nombreux Libériens pensaient que l'insécurité à travers le pays appartiendrait désormais au passé. Ce n'est pas le cas, car les jeunes sans emploi et toxicomanes commandent les rues de Monrovia après le crépuscule, terrorisant les citoyens pacifiques enleur arrachant de force effets personnels etargent sous la menace parfois d'armes à feu, decouteaux ou autres objets mortels.

Mort suspecte de quatre auditeurs, dont le directeur général de l'Agence d'audit interne (IAA) E. BarthenNyenswa en 2020, couplée au meurtre de trois personnalités de premier plan, dont deux fils de deux anciens présidents et un officier du Libéria Le service d'immigration en 2021 a jeté un nuage sombre sur la nation.

Dans la cinquième année de l'administration Weah, laquestiondupanierde la ménagère reste toujours un défi pour de nombreux Libériens ordinaires. L'économie est généralement stagnante, l'inflation mordant au milieu des prix élevés et du pouvoir d'achat en baisse.

Néanmoins, le président Weah a réalisé des progrès dans le développement des infrastructures, en particulier les routes, l'enseignement universitaire gratuit, la santé, la liberté d'expression et la liberté de la presse et de réunion pacifique, entre autres. Mais la corruption systémique à tous les niveaux du gouvernement devient un obstacle à ces efforts sérieux.

Deux ans plus tard, le gouvernement qui brigue unsecond mandat se rendrait un grand service en démontrant publiquement son engagement à lutter contre la corruption et autres vices négatifs visant à éroder son image et sa crédibilité.

Le président Weah a parlé également de la formation continue de 35 enseignants universitaires à l'étranger, de l'acquisition d'une bibliothèque numérique, de la révision des manuels pour les étudiants et de la mise à niveau du programme.

En outre, a-t-il ajouté, dans un effort pour combler les lacunes dans l'éducation des filles, le gouvernement offrira des bourses d'études à 3 000 filles admises en 10e année dans quatre comtés où les taux d'abandon des filles au lycée sont les plus élevés . "Comme il n'y a pas de frais de scolarité dans les écoles publiques, le parrainage couvrira tous les frais d'inscription, les uniformes, les manuels et les allocations annuelles en espèces", a ajouté le président.

Les sanctions économiques ne vont pas apporter la paix en Éthiopie

DDIS-ABEBA/CHICAGO - La récente décision de l'administration du président américain Joe Biden de révoquer l'éligibilité de l'Éthiopie à la Loi sur la croissance et les perspectives économiques de l'Afrique (AGOA) a relancé le débat sur l'efficacité de l'imposition de sanctions économiques aux pays pauvres. L'administration a cité au motif de cette décision des « violations flagrantes des droits de l'homme internationalement reconnus » dans le conflit au Nord de l'Éthiopie. Mais il n'est pas certain que l'exclusion de l'Éthiopie de ce programme mette fin aux violations, surtout compte tenu de l'implication de multiples acteurs étatiques et non étatiques dans le conflit.

L'AGOA offre aux pays éligibles d'Afrique subsaharienne un accès en franchise de droits au marché américain pour certains produits. L'Éthiopie risque de perdre un accès préférentiel à une part de marché d'une valeur de 240 millions de dollars, équivalente à environ 9 % des exportations totales du pays. La perte va surtout peser sur les industries de l'habillement et du cuir, qui emploient environ 200 000 personnes, dont la plupart sont des femmes.

En général, rien dans la documentation ne soutient l'idée consistant à utiliser des sanctions économiques internationales dans le but d'influencer le comportement politique des gouvernements. Les explications existantes sont tirées du modèle Heckscher-Ohlin du commerce international, selon lesquelles un pays bénéficie de l'exportation de marchandises produites avec ses ressources les plus abondantes et de l'importation de marchandises qui utilisent des ressources qui sont rares. Si des sanctions sont imposées et que les échanges commerciaux sont limités, l'équilibre de l'offre et de la demande du pays sera perturbé et le bien-être général déclinera - ce que les dirigeants politiques souhaitent éviter.

Si personne ne remet en question qu'il fut sage d'emprunter pour répondre à une urgence de santé publique et à la menace d'une crise économique, ces lourdes dettes posent des problèmes de gestion. Les maigres ressources budgétaires qui pourraient sinon être allouées aux soins de santé, à l'éducation et aux infrastructures vont être aspirées par le service de la dette. Et le poids de celle-ci ira croissant à mesure que la Réserve fédérale des États-Unis durcira sa politique monétaire et que se raréfieront les capitaux à l'échelle mondiale, c'est-à-dire qu'augmenteront les pressions à la hausse sur les taux d'intérêt.

La dette publique n'est en outre qu'une partie du problème. Depuis l'apparition de la pandémie, les dettes des ménages et des entreprises non financières ont augmenté presque aussi vite que celles des États. Lorsque ces débiteurs s'avéreront insolvables, il est probable que les pertes seront socialisées et pèseront sur les bilans des finances publiques.

Un autre facteur devrait inciter au scepticisme concernant le consensus sur les marchés émergents : les risques de la promiscuité au travail poussent à l'accélération de l'automation dans les économies avancées. Comme la nécessité d'une étroite coordination occulomotrice entravait encore, voici peu, ce type d'évolution, l'exportation des industries manufacturières à forte concentration de maind'œuvre constitua longtemps la voie traditionnelle d'augmentation des revenus sur les marchés émergents et dans les pays en développement. Si ces industries ne demandent ni de lourds investissements ni une main-d'œuvre hautement qualifiée, elles ont le mérite de familiariser cette dernière avec la discipline de l'usine, de permettre la formation par l'apprentissage, d'acclimater les entreprises à la concurrence sur les marchés mondiaux et de rapporter des devises.

Il est à craindre que ces produits manufacturés soient très bientôt fabriqués par des robots et des

imprimantes 3D, dans les pays mêmes où ils sont vendus. Une telle perspective renforce les inquiétudes déjà formées quant à la « désindustrialisation prématurée » des marchés émergents.

Concomitamment, les chaînes d'approvisionnement, dont l'importance pour les économies émergentes est cruciale, connaissent, du fait de la pandémie, des perturbations importantes, qui conduisent les entreprises à rechercher des facteurs de production plus proches. Les gouvernements des pays développés arguent quant à eux de leur sécurité économique pour justifier les incitations qu'ils mettent en place afin de rapatrier une partie de la production manufacturée.

Pour les marchés émergents, les effets négatifs ne sont pas sans ressembler à ceux de l'accélération de l'automation. Nombre de pays à revenu faible ou intermédiaire commencent par des tâches d'assemblage simples avant de s'engager dans des opérations de fabrication plus complexes. Les occasions de ce type se raréfieront si les économies développées assemblent plus de biens chez elles.

Le Mexique pourrait tirer profit des efforts consentis par les sociétés aux États-Unis pour contracter leurs chaînes d'approvisionnement. Les pays d'Europe de l'Est pourraient aussi bénéficier d'une dynamique analogue dans les pays de l'Union européenne. Mais l'Asie du Sud, l'Afrique et l'Amérique latine pourraient se trouver évincées.

Et surtout, il faut compter avec les conséquences du Covid-19 sur la formation du capital humain. Si ses effets sont partout négatifs, ils le sont encore plus sur les marchés émergents, où la bande passante à grande vitesse, nécessaire pour dispenser un enseignement à distance correct, est une denrée rare. Le rythme plus lent des vaccinations va se traduire par la prolongation des fermetures de classes dans les établissements d'enseignement et par la multiplication des absences. Selon une estimation de la Banque mondiale, la proportion d'enfants de dix ans ne sachant ni lire ni comprendre un texte simple passera dans les pays en développement de 53 % à 63 % du simple fait de la pandémie.

L'objection la plus convaincante à ces prévisions pessimistes résiderait dans le dopage d'après-crise de l'économie mondiale, qui profiterait aux marchés émergents. La croissance de la productivité dans les économies avancées, qui marquait un ralentissement depuis plusieurs décennies, fut soutenue durant la pandémie, notamment aux États-Unis. Les évolutions technologiques et structurelles induites par la pandémie pourraient désormais entretenir cette accélération. Une croissance plus rapide dans les pays développés créerait ainsi une demande supplémentaire pour les exportations des marchés en développement.

À ce stade, cet argument ne relève que de l'hypothèse. La hausse récente de la productivité dans les économies avancées est entièrement imputable à des facteurs conjoncturels - pour les plus récents d'entre eux à l'utilisation plus intensive de leurs ressources par les entreprises au moment des rebonds qui ont suivi les dépressions enregistrées en 2020. À vrai dire, ces regains de la productivité ressemblent beaucoup à ceux des précédentes reprises liées aux cycles économiques ce qui signifie qu'il n'est nullement certain que l'accélération se poursuive.

Senate gives NFAA autonomy


he Plenary of the Liberian Senate passes into law a bill, granting the National Food Assistance Agency an autonomous status. The decision comes as a result of a report by the committee on Agriculture, Fisheries and Forestry.

Montserrado County Senator Abraham Darius Dillon proffered the Bill last year, seeking to make the NFAA autonomous.

In his communication to plenary, Senator Dillon said the agency's function and The Committee that is chaired by Margibi County Senator Jim Tornonlah, said NFAA should be financed through the National Budget and donor partners.

It noted in its report that the Government of Liberia intends to encourage investment in such sectors to ensure sustainable development and realization of food security in line with the 2030 United Nations Sustainable Development Goals to end poverty.

The Committee's report however states that the Government of Liberia and its international partners endeavor



responsibilities are very cardinal to the food security of the nation.

He noted that the NFAA was established by an Executive Order in the 70s, and has been operating with the statutory mandate to coordinate all food assistance programs on behalf of the Government of Liberia.

Based on his communication, the Committee on Agriculture, Fisheries and Forestry recommended that plenary should pass the bill into law.

Samukai ordered jailed!

he Supreme Court of Liberia has ordered the enforcement of a two - year jail term against the country's former Defense Minister and now Lofa County Senator - elect Mr. Brownie Samukai and his two deputies in relation to their conviction for corruption.

The three officials were earlier ordered to restitute funds they were accused of misapplying or face jail terms, but the court has found that they have failed on the restitution order.

The Supreme Court ruled Thursday, 27 January 2022 that Mr. Samukai having failed to comply with the mandate to pay 50% of the judgment sum in the [tune of] US\$ 573,828.15 within the period of six months, he has breached the conditions of the suspended sentence.

The court therefore revoked the suspension against the execution of his two - year jail term to now allow him to be put behind bars.

Reading the Court ruling, Associate Justice Sie - A - Nyene G. Yuoh said the convicts will now serve two years

together and so they have to pay the money collectively.


Justice Yuoh added that Circuit Court Judge A. Blamo Dixon improperly executed the mandate of the Supreme Court when he relied on the ruling of Judge Yamie Quiqui Gbeisay which had been modified by the Court and apportioned the judgment amount of US\$ 1,147,656.35 among the three respondents and ordered that each of them, including Samukai, pay his share of 50% of the Judgment sum.

The Circuit judge had calculated that to be US\$ 191,276.05, but the Supreme Court says the judge is clearly in error. Justice Yuoh further explained that given the clear language of the February 8, 2021 opinion and judgment of the Supreme Court regarding the joint liability of restituting the judgment amount, the payment by Corespondent Samukai in the amount of US\$191,276.05 cannot be considered compliance with the mandate of the Supreme Court.

"That a bill of information will lie to prevent the inferior court or officer thereof who attempted to execute the mandate of the Supreme Court in an improper manner; or to prevent anyone whosoever from interfering with the judgment or mandate of the court. Hence, this bill of information is the appropriate remedy where it is established that the trial court is improperly executing the mandate of the Supreme Court," she emphasized.

She also explained that the bill of information filed on August 18, 2021 by the respondent Samukai requesting for enlargement of time is a plea made in bad faith, as one cannot claim satisfaction or reparation and at the same time pray for time to comply.

She said the bill of information requested for enlargement of time has become moot.



Samukai and his two former deputies, Mr. Joseph P. Johnson and Mr. Nyumah Borbor served during the Ellen Johnson-Sirleaf regime and were convicted for misappropriating soldiers of the Armed Forces of Liberia (AFL) personal pension saving funds and were asked to restitute the amount or face a jail sentence.

Mr. Samukai was elected Senator of Lofa County during the 2020 senatorial election held across the 15 counties, but the Supreme Court has prevented him from being certificated or taking his seat at the Liberian Senate until he removed the liability imposed upon him by his conviction.

imprisonment and pay full judgment amount of US\$ 1,147,656.35, less the amount already paid by them.

"[Therefore], upon their failure to pay, they shall remain in prison until the balance is fully liquidated at the rate US\$ 25.00 per month," Justice Yuoh said.

She maintained that the law provides that where criminal defendants are jointly adjudged guilty of a crime, they are together considered collectively responsible for any fine and/ or penalty until the judgment is fully satisfied.

Mr. Samukai made some efforts aimed at paying 50 percent of what he thought was his portion of the total judgment sum, but the Court says he and his two deputies were convicted

deaths of the worshipers confirmed by health authorities here.




