outh Africa chose to abstain Wednesday when the United Nations General Assembly voted on a resolution calling on its BRICS partner, Russia, to withdraw its military forces from Ukraine. South Africa's U.N. ambassador defended the move, but some South Africans were unhappy with the decision.

South Africa was one of 17 African nations that abstained.

In a statement, South Africa's U.N. Ambassador Mathu Jovini objected to the phrasing of the resolution, saying it "does not create an environment conducive for diplomacy, dialogue and mediation."

Political science professor Bheki Mngomezulu said South Africa is also influenced by its historical ties to the former Soviet Union.

"There are a number of South Africans, most of whom are now in government, who trained both in Russia and Ukraine. So, they do have relations with Ukraine. And the majority of the people are of the view that the liberation struggle was supported solely by Russia in but the reality of the matter is all the countries that were part

of the USSR participated in terms of assisting the liberation struggle not only in South Africa but in Africa in general,' Mngomezulu said.

The main opposition party in South Africa, the Democratic Alliance, released a statement condemning the country's stance. The party's shadow minister for international relations Darren Bergman said the party is shocked that South Africa could abstain from such a

time for South Africa to take a stand and to assert itself on the international stage," Bergman said.

He said considering how hard South Africans fought to end the racially oppressive system of apartheid and get the right to vote, and how the international community helped them win their fight, they should've repaid the favor.

"An abstention or voting for Russia is pretty much the against Ukraine. It's a vote against peace, and it's a condonation of the violence that's currently taking place in Ukraine," Bergman said.

Other South Africans added their voices to the chorus of disappointment, including analyst Mngomezulu.

"Of course, it doesn't paint the country in a positive light, more especially because part of South Africa's foreign policy agenda is to respect human rights, and in this case it's clear that the human rights of the affected," Mngomezulu.

Ronnie Gotkin, who was out for an afternoon stroll in the summer sunshine, said he was outraged.

"I think it's pretty appalling. It's not taking a moral stance. I understand that in the real world there are politics and allies, but sometimes morality should trump out," Gotkin said.

In all, 141 nations voted in favor of the resolution, five nations, including Russia, voted no, and 35 abstained.

Eritrea was the only African nation to vote with Russia. VOA

Cameroon have claimed responsibility for an attack Wednesday that killed seven people, including a senior official and a mayor. Cameroon's military says the officials were on a tour to raise support against the rebels when a homemade

The government said the explosive device hit the officials' car in Bekora village in the Ekondo Titi district of Cameroon's English-speaking South-West region. The government says six officials, including Timothee Aboloa, highest government official in Ekondo Titi, Nanji Kenneth,

Ebeku William, the Ekondo Titi president of Cameroon's ruling Cameroon People's Democratic Movement party, died on the spot.

EDITORIAL **Minister Isaac Doe**, the woman beater

NEWS THAT THE deputy minister for youth development at the ministry of youth and sports Isaac Doe, brutally assaulted a woman believed to be his girlfriend over the weekend is despicable and highly disappointing. How disgusting it is that a senior official of the Weah administration would go to this extent of disgracing womanhood in public!

THIS UNCOUTH ACT by the talkshow personality clearly contradicts the character he portrays on the famous Spoontalk, as an ardent supporter and promoter of good mannerism, good governance and respect for human dignity, especially women.

According to a Frontpageafrica's publication, the CEO of Spoon Communication, Stanton Whiterspoon, has with immediate effect, suspended Mr. Isaac Doe from the live panel show, pending full investigation of the matter.

HOWEVER, THE GOVERNMENT in Monrovia seems to be conspicuously silent on the issue except Minister Doe's immediate boss, Minister Zeogar Wilson, who has reportedly acknowledged the incident, but disclosed that calls placed to Doe went unanswered. Putin's War Has Given Birth to Geopolitical Europe

GDP's Days Are Numbered

AMBRIDGE - How should we measure economic success? Criticisms of conventional indicators, particularly gross domestic product, have abounded for years, if not decades. Environmentalists have long pointed out that GDP omits the depletion of natural assets, as well as negative externalities such as global warming. And its failure to capture unpaid but undoubtedly valuable work in the home is another glaring omission. But better alternatives may soon be at hand.

In 2009, a commission led by Joseph Stiglitz, Amartya Sen, and Jean-Paul Fitoussi spurred efforts to find alternative ways to gauge economic progress by recommending a "dashboard" of indicators. Since then, economists and statisticians, working alongside natural scientists, have put considerable effort into developing rigorous wealth-based prosperity metrics, particularly concerning natural assets. The core idea is to create a comprehensive national balance sheet to demonstrate that economic progress today is illusory when it comes at the expense of future living standards.

In an important milestone in March of this year, the United Nations approved a statistical standard relating to the services that nature provides to the economy. That followed the UK Treasury's publication of a review by the University of Cambridge's Partha Dasgupta setting out how to integrate nature in general, and biodiversity in particular, into economic analysis. With the consequences of climate change starting to become all too apparent, any meaningful concept of economic success in the future will surely include sustainability.

The next steps in this statistical endeavor will be to incorporate measures of social capital, reflecting the ability of communities or countries to act collectively, and to extend measurement of the household sector. The COVID-19 pandemic has highlighted how crucial this unpaid work is to a country's economic health. For example, the US Bureau of Labor Statistics intends to develop a more comprehensive concept of living standards that includes the value of such activity.

Aggregate measures such as these can be useful for guiding important policy decisions in a manner consistent with familiar economic concepts. This approach also helps the conversation with finance ministry officials and business executives, whose support for a longer-term perspective regarding prosperity will be essential to bring about change.

But many advocate thinking about economic success and failure in terms of well-being, a broader and fuzzier concept. The idea that policy decisions should focus on what ultimately matters in people's lives is intuitively appealing. And a number of governments, from New Zealand to Scotland, have recently adopted explicit well-being policy frameworks.

This approach, however, raises even more difficult measurement questions. Well-being depends on many aspects of individuals' life circumstances. To be sure, there is a large body of research in psychology and economics concerning how to measure well-being and analyze the factors that influence it. Often, the measurement involves surveying people's satisfaction with their lives or their level of anxiety. For example, the United Kingdom's Office for National Statistics has been tracking anxiety and depression throughout the pandemic.

But while policymakers need some top-down, aggregate statistics to facilitate their decision-making, such indicators have limitations. For example, whereas the links between well-being and factors identified by econometric analysis - such as being employed or in good mental health - are intuitive, the causal connections are not well understood. A depressed person may benefit from therapy, as well-being advocates often urge, but decent housing might be even more effective. Public policy based on well-being thus still lacks a theoretical underpinning.

Moreover, some policymaking contexts will require a more granular level of detail. Qualitative research - rather than large-scale surveys with predefined questions points to a wider range of considerations affecting well-being. For example, one recent UK study, co-produced by researchers and people experiencing poverty, found that while basic material needs including health were important to well-being, autonomy and a sense of purpose mattered just as much. The top-down aggregate indicators devised by social scientists and statisticians cannot capture such findings.

BRUSSELS - Some weeks can feel like decades, and this week has been one of them. With Russia's naked act of aggression against Ukraine, the tragedy of war has erupted in Europe once again. Russian forces have shelled residential housing, schools, hospitals, and other civilian infrastructure. The Kremlin's propaganda machine has been pushed into overdrive in its effort to justify the unjustifiable. More than one million people have already fled the violence with more to come.

Ukrainians, meanwhile, are mounting a heroic defense of their country, galvanized by President Volodymyr Zelensky's leadership. Faced with an escalating onslaught and the Kremlin's absurd claims denying their national identity, Ukrainians have demonstrated unity and resilience. Stuck in the past, Russian President Vladimir Putin may have convinced himself that Ukraine belongs to him under his vision of a "greater Russia." But Ukrainians have demonstrated that their country belongs to them, and that they intend for it to have a European future.

The European Union has sprung into action. While some expected us to dither, disagree, and delay, we have acted at record speed to support Ukraine, breaking taboos along the way. We have imposed unprecedented sanctions on Kremlin-linked oligarchs and those responsible for the war. Measures that were unthinkable just a few days ago - such as barring leading Russian banks from the SWIFT system and freezing the Russian central bank's assets - are now in place. And for the first time ever, the EU is supporting member states as they supply military equipment to embattled Ukraine, mobilizing €500 million (\$553 million) under the European Peace Facility.

We have done all this together with other countries to ensure maximum effect. The United States, the United Kingdom, Canada, Switzerland, Japan, Singapore, and many other financial and economic nerve centers have joined us in adopting tough sanctions. The international outrage against Russia is cascading, even into sports and the arts. A stampede of companies is leaving the Russian market.

Still, the news from the ground in Ukraine is horrific and sobering, and no one knows how this war will end. Putin will try to excuse the bloodshed he has unleashed by depicting it as an unavoidable byproduct of some mythical clash between the West and the Rest; but he will convince almost no one. The vast majority of countries and people around the world refuse to accept a world where an autocratic leader can simply seize whatever he wants through military aggression.

On March 2, an overwhelming majority of the United Nations General Assembly - 141 countries - voted to support Ukraine's sovereign rights, denouncing Russia's actions as a clear violation of the UN Charter and international law. Only four countries voted with Russia (the remaining 35 abstained). This historic display of global consensus shows just how much Russia's leaders have isolated their country. The EU worked hard to achieve this outcome at the UN, and we fully agree with UN Secretary-General António Guterres that the task now is to end the violence and open the door to diplomacy.

In the week since Russia's invasion, we have also witnessed the belated birth of a geopolitical Europe. For years, Europeans have been debating how the EU can be made more robust and security-conscious, with unity of purpose and capabilities to pursue our political goals on the world stage. We have now arguably gone further down that path in the past week than we did in the previous decade.

This is a welcome development, but there is so much more to do. First, we must prepare to support Ukraine and its people for the long haul - for their sake as well as our own. There will be no security for anyone if we allow Putin to prevail. If there are no longer any rules, we will all be in danger. That is why we must ensure that a free Ukraine survives. And to that end, we must maintain an opening for Russia to return to reason, so that peace can be re-established.

Second, we need to recognize what this war means for European security and resilience more broadly. Consider the energy dimension. Clearly, reducing our dependence on energy imports from authoritarian and aggressive powers is an urgent strategic imperative. It is absurd that we have literally financed our opponent's ability to wage war. The invasion of Ukraine should lend new momentum to our green-energy transition. Every euro that we invest in developing renewables at home will reduce our strategic vulnerabilities, as well as helping to avert catastrophic climate change.

Third, in a world of power politics, we need to build greater capacity to defend ourselves. Strengthening our defense means tackling Russia's aggressive disinformation networks and going after the Kremlin's ecosystem of finance and influence peddling.

Yes, this includes military means, and we need to develop them more. But the essence of what the EU did this week was to use all policies and levers - which remain mainly economic and regulatory in nature - as instruments of power. We should build on this approach in the weeks ahead, in Ukraine but elsewhere, too, as needed.

The core task for "geopolitical Europe" is straightforward. We must use our newfound sense of purpose first to ensure a free Ukraine, and then to re-establish peace and security across our continent.

While time-intensive ground-level research will not always be practical, it is important to keep in mind that the concept of well-being is much richer than most other economic indicators. Importantly, the comprehensive wealth and well-being approaches outlined here are complementary: the assets measured by the former provide the means to achieve the latter. Indeed, New Zealand's policy framework makes this link explicit.

What is exciting about these alternative approaches to assessing and measuring the economic success of a community or country is the amount of practical progress already made in defining concepts, creating metrics, and building expert consensus about the direction policymaking should take. Ditching GDP as the main gauge of prosperity was always impossible in the absence of broad agreement about what the alternative might be. And it will take many more years of work at the statistical coalface to develop a framework as sophisticated and well-embedded as GDP and related economic indicators. But the direction of change is clear, and the impetus to bring it about is powerful.

ormer Montserrado County District#10 Representative Julius Berrian has reportedly died in the United States in a car crash. He was a member of the 53rd National Legislature.

According to sources, former Representative Berrian was involved in tragic motor accident late Tuesday evening March 2, 2022 in the United States of America.

Sources add that following the accident, he went unconscious and was rushed to a nearest hospital in America

where he was later pronounced dead by Hospital authorities.

The late Berrian contested the 2017 Presidential and Legislative Elections on the ticket of the opposition People's Unification Party (PUP), but lost to Independent Candidate Yekeh Kolubah now Representative of Montserrado district#10.

In an interview with reporters in Monrovia prior to his death on assessment of the performance of his predecessor Rep. Kolubah, the late Berrian said Yekeh has not done much in the areas of lawmaking, representation, and advocacy.

The administration adds that this was further clarified by the Ministry of Finance and Development Planning and the Civil Service Agency in a zoom meeting held with the University which TUFA members allegedly declined to attend.

"To that effect, the Ministry of Finance and Development Planning (MFDP) and the Civil Service Agency (CSA) have committed to work with all stakeholders to address the issues of harmonization and any disparities in the payroll", administration reveals.

It says the Ministry of Finance and Development Planning (MFDP) and the Civil Service Agency (CSA) have agreed to set up a joint team to visit and work with TU's administration to probe the issues of salary increment and any possible disparity in pay among faculty, clarifying that TU does not have the authority to automatically raise salaries for its employees.

It says TU's payroll is controlled by the MFDP and the CSA, both of which must approve such increases, and that tenure and promotions for faculty are performancebased.

The University further notes that as a matter of best practice in higher education the world over, the faculty, not administration, normally organizes promotion and tenure committees. "Regrettably, despite constant reminder by administration, the faculty is yet to establish said committees."

On question of housing and housing allowances. administration further reveals

that following the February 17, 2022 meeting held at the University's conference room, the President's cabinet reached the decision to abolish the collection of maintenance fees from resident faculty members, and it is therefore, surprising that TUFA would again raise this same issue.


Additionally, administration says it introduced maintenance fees collection to enable repairs and maintenance of facilities, while the Cabinet also agreed to avail all records collection and expenditure of the maintenance fees to a certified public accountant for audit purposes as requested by TUFA.

Administration reminds TUFA that a formal contract existed between SAAR Insurance and Tubman University to provide group insurance, and premiums paid are non-refundable, adding the insurance contract was renegotiated and cancelled based on complaints from employees that SAAR's services were unfavorable.

Contrary to TUFA's claims that the University has refused to give audience to plights of its members, the administration says it held three meetings in February alone, including the zoom meeting with the MFDP and CSA, to resolve issues raised by them.

Meanwhile, the administration calls on students of TU to remain calm as the Board of Trustees engages with both sides to find a workable and lasting solution to the conflict in the best interest of the parties, especially the students.

"As a university family, we must now realize that peace and tranquility are indispensable for a conducive learning environment. The university also encourages all members of the faculty to return to the classroom, and implore the leadership of TUFA to return to the negotiation table especially now that the Board of Trustees is involved", the statement concludes.

He further discloses that in 2023, the ministry of health conduct a nationwide campaign not only measles but Robillard.

"So, we will be targeting children between 9 months up to less than 15 years." He says.

Director Clark says data received from these cases. suggests that the number of cases is almost 1.97 times higher in 2022.

"This means that we need a national effort to intervene relatively to measles cases otherwise we may just be seen the tip of the iceberg."

"We have the total of 7,386 cumulative cases that had been reported as a country of which we have at the moment, identified 22 active and we just reported a new case", he adds.

At the same time, he says since April 1, 2021, the Government of Liberia has vaccinated one million, one hundred and thirty-four thousand, three hundred and nineteen persons across the country.

RUXELLES - L'économie des énergies renouvelables s'est considérablement améliorée. L'énergie solaire est désormais la forme d'électricité la moins coûteuse de toute l'histoire. Plus de 90 % de la capacité de production d'électricité créée à travers le monde au cours de l'année dernière concerne des énergies renouvelables. Pour conserver une chance de limiter le réchauffement climatique à 1,5°C au-dessus des niveaux préindustriels, il est cependant nécessaire que les systèmes énergétiques mondiaux se transforment plus rapidement encore. Ceci exige que les gouvernements et institutions financières cessent de financer les combustibles fossiles, et qu'ils insistent sur le soutien international à la transition vers des énergies propres.

Les données scientifiques sont sans équivoque. Pour honorer l'objectif d'1,5°C fixé par l'accord climatique de Paris, la transition énergétique mondiale va devoir s'opérer 4 à 6 fois plus rapidement qu'à son rythme actuel. Les combustibles fossiles produisent encore aujourd'hui 84 % de l'énergie mondiale, et représentent plus de 75 % des émissions planétaires. La feuille de route Neutralité carbone d'ici 2050 de l'Agence internationale de l'énergie démontre la nécessité de systèmes énergétiques mondiaux libérés des combustibles fossiles d'ici 2040. Or, depuis la signature de l'accord de Paris, les gouvernements du G20 ont consacré chaque année aux combustibles fossiles plus de trois fois plus de financements publics (77 milliards \$) qu'aux énergies renouvelables.

Les tempêtes, inondations et incendies catastrophiques que nous avons connus cette année démontrent qu'il nous faut agir sans tarder. Et dans la mesure où la prospérité future réside dans des investissements énergétiques propres, le bien-fondé d'une intensification de nos efforts apparait également clair sur le plan du développement économique. L'éolien et le solaire sont désormais moins coûteux que les nouvelles centrales à charbon et gaz pour deux tiers de la planète. La diminution considérable des coûts ces dix dernières années a refaçonné les possibilités de choix énergétiques mondiaux, en particulier dans les pays les plus pauvres, où les mini-réseaux fondés sur les énergies renouvelables offrent de réelles opportunités de remédier à la pauvreté énergétique, et d'assurer un accès à l'électricité.

Le renforcement de l'investissement dans les énergies renouvelables est également essentiel à la création d'emplois, à la croissance économique, ainsi qu'à la réduction de la pollution de l'air. D'après l'Agence internationale pour les énergies renouvelables, le déploiement de ces énergies à grande échelle pourrait contribuer à créer 42 millions d'emplois à travers le monde d'ici 2050. Ces emplois climatiques (COP26) de Glasgow, qui se tiendra au mois de novembre, gouvernements et institutions financières devront s'engager à soutenir des énergies moins coûteuses, moins polluantes, des énergies que nous ne regretterons pas, ainsi qu'à mettre un terme à tous les soutiens internationaux en faveur des combustibles fossiles. Cela ne devrait pas être trop difficile, dans la mesure où de nombreux investissements préexistants deviendront inévitablement des actifs voués à l'échec.

Nous observons d'ores et déjà plusieurs avancées importantes dans cette direction. Au mois de mai, les États membres du G7 se sont engagés à stopper d'ici 2021 tous leurs financements internationaux en faveur de projets au charbon, ainsi qu'à « cesser progressivement les soutiens publics directs aux énergies fossiles internationales à forte intensité de carbone ». Par ailleurs, la Corée du Sud, le Japon, et désormais la Chine plus grands fournisseurs mondiaux de financements en faveur du charbon - ont également convenu de cesser de financer des projets au charbon à l'étranger.

En 2019, la BEI est devenue la première banque multilatérale à annoncer la fin de tous les financements en faveur de projets d'énergies fossiles (d'ici 2021). La banque accroît ses investissements dans les énergies propres, y compris au sein de pays en voie de développement afin d'appuyer leur transition. Au Kenya, les investissements de la BEI ont contribué à la construction du plus grand parc éolien d'Afrique, voué à fournir une énergie propre et abordable à l'ensemble de la région.

t this dark hour, when we see Russia's unprovoked and unjustified invasion of Ukraine and massive disinformation campaigns and information manipulation, it is essential to separate lies - invented to justify what cannot be justified - from facts.

The facts are that Russia, a major nuclear power, has attacked and invaded a peaceful and democratic neighbouring country, which posed no threat to it, nor provoked it. Moreover, president Putin is threatening reprisals on any other state that may come to the rescue of the people of Ukraine. Such use of force and coercion has no place in the 21st century.

What Putin is doing is not only a grave violation of international law, it is a violation of the basic principles of human coexistence. With his choice to bring war back to Europe, we see the return of the "law of the jungle" where might makes right. The target is not only Ukraine, but the security of Europe and the whole international rules-based order, based on the UN system and international law.

His aggression is taking innocent lives, crushing people's wish to live in peace. Civilian targets are being struck, clearly violating international humanitarian law, forcing people to flee. We see a humanitarian catastrophe developing. For months, we pursued unparalleled efforts to achieve a diplomatic solution. But Putin lied to the faces of all who met him, pretending to be interested in a peaceful solution. Instead, he opted for a full-scale invasion, a fully fledged war.

Russia must cease its military operations immediately, and unconditionally withdraw from the entire territory of Ukraine. The same goes for Belarus, which has to immediately stop its involvement in this aggression and respect its international obligations. The European Union is united in offering its strong support to Ukraine and its people. This is a matter of life and death. I am preparing an emergency package to support the Ukrainian armed forces in their fight.

We know this - and many Russians know this. There have been courageous protests in cities across Russia since the invasion started, demanding the end of the aggression against a peaceful neighbouring nation. We hear their voices and recognise their courage in speaking out, and we also see many prominent public figures in Russia protesting this senseless invasion.

I continue to work with our partners around the world to ensure the joint action of the international community against the Kremlin's behaviour. On 25 February, only Russia vetoed a UN security council Resolution on Russia's aggression against Ukraine, with China, India and the United Arab Emirates abstaining. From all over the world, countries condemn Russia's attacks, and at the General Assembly, the entire international community needs to join forces and help to end Russia's military aggression by adopting the related UN resolution.

The international community will now in response opt for a full-scale isolation of Russia, to hold Putin accountable for this aggression. We are sanctioning those who finance the war, crippling the Russian banking system and its access to international reserves.

Captan suggested that Liberia needs to invest more into its own electricity so that whenever there's a problem with the Ivory Coast, Liberia will have a stand by.

He said Ivory Coast is carrying \$7.2 million for two months of current supply. According to Mr. Captan, if the money is too much, Liberia can reduce the amount of current they want because Ivory Coast doesn't compromise its prices.

For his part, Nimba County Senator Jeremiah Koung said the lack of current is affecting the economy.

He said the LEC Board chair is not to be blamed for the problem in the company, but the Nimba Senator argued that the Board Chair has served on the board for years before becoming chairman.

River Gee County Senator Jonathan Boycharles Sogbie said his county has not benefited from the county's electricity as though it is not a county in the country.

The Board Chair of the Liberia Electricity Cooperation (LEC) Mr. Monie Captan has alarmed here that the lack of sufficient logistics to carry on the institution's operations is one main problem that challenges the company in regards to connecting more people to its powerline.

Appearing before the Plenary of the Liberian Senate Thursday, 3 March 2022, Mr. Captan said when he took over as LEC Board Chair six months ago, there were challenges that he met there, noting that they are complicated.

According to him, there's no capital injection from the only shareholder of the company which is the Government of Liberia.

"If we have more shareholders, there will be more investments done in the company," he suggested.

Mr. Captan complained that LEC has a few pickups to carry on its operations. He said the corporation cannot attend to people swiftly because of the lack of logistics.

Additionally, the LEC Board Chair disclosed that the government here was owing the West African Power Pool US\$9.6 million. Out of that amount, he said the company has already paid US\$1m and is left with a balance of US\$8.6 million.


Mr. Captan reported that the debt came about during former President Ellen Johnson - Sirleaf's administration.

He explained that the former president was on a tour in the southeast and the people ordered the current to come. He said since that time, the current has not gone off.

Mr. Captan noted that it was from that point that the people of Maryland, Grand Gedeh and part of Nimba Counties started owing the West African Power Pool.

Captan said further that there was no management mechanism during former
