### Reporting Under Attack i South Sudan, Su

ournalists in both Sudan and South Sudan say threats, intimidation and arbitrary arrests are part of everyday life, limiting their ability to inform the public.

South Sudan ranks 128th and Sudan ranks 151st out of 180 countries in Reporters Without Borders' annual World Press Freedom Index, released Tuesday to coincide with the United Nations' annual recognition of World Press Freedom Day. The bigger the number, the worse the environment for news media.

Irene Ayaa of the Association for Media Development in South Sudan says government censorship in her country is widespread.

"Last month, we registered four articles removed from newspapers," she said.

Between January and March alone, security personnel removed dozens of articles from the Juba Monitor, Anna Namiriano, editor-in-chief of an Englishlanguage daily, told South Sudan in Focus. "They removed stories and we left the space blank. They say why we are not listening to them,



so on 17th of March, they suspended the newspaper."In February, a handful of journalists were briefly detained for covering a press conference by opposition lawmakers in parliament. A Juba Monitor newspaper article about the incident was removed by security agents at the printing plant.

"We don't have freedom of the press in the country," Namiriano said. "The solution is let us do our work as media houses. We have the code of conduct, we have the media law to guide us, and removal of stories is really very bad."

South Sudan's information minister, Michael Makuei, insists press freedom is alive and well in his country.

"South Sudan is the only place where journalists are free, where they enjoy absolute freedom according to the law. I say, 'according to the law,' because there is nothing absolute in this world," Makuei told South Sudan in Focus.

The United Nations Commission on Human Rights refutes that assertion. In a report issued last October, it

said the government is harassing activists, journalists and their families, limiting their activities and targeting their work and finances. South Sudan is one of the most dangerous places in the world to be a journalist, according to the commission.SEE ALSO:



"South Sudan has a lot of work to do to establish and solidify the institutions that are critical to a wellfunctioning democratic state," David Renz, charge d'affaires for the U.S.

Embassy in South Sudan, said in a statement Tuesday, adding that the U.S. remains deeply concerned about the state of press freedom in South Sudan.

"We have seen some of the local radio stations shut down over very trivial matters," Renz said. "And we also are aware that journalists of radio and television and even social media are self-censored" and wary of local and national governments' actions "to penalize journalists who say things the government would prefer that they not say." In Sudan, journalists in the capital city of Khartoum say harassment and threats have increased since the October 25 military takeover. VOA

# Pastor charges \$700 fee to 'take people to heaven'

n evangelist is in trouble after telling people he knows of a gate leading to heaven from south-western Nigeria that he can show them - for a fee.

Pastor Ade Abraham was reported to police by one of his followers, who said the pastor had charged him 310,000 naira (\$750; £600) to see the supposed site in Araromi-Ugbeshi town, Ekiti state.

The cleric admitted to the BBC that he had made the statement about heaven's gate, saying it was "the God he serves" who revealed it to him to try the faith of his church members, but says he has not received any payment.

Pastor Ade Abraham's church was originally based in Kogi state then Kaduna state, before moving southwards with his followers to a camp he built in Ekiti state. ### **Extremist Rebels Launch Deadly** Attack in Northeast Nigeria

The rebels attacked Kautukari village in the Chibok area of Borno on Tuesday evening, said residents. The attack happened at the same time that U.N. Secretary-General Antonio Guterres was

## Grand Mufti Sumaworo's warning deserves attention

RECENTLY, THE GRAND Mufti of Liberia Sheikh Abubakar Sumaworo warned the Weah administration not to allow jihadists mainly from Shia Muslims to establish mosque or school in Liberia.

"WE ARE HEARING that the jihad regime is about to spread in some parts of Africa, and with the information we gathered so far is that wherever they reach, they can establish the jihad war, school, including Mosque and these could subsequently lead to terrorism", the Muslim Cleric further cautioned.

ACCORDING TO HIM, jihadists are a sect of Muslims, who travel from one country to another, causing confusion among other Muslims, and added that they are often linked to terrorist groups hence, the Government of Liberia should not allow them into the country to establish mosque or school.

IF THE WEAH administration has been paying deaf ears to warnings coming from the public, it should take this one with full attention. The warning by the Grand Mufti should be treated with all seriousness it deserves, because jihadist activities in West Africa are widespread and devastating with huge human costs.

FROM NIGERIA, MALI, Burkina Faso to next door neighbor Ivory Coast, jihadist groups have rained and continue to rain terror on unarmed civilians with unimaginable consequences.

RECENTLY, THE AUTHORITIES here deported two staff of the Turkish Light International School in Monrovia for alleged terroristic activities, which left the population panicking.

GRAND MUFTI SUMAWORO is a serious cleric that commands huge followers in the country. He would not have sounded the caution to the government if he had not sensed something. Government should take cue and be on the alert.

LIBERIA WITH POROUS borders is vulnerable to unsuspected activities. Often, reports of illegal migrants from Burkina Faso crossing into the country allegedly for farming purposes have saturated the media here.

WITH MUSLIMS REPEATED request to government to legislate end of the Holy Month of Ramanda as public holiday, it is possible that jihadists could exploit the situation to cry suppression and attract sympathy from outside.

THE GOVERNMENT SHOULD put its security forces on full alert in the wake of the warning and previous action at the Turkish Light International School, because where there is smoke, fire could likely follow.

### The World Needs a Breakthrough Year

ONDON - This year must mark a global turning point. Whereas international cooperation often failed in 2020, we now have an opportunity - and the responsibility - to usher in a new era in which a healthier, greener, safer, and fairer world is possible.

The great truth that has emerged from the coronavirus pandemic is that no one, anywhere, is safe from COVID-19 until everyone, everywhere, is safe. The first step, which will pay for itself many times over, is to ensure mass vaccination in every affected country. Support from the G7 and G20 that will make vaccines readily accessible to low- and middle-income countries is not an act of charity; it is in every country's strategic interest. Indeed, the International Monetary Fund believes that such support would be the best public investment ever made.

At the G7 summit this week in Cornwall, member states and their invitees should lead the way by guaranteeing to pay 67% of required funding for the Access to COVID-19 Tools (ACT) Accelerator this year and next. This is based on a fair-share financing approach and a financial burden-sharing formula proposed by the governments of Norway and South Africa, and reflects a realistic assessment of countries' ability to pay.

The G7 should also lead the way in support of dose sharing and voluntary licensing agreements, potentially including temporary patent waivers that would allow the knowledge and technology transfer needed to manufacture vaccines on every continent.

Moreover, the world's multilateral and regional financial institutions should be asked to release new resources for low- and middle-income countries to strengthen their health systems' capacity. And they should also support implementation of the detailed recommendations of the recent report to the World Health Organization by the Independent Panel for Pandemic Preparedness and Response.

Global economic policy alignment will be crucial in rebuilding the world economy in the pandemic's wake. We were fortunate that, over the past year, in the initial COVID-19 recovery phase, most countries followed similar policies, resulting in an acceptable level of alignment. What we need now is an agreed global growth plan with coordinated monetary and fiscal interventions to prevent an uneven and unbalanced recovery - and ensure a more inclusive, equitable, and greener future. For example, the IMF's proposals for a synchronized push on infrastructure, including green infrastructure, across all continents would, if adopted by the G7 and G20, raise global economic output by a projected \$2 trillion by 2025.

The G20 and G7 must also address the growing divergence caused by differences in health outcomes and uncoordinated macroeconomic policy approaches. While most advanced economies can look forward to strong growth and widely available vaccines, much of the emerging and developing world must face the new waves and new variants of the virus with depleted economic and social buffers. Following a slow recovery in global trade and foreign direct investment, many countries face rising debt and falling tax revenues, as well as declining aid flows.

With up to 150 million more people forced into poverty by COVID-19, and with widespread cuts in health-care and education budgets, the pandemic may have delayed progress toward the 2030

Sustainable Development Goals (SDGs) by up to

five years, with girls and women suffering most. We call on the G7 to extend their initiative on girls' education and to support the UNICEF plan for digital connectivity that ensures the inclusion of all young people.

The G7 and G20 can help to bridge the financing gaps faced by vulnerable countries and act to restore a viable path toward the SDGs. This will require the multilateral development banks to deploy more finance, more efficiently, optimizing their balance sheets and reviewing their capital adequacy framework, as already requested by the G20, and consider replenishments. In this respect, we need to examine new guarantee-based instruments to crowd in private-sector finance for health, education, and social safety nets, and we need to make progress on international agreements to curtail tax avoidance such as the global minimum rate recently backed by G7 finance ministers.

In addition, we must redouble our efforts to ensure debt sustainability for low- and middle-income countries. That means extending the G20's Debt Service Suspension Initiative and encouraging broader participation by private creditors, and possibly by non-G20 official creditors, in the new Common Framework for Debt Treatments. Success will depend on greater transparency on the part of both debtors and creditors.

This year is also vital for progress toward reaching net-zero carbon dioxide emissions by 2050. In advance of the United Nations climate summit (COP26) in Glasgow this November, the G7 and G20 countries must announce bold national commitments. They must require companies to disclose their carbon footprints, deliver on the proposed fund for mitigation and adaptation in lowand lower-middle-income countries, and ensure that their economic recovery plans boost renewables and green infrastructure.

This is not a task for national governments alone. Firms, cities, and multilateral institutions all must be at the center of efforts to achieve net-zero emissions by mid-century. And, as with the post-pandemic global recovery, the coordinated efforts we need must be set firmly in place this year.

### **Leveling Up Is Hard to Do**

AMBRIDGE - One of the economic challenges facing all Western governments in these uniquely testing times is how to redress geographic inequalities that have emerged over several decades. Tackling this problem will require policymakers to adjust their perspective and adopt a much more holistic approach to economic development.

In the United Kingdom, regional inequality has given rise to its own vocabulary: the "red wall" of longtime Labour but now Conservative electoral constituencies in England's former industrial heartlands, and the imperative of "leveling up" the country to bring about a more equitable economic balance between the struggling north and the richer south. But many governments face the same challenge of restoring prosperity to rural communities and small towns that have not shared in the economic boom enjoyed by large urban areas.

The pandemic-induced trend of working from home might temper these underlying economic dynamics, but it is unlikely to reverse them. The most productive businesses in today's services-oriented Western economies are those best able to attract highly skilled employees, and that rely on "tacit" knowledge, or know-how-insights that are impossible to write down in detail.

This type of expertise tends to cluster together, because knowledge workers thrive on the presence of other similar people with whom to share ideas, and they also like environments with abundant cultural amenities. This has produced today's well-known clusters in technology, the creative sector, finance, and professional services. Platforms such as Zoom and Microsoft Teams have kept such know-how businesses going through the pandemic, but they are an imperfect substitute for exchanging ideas in person: nobody schedules a Zoom meeting to share a serendipitous idea that came to mind while they were making coffee.

If this "superstar" clustering resumes as the pandemic fades, the momentum toward ever-increasing geographic inequality could become inexorable. We might then have to learn to live with large differences in economic outcomes and even life expectancy across the space of a few miles.

There is no shortage of policy ideas to halt or reverse this uneven trend. Infrastructure investment tops the list, and is needed anyway after decades of failure to maintain or enhance assets that are essential enablers of productivity and growth. But many infrastructure projects - some involving new bridges or expansion of broadband - have not had the hoped-for impact on the places they were intended to help. Such investments on their own will be insufficient. Economically disadvantaged areas need other kinds of public and private investment, including in skills, new technology adoption by businesses of all kinds, health, education, and other key social infrastructure.

But even this wish list of desirable policies will not be enough to trigger a virtuous cycle of growth in "left-behind" places in the absence of better coordination of government policies, public spending, and private investment decisions. An economy is like an orchestra: it will not perform if some sections - the woodwinds, say, or the strings - are missing. In unproductive areas, policymakers need to fix the economy's entire underlying structure by lining up all its parts.

Policymakers must therefore break with the conventional pattern of clever analysts devising a strategy and handing it over to others to implement. Public-interest technology, sometimes referred to as "govtech," demonstrates the integrated approach that will be needed. As recent books focusing on the United States and the UK make clear, digitizing public services to make them more efficient opens a path to redesigning the processes involved, rather than simply replacing paper with bytes.

The key change in perspective needed to deliver better outcomes more cheaply and efficiently is to design policies from the viewpoint of users and administrators, rather than that of the policy analyst. An abundance of evidence from the US and the UK shows that talking to the people involved reveals vital information. In many cases, the barriers to a government service's uptake or success may lie in a completely different policy domain, whose analysts would otherwise never imagine that their contribution could be useful. For example, the lack of a bus service or after-school childcare may affect an unemployed person's ability to take part in a training program. The powerful logic of designing a digital process uncovers the analog landscape through which people are forced to navigate.

Of course, better bus services are not the solution to the leveling-up challenge (although in some countries they may prove surprisingly important). But recognizing the need for a holistic approach to regional development is essential to address the problem. The real breakthrough will come from making such collaboration happen.

Digitalization has been transforming how businesses operate since the 1990s. It can do the same for government policies, so that they better serve all citizens, no matter where they live.





En Guinée, le procureur général a annoncé ce mercredi 4 mai des poursuites contre l'exprésident Alpha Condé et 26 anciens hauts responsables sous sa présidence. Ils sont notamment accusés d'assassinats, actes de torture et enlèvements.

Ces poursuites judiciaires visent essentiellement l'exprésident Alpha condé, 13 anciens membres de son gouvernement et de hauts responsables administratifs et sécuritaires à des degrés divers, rapporte notre correspondant à Conakry, Mouctar Bah.

Parmi eux, l'ancien Premier ministre Ibrahima Kassory Fofana, les anciens ministres Dr Mohamed Diané, Alpha Ibrahima Kéira, Albert Damantang Camara, Ibrahima Kalil Kaba, Tibou Kamara et Kiridi Bangoura pour ne citer que les plus influents. Certains d'entre eux sont en prison pour des faits présumés de corruption, de détournement de deniers publics et blanchiment.

D'autres hauts responsables de l'appareil judiciaire et sécuritaire sont aussi visés par cette procédure, dont entre autres l'ancien président de la Cour constitutionnelle, Mohamed Lamine Bangoura, les anciens présidents du Parlement, Claude Kaury Kondiano et Amadou Damaro Camara, et le général Ansoumane Camara qui était directeur général de la police à l'époque.

Ces poursuites ont été lancées suite aux violences qui ont entouré en 2019 le projet d'un 3e mandat d'Alpha Condé, et notamment la répression, souvent brutale, des manifestations contre le référendum permettant de modifier la Constitution pour qu'Alpha Condé reste au pouvoir.

### **Ne prenez pas la mise en garde** du Grand Mufti à la légère

Récemment, le grand mufti du Libéria, le cheikh Abubakar Sumaworo, a mis en garde l'administration Weah contre l'autorisation des djihadistes, principalement des musulmans chiites, d'établir des mosquées et des écoles au Libéria.

"Nous entendons dire que le régime du jihad est sur le point de se répandre dans certaines parties de l'Afrique, et avec les informations que nous avons recueillies jusqu'à présent, c'est que partout où ils arrivent, ils peuvent établir la guerre du jihad, l'école, y compris des mosquées et ceux-ci pourraient par la suite conduire au terrorisme », a encore averti le religieux musulman.

# 2021, un tournant pour l'humanité

ONDRES - Cette année constitue un tournant pour la planète. Même si la coopération internationale a souvent échoué en 2020, nous avons maintenant l'occasion - et la responsabilité - de faire que la nouvelle ère qui s'ouvre soit plus équitable et plus protectrice de la nature et des hommes partout dans le monde.

La pandémie de COVID-19 nous a appris que personne ne sera en sécurité tant que le monde entier ne le sera pas. La première étape, qui rapportera beaucoup plus qu'elle ne coûte, est de parvenir à une vaccination de masse dans tous les pays affectés. L'aide du G7 et du G20 pour vacciner aussi tôt que possible la population des pays à revenu faible et intermédiaire n'est en rien un acte de charité, car c'est dans l'intérêt de tous. Le FMI estime même que ce sera l'investissement public le plus rentable jamais réalisé.

Lors du sommet du G7 qui se tient ce week-end en Cornouailles, les Etats membres et leurs invités devraient ouvrir la voie et s'engager à fournir cette année et l'année prochaine 67 % du budget nécessaire au dispositif d'accélération d'accès aux outils de lutte contre le COVID-19 (ACT, Access to COVID-19 Tools). Ce pourcentage est basé sur le principe d'un financement équitable et sur une formule de partage de la charge financière proposés par la Norvège et l'Afrique du Sud qui prennent en compte la capacité de paiement réelle de chaque pays.

Le G7 devrait également montrer l'exemple en ce qui concerne le partage des doses de vaccin et les accords de licence volontaire qui pourraient inclure des dérogations temporaires aux brevets. Cela permettrait le transfert de savoir et de technologie nécessaires à la fabrication de vaccins sur tous les continents.

En outre, il faut demander aux institutions financières multilatérales et régionales de dégager de nouvelles ressources pour les pays à revenu faible ou intermédiaire afin de renforcer leur système de santé. Elles devraient également soutenir la mise en œuvre des recommandations détaillées du récent rapport du Groupe indépendant sur la préparation et la réponse aux pandémies commandé par l'OMS.

L'alignement des politiques économiques au niveau international sera crucial pour reconstruire l'économie mondiale dans le sillage de la pandémie. Par chance, au cours de l'année écoulée la plupart des pays ont adopté des politiques similaires dans la phase initiale de reprise économique face au COVID-19, ce qui a permis un niveau acceptable d'alignement. Il faut maintenant se mettre d'accord sur un plan de croissance mondial incluant des interventions monétaires et budgétaires coordonnées pour éviter une reprise inégale et déséquilibrée - et garantir un avenir plus inclusif, plus équitable et plus vert. Par exemple si le G7 et le G20 les adoptent, les propositions du FMI en faveur de mesures synchronisées d'amélioration des infrastructures sur tous les continents (notamment les infrastructures vertes) permettraient d'augmenter la production mondiale de 2000 milliards de dollars d'ici 2025.

Le G20 et le G7 doivent également s'attaquer aux divergences croissantes dues aux différences de résultats en matière de politique de santé et à l'absence de coordination des politiques macroéconomiques. La plupart des pays avancés peuvent espérer une croissance forte et des vaccins largement disponibles. Par contre, une grande partie des pays émergents et en développement doit faire face aux nouvelles vagues de la pandémie et aux nouveaux variants du virus, sans grands moyens pour amortir le choc économique et social de la crise. Après un lent redémarrage du commerce mondial et des investissements directs étrangers, de nombreux pays sont confrontés à une augmentation de la dette, à une baisse de leurs recettes fiscales et à une diminution de l'aide internationale.

Avec prés de 150 millions de personnes qui ont basculé dans la pauvreté à cause du COVID-19 et la réduction des budgets consacrés à l'éducation et à la santé dans nombre de pays, la réalisation des Objectifs de développement durable initialement prévue pour 2030 pourrait prendre jusqu'à 5 ans de retard ; les femmes et les fillettes en seraient alors les premières victimes. Nous appelons le G7 à élargir son initiative en faveur de l'éducation des filles en soutenant le plan de l'UNICEF destiné à combler le fossé numérique au sein et entre les diverses populations.

Le G7 et le G20 peuvent contribuer à combler l'insuffisance de budget des pays vulnérables pour atteindre les Objectifs de développement durable. Les banques multilatérales de développement devront y consacrer plus de moyens, de manière plus efficace, en optimisant leurs bilans et en réexaminant leur dispositif d'adéquation des fonds propres comme l'a déjà demandé le G20, et envisager leur reconstitution. À cet égard, nous devons examiner de nouveaux instruments fondés sur des garanties afin d'attirer le financement du secteur privé dans les domaines de la santé, de l'éducation et de la protection sociale. Nous devons aussi progresser dans la mise en œuvre d'accords internationaux visant à réduire l'évasion fiscale, incluant notamment un taux minimal d'imposition mondial -mesure qui a reçu récemment le soutien des ministres des Finances du G7.

Par ailleurs, nous devons redoubler d'efforts pour assurer la solvabilité de la dette des pays à revenu faible et intermédiaire. Autrement dit, il faut étendre l'Initiative de suspension du service de la dette du G20 et encourager une participation plus large des créanciers privés, et même des créanciers officiels non membres du G20 dans le nouveau Cadre commun de traitement de la dette. Le succès dépendra d'une plus grande transparence tant de la part des débiteurs que des créanciers.

Cette année est également essentielle pour parvenir à des émissions nettes nulles de dioxyde de carbone à l'horizon 2050. Avant le sommet des Nations unies sur le climat (COP26) qui se tiendra à Glasgow en novembre, les pays du G7 et du G20 doivent annoncer des engagements nationaux audacieux. Ils doivent exiger des entreprises qu'elles divulguent leur empreinte carbone, mettre en place le fonds proposé pour aider les pays à revenu faible et moyen inférieur face au réchauffement climatique et veiller à ce que leurs plans de relance économique favorisent les énergies renouvelables et les infrastructures vertes.

Cette tâche n'est pas du ressort exclusif des Etats. Les entreprises, les villes et les institutions multilatérales ont un rôle essentiel à jouer pour parvenir à des émissions nettes nulles de dioxyde de carbone d'ici 2050. De même que pour la reprise mondiale post-pandémique, il faut mettre en place dès cette année les mesures coordonnées pour cela!

ActionAdid Liberia along with its implementing partners converged at a local

inclusive community in the country.

The MAPUTO protocol is an African charter protocol on Human and people's right, right of women in Africa and international human right instrument established by the African Union that went into effect in 2005 which Liberia is a signatory to.

The program was graced by several women grouping including Civil Society Organization and the Deputy Minister of Gender, Children and Social Protection, Madam Alice Johnson Howard.

Madam Howard urged the Government to update the health system by making available qualified medical workers, electricity and ambulance to all healthcare centers in the country, adding that by doing so Liberia will achieve a lot in fighting sicknesses here.

Speaking on Liberia's position on the MAPUTO, she said Liberia is a signatory to the MAPUTO declaration and pregnant women are now allowed to attend school in Liberia from now onward.

Madam Howard indicated that it's significant to remove legal, regulatory and barriers limiting access to sexual reproductive health (SRH) communities program and service.

"Develop and implement legal and policy framework that prevents child marriage, and implement policies strategy and plan to reduce unintended pregnancies and unsafe abortion by developing legal framework strategic with program that deal with SGBV," she urged.

"We will make sure that this is taught to all people particularly, children, adolescents and youth both in and out of school with age appropriate and culturally sensitive," Madam she continued.

# **'Stop raising** unnecessary expectation

iberia's Vice President Madam Jewel Howard - Taylor has warned politicians here against unnecessarily raising the masses' expectations through false campaign promises ahead of the 2023 presidential and legislative elections.

Speaking to a group of young people Thursday, 5 May 2022 at a day-long conference organized by the Angie Brooks International Center (ABIC), Vice President Howard - Taylor warned politicians against making campaign promises about things that are not within their capacity to implement when elected.

"We should have to say the truth when we are on the campaign so we do not raise unnecessary expectation. Let's stop that because at the end all those promises they will make about constructing road [they] will not be done because it's the government that can do that, not an individual lawmaker," said Vice President Howard - Taylor.

She argued that it costs one million United States dollars to construct a mile of road and it's something that nobody should fool people that they will do it when they are elected to public office. She said it's only the government that can do such

a work.

According to VP Taylor, Liberians will have to decide or make the choice of the kind of leaders they need because true representation is important.

She told young people here that politicians will come with fake promises that they will build roads, construct clinics, and schools, among other things, when they know it's not in their capacity to do so.

"One bag of rice cannot keep you for six years neither one month. People are taking decisions in other parts of the world like I watch in Ghana recently where citizens threaten to burn a car that had rice in it that was brought by [a] politician to be distributed," VP Howard-Taylor explained.

She noted that young people have to decide what they want during electoral processes because when women wanted rape to be taken serious, they threatened to not vote and their demand was addressed.

"Therefore, I believe the same thing can happen if you demand that you need better school for your children, have computer and ICT training, drinking water not hand pump because we passed that," she said.

She encouraged the young people to determine what they want and with that people will do

# Flomayan questions NEC's credibility

he Ex-chairperson of the National Elections Commission (NEC) James Flomayan has questioned the Commission's credibility to conduct free, fair and transparent elections in 2023.

Speaking recently in Monrovia, Mr. Flomayan claimed that the power from above is remotely controlling the electoral body, which he

said is responsible for the NEC's alleged inability to rule in the ongoing CPP framework document case that is currently at the Supreme Court of Liberia.

Mr. Flomayan continued that the manner and form in which the NEC is proceeding with electoral dispute involving the controversial CPP framework documents clearly indicates the Commission has presented itself as a part in the ongoing conflict.

"Once you enter into an agreement and one group decides to pull out due to whatever reason that should not be a problem", he argued. He said once the original framework document is brought forth, it will then be the court that will tell which party is saying the truth about signing or not signing, analogizing that people can get marry and yet divorce so, if one party decided to pull out of whatever negotiation, there's nothing wrong with it and at such, it shouldn't be a genuine concern of the NEC.

The former NEC boss further argued that with all of the facts available and the NEC's alleged refusal to take a decision, rather leaving its responsibility with the court to decide, definitely defines the Commission as being a party. "For me, Mr. Samukai should have been certificated long, because he followed both the Elections and the court laws and registered and subsequently won the election landslide yet, you wouldn't certificate him; these are problems."
