#### **Basic Function of Position**

The USAID Project Management Specialist (Strategic Information/Monitoring, Evaluation, and Learning [SI/MEL]) position sits within the USAID Liberia Health Office, Service Delivery Team, and supports the development of and reporting on PEPFAR strategic information and monitoring, evaluation, and learning systems in support of Contracting/Agreement Officer's Representatives (C/AORs), Activity Managers and Advisors managing Mission PEPFAR programs/projects/activities as well as the interagency PEPFAR team.

The SI Specialist provides technical expertise for program monitoring and evaluation; data collection, use and analysis of large complex data sources; and surveillance and health informatics analysis and visualization for the USAID Mission, the broader PEPFAR inter-agency and host country stakeholders. He/she serves as the coordinator for meeting key reporting timelines related to the interagency Liberia PEPFAR program. The incumbent will be responsible for reporting on progress toward achieving PEPFAR targets as well as translating strategic information into improved PEPFAR programming, responsive service delivery and providing accountability for use of PEPFAR resources. S/He will coordinate data collection across the implementing agencies for all PEPFAR data streams, including performance indicators, site improvement through Monitoring System (SIMS) results, and expenditure analysis data.

The job holder guides USAID Implementing Partners (IP) and collaborates with development partner stakeholders and host country counterparts on mutually identified critical operational research and/or targeted public health evaluation questions; provides assistance in development of strategies and protocols to address those questions; and helps disseminate findings to the broader community within USG, development partners and host country stakeholders. The incumbent may be expected to perform work-related travel.

#### Major Duties and Responsibilities

#### A. Program/Project/Activity Performance Management and Reporting (50%)

- Responds to strategic information inquiries; gathers and compiles regular updates for OGAC, PEPFAR West Africa Region,  $USAID/Washington; assists CORs/AORs/Activity\ Managers\ by\ interfacing\ directly\ with\ implementing\ partners\ on\ data\ reported$ to USAID, the interagency and/or to the Government of Liberia (GOL).
- Addresses program-related vulnerabilities; and shares pertinent information on other development partner programs. S/he conducts regular site visits to review and provide feedback on program implementation, this may include meeting with
- Provides technical guidance to Health Office, Mission staff, IPs, and other USG agencies on MEL concepts, processes, design, training, and best practices. Provides guidance to IPs in understanding of the Performance Monitoring Plan systems, and their role in the process, and advises on specific measurement techniques appropriate for their programs/projects/activities
- Provides technical strategic information (SI) and monitoring and evaluation (M&E) expertise to the Program Office, USAID/Washington, and other USG agencies in order to plan and manage Health Office responsibilities related to the PMP, including collection, assessment of validity, and improving data quality. Develops innovative and cross-cutting monitoring tools, including Data Quality Assessment and Improvement (DQA/I) tools in coordination with the Program Office and SI/MEL contractors; tracks and maintains multiple sets of key indicators, common indicators related to standard components in all USAID programs/projects/activities, indicators at the strategic objective level, and detailed indicators at the activity level; and, ensures proper collection of data, and that indicators serve is an appropriate measure of their corresponding result.
- Leads, designs and performs assessments/studies/research requiring independent analysis and interpretation, on a regular and recurring basis; studies and research are cross-cutting, and include substantive and often sensitive Mission and Health Office topics. Briefs Health Office and Mission leaders on findings and makes recommendations to impact strategic, operational and programmatic direction.

- Provides support to strengthen the capacity of USAID and partners staff in the use of appropriate data management systems to measure and track progress made toward achieving targets based on required indicators. Advises on data collection and program monitoring tools and systems.
- Leads work and coordination with IPs to ensure PEPFAR data reporting requirements are met on a timely basis. Related activities include reviews of guidance documents, PEPFAR targets for the annual ROP, quarterly progress reports, and stakeholder meetings to analyze progress against targets.
- Assists in the analysis and interpretation of quantitative and qualitative data from various sources including SIMS (Site Improvement Monitoring System), Data for Accountability, Transparency, and Impact Monitoring (DATIM), District Health Information System 2 (DHIS2), and facility and partner-level data.
- Participates in the review and approval of annual work plans and periodic reports of USAID partners.

#### C. Representation & Public Speaking

- Attends external meetings, committees, and task teams, including GOL-facilitated technical working groups, as needed to represent the Liberia/PEPFAR interagency team. Supports development and presentations for research publications and/or abstracts for national and international conferences and
- Presents PEPFAR program performance results, research results and M&E plans to OGAC, USAID/Washington, USAID/Liberia, PEPFAR interagency stakeholders and external stakeholders that include other development partners, private sector partners,
- GOL, USG counterparts from other countries and PEPFAR Ips. Actively engages in local SI capacity building of host country governments and other local organizations to strengthen the collection, analysis and use of data for program planning and direction.

#### II. MINIMUM QUALIFICATIONS REQUIRED FOR THIS POSITION

- 1. Education: Minimum of bachelor's degree in social science, statistics, mathematics, mathematics, economics, computer science, epidemiology, health informatics, public health, infectious disease, zoonotic disease, biology is required.
- Prior Work Experience: Minimum of five years of progressively responsible job-related professional-level experience in monitoring, evaluation, and learning (MEL) and other surveillance systems, evaluation of program/project/activity implementation, in direct program/project/activity management, or in a closely related activity is required. # **EDITORIAL**

# Chief of Staff Maj./Gen. Johnson was brutally frank

MINISTER OF DEFENSE Daniel Ziankan had no reason leaving his busy schedules to come clarify a leaked audio on social media in which the Chief of Staff of the Armed Forces of Liberia (AFL) Maj./General Prince C. Johnson, III, strongly criticized the Minister of Finance Samuel D. Tweah, for a 20 percent cut in soldiers' salary. We believe the cut was absolutely wronged in the first place, and shouldn't have taken effect.

IN A LEAKED audio, a rather furious Maj./General Johnson is heard criticizing the cut and condemning the Finance Minister's decision, which he notes, poses serious threat to Liberian troops serving peacekeeping mission in Mali, where they face issues of rental and other obligations.

AMID CURRENT ECONOMIC stagnation in the country, the least that a responsible government would do is to reduce soldiers' income. In the words of opposition politician Alexander B. Cummings public service workers should earn a living wage. But in Liberia, this is far from reality except for cronies of the President.

THE GLOBAL SEARCH engine Goggle defines living wage as a theoretical income level that allows individuals or families to afford adequate shelter, food, and other necessities. The goal is to allow employees to earn enough income for a satisfactory standard of living that would prevent them from falling into poverty. Economists suggest that it should be sufficient to ensure that no more than 30 percent of income is spent on housing.

In Liberia, public service workers, including security forces live below the poverty line, with their disposal income unable to meet their basic needs, let along wants.

**AND SO, WHEN** the Chief of Staff of the military, who is directly accountable for troops sacrificing their lives in foreign land, gets to learn that their already meager income is being arbitrarily sliced by 20 percent, he is frustrated, because it lowers morale.

ANNUAL BUDGET FOR the Ministry of Defense is below US\$20 million that includes the Infantry and the National Coast Guard. When the army was dissolved after the civil war in 2023, enlisted men received a life-time benefit of US\$520 each and this was the end.

IT IS ONLY thru peacekeeping missions that soldiers, particularly in Africa earn a decent income that could sustain their upkeep after active service. But when this money is being cut for whatever reason, such as in the case of Liberian troops serving peacekeeping mission in Mali, there is every reason for dissatisfaction and frustration.

THE GOVERNMENT SHOULD be circumspect in how it treats soldiers, who sacrificing their lives for the country. They deserve all honor and respect, particularly as it regards their wellbeing.

WE BELIEVE THAT Maj./Gen. Johnson was only performing his duty under the unpleasant circumstance. He used the brutal military language that he has been trained to express, and there is nothing to apologize for.

# **Ecosystem Restoration Is Good for Your Health**

EW DELHI - Humanity currently faces multiple, interlinked existential crises. The catastrophic consequences of climate change, ecological degradation, and biodiversity loss have cascading knock-on effects on human health and well-being. As the COVID-19 pandemic illustrates, ecosystem damage can contribute significantly to a global public-health emergency. But scientists are also increasingly finding that ecological restoration, by reversing the threats to soil, biodiversity, water, and other ecosystem services, can deliver major health benefits.

There have been many attempts to understand the nexus between ecological degradation and human health. A recent study of over 6,800 ecosystems across six continents provided further evidence that deforestation and extinction of species will make pandemics more likely. Ecosystem damage also leads to water contamination, creating breeding grounds for infectious diseases. Similarly, soil degradation not only reduces agricultural productivity, but also has been linked to disease and increased mortality.

The emergence and spread of zoonotic diseases like COVID-19 are closely associated with the health of ecosystems. For example, 75% of emerging infectious diseases are zoonotic, caused by unsustainable use of natural resources, factory farming of animals, and other industrial-scale anthropogenic factors.

Ecosystem decline has also contributed in recent decades to reduced immunological resilience and an increase in allergic conditions in humans. The effects are not limited to physical health, but also include mental-health problems such as an increase in eco-anxiety, or fear of environmental damage due to ongoing ecosystem degradation.

Conversely, restoring natural ecosystems could provide pathways for reversing some of the effects of climate change and ease the global chronic-disease burden, thus improving human health and well-being. One recent study showed that soil restoration and the reintroduction of native plant species led to a reduction in physical and psychological impacts of certain diseases. In another case, ecological restoration of an urban river in northwest England was linked to psychological benefits for surrounding communities.

There is also evidence that ecological restoration can protect people from extreme climate events and related public-health crises. Finally, using alternative cooking fuels such as biogas in improved stoves, thereby reducing the need for fuelwood and helping to prevent forest degradation, has been shown to improve respiratory health and household diets.

The economic case for ecological restoration is strong. Rising public-health costs and the significant disease burden - exacerbated by the pandemic - strengthen the case further. The World Health Organization estimates that global spending on health rose continuously between 2000 and 2018, to \$8.3 trillion, or

10% of world GDP.

Some prominent international efforts to reap the benefits of ecological restoration to planetary and human health are already underway. The United Nations Decade on Ecosystem Restoration, running from 2021 to 2030, and the land degradation neutrality program of the UN Convention to Combat Desertification encourage signatory countries to recognize the central importance of ecological restoration. Likewise, the #HealthyRecovery initiative, signed by over 4,500 health professionals from 90 countries, urged G20 leaders to fund projects that enable ecological restoration as part of their pandemic stimulus packages.

In recent decades, researchers have developed various models - including the Mandala of Health, the Wheel of Fundamental Human Needs, and, more recently, the One Health approach - to capture the interconnected relationship between humans and nature. The challenge now is to develop a unifying framework to maximize the synergy of ecological restoration and human health. Policies designed to address one should not exclude the other.

We therefore need to redefine ecological degradation, understand its far-reaching effects on human health, and recognize that these effects cannot be fully addressed without structured, context-specific ecological restoration plans. Achieving this will require institutionalizing and mainstreaming intersectoral collaboration between scientists and practitioners from the ecological, medical, and sustainability domains.

Alliances and a sense of ownership among core governance structures of public health and ecosystem restoration will be crucial. In India, for example, a pioneering effort to mainstream cross-disciplinary initiatives is bringing together the government, scientists, and local partners and practitioners with the aim of improving zoonotic-disease control. Such a framework can generate valuable knowledge and insights for similar collaborative initiatives elsewhere.

Ecological restoration is a clear and identifiable way to tackle the global disease burden and improve public health. As the UN Decade on Ecosystem Restoration commences, policymakers should encourage collective action to spur inclusive, interdisciplinary activities that demonstrate the positive global benefits of restoration for social, physical, and mental health. We owe it to ourselves and to the planet to mitigate at least some of the threats we have created.



Dr. Lawrence D. Sekajipo, Chairman of the BoC, thanked ERERA for its continuous support to the work of LERC since its creation. He recounted that ERERA over the years continued to provide training for its staff members at the Commission including the BoC.

Dr. Sekajipo told the delegation that the Commission is open to training opportunities for members of its professional staff since electricity regulation is new to Liberia. "LERC is striving to be the best regulator it can in the region", he asserted during the working session.

## Le passeport diplomatique libérien aux mains des criminels

La manière dont l'on traite les passeports diplomatiques libériens officiels sous l'administration Weah laisse à désirer à tous égards.

Ce document officiel qui est sensé être sacré a maintenant l'air d'un papier hygiénique. Pire, on le trouve entre les mains des criminels et des fraudeurs purs et durs, au point de ternir l'image de notre chère République.

Un homme d'affaires libérien proche de la vice-présidente Taylor aurait été interpellé aux États-Unis pour blanchiment d'argent.

Ce qui est plus honteux, c'est que le suspect, quoi qu'il ne travaille pas pour le gouvernement libérien, dispose d'un passeport diplomatique libérien, ce qui lui permet de se livrer aisément à ses activités criminelles en se faisant passer pour un diplomate.

Cette situation suscite plus de questions sans réponses : Comment a-t-il obtenu le passeport diplomatique libérien ? Qui le lui a délivré ? La vice-présidente Taylor est-elle au courant et depuis combien de temps a-t-il de manière douteuse ce passeport diplomatique, exerçant son métier de criminel? Voilà des questions auxquelles l'on devra répondre.

De toutes les façons ce n'est pas la première fois que le passeport diplomatique libérien tombe aux mains d'un criminel. En septembre 2020, l'ancien secrétaire d'État américain Michael R. Pompeo sous l'administration Trump a interdit à l'ancien directeur libérien des passeports Andrew Wonplo et à sa famille immédiate de se rendre en Amérique "pour son implication dans une affaire de corruption importante". Cela a réduit la confiance du public libérien dans la gestion des documents d'identité et de voyage par le gouvernement actuel et compromis l'intégrité et la politique d'immigration.

L'enquête sur le scandale à l'époque a abouti à l'inculpation de Wonplo et d'un nigérian nommé Adedoyin Emmanuel Atiro qui s'était fait passer pour une autorité du ministère libérien des Affaires étrangères et offrait des opportunités de voyage movennant des sommes d'argent importantes.

Dans l'affaire récente, selon FrontPageAfrica, Sheik Kante, communément connu au Libéria sous le nom de Royal Gold, a été arrêté à son domicile aux États-Unis le 20 avril et par la suite accusé de complot de blanchiment d'argent quelques heures avant son départ prévu de l'aéroport international de Dulles à Washington pour les Emirats Arabes Unis.

Ce qui est encore plus dégoûtant, c'est que ceux qui détiennent illégalement des passeports diplomatiques libériens ont généralement des liens avec de hauts responsables du gouvernement libérien, comme dans ce cas, avec la vice-présidente Taylor, ce qui laisse place aux soupçons.

Pendant que le suspect Kante est en garde à vue aux États-Unis, la vice-présidente du Libéria doit tout faire dès maintenant pour se disculper en disant ce qu'elle sait sur le passeport diplomatique que détient un homme d'affaires libérien ordinaire avec lequel elle aurait des liens.

C'est important non seulement pour l'intégrité personnelle de la vice-présidente que les Libériens tiennent en très haute estime, mais aussi pour l'image du régime actuel et du pays tout entier.

# NAREMOL frowns on scarcity of LRD 5, 10 and 20 banknotes

group identified as National Revolutionary Movement of Liberia or NAREMOL, calls on the Central Bank of Liberia and the Ministry of Finance to address the scarcity of 5, 10 & 20 Liberian Dollars Banknotes on the market.

Speaking on Wednesday, May 11, 2022, in Central Monrovia, Chairman Siaffa of mutilated legacy banknotes in the market.

He laments that the intent of the printing of the money has not been met because the Liberian market is currently flooded with mutilated banknotes, while the newly printed family of banknotes is scare, adding that the legislature has also been unable to adequately exercise its oversight responsibility by inviting and questioning the Central Bank authorities about the current government officials and not for the ordinary people. Peace-loving Liberians, as you may be cognizant, local trade and business transactions are done in small demonstrations; and if so, what is the rationale behind printing 48 billion Liberian Dollars in 500, 100 Banknotes and leaving out the \$5, \$10, \$20 & 50LD? We feel that this is a strategy to rob our people and the state or keep monies for their respective positions comes 2023 elections."

NAREMOL notes that the absence of 5 and 10LRD Banknotes and the gradual disappearance of 20LRD from the Liberian market are creating serious embarrassment for the balance of local trade on the market, adding that due to the absence of these small banknotes on the market, passengers, drivers, riders of kekeh and their passengers are getting into fight daily because of change issue.

Kanneh says failure on the part of the Central Bank and the Economic Management Team of the President to act in addressing the situation, the group would be left with no option but to stage an unannounced action at both the Ministry of Finance and the Central Bank of Liberia.

Meanwhile, NAREMOL says issue of the disappearance of

despicable acts that rob Liberians of their heritage because of a few pieces of silver," Mr. Anderson Miamen, Executive Director of CENTAL. said during a press conference in Sinkor Thursday, 12 May 2022.

Quoting a local daily's report in Monrovia, Mr. Miamen said Liberian businessman Sheik Bassirou Kante is undergoing trial in the U.S. for money laundering conspiracy and was denied bail over several concerns, including possession of a Liberian diplomatic passport.

He said there have been multiple cases reported about the alleged continuous sale of Liberian Passports (ordinary, official, and diplomatic) to undeserving and unscrupulous individuals for probable dubious business dealings and other clandestine purposes.

Miamen indicated that the U.S. also denied Mr. Kante bail, citing his 'deep personal relationship' with the Vice President of the Republic of Liberia, Madam Jewel Howard -Taylor.

He said it was reported that Mr. Kante, alias Royal Gold, who is being tried for wire fraud amounting to US\$ 7 Million, admitted to occupying no formal diplomatic position in the Liberian Government.

The CENTAL Executive Director said the latest passport scandal speaks to many things including gross vulnerability of the system and the process for awarding passports - ordinary, official, and diplomatic.

Miamen narrated that the level of commitment required from the Presidency and the Legislature to thoroughly and independently investigate these matters as well as fully support institutions statutorily mandated to do so are very limited.

He also blamed the situation on weak leadership and oversight of the Legislature for its alleged failure to effectively and independently oversee the work of the Executive, the Ministry of Foreign Affairs and the passport granting process in this instant case.

The CENTAL Executive Director said his institution is deeply concerned about the unceasing trends of these incidents, especially this latest passport scandal, which adds to multiple similar cases reported here.

Miamen recalled that the situation is no different from the Andrew Wonploe saga of 2020, the Danish Journalist saga of 2012, and other scandals previously uncovered.

He warned that this undermines the rule of law, national security, and the integrity and sanity of the country's passport granting

Additionally, Miamen believes that it exposes the vulnerability of Liberia's systems and processes and devalues the country's priceless identity.

"It is extremely painful that while ordinary citizens queue during early morning hours and for several days to get passports, to which they are entitled, others have found it rewarding to deny their own citizens in favor of a passport black market," Miamen lamented.

He said this is a disgraceful act that has the tendency to place Liberia as a pariah in the comity of nations, since they have the propensity to undermine international peace and security.

"CENTAL is very disappointed that the unorthodox dealings of public officials and their accomplices have become commonplace in Liberia," he said.

He alleged that government officials and their collaborators orchestrate plans to defraud the country and fatten their own pockets at the expense of ordinary Liberians and voters who continue to be grossly mistreated by their leaders.

He also alleged limited political will and the culture of impunity for corruption and other related offenses, especially those perpetrated by high-ranking public officials.

Meanwhile, Mr. Miamen on behalf of CENTAL, has thanked President Weah for launching an investigation into the passport matter.

"While the move by the President to instantly probe into the matter is welcoming, we strongly believe that the Ministry of Foreign Affairs is conflicted and cannot be trusted to independently and robustly interrogate said scandal," said Miamen.

He called on the President to constitute an independent committee composed of credible and reputable individuals from the religious community, civil society, the Press as well as the Liberia Anti-Corruption Commission to thoroughly oversee the matter.

"We call on our development partners to be more vigilant and unwavering in standing by the Liberian People by exposing individuals who continue to collude to defraud the Country and keep ordinary Liberians trapped in poverty-stricken conditions," he added.

# Development Superintendent **losses house to fire**

Residents said though others may have termed the situation as a witch-haunt, the actual cause of the fire could likely be a result of poor wiring. They said although the owner (Robin Scott) of the damaged house haven't spoken, the situation is worrisome and regretting.

They expressed that despite efforts applied to off the fire, it didn't materialize, leaving nearly
