No disrespect to Representative **Solomon George**i

OUR FRIEND Representative Solomon George of Montserrado County District #7 is unhappy about a nickname ascribed to him in our last editorial for which he called this paper and expressed so. Sorry; we did not in any manner or shape intend to disrespect the Montserrado lawmaker.

AND IF Rep. George felt insulted or disrespected for the nickname ascribed to him in that editorial, we use this medium to publicly apologize.

NOTWITHSTANDING, WE vehemently maintain our opposition to his recent call for President George Manneh Weah to ban student politics at the University of Liberia or in schools across the country. We think the call by Rep. Gorge is not only preposterous but highly disgraceful and disappointing. It is an ill-advice to the President from a blind loyalist that does not see beyond his nose.

FOR THE ruling Coalition for Democratic Change (CDC) lawmaker to question whether the campus-based Vanguard Student Unification Party (SUP) at the University of Liberia is a political party clearly demonstrates that he is power-possessed and speaks like someone, who has never entered the classroom.

WE WONDER what fear does Rep. George have for which he wants student politics banned in the country. Isn't he aware that this one of many extra-curriculum activities that allow students to demonstrate their potentials and talents for future responsibility?

WE REITERATE that the recent July 26 Independence Day violence before the Embassy of the United States near Monrovia was master-minded and executed by the CDC-Council of Patriots, not members of SUP. Instead, the victims were students of the University of Liberia.

THE ONLY wrong they did for which they were brutalized was to peacefully call on the government to address the excruciating hardship in the country that has made the learning environment unconducive for them.

THE RAMPANT human rights abuses, mysterious deaths and arbitrary killings by state security forces under the Weah administration are not the works of students, including massive corruption and flagrant constitutional breaches that Liberians and the international community continue to lament on.

ON THE contrary, it is innocent and peaceful students across the country, who are enduring the scorches of pillage and loot by public officials which denies them opportunities for a better future.

IT IS sad that the Montserrado District#7 lawmaker would ignore the plight of his constituents - the neglected people of the township of West Point and surroundings in the current county tour of the President, and rather called for a ban on student politics. How does this benefit his people directly?

REPRESENTATIVE GEORGE should rather advocate for his district to benefit better schools, toilets and health facilities than focusing his energies on something that does not in any way | interfere with his role as a lawmaker or the governance of the State. Students do not contest in national elections, but it is their right under the Constitution to express reservation about how the country is governed.

THE GOVERNMENT and its officials, including the likes of Rep. George seem to be terrified by reaction from the United States Government against unabated public corruption in the Weah administration that has led the American Treasury to designate three confidants of President Weah.

THE CDC lawmaker should rather advise the President to take steps against officials bent on tarnishing his government and the country's image than seeking to prey on suffering innocent students, who hardly find a decent daily meal because their parents are jobless, primarily due to the appalling economic situation prevailing in Liberia.

Minister Nathaniel F. Mcgill Writes President George Weah

Your Excellency:

I have the honor, most respectfully, to present my compliments and to congratulate you for Your Excellency's exceptional statesmanship in steering the affairs of this nation in these trying times of our national existence.

Excellency, let me commend you for your unwavering determination to fight waste, abuse and the mismanagement of public resources which was a solemn pledge you made at Your Excellency's inauguration, and for the swift and decisive action taken thus far, in ordering my immediate suspension and others named in the United States Treasury Department report for alleged corruption to face investigation.

Excellency, the United States Treasury Department report contains several criminal mischaracterizations of my person, name and character as Your Excellency's Minister of State, as in keeping with the Executive Law of Liberia, and given that the allegations range from bribing business owners, receiving bribes from potential investors, and accepting kickbacks for steering contracts to companies, and or manipulating or manipulated public procurement processes in order to award multi-million dollar contracts to companies in which I have ownership, including by abusing emergency procurement processes to rig contract bids, among others, I humbly welcome Your Excellency pronouncement to set up an investigative committee to probe into these grave allegations to afford me the opportunity to have my "day in court" as in keeping with the principle of due process. These allegations are crimes also under Liberian law and must be investigated consistent with law controlling.

Excellency, please allow me to provide you brief analyses and clarifications of some of the allegations: that I have been accused of:

1. Bribed business owners, received bribes from potential investors, and accepted kickbacks for steering contracts to companies in which he has an interest:

Response: a. Bribed business owners--- To what end, and for what purpose, and in in whose interest? One who bribes business owners must have an objective to achieve something in his own interest, but in this case, no interest is defined, and no reason is provided.

- b. Receiving bribes from potential investors---What are the names of the investors? And who are the investors? I have at no time ever received bribes from any investors.
- c. Kickbacks for steering contracts---I do not preside over contract negotiations, nor do I sign contracts, and so where will the kickbacks come from?

 Those who may have provided wrong information to the members of the Treasury Department investigators who were seeking to gather accurate and genuine allegations of corruption, abuse, waste and mismanagement of public funds in the fight against corruption unfortunately provided the wrong and false information. For full disclosure Mr. President, my only involvement with contract discussions is the current ongoing impasse between and amongst AML, HPX and the SOLWAY issue.
- 2. Manipulated public procurement processes in order to award multi-million dollar contracts to companies in which he has ownership, including by abusing emergency procurement processes to rig contract bids.

Response: Under this count, while I have not seen any evidence today, the multi-million dollar contract that I am aware of, since the ascendancy of this government is the US\$116millon dollars RIA Road Contract to East International. As you are aware Mr. President, this matter was presented to the cabinet in 2019 by then Public Works Minister, Mobutu Nyanpan that the RIA Road project would cost US\$116M and that cabinet should approve the borrowing of said amount. It was then the decision of the cabinet that due to Liberia's huge debt burden said amount was too huge for the government to borrow at the time. Therefore, the cabinet decision was that since Madame Ellen Johnson Sirleaf government had granted East International a concession of US\$56, 432Million (plus) agreement ratified by the legislature for the construction of feudal roads in Liberia before your ascendancy, said agreement should be presented to the legislature for amendment so that instead of borrowing US\$116m, the government will now borrow US\$56, 432Million (plus) for the RIA road project. My ownerships in East International as alleged is false and misleading because East International was in existence around 2011 and granted road contracts under the Unity Party Government, one of which was the US\$9,567,010.9 Million contract. I do not see how the Unity Party government would have granted a US\$9, 567,010.9 Million contract to a company with an ownership of the sitting chairman of the CDC. Also the Unity Party government granted the following contracts to East International prior to the ascendancy of the CDC lead administration. Also, in January 2017 the Unity Party Government awarded East International was awarded US\$19, 900, 005 million under the signature of Gyude Moore. The total contract granted East International by the Unity Party government is US\$ 79,467,015.9 million.

Instead of accusing the Unity Party people of creating and owning East International, I am been accused as it owner.

3. Accused of involvement in a wide range of other corrupt schemes including soliciting bribes from government office seekers and misappropriating government assets for his personal gain.

Response: While these allegations are broad and require specificity, it is the fact of public records both in the media that criminal individuals have been using my name without my knowledge to get money from people seeking public office.

4. Used government funds allocated to other Liberian government institutions to run his own projects, made off-the-books payments in cash to senior government leaders, and organized warlords to threaten political rivals;

Response: Apart from asking public and private institutions to support the cause of poor and underprivileged Liberian high school students, I do not run private projects. For the records, all monies donated to public High School students are deposited in the school accounts for the specific counties to which I am not a signatory and counties that have benefited thus far are Bong, Margibi, Nimba and Grand Bassa. Unfortunately, we are yet to raise all of the monies that have been pledged to these counties for student projects.

- a. I would highly appreciate the senior government officials to come forth with the evidence. And since these are senior government officials, I would be glad to face them. In the case of politicians being attacked by some individuals I have no idea. I am a friend to all of the political leaders and none has personally complained to me about being attacked.
- 5. Received an unjustified stipend from various Liberian government institutions and used his position to prevent his misappropriation from being discovered.

Response: Again, these allegations are broad, but for the records, I deny and reject them because I do not receive stipends from other government agencies as doing so would greatly erode my stature and authority as the 'Principal Assistant to the President and Minister of State for Presidential Affairs. Because doing so I would be involved in corruption with them.

6. Regularly distributes thousands of dollars in undocumented cash to other government officials for government and non-government activities:

Response: I hereby incorporate the averments of my response in count 5 and hereby deny and dismiss the allegations contain herein. However, when a friend or any Liberian citizen in need seeks assistance from me, it is a public information and a fact that individual coming to me for assistance, I always ask other private institutions and individuals to help.

L'USAID met fin à son programme réussi de lecture au primaire et à la maternelle

'ambassadeur des États-Unis au Libéria, ■Michael McCarthy, en compagnie avec des responsables du Ministère libérien de l'Éducation et autres parties prenantes, a procédé à la clôture du programme de lecture qui avait été lancé il y a cinq ans et qui a considérablement amélioré les compétences en lecture notamment des élèves du primaire et de la maternelle dans six comtés du pays.


Le programme USAID Read Liberia a été lancé en 2017 et a permis au gouvernement du Libéria d'atteindre plus de 180 000 élèves des 1ère et 2ème années dans 640 écoles primaires publiques avec un enseignement amélioré de la lecture dans six comtés, dont Lofa, Bong, Grand Bassa, Nimba, Margibi , et Montserrado. Plus de 5 000 élèves de la maternelle ont aussi bénéficié d'une amélioration des compétences en lecture et du vocabulaire, tandis que plus de 4 500 enseignants ont été formés à l'utilisation de la méthodologie de lecture au niveau élémentaire, et 391

418 kits d'enseignement et d'apprentissage ont été distribués.

Le programme a en outre amélioré les compétences dans le vocabulaire oral d'environ 2 700 élèves de la maternelle issus de 60 écoles maternelles publiques. Grace au programme, environ 57 000 élèves des 1ère et 2ème années sont capables de lire des textes de niveau scolaire avec aisance et compréhension.

This Rigid Pavement Pre-Financing Agreement (the "Agreement"), dated _____Day of ______between the Republic of Liberia, represented by the Ministry of Public Works, the Ministry of Finance and Development Planning (hereinafter referred to as the "Government") and East International Group Incorporated, a company established under the laws of the Republic of Liberia (hereinafter referred to as the "East International") for the purpose of pre-financing the implementation of the pavement of 51 KM Neighborhood Roads and 24.5 KM of Existing Roads from Klay to DC Clark in Bomi County (as defined in the Appendix 1 to this Pre-financing Agreement).

WHEREAS, the Government of Liberia has a goal of reducing travel time for its citizens, enhancing national economic efficiency, and promoting social welfare of the Liberian people;

WHEREAS, the Government is mindful of the relevance of constructing durable road networks throughout the Republic, which it deems critical to achieving its goal geared towards providing ease of access for all its citizens and residents alike, thereby spurring national development;

WHEREAS, the deplorable condition of the existing road corridor from Klay to DC Clark in Bomi County, poses a continuing challenge of access to medical care, as experienced during Liberia' recent EBOLA crisis, which prevented first responders from accessing outlying communities to transport EBOLA infected persons to designated treatment centers;

WHEREAS, the rehabilitation and upgrading of the neighborhood roads will improve the social welfare, economic conditions, and zoning effect of one of Africa's oldest capitol city;

WHEREAS, this pre-financing agreement is necessitated as a consequence of the Government of Liberia's current economic constraints, prohibiting its ability to implement and complete a number of critical national projects;

WHEREAS, East International Group Inc., a construction company licensed to undertake construction works in Liberia, did participate in and won the National Competitive Bidding (IFB No. MPW/RPP/NCB/001/15/16) issued on November 15, 2016, for the aforementioned road corridors under a pre-financing arrangement, where they are to provide the requisite finances for

he implementation of the project;

NOW THEREFORE, the Government and East International hereby agree as follows:

ARTICLE 1. DEFINITONS

Section 1.1 Where used in this Agreement, unless the context otherwise requires, the following terms have the following meanings:

- "Agreement" means this Rigid Pavement Pre-financing Agreement, its schedules, and appendices.
- "East International" shall have the meaning given in the preamble.
- "Environmental and Social Impact Assessment" or "ESIA" means the framework form and substance satisfactory to the Environmental Protection Agency (EPA), setting out modalities to be followed in assessing the potential adverse environmental and social Impact associated with activities to be implemented under the Project, and the measure to be taken to offset, reduce, or mitigate such adverse impact.
- "Environmental and Social Management Plan" or "ESMP" means a plan, approved by EPA for the Project, to be prepared by East International Group Incorporated, by proposing appropriate mitigation, monitoring and institutional measures designed to mitigate potential adverse environmental and resettlement impacts, offset them, and reduce them to acceptable levels or enhance positive impacts, as the same may be amended from time to time.
- "Financing Amount" means an amount not more than Fifty-Seven Million United States
 Dollars to be pre-financed by East International for completion of the Project.
- "Government" shall have the meaning given in the preamble.
- "Ministry of Public Works" or "MPW" means the Government of Liberia's Ministry of Public Works.
- "Notice of Effectiveness" means a written notice in the form set forth hereto, which shall be the Project Start Date.
- "Project" means the rigid concrete pavement of certain roads as described heretofore
- "Project Implementation Team" or "PIT" means the project implementation team within the Ministry of Public Works as referred heretofore in this agreement, which shall include, at a minimum, a Project Coordinator, a Procurement Specialist, a Financial Management Specialist, and an Environmental Specialist.
 - "Project Start Date" means the date the Notice of Effectiveness is issued confirming that the Effective Date of this Agreement has occurred and the execution of the Subsidiary Contract Agreement.
 - "Resettlement Action Plan" or "RAP" means the plan prepared by the Government of Liberia on the basis of the RPF (as hereinafter defined) supplemented from time to time with the prior written concurrence of East International and subject to the initial consultation and disclosure requirements carried out on the RAP.
 - "Repayment Schedule" means the schedule showing the dates and amounts of repayment of the Loan set forth herein.
 - "Subsidiary Contract Agreement" means the works contract required under this agreement to be executed between the Government and East International pursuant to which East International Group shall implement the project.

ARTICLE 2. FINANCING

- 2.1 The EAST INTERNATIONAL GROUP INCORPORARTED agrees to procure on behalf of the Liberian Government, for the purpose of implementing the Project, an external loan in an amount not to exceed Fifty Nine Million Five Hundred Sixty Seven Thousand Ten United States Dollars and Nine Cents (US\$59,567,010.9) on the terms and conditions set forth or referred to in this Agreement (the "Financing Amount")
- 2.2 The Government and East International shall utilize and drawdown the proceeds for the financing in support of the Project in accordance with terms and conditions in this Agreement and the Subsidiary Agreement.
- 2.3 There shall be no interest payable by the Government on the Financing.
- 2.4 The payment of the Financing to the Contractor(s) shall be as required by the Subsidiary Agreement in accordance with the terms and conditions stipulated herein.
- 2.5 All disbursements and repayments of the Financing Amount shall be recorded in United States Dollars, except as otherwise agreed to by the Parties.
- 2.6 The repayment of the Financing Amount shall be completed in accordance with the Repayment Schedule,
- 2.7 The entire proceeds of the Financing shall be applied for the sole purpose of the financing of One Hundred percent (100%) of the Project in accordance with the terms and conditions of this Agreement and the Subsidiary Contract Agreement.

ARTICLE 3. DISBURSEMENT OF FINANCING AMOUNT

Section 3. 1 The first disbursement of the Financing Amount is subject to the satisfaction of the following:

- a. This Agreement is ratified by the National Legislature and approved by the President.
- (a) The Government and East International shall enter into a Subsidiary Contract Agreement defining the terms and conditions for completion of the Project. The Subsidiary Contract Agreement shall provide that:
- (i) East International shall submit Quarterly Project Reports to the MPW to be submitted within two weeks of the end of each quarter, which shall include the status of: (a) engineering, procurement and construction contracts and activities; (b) Project cost and disbursement; and (c) the results monitoring indicators for its Parts of the Project;
- (ii) Construction and completion of the Project shall be in compliance with Liberian law, including environmental and labor laws;
- (iii) Except for an initial mobilization amount to be agreed upon by the Parties, a Certificate of Completion for each phase of work shall be issued by the Ministry of Public Works, upon confirmation by an Independent Consultant, prior to any payments or drawdown from the Financing Amount by East International;
- (iv) Submit to MPW the Project Reports referred to above not later than two (2) weeks after the end of the period covered by such reports developed by EAST INTERNATIONAL GROUP INCORPORARTED; and
- (v) During the term of this Agreement, East International shall maintain a financial management system, prepare financial statements and conduct regular audits in accordance with standards acceptable to the General Auditing Commission of Liberia (GAC) relating to the payment/drawdown of the Financing Amount, costs and expenditures, and repayment of the Financing Amount by the Government.
- (vi) East International shall with due care and diligence, design, execute and complete the works and remedy any defects therein in accordance with the provision of the Subsidiary Contract Agreement and shall provide superintendence, labor, materials, plant, equipment, and all other things, whether of a temporary or permanent nature, required in and for such design, execution, completion of the Project and remedying of any defects.

ARTICLE 4. REPRESENTATIONS AND WARRANTIES

Section 4.1 The Government and East International jointly declare their commitment to the completion of the Project and shall ensure the Project is completed in accordance with this Agreement and the Subsidiary Contract Agreement.

Section 4.2 The Government hereby represents and warrants as follows:

- (a) The Republic of Liberia is represented by the Ministry of Public Works and Ministry of Finance and Development Planning of Liberia, and has full power, authority and legal rights to borrow the Financing Amount on the terms and conditions hereunder.
- (b) As of the Effective Date, the Government has completed all the authorizations, acts and procedures as required by the laws of the Liberia in order for this Agreement to constitute valid and legally binding obligations of the Government in accordance with its terms.
- (c) As of the Effective Date, this Agreement constitutes legal, valid and binding obligation of the Government.

Section 4.3 East International hereby represents and warrants as follows:

- (a) It is a corporation duly organized, validly existing and in good standing under Liberian Law, and has the corporate power and authority to execute, deliver and perform its obligations under this Agreement.
- (b) This Agreement has been duly authorized by all necessary corporate action on the part of East International, and this Agreement constitutes a legal, valid and binding obligation of East International enforceable in accordance with its terms.
- (c) East International has the technical and financial capacity to provide the Financing

 Amount and implement the Project.

ARTICLE 5. **EFFECTIVENESS**

Section 5.1 The Condition of Effectiveness consists of the following (the "Effective Date"):

- (a) This Agreement has been duly signed by the Parties, ratified by the National Legislature and approved by the President;
- (b) The Subsidiary Contract Agreement has been executed in form and substance satisfactory to the Parties, to encompass the specification of the Project as envisaged by Section 3(b) of this Agreement;
- (c) A Notice of Effectiveness is issued certifying the completion of Section 3. (a) and 3.(b).
- (d) The Effectiveness Deadline shall be the date ninety (90) days following the ratification of this Agreement by the National Legislature and approval by the President.

ARTICLE 6. SUSPENSION; TERMINATION; REMEDIES

If an Event of Suspension shall occur and is continuing for a period of thirty (30) business days following receipt of notice of the occurrence of an Event of Suspension, the Party claiming the Event of Suspension may suspend performance until such time as such Event of Suspension is remedied.

Section 6.2 A "Government Event of Suspension" shall mean the Act creating the Ministry of Public Works has been amended, suspended, abrogated, repealed the ability of the Ministry of Public Works to perform any of its obligations under this Agreement.

Section 6.3 A "Company Event of Suspension" shall mean that East International shall fail to perform any obligation under this Agreement or is in breach of the Subsidiary Contract Agreement and such failure to perform or breach is not remedied within thirty (30) business days following receipt of notice from the Government of the occurrence of a Company Event of Suspension.

Section 6.4 This Agreement may be terminated upon the occurrence of an Event of Suspension that is continuing for thirty (30) business days following notice of such Event of Suspension, the Party claiming the Event of Suspension may terminate this Agreement upon thirty (30) days prior written notice of termination.

ARTICLE 7. MISCELLAEOUS

Section 7.1 This Agreement shall be governed and construed in accordance with laws of Liberia. Any claim or dispute by either party against the other arising out of this Agreement may be settled by negotiation between the Parties, and failing such settlement, the Party bringing such dispute may seek all remedies available at law.

Section 7.2 All notices or other documents in connection with this Agreement shall be in writing and shall be delivered or sent either personally or by post or email to the following respective address or email addresses of both parties; in the event that the following address or email of any party hereunder has changed, such party shall immediately inform the other party in the way set out in this Agreement:

Section 7.3 Unless otherwise provided, no failure or delay by either Party in exercising any of its rights, power or privilege under this Agreement shall impair such right, power or privilege or operate as a waiver thereof, nor shall any single or partial exercise of any right, power or privilege preclude any further exercise thereof or the exercise of any other right, power or privilege.

Section 7.4 The appendices to this Agreement, as has been adjusted, shall be deemed as an integral part of this Agreement and have the same legal effect as this Agreement.

Section 7.5 The Subsidiary Agreement referred to in Article 3 of this Pre-financing Agreement shall conform to the overall objectives of the Project and shall not deviate from any of the provisions and terms of the Pre-financing Agreement, including the adjusted Appendix 1.

Section 7.6 Contract no. MPW-W-003-16/17 entered by and between the Ministry of Public Works and East International Group Inc. shall be incorporated and be an integral part of this Prefinancing agreement.

Section 7.7 This Pre-financing Agreement shall be subject to review every two (2) years to make the necessary adjustment to any change in circumstances and any change from said review shall be approved by the Legislature.

Section 7.8 The terms and conditions of this Agreement shall inure to the benefit of and be binding upon the Parties hereto, their successors by operation of law and permitted assignees and legal representatives including without limitation in the case of Government, all successor Governments and/or institutions.



It says "All power is inherent in the people. All free governments are instituted by their authority and for their benefit and they have the right

In order to ensure democratic government which responds to the wishes of the governed, the provision says the people shall have the right at such period, and in such manner as provided for under this Constitution, to cause their public servants to leave office and to fill vacancies by regular elections and appointment.

He said the latest round of sanctions imposed on Liberian government officials by the U.S. while very troubling, are no surprise to the Liberian people.


According to him, Liberians have for over five years been suffering and have become poorer because of endemic corruption and the predatory nature of the Weah administration.

The letter, a copy of which was sent to this paper, McGill responded to each of the counts brought against him with outright denial challenging the allegations while calling for the evidence.

A very visible figure in the government, McGill countered the allegations linking him to kickbacks he was accused of receiving for influencing contract awards to companies he has interest

Relating to the content of the allegations levied against him by the US Treasury Department, McGill said the report contained several criminal mischaracterizations of his person, name and character.

The allegations against McGill range from bribing business owners, receiving bribes from potential investors, and accepting kickbacks for steering contracts to companies.

They also includes manipulating public procurement processes to award multi-million-dollar contracts to companies in which he allegedly has ownership, while at the same time abusing emergency procurement processes to rig contract bids, among others.

However, Mr. McGill said he welcomed the President's pronouncement to set up an investigative committee to probe into these grave allegations to afford "me the opportunity to have my "day in court" as in keeping with the principle of due process."

He contended that these allegations are crimes also under the Liberian law and must be investigated consistent with the controlling laws.

Meanwhile, in his responses to the allegations, McGill denied that he ever "Bribed owners, received bribes from potential investors and accepted kickbacks for steering contracts to companies in which he has an interest."

"To what end, and for what purpose, and in whose interest? One who bribes

business owners must have an objective to achieve something in his own interest. But in this case, no interest is defined, and no reason is provided," he argued.

On receiving bribes from potential investors, McGill rejected the claim, saying "What are the names of the investors? And who are the investors?"

"I have at no time ever received bribes from any investors," he said, going further to also deny ever receiving kickbacks from steering contracts.

"I do not preside over contract negotiations, nor do I sign contracts, and so where will the kickbacks come from?"

McGill believes that wrong and false information may have been provided to the members of the Treasury Department investigators who were seeking to gather accurate and genuine information about corruption, abuse, waste and mismanagement of public funds.

He told President Weah that for full disclosure, his only involvement with contract discussions is the current ongoing impasse among ArcelorMittal Liberia (AML), HPX and the SOLWAY.

He also responded to allegations of manipulating public procurement processes in order to award multi-milliondollar contracts to companies in which he has ownership, including by abusing emergency procurement processes to rig contract bids.

McGill said while he has not seen any evidence against this count, the multi-million-dollar contract that he was aware of since the ascendancy of this government is the US\$116 million dollars Roberts International Airport (RIA) Road Contract to East International.

He reminded President Weah how the late Minister of Public Works, Mobutu Vlah Nyenpan, made a presentation at a Cabinet meeting in 2019 that the RIA Road project would have cost US\$116M.

He added that the Minister had called on cabinet to approve the borrowing of said amount.

"It was then the decision of the cabinet that due to Liberia's huge debt burden; the said amount was too huge for the government to borrow at the time," McGill explained.

He indicated that the cabinet's decision was that since Madame Ellen Johnson Sirleaf's government had granted East International a concession of US\$56, 432 million (plus) agreement ratified by the legislature for the construction of feeder roads in Liberia, said agreement should be presented to the legislature for amendment.

Instead of borrowing US\$116m, he said, the cabinet decided that the government will now borrow US\$56, 432 million (plus) for the RIA road project.

"My ownership in East International as alleged is false and misleading because East International was in existence around 2011 and granted road contracts under the Unity Party Government, one of which was the US\$59,567,010.9 Million contract," said McGill.

McGill said he does not see how the Unity Party government would have granted a US59, 567,010.9 million contracts to a company with an ownership of the sitting chairman of the then opposition, CDC.

Also, to delink himself from the East International Company of having a controlling stake in the company, McGill said in the communication that the construction outfit was given contracts amounting to US\$79,467,015.9, under the UP government, US\$19,900,005.00 of which was given under the signature of Gyude Moore, former Minister of Public Works.

"Instead of accusing the Unity Party people of creating and owning East International, I am being accused as its owner," he said. (see full text of letter and documents on pages 7, 10, 11 & 12)

The President's claim was made during his announcement of plans to construct a new JFK hospital in Monrovia.
