The plan was carried out with Mr Ruto's knowledge, it alleges, but the petition does not provide any evidence to back this up.

Mr Odinga raises questions about the tallying process and says that not all the constituency results were announced before the final result was declared.

He also says there is evidence that the results from some polling stations were altered in his opponent's favour before they were displayed on the IEBC's web portal. And he suggests that the voter turnout figure was manipulated so Mr Ruto di not have to go into a secondround run-off. Speaking after handing the petition over to the Supreme Court, Mr Odinga said "corruption cartels" were undermining democracy, but did not specify who he meant. This was the fifth time that the 77 year old had run for president. Previously he had been the opposition candidate, but this time he was backed by outgoing President Uhuru Kenyatta.

politician successfully challenged the result of that year's presidential election, which he lost to Mr Kenyatta, and the Supreme Court ordered a re-run. The case highlighted logistical issues in the way the results were collated. However, in 2013 his challenge was dismissed.

This time the IEBC tried to make the results process as transparent as possible by publishing the polling station tallies as soon as they were available. The independent **Elections Observation Group** did its own tally and said its estimates were consistent with what the electoral commission published.

A week ago, there were chaotic scenes at the

national tallying centre moments before the final result of the 9 August poll was about to be read out. Some of Mr Odinga's political allies stormed the stage and scuffles broke out. Two electoral commissioners were injured and four others left the compound to hold a press conference to denounce the outcome.

Nevertheless, Mr Chebukati proceeded with the announcement and handed Mr Ruto the certificate confirming that he was the winner.

The election commission head said he had defied threats to perform his duty of announcing results according to the will of the people, while Mr Ruto hailed him as a "hero".Last week, Mr Ruto said he would respect the court process, which is part of the country's electoral law.

"I'm a democrat. I believe in the rule of law. I respect our institutions," he told journalists.

# Twelve die in Uganda from suspected alcohol poisoning



olice in northwestern Uganda are investigating the deaths of a dozen people who are suspected to have consumed a locally manufactured gin. The deaths are said to have been registered between Saturday and Sunday in Madi-Okollo district.

Several others, including one trader who was selling the gin known as City 5 Pineapple Flavoured Gin, have been hospitalised with suspected poisoning.

It is not clear what the ingredients in the drink are,

but "demineralised water, extra neutral alcohol and pineapple flavour" are listed on the bottle.A regional police spokesperson said that samples of the gin have been collected and will be submitted to the government chemist to conduct tests. Four suspects have been arrested, and the cottage factory where the gin was being manufactured closed, as investigations continue. Deaths from adulterated alcohol are common in Uganda. In 2010, at least 80 people died in southwestern Uganda after drinking alcohol laced with methanol, according to authorities. BBC

**OUR FRIEND** Representative Solomon George of Montserrado County District #7 is unhappy about a nickname ascribed to him in our last editorial for which he called this paper and expressed so. Sorry; we did not in any manner or shape intend to disrespect the Montserrado lawmaker.

AND IF Rep. George felt insulted or disrespected for the nickname ascribed to him in that editorial, we use this medium to publicly apologize.

NOTWITHSTANDING, WE vehemently maintain our opposition to his recent call for President George Manneh Weah to ban student politics at the University of Liberia or in schools across the country. We think the call by Rep. Gorge is not only preposterous but highly disgraceful and disappointing. It is an ill-advice to the President from a blind loyalist that does not see beyond his nose.

**FOR THE** ruling Coalition for Democratic Change (CDC) lawmaker to question whether the campus-based Vanguard Student Unification Party (SUP) at the University of Liberia is a political party clearly demonstrates that he is power-possessed and speaks like someone, who has never entered the classroom.

**WE WONDER** what fear does Rep. George have for which he wants student politics banned in the country. Isn't he aware that this one of many extra-curriculum activities that allow students to demonstrate their potentials and talents for future responsibility?

WE REITERATE that the recent July 26 Independence Day violence before the Embassy of the United States near Monrovia was master-minded and executed by the CDC-Council of Patriots, not members of SUP. Instead, the victims were students of the University of Liberia.

# **Bystanders No More**

ELBOURNE - In March 1964, the New York Times reported that 38 witnesses saw or heard a brutal, drawn-out, and ultimately fatal attack f V lon a woman called Kitty Genovese, but none did anything to help her, or even summoned the police. The report was later shown to be erroneous, but the "bystander effect" is real. As many psychology experiments have shown, an individual is less likely to come to the aid of another if they can see that other people who could help are not doing so.

Last month, in the middle of the day on a busy street in the Italian town of Civitanova Marche, Alika Ogorchukwu, a Nigerian street vendor, was attacked and killed by a man using his bare hands. Although the police were called, and someone filmed the attack, no one intervened. Amid general outrage, an editorial in the Italian newspaper La Stampa took this as a sign that we are in "the twilight of civilization."

If you had been there, would you have aided Ogorchukwu? Consider, before you answer, that to intervene would have involved some personal risk. The assailant was not using a weapon, but how could you know that he did not have one? And even without a weapon, he was evidently both enraged and strong.

Whatever you feel you would have done had you been present, a far bigger bystander effect is playing out right now. In this case, you can assist in saving the lives of others, without any danger to you. Moreover, some of those whom you may be able to save are Nigerians, which makes it possible to think of the assistance as a token of your opposition to the failure to help Ogorchukwu.

A report issued recently by the United Nations Food and Agriculture Organization and the World Food Program warns that between now and September, famine could affect 49 million people in 46 countries. The countries most at risk are Afghanistan, Ethiopia, Nigeria, Somalia, South Sudan, and Yemen. Civil strife is one major risk factor for famine in these countries, but the report also cites weather extremes, such as storms, flooding and drought, and rising food and energy prices stemming from the war in Ukraine.

And yet a disturbing trend has become evident: governments of affluent countries are giving less foreign aid. The most striking example is the United Kingdom, a country that gradually, with bipartisan agreement, worked its way up to the United Nations foreign-aid target of 0.7% of gross national income. That target was reached in 2013 and was met every year until 2020. In 2021, however, the UK's foreign-aid budget was slashed to 0.5% of GNI, and it will most likely remain at that level in 2022.

As Mark Lowcock, a former permanent secretary of the UK Department for International Development, pointed out in a recent interview, his country, which used to be a world leader in making extreme poverty the clear priority of its aid program, is now placing less emphasis on helping the poorest and weakest countries. Aid to countries like Yemen, South Sudan, and Somalia has been cut, increasing the loss of life from humanitarian disasters. Instead, Lowcock says, aid is going to middle-income countries where its impact on people's lives is not nearly as big as when it goes to those living below the World Bank's extreme poverty line of \$1.90 per day.

There are two important ways in which you can avoid being a bystander to the avoidable deaths of millions of people in the coming months.

First, according to preliminary OECD figures, in 2021, only Luxembourg, Norway, Sweden, Germany, and Denmark have reached or exceeded the 0.7%of-GNI target for foreign aid. The United States still lags near the bottom of the table of donor countries, giving only 0.18% of its GNI, while Australia, at 0.22%, is not much better. If you live in an affluent country that is not meeting the 0.7% target, contact your elected representatives and tell them that you are ashamed of your country's failure to do its share to create a world in which everyone can meet their basic needs. Join with others to create a movement for more and better foreign aid.

Second, after you have done that, don't just sit around waiting for your government to do the right thing. Do it yourself. If you are affluent enough to go to a café and order a cup of coffee there, you are probably spending more doing that than nearly one in ten people on this planet have to live on for an entire day.

### President Weah Declares **Wednesday as National Flag Day**

resident George Manneh Weah has by Proclamation declared Wednesday, August 24, 2022, as National Flag Day and is to be observed throughout the country as a National Holiday.

The Proclamation is in consonance with an Act approved on October 25, 1915, by the National Legislature of the Republic of Liberia declaring the 24th day of August of each year as "National Flag Day" to be observed as a National Holiday.

According to a Foreign Ministry release, the Day is commemorated annually by citizens of the Republic in testimony of their allegiance and loyalty to the National Ensign which is an embodiment of the nation's existence as a sovereign entity and to encourage national pride and patriotism.

The Proclamation further orders citizens and foreign residents within the borders of Liberia to give prominence to the observance of the event throughout the Republic by flying the National Flag from each dwelling and public building.

The Proclamation also orders that Government offices as well as public and business houses remain closed

during the observance.

The Proclamation recalls that the National Flag was designed and produced by a committee of ladies led by Mrs. Susannah Lewis who were talented and visionary citizens of the Republic at the time. The release noted that the making of the National Flag of the Republic of Liberia was a historic event of great significance for Liberia as Africa's Pacesetter in the struggle for selfdetermination and inspiration to future African States. The release recounted that the National Ensign of the Republic of Liberia is visible



Plus de 5 000 élèves de la maternelle ont aussi bénéficié d'une amélioration des compétences en lecture et du vocabulaire, tandis que plus de 4 500 enseignants ont été formés à



l'utilisation de la méthodologie de lecture au niveau élémentaire, et 391 418 kits d'enseignement et d'apprentissage ont été distribués.

Le programme a en outre amélioré les compétences dans le vocabulaire oral d'environ 2 700 élèves de la maternelle issus de 60 écoles maternelles publiques. Grace au programme, environ 57 000 élèves des 1ère et 2ème années sont capables de lire des textes de niveau scolaire avec aisance et compréhension.

Les élèves qui ont bénéficié du programme Read Liberia peuvent désormais lire correctement par minute près de deux fois plus de mots qu'avant le lancement du programme. ### **TOPIC:** Teenage pregnancy

Teenage pregnancy is on the rise across Liberia, affecting girls in school. As a result, most female students drop out of school, reducing enrolment among girl children.

In a recent random interview with some residents of Sanoyea District, in Bong County, The NEW DAWN asked what should be done to curtail the problem that is impeding the educational sojourn of our girls, which could deny them of a better future.

"As for me, the thing we can do is to advise them and give them family planning medicine because this time children, when you advise them, some of them don't hear people. When you advise them that having early sex as teenagers leads to early pregnancy, they will not hear us, as long sex business gets in their head. And when we are taking them for family planning, they shouldn't take five years pills or implants because the five years is not good for young person. It's only good for people who born plenty children. And I think some of them that are educated should go by their menstrual

In Sanoyea District here most of the young people that are carrying pregnancies are teenagers; it is giving us hard time. So, people who are educated in science can advise the young people to go by their menstrual cycle. I think that is one of the ways to stop the rate of teenage pregnancy. But it's very difficult for us here."

"The issue of teenage pregnancy, to have it stopped will be a little bit difficult, because our children this time don't want to be under control. Some of them leave their parents' house because they don't want to be under parental care and secondly, because some parents don't have the

financial means to take care of their children. So, most of the children have become breadwinners for the family. And because of that, some parents no longer bear. Some of them decided to use violence to take them from the street and it will not help us as parents. We parents need to stand strong to talk to our children to go back to school and have some vocational training as well as educating them on the effects of teenage pregnancy. We just have to continue to talk to them and see how best we can get them under control."

"I think to stop the rate of teenage pregnancy, there should be a lot of training awareness on family planning,

mainly on the radio for teenagers. I think it will help to minimize it."

"For me, when it comes to teenage pregnancy around the country especially, in the rural areas -Sanoyea District where I work, we need to create more awareness on family planning, because the reason teenage pregnancy is on high increase is that most

themselves. So, we have to create more awareness because it is out of ignorance, they do this. We have to educate them and parents to understand that it is not good. Secondly, the Ministry of Health needs to carry out awareness in schools; do advertisement in newspapers and conduct training on family planning to educate our teenagers to avoid teenage pregnancy."

"The first thing is that our children are not willing to go to school to be educated, because when you are educated and know the effect of you being pregnant at an early age than you will know how to prevent yourselves. But the children that are in school now when the team from the health sector go to schools, telling the girls children about birth control the good and bad sides to prevent them from teenage pregnancy, they aren't willing to take the medicine whenever we tell them. The children will say family planning medicine can give them infection so, whenever they go around and get the first and second pregnancies, they will not stop. When you try to talk to them as parents, still they don't want to be educated from home. They are hiding these days. So, what can be done for the girl children, we need to bring them closer as parents. I think there should be some awareness in communities to tell them the good and bad sides of

teenage pregnancy, maybe they

will listen. I have my own children and then my daughter has her own, for that reason I am unable to finish my education and I have to take care of my children and my daughter's children so, it is the poverty race we're in. And it's bringing poverty on us, and we are just growing inside. So, the government needs to stand strong. The wave of teenage pregnancies in Sanoyea District, more of them are not educated, and because they are not educated to do something, it is on the increase. We have from 14 to 15 years old getting pregnant. I think there should be more teenage awareness in school and on the radio."

after this case was brought. The decision also expressly recognizes that even though this was one of worst single episodes of the Liberian Civil Wars, Thomas has never been criminally prosecuted for leading the attack.

Following the Court's decision, the CJA said despite recommendations from Liberia's Truth and Reconciliation Commission (TRC) over a decade ago calling for an investigation, Liberia has taken no steps to hold a single perpetrator of the Massacre accountable.

What is now left to be seen is how the US court intends to get Liberian authorities to collaborate with it in ensuring that the amount it has awarded to the four victims is paid.

But with the milestone decision made by the U.S. Court, the CJA has suggested that Liberia has an opportunity to see that Col. Thomas is prosecuted for his crimes, urging Liberia to act and ensure the defendant is fully brought to justice for his

He survivors, represented by CJA and Debevoise & Plimpton LLP with support from the Global Justice and Research Project,

submitted nearly 2,000 pages of evidence.

They had argued that Col. Thomas commanded an elite special forces unit in the massacre of 600 civilians in a Red Cross shelter at St. Peter's Lutheran Church in Monrovia, Liberia during the country's first civil war in July 1990.

Liberia's brutal civil conflict is estimated to have left over 200,000 victims dead, destroyed properties worth millions of dollars, displayed many others and sent some into exile.

Two successive civil wars in the West African state also immensely broke down almost every system, infrastructure and affected human capital development for decades.

The scars of the civil wars are still fresh nearly two decades after a ceasefire agreement was signed in Accra, Ghana, and three peaceful elections held here subsequently.

War - affected youth remain at the disadvantaged level of society to date in Liberia, with a lot of them who were never properly rehabilitated, still finding comfort in illicit drug abuse and other acts of criminality.

# US nails another Liberian war actor



U.S. Court has ordered Col. Moses Thomas, a former Liberian soldier who supervised the massacre of unarmed civilians at the Lutheran Church in the 1990s, to pay US\$84m to four unanimous survivors.

The Court in Pennsylvania orders that each of the survivors be paid US\$6 million in compensatory damages and US\$15 million in punitive damages. The United States - based Center for Justice and Accountability (CJA) says the case was brought in 2018 by four survivors of the massacre - Jane W, John X, John Y, and John Z - against Moses Thomas, a former commander of the Armed Forces of Liberia (AFL). The magistrate judge in determining this award last week, made clear the egregiousness and brutality of the Massacre.

The court's ruling on damages follows a September 2021 decision holding Col. Thomas

responsible for the war crimes, crimes against humanity, extrajudicial killing, attempted extrajudicial killing, and torture that took place during the Massacre.

The Lutheran Church Massacre is one of the deadliest attacks on civilians during the Liberian Civil Wars from 1989 to 2003.

Now imprisoned former President Charles Ghankay Taylor's rebel forces were fighting government troops at the time of the Massacre in the outskirts of Monrovia.

The killings were blamed on the army of slain President Samuel Doe.

Col. Thomas, formerly a resident of Pennsylvania, has now returned to Liberia, according to the CJA.

The U.S. Court's decision emphasized the importance of ensuring that the United States is not a safe haven for torturers and death squad leaders.It also pointed out that Col. Thomas had lived freely in the U.S. for approximately 19 years before fleeing back to Liberia less than two years
