Togo Extends State of Emergency Due to Militant Attacks

OME, TOGO – The West African nation of Togo has extended a state of emergency in its northern Savanes region for another six months due to continued attacks by Islamist militants.

A six-month state of emergency was approved Tuesday by the Togolese parliament to restore security in the region.

A statement from Damehame Yark, the Togolese security minister, said that the extension was 'necessary for the proper conduct of military operations" and "a return to peace" in the region.

attacked an area near the border with Burkina Faso, killing eight troops and wounding 13.

More recently, local media said that between 15 and 20 people were killed in a series of attacks on July 15. While the army gave no official figures about this incident, it was confirmed that "several" people were killed and wounded.

Togolese defense and security forces were again attacked on August 22 in the village of Blamonga, close to the border with Burkina Faso. A few soldiers were injured during an exchange of fire that lasted several minutes before armed groups retreated. Togo, after Benin, Ghana and Ivory Coast, is the latest country on the coast of West Africa to become the target of Islamist militants coming from the Sahel region.VOA

New malaria vaccine is world-changing, say scientists

malaria vaccine with "worldchanging" potential has been developed by scientists at the University of Oxford.

The team expect it to be rolled out next year after trials showed up to 80% protection against the deadly disease.Crucially, say the scientists, their vaccine is cheap and they already have a deal to manufacture more than 100 million doses a year. The charity Malaria No More said recent progress meant children dying from malaria could end "in our lifetimes". It has taken more than a century to develop effective vaccines as the malaria parasite, which is spread by mosquitoes, is spectacularly complex and elusive. It is a constantly moving target, shifting forms inside the body, which make it hard to immunise against. Last year, the World Health Organization gave the historic go-ahead for the first vaccine - developed by

pharmaceutical giant GSK - to be used in Africa. However, the Oxford team claim their approach is more effective and can be manufactured on a far greater scale.

Trial results from 409 children in Nanoro, Burkina Faso, have been published in the Lancet Infectious Diseases. It shows three initial doses followed by a booster a year later gives up to 80% protection."We think these data are the best data yet in the field with any malaria vaccine," said Prof Adrian Hill, director of the Jenner Institute at the university.

The team will start the process of getting their vaccine approved in the next few weeks, but a final decision will hinge on the results of a larger trial of 4,800 children due before the end of the year.

The world's largest vaccine manufacturer - the Serum

Institute of India - is already lined up to make more than 100 million doses a year. Prof Hill said the vaccine - called R21 - could be made for "a few dollars" and "we really could be looking at a very substantial reduction in that horrendous burden of malaria".He added: "We hope that this will be deployed and available and saving lives, certainly by the end of next year.'

Malaria has been one of the biggest scourges on humanity for millennia and mostly kills babies and infants. The disease still kills more than 400,000 people a year even after dramatic progress with bed nets, insecticides and drugs.

This malaria vaccine is the 14th that Prof Katie Ewer has worked on at Oxford as "this is not like Covid where we have seven vaccines straight away that will work... it's much, much harder".BBC

EDITORIAL **Welcoming Chief Justice** Yuoh's intervention

ALTHOUGH SHE has not formally taken office, but immediate step taken by the incoming Chief Justice of the Supreme Court of Liberia, Her Honour, Cllr. Sie-A-Nyene G. Yuoh in freezing the account of the judiciary, is prudent and welcoming, for the sake of accountability.

THE ACTION by Chief Justice Yuoh comes at the time her predecessor, outgoing Chief Justice Francis Korkpor, Sr., who reached the 70 years age limit for anyone occupying the nation's Highest Court, drags to leave.

FORMER CHIEF Justice Korkpor, who reportedly turned 70 this week, is said to be holding on to end the March Term of Court before departing office sometimes this month.

BUT AMID the seeming vacuum, financial transactions could take place that could have a bearing on the incoming administration with accountability and transparency reservations.

SO, THE intervention should serve as a lesson for change of administration in any sector of | government. Chances should not be created for public funds to be left at the discretion of officials, who are on their way out, for this may leave room for misappropriations at the detriment of the State.

BY THIS singular action, Chief Justice Sie-A-Nyene G. Yuoh clearly demonstrates that she is climbing the Judiciary's highest seat with full knowledge of her game. This was administratively correct and fiscally prudent.

THE JUDICIARY is a place of honor, trust and respect. Those ascending to leadership there should act and be seen as people with farsightedness, astuteness and discipline.

HOWEVER, WE do not by any imagination or insinuation belabor the leadership that outgoing Chief Justice Francis Korkpor provided over the Third Branch of the Liberian government during his nearly 20 years of service.

As the internet activist Eli Pariser noted in 2011, Facebook also creates filter bubbles, whereby individuals are more likely to be presented with content that reinforces their own ideological leanings and confirms their own biases. And more recent research has demonstrated that this process has a major influence on the type of information users see.

choices, the broader social-media ecosystem allows people to find subcommunities that align with their interests. This is not necessarily a bad thing. If you are the only person in your community with an interest in ornithology, you no longer have to be alone, because you can now connect with ornithology enthusiasts from around the world. But, of course, the same applies to the lone access or propagate hate speech and conspiracy theories.

True, some find such observations alarmist, noting that large players like Facebook and YouTube (which is owned by Google/Alphabet) do much more to police hate speech and misinformation than their smaller rivals do. especially now that better moderation practices have been developed. Moreover, other researchers have challenged the finding that falsehoods spread compared to other media.

Still others argue that even if the current socialmedia environment is treacherous, the problem is have always been misused. Martin Luther used the printing press to promote not just Protestantism but also virulent anti-Semitism. Radio proved to be a powerful tool in the hands of demagogues like Father Charles Coughlin in the US and the Nazis in Germany. Both print and broadcast outlets remain full of misinformation to this day, but society has century thinker, warned about where this can lead. adjusted to these media and managed to contain their negative effects.

But such measures fail to address the depth of around the world glued to their mobile the problem. Social media is not only creating echo chambers, propagating falsehoods, and facilitating the circulation of extremist ideas. It also may be shaking the very foundations of human artificial social networks for real ones.

Earlier media innovations capitalized on this, yet none of them modified the very nature of human networks the way that social media have.

What happens when platforms such as Facebook, Even leaving aside Facebook's algorithmic Twitter, or Reddit start manipulating what we perceive as our social network? The worrying truth is that nobody knows. And though we could eventually adapt to this change and find ways to neutralize its most pernicious effects, that isn't an outcome that we should count on, given the direction the industry has been heading.

Social media's most corrosive effects are starting extremist who can now use the same platforms to to look exactly like what the cultural critic Neil Postman anticipated almost four decades ago in his landmark book Amusing Ourselves to Death. "Americans no longer talk to each other, they No one disputes that social-media platforms entertain each other," he observed. "They do not exchange ideas, they exchange images. They do not disinformation, and propaganda. Reddit and argue with propositions; they argue with good looks, celebrities, and commercials."

Comparing George Orwell's 1984 to Aldous 2021, attack on the United States Capitol. Former Huxley's Brave New World, Postman then added US President Donald Trump's anti-Muslim tweets that, "What Orwell feared were those who would were found to have fueled violence against ban books. What Huxley feared was that there would be no reason to ban a book, for there would be no one who wanted to read one. Orwell feared those who would deprive us of information. Huxley feared those who would give us so much that we would be reduced to passivity and egoism. Orwell feared that the truth would be concealed from us. Huxley feared that the truth would be drowned in a sea of irrelevance."

Whereas Postman was worried more about a faster on Facebook and Twitter, at least when Huxleyan future than an Orwellian one, social media have been ushering in both at the same time. While governments acquire the means both to manipulate our perceptions of reality and to reduce us to passivity and egoism, our virtual "friends" are transitory. After all, novel communication tools increasingly policing our thoughts. One now must continuously signal one's virtue and call out people who deviate from prevailing orthodoxy. But "virtue" is whatever one's artificial online social circle says it is; and in many cases, it is based entirely on lies.

TAKING OVER from the reformist, developmentally-towering and fearless late Chief Justice Johnnie R. Lewis under the administration of ex-President Ellen Johnson Sirleaf, Chief Justice Korkpor succeeded in not just keeping lawyers in check, but the entire judiciary intact, for which he should be commended.

AS HE steps down to give way to his successor, Chief Justice Sie-A-Nyene G. Yuoh, we can but only wish the judiciary a smooth transition particularly, the Supreme Court of Liberia, the final arbiter of justice in the land.

You know, often, people tend to become explosive out of deep-rooted hurt and disappointments. They then resort to going all out publicly revealing things that were either once said in private or in confidence when things fall apart.

The downside of this is that it makes the road to reconciliation much longer than it would have been when things had stay as they were.

Fahngon has only found it compelling to tell it all and paint a ghastly picture of the Weah regime as a way of getting back at it to win public sentiment, but he has for the years he worked in the same administration benefitted immensely as well.

But to the contrary, his outburst has become a double edge sword swinging making a victim of his own account as well as bringing his integrity into question-Why now?

h e House of Representatives has r e j e c t e d a controversial pension and benefit scheme passed by the Liberian Senate with lucrative life - time benefits appropriated for retired lawmakers and their from the Government a pension annuity equal to 50 percent of his or her last highest gross salary earned as Speaker per annum.

The condition set is that the retired speaker shall not in any way be gainfully employed by the



families.

The Act is cited as the Integrated Pension and Benefits of 2022.

It says a Speaker of the House of Representatives who retires honorably after serving a full term of six years or more shall receive government.

The honorably retired speaker is also entitled to personal staff and facilities for the reminder of his or her life.

The retiree is also entitled to police or other state security protection and other services around the clock.

If the retiree becomes gainfully re-employed by the government, the Act says the annuity shall be suspended until the new employment is terminated or retired.

Additionally, the Act says the surviving spouse of the deceased speaker or former speaker shall be entitled to 50 percent of the annuity of the speaker during the natural life of the spouse.

This annuity, the Act says, if applicable, shall commence as of the date of the death of the speaker or former speaker.

On the death of the spouse or if there is no spouse, the Act further says the annuity provided for the surviving spouse shall be paid in equal portion to each of the children of the deceased speaker or former speaker until they attain the age of 21.

Similar provisions are made for the Vice President and Deputy Speaker in the Act.

As for the members of the House of Representatives, the Act says retirees are entitled to 10 percent of the last highest salaries, paid in equal monthly installments.

According to the Act, an elected officer of the House of

Representatives or the Liberian Senate who retires honorably after six years of service shall receive a pension annuity that equals 10 percent of his or her last highest gross salary as an officer of the Legislature.

It further says an elected officer of the House of Representatives or Liberian Senate who has served for 12 years and retires honorably shall receive a pension annuity that equals 30 percent of his or her last highest salary.

Moreover, the Act says an elected officer of the House or the Senate who serves three consecutive legislative terms and retires shall receive 50 percent of his or her last highest salary.

The condition set is that the retiree shall not be gainfully employed by the Government.

Representatives on Thursday, 8 September 2022 saw the act as a disservice to the Liberian people.

According to them, the Act is not in the interest of the Liberian people and they can not add more to what the Liberian people are going through.Lofa County Electoral District #2 Representative Clarence Massaquoi made the motion that the Act be sent back to the Liberian Senate and that it be treated like it has never existed.

According to the Act it will help address current gaps and shortcomings in existing pension laws for the categories of officials covered under as well as make necessary and proper adjustments that holistically address those gaps and shortcomings. The Liberian Senate passed and forwarded to the House of Representatives the Act Adopting an Integrated Pensions and Benefits Scheme for Certain Categories of Officials of the Government of the Republic of Liberia.

The Act was endorsed and passed by majority Senators through a vote after it was forwarded by the Senate Committee on Judiciary, headed by Senator Varney Sherman of Grand Cape Mount County.

Mother of twins appeal for help

She said it was by God's grace that some residents intervened and rescued the kids that were lying in the room. "My people, I left my children in the room and I went to look for food because we have been abounded by the father for four months now", she said.

Madam Toe continued that due to the present condition of the children, it has been difficult for her to get something doing because she can't leave them in the care of anyone in the name of work.

"We have been managing by the help of other residents because as you can see the kids' condition, I can't leave them home and the father, I who should've helped us, has

2022, leaving several tenants displaced and properties damaged.

Speaking to this paper, several residents near the damaged apartment regretted the situation, which they suspected was a witch-haunt.

Although actual cause of the fire is yet to be established, but sources said the situation is worrisome because the house wasn't electrified, and nobody was cooking inside when it suddenly burst in flames.

They narrated that the fire started from the rear of the house and subsequently engulfed the entire premises, as community turned his back on the kids and I." "So, I really want people to help me because four months

Probably not with the same budget, but maybe with a lesser budget to be able to maintain the structure," he said.

According to him, from July 2020 to now they have been no direct donor support but added that UN Women has been channelling support to the ministry of gender and other CSOs including the system for providing Aid to help sustain the project.

The chairman of Samukai Town, Upper Caldwell, Montserrado county, Clarence A. Zayzay applauded the spotlight initiative, saying through training, the community has set up series of activities to help minimize SGBV cases.

"For us at the community level, we used to judge a lot of cases on domestic violence, but since they came in that has been minimized," Chairman

Chairman of the Vouson community in Brewerville also indicated that the program has been a serious eye opener for them. According to him, after the training from the UN EU spotlight initially, the community set up a taskforce to monitor all SGBV cases and after their intervention, the issue of SGBV in their community has also been reduced.

"The rape issue is no more in our community because we are working in line with the ministry of gender to handle rape cases in our community. once someone is accused of rape in our community, we usually report them to the police", he indicated.

Director of the United Funding and Development for Underage Mothers (UFDUM) Meki D. Lamar, encouraged members of the community to continuously practice community policing, as they tackle FGM issues.

"Just a few days ago, a little child was raped and she lost blood, at a result of this, the little girl died but we want you to make sure that your children are protected", she advised residents.

She indicated that few years ago, the U.N. funded the EU spotlight initiative, which focused on the book titled **Comprehensive** Prevention Strategies that talks about

Liberian Journalist Sues Steel giant-Arcelormittal, Others For Action Of Damages



iberian Journalist Lyndon Ponnie yesterday ∎sued steel giant ArcelorMittal and other companies, for Action of Damages at the Civil Law Court at the Temple of Justice in Monrovia.

Mr. Lyndon Ponnie, Editor of the Concord Times Newspaper in Monrovia sued ArcelorMittal and other companies in Liberia and England, for singly and jointly illegally shutting down his newspaper's websiteconcordtimes.net for publishing a 17-year-investigative story that revealed that Mittal Steel did not originally win the bid for the Nimba Mountain; and that it sought the assistance of former US Ambassador accredited to Liberia John W. Blaney to take control of the former LIMINCO. ArcelorMittal through their lawyers in London claimed the Concord Times reports were incorrect; and therefore asked the website host which is also based in England, to take down the stories without approval from the management of the Newspaper in Liberia.

The website host didn't just take the stories down but shut down the entire website in 2020.

Based on these illegal and draconian actions by Mittal Steel and others; lawyers representing Mr. Ponnie and Concord Times Newspaper, Counsellor-At-Law Finley Y. Karngar, and other counsels from the Success Thinkers law office in Monrovia, filed a lawsuit for the action of Damages against Mittal and its collaborators and is claiming US\$9,700 in specific Damage representing the loss of business opportunities since the unilateral shutdown of the website.The lawyers are also demanding an amount not exceeding U\$10 million and not to be below US\$8 Million, for the pains experienced by Mr. Ponnie due directly and indirectly to the defendants, individual and joint conducts; and grant unto him other rights and privileges the court considers just, legal and equitable under the circumstances.

employees of the Liberia Electricity Corporation are illegally connecting power lines that is increasing power theft.Though partners, including Millennium Challenge Corporation and the European Union, among others have spent hundreds of millions to reconstruct the Mount Coffee Hydro aimed at ensuring adequate power supply, power outages have become the order of the day in and around Monrovia.

"We are tired and sick of LEC attitude; our goods continue to damage because they can't survive without current", said Lorpu Smith, a

Corporation (LEC) that was completely revamped by the Government of Liberia with support of foreign partners and friendly governments after the 14 years of civil war, still faces distribution challenges.

Despite interventions, about 85 percent Monrovia residents still lack access to electricity, leaving many unscrupulous persons to resort to power theft. Several communities in the capital, including Neezo in Paynesville, Slipway and Capitol Bye- Pass in Central Monrovia, New Georgia Estate in Gardnerville as well as New Matadi and Lakpakzee communities in Sinkor, have causing serious problem for his business, noting that

Plusieurs études plus récentes démontrent également que ce processus exerce une influence majeure sur le type d'informations qui leur sont présentées.

Même sans tenir compte des choix algorithmiques de Facebook, l'écosystème des réseaux sociaux dans son ensemble conduit l'utilisateur à découvrir des souscommunautés qui partagent ses centres d'intérêt. Ce n'est pas nécessairement une mauvaise chose. Si vous êtes seul dans votre entourage à vous intéresser à l'ornithologie, cette solitude n'est plus un problème, car vous pouvez désormais échanger avec des amateurs d'ornithologie dans le monde entier. Le même principe s'applique évidemment aux extrémistes isolés, qui peuvent désormais utiliser les mêmes plateformes pour propager ou accéder à des discours de haine et théories du complot.

Plus personne ne le conteste, les réseaux sociaux sont devenus un canal de transmission majeur de la haine, de la désinformation et de la propagande. Reddit et YouTube sont aujourd'hui de véritables terreaux de l'extrémisme de droite. La milice Oath Keepers a ainsi utilisé notamment Facebook pour organiser son action le 6 janvier 2021, date de l'assaut contre le Capitole des Etats-Unis. De même, il a été démontré que les tweets antimusulmans de l'ancien président américain Donald Trump avaient alimenté les violences contre les minorités aux États-Unis.

Certains considèrent ces observations comme alarmistes, estimant que les acteurs majeurs tels que Facebook et YouTube (qui est détenue par Google/Alphabet) accomplissent bien davantage que leurs concurrents de moindre envergure dans la lutte contre les discours de haine et la désinformation, notamment depuis que de meilleures pratigues de modération ont été mises en place. D'autres chercheurs contestent également les conclusions selon lesquelles les contre-vérités se propageraient plus rapidement sur

informations qu'ils consomment ont également évolué En réalité, ces mesures échouent à appréhender la profondeur du problème. Les réseaux sociaux ne font pas que créer des caisses de résonnance, propager des contre-vérités, et faciliter la circulation d'idées extrémistes. Ils risquent également de bouleverser les fondements mêmes de la communication humaine et de la cohésion sociale, en remplaçant les véritables réseaux sociaux par des réseaux sociaux artificiels.

> Nous nous distinguons principalement des autres espèces par notre capacité avancée à apprendre de animales notre communauté, à accumuler un savoir en observant les autres. > Postman s'inquiétait davantage d'un avenir huxleyien que d'un futur orwellien. Les réseaux sociaux ont simultanément fait naître les deux. Si les gouvernements acquièrent les moyens à la fois de manipuler notre perception de la réalité et de nous réduire à la passivité ainsi qu'à l'égoïsme, nos « amis virtuels assurent de plus en plus la police de notre pensée. Il s'agit désormais de saluer la vertu de l'un, et de condamner l'autre lorsqu'il dévie de l'orthodoxie dominante. Or, la « vertu » n'est que ce que détermine l'artificiel cercle social en ligne d'un individu, et elle est bien souvent fondée entièrement sur des mensonges.

On all of this, we propose Europe to be Africa's partner of choice. European investment in Africa is over five times more than that of China. A quarter of African trade is with the EU; it is only 15% with China and 2% with Russia and 90% of African exports enter the EU duty-free. The EU works with African partners on building the continent's first manufacturing sites for vaccines and we approved at the AU-EU summit

a Global Gateway €150 billion investment package. With the European Peace Facility and our training missions, we help strengthen peace and security.

However, the world's future is clouded by the devastating consequences of Russia's war against Ukraine on food security, energy prices, debt and security issues. This war is affecting everyone, but Africa is one of its main collateral victims. While we know that some countries on the African continent look at this war from a different perspective than we do, I think we can agree on four fundamental points.

First: Europe, Africa and the entire world cannot accept a world of 'might makes rights', where big powers can claim 'spheres of influence' and attack grain to Africa; and aligning our food security response in the multilateral system with the UN at its core.

Others try to distract from their responsibility by blaming sanctions. However, the facts are clear. EU sanctions do not prohibit African countries from importing and transporting Russian agricultural goods, or from paying for them. The Russian war is the problem, not sanctions. If our African partners face any concrete issues importing agricultural goods that seem related to our sanctions, we will jointly look at this.

Third: We need to step up our joint work to preserve Africa's security and safety. In that area, the EU is Africa's most reliable partner, supporting African peace efforts in eleven operations in Africa compared to the 6000 coming from EU countries. On the contrary, Russia contributes to the deterioration of the security situation in Africa with several hundred mercenaries from private military companies such as Wagner or Patriot. This presence only aggravates crises and multiplies the violations of human rights, as we see in Mali and Central African Republic.

Fourth: Africa and Europe should continue to prepare the future instead of falling back into the past. While some try to divide us by resuscitating old patterns, this ignores the long way we have come together during the last decades. Colonialism is an indelible stain on the conscience of Europe, but dealing with our responsibility for the past has made us better partners for the future. Europe is looking at Africa with fresh eyes: with optimism and confidence. That is the reason why we want to



neighbours to annex their

territory. The Russian aggression against Ukraine is a perfect example of 19th century type of cruel imperialism that Africa experienced. Precisely because Europeans are aware of their responsibilities in that era, the EU intends to stand against renewed imperialism. We must uphold and reinvigorate the multilateral order, to defend the rule of law as we decided jointly at the recent EU-Africa Summit. That is one particular reason why the EU supports the call of President Sall for a G20 seat for the African Union.

Second: We must act to ease the current food crisis. With over 70 partners, many in Africa, the EU is delivering along four strands of action: solidarity with those who cannot afford food; support to food production; facilitating agricultural trade including by getting Ukrainian

missions across the continent. Last April, we supported the African Union with a further €600 million to improve conflict prevention, crisis management and counter-terrorism. This week, I will be in Mozambique and Somalia. In Mozambique, the EU supports the armed forces so they can restore security in the Cabo Delgado province, and our assistance measures via the European Peace Facility now amounts to €89 million. We are also finalizing programs to support the SADC and Rwandan contingents. Similarly, Somalia can count on our missions to counter piracy and train the Somali armed forces. With a total of €2.3 billion, the EU has also been a reliable supporter of the AU Mission to Somalia, for more than 10 years.

With 78 security personnel, Russia contributes very little to UN peacekeeping

deepen our partnership, always giving top priority to "African solutions for African problems".

However, others seem tempted to repeat the mistakes made once by Europeans, by seeking to simply extract African raw materials, control land and agriculture, place African countries in financial dependence or try to exploit the dynamism of its youth for their own benefit.

As we in Europe are working to reinforce the EU's strategic autonomy, we are supporting Africa to do the same. We must all work with multiple partners, based on mutual respect and international law. These are the rules of the 21st century. In that framework, Africa and Europe should further deepen their ties and cooperation because your future is also our future.

he Ministry of National Defense (MoD) and the Armed Force of Liberia (AFL) have sounded a very strong caveat to the public concerning their roles and responsibilities leading to the 2023 presidential and legislative elections.

According to the 2013 Survey, the median age for first time sexual intercourse is 16.2 for girls in Liberia, and 18.2 for boys, with some 31% women aged 15-19 already involved in childbearing and by 18, this rises to 52%.

Early childbearing increases risk for both adolescent mother and her child, with a higher likelihood of maternal death, life-threatening sexual and reproductive health (SRH) consequences, including HIV infection.

Students protest at Capitol



The University of Liberia (UL) through its Center for Testing and Evaluation (CTE) has released the results for its first Entrance and Aptitude Test for 2022.A total of 12,338 candidates sat for the Undergraduate Colleges Entrance and Placement Exam, while 1,040 candidates sat the Graduate and Professional Schools aptitude test.

Out of the total number of candidates who participated, 5,053 candidates passed successfully.

At a press conference held on Thursday, September 8, 2022, to officially release the results, UL President Prof. Dr. Julius Julukon Sarwolo Nelson, Jr., said the first entrance and placement exam and aptitude test was administered from June 21 to July 16, 2022, in which over 13,000 candidates participated.

President Nelson said the first entrance and placement exam and aptitude test for 2022 tapped on the success of UL's digitization and decentralization process and rolled out a digital entrance at the Undergraduate level for the first time.

"All of these exercises, in conjunction with the Tuition Free Policy, have improved access to higher education for Liberians of all walks of life regardless of where they live," he said.In a brief remark, Dean Ezekiel Hinneh, Chairperson of the Testing and Evaluation Committee, University of Liberia, said the committee was formulated, appointed by the President of the University in March this year, and tasked to administer the entrance exam and aptitude test.

The committee successfully administered the first entrance and aptitude test for 2022 following its appointment.

Assistant Prof. Moses Hinneh, Executive Director, Center for Testing and Evaluation (CTE), said the number of candidates who made a regular pass (those who passed all subjects successfully) was 5,053 candidates.

Also announcing the results for the Graduate and Professional Schools aptitude tests, Assistant Prof. Calvin Alvin Gaye, Deputy Director, CTE, said a total of 1,058 candidates registered for the Graduate
