

UN Appeals for \$2.6 Billion to Ease Hunger Crisis in Somalia Wanted protester's French escape outrages Algeria

he U.N. is appealing for \$2.6 billion this year to assist 7.6 million of the most vulnerable Somalis who are facing acute hunger and possible famine

Abdelmoula said nearly 6.4 million people are currently facing high levels of food insecurity and that is expected to rise to 8.3 million between April and June, including 727,000 of them who are expected to experience catastrophic hunger levels. > Abdelmoula said the distinction between a declared famine and what millions of Somalis are already experiencing is "truly meaningless," as children are already starving.

> In 2011, after three failed rainy seasons, Somalia went through a famine that killed 250,000 people — half of them children. Now it is in its fifth failed rainy season and the forecast for the upcoming one is not promising.

> "Don't listen to those who tell you that this is the worst drought in 40 years,' Abdelmoula said. "This is the worst drought in Somalia's recorded history, period."He urged donors to step up, noting that after the 2011 famine the international community said "never again."

> "If we truly want to honor that promise, there is no time to lose," he said. "Every delay in assistance is a matter of life or death for families in need."VOA

Milking U.S. Government funds in Margibi

THE PEOPLE OF Margibi county risk being delisted from a U.S. Government-funded health program due to corruption. This is despite the designation of three senior officials of the Weah administration by the United States last year for ongoing public corruption.

A STATEMENT ISSUED on Monday by the U.S. Embassy in Monrovia says the USAID Mission to Liberia will decide whether to retain Margibi as part of a USAID's government-togovernment agreement, pending transparent investigation and associated actions to hold accountable anyone involved in the misuse of any U.S. government funds.

THE STATEMENT FOLLOWED news report on an audio recording I in which Margibi County Health Officer Dr. Augustine Nyankun Fannieh and other senior staff are heard discussing fraudulent billings and collection of kickbacks from vendors under the USAID-sponsored Fixed Amount Reimbursement Agreement (FARA) Program for the Margibi health system, totaling US\$ 801,693.00.

THE PROGRAM, ACCORDING to report, supports cost of implementing components of the Essential Package of Health Services for family planning, maternal and child health, and malaria prevention and treatment in 24 health facilities in the county.

THOUGH THE MINISTRY of Health has taken prompt action, recalling the county health authorities linked to the leaked audio for investigation, but the U.S. Embassy near this capital says it has a special responsibility to ensure that money provided by American taxpayers for the benefit of the people of Liberia, including the people of Margibi, is used for its intended purpose.

IT IS UNFORTUNATE and regrettable that the people of an I entire county would suffer because of the dishonesty and greed of few officials, who see both national and foreign monies as opportunities to line their pockets at the detriment of their fellow citizens.

Dr. Augustine Nyankun Fannieh and other senior staff heard discussing fraudulent billings and collection of kickbacks from vendors under the USAID-sponsored FARA Program are a serious disgrace to the people of Liberia, who need all support from foreign friends to improve their health conditions.

A Blueprint from India for Women's **Economic Empowerment**

S EATTLE - As we embark on a new year, I have been reflecting on "resolutions," and more specifically, what it takes for an individual or a society to be resolute in a world of endless challenges and obstacles. Throughout my career, I have seen many examples of triumph against the odds - extraordinary accomplishments that often begin with a small group of individuals seeking to solve a problem. In the best cases, local communities, government, and the private sector align and invest in programs and policies that create more opportunities for these groups to flourish.

The extraordinary success of women's self-help groups in India represents one of the best-case outcomes. Established by women determined to build a brighter future for themselves and their families, these groups have thrived thanks to innovative financial and infrastructure support from the Indian government. With over 80 million women participating in 7.5 million such groups, India is fostering the world's largest community development program, which is now a key component of the country's economy.

Women, especially in rural areas, face gender-based barriers to participating fully in their communities and building a livelihood: Many, unable to open a bank account or access credit, are dependent on informal loans from relatives, friends, or money lenders. Moreover, traditional family structures and social norms may constrain women from engaging in activities necessary to start or expand a small business.

Self-help groups were first formed in the mid-1980s to address these barriers by providing access to savings and credit so that women could earn a livelihood and lift themselves and their families out of poverty. The results speak for themselves: women's self-help groups have contributed to India's extraordinarily sharp reduction in poverty, from 55.1% to 16.4% (415 million people), over the last 15 years.

Initially, new groups were dependent on members, though often impoverished, pooling what little money they had to get started. The Indian government stepped in to alleviate this hardship by providing unsecured loans without the need for a formal, registered business entity. Importantly, these loans are offered at a very competitive interest rate of 12%, which drops to 7% if a group repays its loans within 30 days of the due date. With this support, the average self-help group was able to borrow around ₹200,000 (\$2,500) each, and in 2021 the limit for collateral-free loans was increased from \$10,000 to \$25,000.

Over the past decade, more than \$60 billion has been made available to self-help groups in India and, cumulatively, women in these groups have saved an estimated \$6 billion. Access to low-interest loans continues to help an increasing number of women create sustainable sources of income, accumulate assets and savings, and build financial security. And individual group members are building more than their financial skills; they are also raising their self-confidence and influence within the community.

For example, a self-help group in Chak Singar Barari village in Bihar state was able to structure their enterprise so that each member is sent home with ₹3,000-4,000 per month. And each woman has her own story: Sunila Devi enrolled her children in private schools, Chitrekha Devi is working toward a bachelor's degree, and Pushpa Devi has started her own ambitious business renting mobile sound systems, which allows her to employ others.

Now multiply those stories by millions, and you can begin to grasp the full effects of these groups. As each woman contributes more to the household income, she gains more say in household decisions. And collectively, they show what is possible when one of the most essential challenges to gender equality - increasing women's economic power - is addressed.

Ultimately, we know that increasing a woman's economic power bolsters her personal agency and empowers her to play a greater role in her family and in her community. India's government-supported self-help groups demonstrate the transformative effects of policy initiatives that are designed to meet the needs of marginalized women. The task now is to replicate this success.

The goals should be clear: In this case, to make credit accessible and affordable, build women's financial skills and credit history, and strengthen their financial security. And the various players must be resolute in their support. The closer you look at the details of the self-help groups in India, the more you see the dedication it took from all stakeholders - across economic sectors, states, and organized interest groups - to bring together the people, resources, and tools needed to succeed at this scale. Government agencies at both the federal and state levels were involved, along with banks and other financial institutions, researchers, and an extensive network of non-government and voluntary organization partners working at the grassroots level in communities across India.

This formula of determination, collaboration, and political will can be applied to other stubborn barriers to gender equality. One of the more persistent challenges I hear from women, most recently during a visit to Dakar, Senegal, is that entrepreneurs also need business development services, skills-building, and access to markets and value chains. India's program shows that this is feasible: Currently about 20% of self-help group members have these additional supports, and efforts are underway to promote womenowned cooperatives and businesses.

Everyone deserves the chance to live a healthy and productive life. My resolution for this year is to remain inspired by the determined efforts of individuals and by our collective capacity - as India's self-help groups' remarkable success have demonstrated - to innovate as we strive for a healthier, happier, more equitable world.

The Transatlantic Subsidies Race We Need

RUSSELS - The US Inflation Reduction Act (IRA) has America's trading partners in a tizzy. The legislation is not only gargantuan, dedicating some \$369 billion to climate and clean-energy programs; it also has a "buy American" component, delivering cash benefits only to buyers of North American automakers and subsidies to renewable-energy producers that satisfy domestic-content rules. Many countries, particularly in Europe, are now weighing the possibility of implementing their own green industrial policies. This is the wrong response.

The IRA's subsidies for American-made products are undoubtedly contentious, particularly among leading US trading partners such as Japan, South Korea, and the European Union. US President Joe Biden is now in damage-control mode, as he attempts both to reassure partners and to find ways to soften the impact on allies by bending the IRA's buy-American provisions.

European policymakers are unconvinced. They fear that, unless they introduce subsidies of their own, the IRA will effectively guarantee US leadership in green industries. But the logic underpinning this conclusion is dubious, at best.

True, some European firms have threatened to leave for the US if they do not receive similar subsidies at home. But European producers of, say, wind turbines are unlikely to stop producing in Europe just because they expect business to boom in the US.

"Buy American" does not mean 100% American. To secure the 10% domestic-content "bonus" - which the IRA offers on top of generous subsidies that do not depend on meeting the threshold - a company, such as a wind farm, must use only American steel, but only 40% US-manufactured components. In other words, even with the added incentive to use American-made components, the US government expects that firms will rely mostly on imports.

Moreover, according to trade lawyers, "US-made" components could consist largely of imported sub-components, rendering the domestic-content provisions even less stringent in practice. So, while the IRA does give firms an incentive to produce certain components in the US, there will still be plenty of demand for European products, not only in the US, but also, increasingly, in Europe.

In any case, the IRA is hardly an exemplar of good industrial policy. On the contrary, some of its key provisions encourage waste. In fact, Europe has already rejected the use of inefficient and costly fixed-rate renewable-energy subsidies - which account for \$250 billion of the IRA's total funding. Instead, most European countries use auctions to find out what subsidy rate is needed to spur emissions reductions. Some are also employing "contracts for difference," under which the government pays investors the difference between the market price and a guaranteed minimum.

Another questionable feature of the IRA is the investment tax credit, which subsidizes 30% of the cost of a renewable-power plant (or 40%, if the domestic-content rules are fulfilled). This is not economically efficient, as the subsidy is not linked to the amount of power that is ultimately produced. There is also a kind of moral-hazard risk: with investors covering only 60-70% of the total cost, they might not put as much effort into reducing costs, or just increase their profits. And waste in the construction of renewable plants would also lead to more emissions, especially if more energy-intensive goods like steel or concrete are used.

Finally, the IRA does little to spur green technological progress. Any project that produces zero-emissions electric power qualifies for IRA support. This means that wind farms and photovoltaic installations - for which costs continue to fall - are likely to be key recipients of IRA subsidies. But while these technologies will be vital to reaching near-term emissions-reduction goals - say, for 2030 or 2035 - a net-zero future will require new technological and engineering breakthroughs.

That is what governments should be subsidizing. Rather than offering inefficient subsidies to existing technologies, governments should be funding research and development for new ones. Yet, for the EU, this presents a formidable challenge.

As it stands, most R&D spending in Europe occurs at the country - not EU - level, with funds being directed largely toward national universities and research labs. Moreover, EU budget allocations are decided every seven years, and can be changed only by unanimous agreement. As a result, it would be practically impossible for the EU to allocate more funding to R&D until 2027.

But European Commission President Ursula von der Leyen has an alternative proposal: transform the EU's temporary pandemic borrowing program, NextGenerationEU, into a permanent resource. Unfortunately, this scheme has little chance of being implemented, so she has also proposed loosening EU rules on state aid, in order to give member states more leeway to field national subsidies - an inferior option.

The poorly conceived, though much-vaunted, European Chips Act follows much the same pattern, giving EU member states more room for national subsidies, without providing much in the way of additional R&D funding. The US CHIPS and Science Act, which allocates \$13 billion to the development of the R&D workforce, is a much better model, both than the European version and the IRA.

The EU should not enter a subsidy race with the US, certainly not based on the IRA model. A "green-tech" race - in which both sides support R&D for new green technologies - is a much better approach. The question is whether Europe has the

Dr. Moniba told a local radio station in Monrovia that he will rapidly tackle corruption, insecurity, the economy, and agriculture.

He also vowed to tackle education, and healthcare as part of his first 100 days of deliverables to the Liberian people.

Dr. Moniba is the son of former Liberian Vice President Dr. Harry F. Moniba who served in the late President Samuel Kanyon Doe's regime.In former President Ellen Johnson-Sirleaf's regime, Dr. Clarence Moniba served as Liberia's Minister of State Without Portfolio, and Board Chair of Liberia Electricity Corporation (LEC).

To aid the anti-corruption fight, Dr. Moniba elaborated

Moniba said.

For agriculture, the presidential hopeful said he will ensure that every county contributes to the development and food security of Liberia. To achieve this, he said every county will immediately start studies to know what it can grow and harvest.

He believes that this will enable every county to contribute to food security as a pathway to ending starvation among Liberians.

Commenting on the healthcare sector of the country, Dr. Moniba promised to revamp the John F. Kennedy Medical Hospital in Monrovia and the Tapeta Hospital in Nimba County.

To achieve this goal, he promised to seek US\$150 million from international partners that will be spent to properly renovate the two hospitals. He said staff will be trained, and he will ensure that the two hospitals become the best in the West African region.

-ailing Professor Jones Dopoe reveals

iberian folk musician and retired Professor of English, Jones B. Dopoe, is battling old age and sickness that have left him partially losing his speech and memory, and confined in a wheelchair.

The NEW DAWN recently visited the residence of a daughter of Prof. Dopoe, Miss Benetta Dopoe, in Duazon community along the Roberts International Airport (RIA) highway outside Monrovia and spoke with the Professor himself, who disclosed that the President of Liberia, George Manneh Weah, is his biological son.

He said President Weah knows

properly take care of their father except her brothers and sisters who have been helping her in the process. Meanwhile, Miss Benetta is appealing to government philanthropists and humanitariar organizations to come to the rescue of Prof. Dopoe, noting that he father impacted so many people educationally, but regrets that he did not educate her.

She adds that they now live by the grace of God despite her father being a well-known personality narrating that she was very little but still remembers how people knew him. Benetta expresses sorrow in seeing her father losing his memory sometimes for two weeks



him to be his (Mr. Weah's) father, but couldn't explain why the President is not paying him any attention even prior to, and after he assumed the Presidency.

But the conversation ended abruptly after Professor Dopoe lost his memory and could not recall anything, including his speech.

However, Benetta Dopoe narrates that her father has about 26 children by many women, and was residing with one of her stepmothers in Mount Barclay but because of lack of care, she went for him.

According to her, Prof. Dopoe had never told the children that President Weah is one of their siblings, adding that she's shock hearing it now while he is on sickbed. Benetta reveals that her father fell sick since 2021 and they haven't taken him to hospital because of lack of money, but her junior sister, Joyce Dopoe, who works at a government-run hospital in Bensonville, has been providing home medication.

She says there is no support to

without help coming from anywhere despite serving the society for many years, impacting lives.

She notes that since her father fell sick, no official of government or politician has paid him a visit including the University of Liberia where he lastly worked as a lecture or to call and check on his health condition.

Besides the University of Liberia this paper gathered that Professor Dopoe also lectured at Cuttington University in Gbarnga, Bong County Central Liberia.

Apart from his academic career Mr. Dopoe is a famous Liberian folk musician, who plied his trade both in Liberia and in neighboring Sierra Leone, where he played with the late king of palm wine guitar music Sooliman Ernest Rogers, aka, 'S.E Rogie' that produced the song "My Lovely Elizabeth."In Liberia, some of his efforts include the famous "Sweet, Sweet Cassava Leave" and "Mama I want to go to school, I tired selling plastic bag", among others Editing by Jonathan Browne

Exploitation des fonds du gouvernement américain à Margibi

Les habitants du comté de Margibi risquent d'être radiés d'un programme de santé financé par le gouvernement américain en raison de la corruption, ceci malgré la désignation de trois hauts responsables de l'administration Weah par les Etats-Unis l'année dernière pour corruption publique continue.

Un communiqué publié lundi par l'ambassade des États-Unis à Monrovia indique que la mission de l'USAID au Libéria décidera de conserver Margibi ou non dans le cadre de l'accord de gouvernement à gouvernement de l'USAID, au terme d'une enquête transparente. Il s'agit de situer les responsabilités dans l'utilisation abusive des fonds du gouvernement américain.

La déclaration a été rendue publique après qu'un enregistrement audio a fait fuite. Dans l'enregistrement en question, le Dr Augustine Nyankun, un agent de santé du comté de Margibi, Fannieh, et d'autres cadres supérieurs discutaient de facturations frauduleuses et de collecte de pots-de-vin auprès des fournisseurs dans le cadre du programme d'accord de remboursement à montant fixe (FARA) parrainé par l'USAID pour le Système de santé de Margibi, à hauteur de 801 693 \$ US.

Le programme, selon le rapport, prend en charge le coût de la mise en œuvre des composantes de l'ensemble essentiel de services de santé pour la planification familiale, la santé maternelle et infantile et la prévention et le traitement du paludisme dans 24 centres de santé du comté.

Bien que le ministère de la Santé ait pris des mesures rapides, rappelant les autorités sanitaires du comté liées à la fuite audio pour enquête, l'ambassade des États-Unis a dit avoir la responsabilité particulière de faire en sorte que l'argent des contribuables américains mis à disposition au profit du peuple du Libéria, y compris les habitants de Margibi, soit utilisé à bon escient.

Last week's arrest and the October 2022 discovery bring to nearly US\$140 million, the worth of narcotic substances that have been easily transited thru Liberia under the Weah

administration in just three months.

Liberians are yet to see full prosecution of cartels trading these substances and their illegal entry here, without a proper check.

Questions are in the air about security at the nation's main port, given frequent discovery of drugs and arms there.

In January, huge cache of assorted arms, including automatic rifles entered the country through the Freeport of Monrovia in a forty-foot container before it was subsequently confiscated by the Police.

Unnamed Kenyan linked to US\$37m cocain

By: Emmanuel wise Jipoh he Liberia Drug Enforcement Agency (LDEA) through its director general, Michael Zeyhou, is linking an unidentified Kenya national to the shipment of cocaine valued US\$37 million to Liberia.

The drugs were confiscated at the Freeport of Monrovia in what's said to be the second largest drug bust here in recent history. The latest catch occurred on Monday, January 30, 2023 by officers of the Liberia Drug Enforcement Agency (LDEA) after tipoff by a whistleblower.On Wednesday, February 8, 2023, the Liberia Drug Enforcement Agency (LDEA), the National Security Agency (NSA) and its collaborating partners witnessed the burning of the drugs at the military barracks, the Barclay Training Center in Monrovia.

LDEA director Zehyou said, no arrest has been made from the record second largest cocaine

traced, and lauded TRH Corporation and partners for their cooperation in the latest confiscation.

He stressed that the LDEA will continue to remain robust in the fight against drugs trafficking and other narcotic substances, while noting that the Agency has always been in the vanguard to curtail importation of illicit substances here.

Zehyou described the confiscation of the US\$37 million consignment as clear manifestation and milestone achievement in the history of Liberia, while emphasizing that the Liberia Drugs Enforcement Agency has made significant efforts in the past few months towards curtailing drugs and other narcotics.

Liberia's Justice Minister and Attorney General, Cllr. Frank Musa Dean, warned traffickers invading Liberian territories to desist, threatening that the Government of Liberia will take severe punishment on anyone caught.

Minister Dean stressed that the burning of the drugs by the LDEA clearly demonstrates



confiscated in the country's history, but swiftly noted that an unknown Kenyan syndicate is allegedly behind the latest smuggling of drugs to Liberia, as number belonging to that East African country was traced during arrest, after a tipoff from its partner TRH Trading Corporation that, according to him, alerted the Agency which led to the confiscation of the drugs.Zehyou told reporters covering the burning of the drugs at the Barclay Training Center that TRH Trading Corporation, the largest importer of Frozen Food in Liberia is the whistleblower.

He explained that brokers of the corporation assigned at the Freeport of Monrovia informed management that an unknown caller with number originating from Kenya, had requested that they had goods kept in the Storage of the TRH Trading Corporation and wanted it removed. He said investigation is
