

The Democratic Alliance's spokesperson on defense and lawmaker Kobus Marais, says the visit led by the chief of the South African army, Lieutenant General Lawrence Mbatha was unannounced.

"This once again demonstrates the ANC government's insensitivity to our diplomatic and trade

U.S. Ambassador to South Africa Reuben Brigety made headlines last week when he said he would bet his life that South Africa had supplied arms to Russia. Marais, who is the shadow minister for defense and military veterans, says the Democratic Alliance has intelligence on what Brigety referred to. He says something worthy of being guarded by men in uniform was loaded onto a Russian cargo ship, the Lady R, when it was docked at Simon's Town Naval Base in December.

"We also know that the U.S. is probably the most advanced in terms of observation technology and specifically with regard to satellites," said Marais. "We know port or airport or even battlefield and tell you exactly what color shirt and pants you are wearing so I assume that they have got their own intelligence that can be used to see from above."

Marais says the unconfirmed rumors that ammunition was taken onto the Lady R seem plausible because the Russian military is struggling in Ukraine.

"What we know is what has been reported that they are in dire straits in terms of ammunition," said Marais. "But that is why we need to establish and know what they have loaded. We know it was not consumables like apples and pears."

In WhatsApp messages, Ukraine's Ambassador to South Africa Liubov Abravitova wrote that it is "disturbing" how Russia is eager to make South Africa appear to be on its side and even more disturbing that South Africa is not postponing engagements such as the delegation's trip to Moscow.

Referring to a statement by South Africa's military that the visit to Moscow was planned well in advance, Abravitova said previously made agreements between Russia and South Africa "cannot justify the intensification of military contacts with the country that violates all possible rules of international law and U.N. Charter."VOA

Namibia has ruled in favor of recognizing same-sex marriages from other countries, making Namibia only the second nation on the continent to do so after South Africa.

A small group of LGBTQ activists gathered at Namibia's Supreme Court Tuesday where justices ruled in a 4 to 1 vote that Namibians married to foreign nationals in foreign jurisdictions must be recognized as any other couple within the country.

One of the judges, JA Mainga, dissented on the basis that the laws of Namibia do not recognize same-sex relationships. The other four judges, however, ruled that not recognizing same-sex couples infringes on their rights to dignity and equality.

he Supreme Court of case, which was dismissed in March, a Mexican national and his Namibian partner asked the top court to grant Namibian citizenship to their child, conceived through surrogacy in South Africa. The Mexican national in that case, Guillermo Delgado, spoke to VOA outside the Supreme Court on Tuesday.

"Our case is very similar and this represents a direct victory also for us, recognition that for marriage and our dependents," said Delgado.Linda Baumann of the Diverse Women's Organization said this judgment will help homosexual couples get access to the same services as heterosexual couples. Hypothetically speaking, she said, as a lesbian woman she could bequeath her estate to her lesbian partner when she dies, or she might be able to buy a house together with a same-sex spouse if the court gave rights to same-sex couples in all spheres of society.

She cautioned that this is just a



judgement of the High Court of Namibia not to recognize their same-sex marriages.

"Today after a six-year battle, we finally won and the court has ruled that the Ministry of Home Affairs has to recognize these marriages by foreign spouses to Namibian spouses," said Schickerling.

Over the past few months, the Supreme Court of Namibia has been hearing similar cases that deal with the subject of homosexuality.

#### Skyrocketing exchange rate is unbearable

Liberians are experiencing a sudden rise in the exchange rate between the United States Dollar and the Liberian Dollar with US\$1.00 costing as much as 168 to 170 Liberian Dollars in just a month from LRD150.

The sudden rise in the exchange rate is creating corresponding increases in prices of basic commodities especially food, petroleum and transportation, imposing serious constraints on ordinary citizens.

Presidential hopeful Cllr. Tiawan Saye Gongloe, recently alarmed here about the rapid rise in the exchange rate, which he attributes to uncontrollable infusion of Liberian Dollars into the market by the ruling CDC-led government to attract voters for the re-election of President George Manneh Weah.

"They are dumping the Liberian Dollars on the market and keeping the United States Dollars. They are saving the United States Dollars because they are not too sure of winning [the] elections", Cllr. Gongloe explained.

Members of the ruling establishment currently in government and out of government that vying for public officials are dishing out huge amounts of Liberian Dollars to citizens across the country to solidify their chances for election and re-election with serious adverse consequences on the heavily import-reliant economy.

An economist and law professor, Cllr. Gongloe warned that ordinary Liberians are going to be pushed to extreme poverty and hardship as a result of what is happening in the economy with huge amounts of Liberian Dollars chasing few United States Dollars.

"Economically, what is happening now is terrible for Liberia. However, between now and the elections, lives [are] going to be much more difficult than Liberians had ever realized", he said.

Even prior to the official start of campaign the ruling Coalition for Democratic Change is carrying series of political projects in several counties, including Lofa and Nimba to soften the ground and rally citizens' support.

As experienced in both the 2017 presidential election and the 2020 Special Senatorial Election when ruling party candidates dished out millions of Liberian Dollars to communities and voters, and flooded the market, a similar replay is expected, as Liberians go to the polls on October 10.

We can but only join Cllr. Gongloe in warning fellow Liberians to tighten their belt and brace themselves for the negative economic consequences during and after the elections that they would have to face as a direct result of election spending though the election law of Liberia has a ceiling on campaign finance.

### **Sell in May and Go Away?**

ONDON - During my lengthy career in finance, I picked up several market heuristics that have generally proven more useful than not. Every January, for example, I remember the "five-day rule," which holds that if the S& P 500's accumulated performance is positive over the first five days of the new year, there is around an 80% probability that the overall market will end the year higher than where it started. So far, this analytical trick has worked pretty well, despite all of the world's uncertainties.

With springtime comes a second rule of thumb: "Sell in May and go away" (and, for us Brits, "come back on St. Leger Day" - September 15). Though less statistically precise, this one has also often proven useful. If you are an investor - especially one who has had a good first four months of 2023 - you might want to bank your gains and sit on the sidelines until the fall, because there is a decent chance that markets will have declined in the intervening months.

Of course, there is no objective reason why either of these rules holds true. After all, equity markets historically tend to rally more than they fall, and they also generally outperform other financial markets - not to mention cash or fixed income - over time. Obviously, one should never let a rule of thumb override the fundamentals. Yet there are times when the fundamentals can become quite hazy, and there is good reason to think that we are in such a period right now.

Consider the latest round of monthly purchasing managers' indices in globally important countries. Not only do they show continuing weakness in manufacturing; they also indicate that the global economy may technically be experiencing a manufacturing recession. At the same time, services indices remain strong and are even accelerating in some cases.

While some services-reliant economies (such as the United Kingdom) can cope relatively well with manufacturing weakness, it is very unlikely that these two indices would move in opposite directions for long. Service industries either will ultimately stimulate other forms of activity, or they will be dragged down by their own dependencies on other industries.

As usual, China offers an important window onto the global economy. Following the end of its zero-COVID policy late last year, the Chinese economy had a strong start to 2023, and forthcoming data will almost certainly show a robust year-on-year acceleration for many components of output and demand in April. But there are signs that the recovery's momentum may be waning, and that various structural challenges are holding back activity. Moreover, inflation has not merely subsided, but has fallen so far as to raise concerns about deflation. Nor is China alone. Other important Asian economies, such as Japan, are also experiencing tame inflation, in stark contrast to the surging price levels seen in Western economies over the past year and a half.

Looking beyond Asia, I have been confounded by the inflation indicators that I tend to rely on most. For example, recent producer-price indices in the United States, along with some components of consumer prices, have shown clear signs of deceleration; and, as I have mentioned before, many global commodity prices are now much lower than they were a year ago. Sooner or later, these developments should feed into many producer and consumer prices. But the latest "core" inflation figures (excluding volatile food and energy prices) in the US, the UK, and the European Union have complicated the picture by revealing continuing strength in price pressures. And the University of Michigan's closely watched five-year inflation expectations surveyrecently showed a notable rise to 3.2%, after having fallen to 2.9% in recent months.

Central bankers doubtless remain troubled by the situation. One hopes the most recent figures are just a one-off exception. But if they are not, the Federal Reserve Board will confront a very problematic situation.

The interest-rate outlook remains the elephant in the room. Right now, markets seem pretty convinced that most central banks are either "done" raising rates or close to it, and some are even anticipating rate cuts before the end of the year. That could well happen; but first, the inflation data would need to improve quite a bit. On the other hand, if current market expectations are forced to change, new rallies in equity markets will be harder to sustain, barring a significant acceleration in earnings.

Where does that leave us before the summer? On balance, I suspect that the inflation picture will continue to improve gradually. But if the Michigan survey's findings about inflation expectations aren't reversed, equity investors will have good reason to worry.

### **Remembering the Pandemic**

AIRFIELD COUNTY, CONNECTICUT - President Joe Biden's administration has officially ended the national health emergency in the United States, allowing the remaining pandemic restrictions to expire on May 11. Other countries have already taken similar steps, and more are expected to follow suit. With the World Health Organization no longer considering COVID-19 a global health emergency, it seems that the virus and its massive death toll will soon fade from memory, along with N95 masks and PCR tests. But this collective forgetting jeopardizes efforts to secure consistent funding for public health.

Our ability to forget something as catastrophic as a pandemic is partly a coping mechanism, reflecting the emotional immune system that enables us to move on with our daily lives. As devastating as the pandemic's social and economic impact has been, it has left an indelible mark on only a relatively small subset of the population, including survivors of lost loved ones, health professionals and other frontline workers, the immunocompromised, and those experiencing long COVID or other related health issues.

While tragic events often inspire us to pursue reform, our willingness to act is often short-lived, making it difficult to affect lasting change. This pattern is particularly evident in the news coverage and Google search trends that follow tragedies such as mass shootings, tsunamis, and earthquakes, which typically show an initial surge of interest that gradually fades over time.

To create and retain memories, the human brain undergoes a complex process that involves multiple interrelated stages, such as encoding, consolidation, and retrieval. When presented with new information, our brains process it by modifying neurons in the hippocampus, a critical center for memory, along with other regions like theamygdala, which handles emotional memories. Together, these neurons form a physical representation of the memory called an engram.

A significant portion of the information we encounter can be lost unless it undergoes memory consolidation, which frequently occursduring sleep and helps to stabilize and retain memories in the long term. During this process, the hippocampus effectively "replays" the memory, which is then distributed to cortical neurons for extended storage. During the final stage, memory retrieval, the trace neurons within the hippocampus and cortex are reactivated.

Every day, we are bombarded with an overwhelming amount of information that our brains struggle to retain. Given that forgetting and remembering are inextricably linked, this "infodemic" further aggravates our tendency to forget. Moreover, the process by which our brains assess risk is deeply personal and influenced not just by data but also by our own biases and needs.

As COVID-19 fades from our collective consciousness, we are reminded why so many people were eager to forget the 1918 influenza pandemic and embrace the joys and risks of the Roaring Twenties. But collective amnesia threatens to leave us woefully unprepared for future airborne disease outbreaks, forcing us to re-learn fundamental lessons about the importance of masking, ventilation, and shifting activities outdoors to prevent transmission.

The 1918 pandemic infected a third of the world's population and claimed more than 50 million lives, surpassing the combined military casualties of World Wars I and II. Yet, despite its enormous human toll, there are no permanent memorials or days of remembrance for its victims. Before 2020, if you asked people to name the deadliest event of the twentieth century, very few would have cited the virus. Only recently, historians such as Guy Beiner have begun to explore this pattern of forgetting. Without rituals of remembrance to commemorate the millions of lives lost to COVID-19, we risk perpetuating the cycle.

People often have a more positive view of the future than the past as a way of building psychological resilience. Thisfuture-oriented positivity bias arises because, unlike the unchangeable past, the future offers endless possibilities. But our tendency to look forward also impedes progress on issues like pandemic preparedness, as it leads us to believe we are better equipped than we are.

Numerous academic bodies, think tanks, public-health organizations, and governments have published detailed recommendations on how to improve pandemic preparedness, but there has been no coordinated and comprehensive effort to implement them. Three years after the start of the pandemic, we still lack clear explanations for why our public-health agencies are understaffed and underfunded, why supply chains failed, why COVID-19 misinformation was allowed to run rampant on social media platforms and cable news outlets, and why our public-health responses remain reactive rather than proactive.

To ensure that we are better prepared for future pandemics, prominent medical and scientific figures in the US have proposed creating a COVID-19 Pandemic National Task Force modeled after the 9/11 Commission, but proposals have languished in Congress. In the face of other crises, it seems that many would rather forget the destruction wrought on our societies by the pandemic and return to "normal."

But as difficult as it may be to break the cycle of normalization that enables us to forget tragedies such as mass shootings and pandemics, it is necessary that we do. We must acknowledge how our biases endanger our lives and those of future generations. There are clear, evidence-based policy roadmaps that could help us reduce gun violence and improve pandemic preparedness, potentially saving countless lives and preventing immeasurable suffering. To implement these measures successfully, however, we must avoid the trap of division and distraction.

It has taken Ireland more than 150 years to build memorials and museums commemorating the impact of the Great Famine of the 1840s. We cannot afford to let the same happen with COVID-19. To ensure that we heed the lessons of the pandemic, we must memorialize its ongoing effects, enact days of remembrance, update school and university curricula, establish permanent museum exhibits, and build monuments. Our ability to remember the past could affect billions of lives in the future.

From a legal perspective, a juror of one's peer is a jury whose members are from the same community as the person on trial.

It is also a way of getting a fair jury made up of men and women who could be considered peers of the person who is on trial. This helps in reducing the chances of bias among the jurors.

In the late Bryant's argument, members of the jury who were charged with responsibility of deciding whether, on the facts of the case, he was guilty or not guilty of the offense for which he was charged were men and women outside of his social circle and therefore, not qualified to try him.

In other words, they could not understand the intricacies of the matter at hand and therefore could not have handed down a fair and unbiased verdict in the trial.

The late Bryant's argument of not being tried by "jurors of his peers" is one of the fundamental problems facing the Liberian Justice System that is most often or not ignored by critics of the local justice system.

Human Rights reports on the Liberian Judiciary have remained focused on bribery and corruption within the local justice system and how the rich and powerful are able to manipulate the system to steer justice in their favor.

But what has not been mentioned beyond bribery and corruption, particularly in criminal trials is the role of jurors. An uninformed jury is totally not aware of the fundamentals of the case at hand and is unable to hand down a fair and unbiased verdict that could be considered a miscarriage of justice as well.

The argument here is that select individuals who are clothed with the authority to determine the factual questions and final judgment should have knowledge of the matter at trial and not just be hand-picked to sit on a juror panel.

From personal experience, it appears that some jurors are not just abreast of the charges or have no experience in such cases. In such situations, verdicts are most likely to be influenced by emotions, intimidation, etc.

When jurors are far from or not connected to the argument of the case at hand, they remained uninformed and have no idea about the factual question of the case at hand. Therefore, their verdict will not just be unfair and biased, but it will also compromise the entire trial.

This raises the question as to how jurors are selected to preside over jury trials here. In one particular case, I was told, the jurors were selected based on their college experiences and not their experiences on such matters.

Selecting a juror because he or she is a "college" graduate with no prior experience sitting on a jury panel to preside over a matter of national security speaks volumes.

In most jurisdictions, relevant life experiences as it relates to the case in question are considered an important aspect in selecting or de-selecting a potential juror.

Other things to consider could include but are not limited to the person's ability to withstand social pressure, legal opinions, ability to be impartial, etc. To select a group of individuals in the name of forming a jury panel is a mockery of the intent of the framers of the Constitution.

In the late Gyude Bryant trial, the Liberian Government lost the case following a series of prohibitions one of which was a writ of prohibition issued by the Supreme Court. Bryant's lawyers asked the Supreme Court to stop his prosecution on grounds that the late Bryant was a former head of state who brought peace to the country and could not be held for actions he took while he was in office. Well whether or not that was decided on merits or demerits, its left for the lawyers' to argue.

It explains that observers covered the entire process of registration from set-up to closing of centers, noting that during this period, several observations were made.

"ECC observed that 160 of the 185 centers opened on schedule between 8:00 am and 8:30 am, which is 86% of all the centers, and that only 11% of these centers opened after 8:30 a.m. as a result of the late arrival of staff, lack of ink for the printer, shortage of cards or a lack of electricity to power the equipment."

It says during set-up, BVR centers were seen to have a complete BVR kit available, adding that these centers were generally accessible, and applicants did not have to go upstairs to access the center.

### La montée en flèche du taux de change est insupportable

Les Libériens assistent, impuissants, à une augmentation soudaine du taux de change entre le dollar américain et le dollar libérien. 1 USD est passé de 150 LRD à 168 voire 170 dollars libériens en seulement un mois.

La hausse soudaine du taux de change crée des augmentations correspondantes des prix des produits de base, en particulier la nourriture, le carburant et les frais de transport, imposant de sérieuses contraintes aux citoyens ordinaires.

L'opposant Tiawan Saye Gongloe, candidat à la prochaine présidentielle, a récemment dit que la hausse rapide du taux de change est attribuable à l'injection incontrôlée de dollars libériens sur le marché par les dignitaires du régime de la Coalition pour le changement démocratique (CDC) pour séduire les électeurs pour la réélection du président George Manneh Weah.

# Corruption allegations against Jeremiah Koung as the senator becomes UP Vice-Presidential aspirant

espite allegations of massive budget fraud hanging on his neck, the political leader of the Movement for Democratic Reconstruction (MDR), Senator Jeremiah Koung was on April 28, 2023, selected by Joseph Nyumah Boakai of the former ruling Unity Party (UP) as his running mate in the pending 2023 presidential election. MDR is one of Liberia's many political parties and was founded by former warlord and current Senator Prince Y. Johnson of Nimba County. Johnson is named in Liberia's Truth and Reconciliation Report as having committed atrocities during the country's first civil war.

According to Transparency International's local chapter, the Center for Transparency and Accountability in Liberia (CENTAL) 2021 State of Corruption Report, several members of the National Legislature were involved in high-level corruption. The two years of an investigation by the CENTAL linked then Nimba County Representative Jeremiah Koung, Montserrado County Senator Saah Joseph and District #6 Representative Samuel Enders, and others to massive corruption.

The CENTAL report said between 2012 to 2021 Nimba County Representative Jeremiah Koung received nearly one million United States Dollars to run his privately owned hospital, the Esther and Geraldine Hospital in Nimba County. According to the report. the African Dream Academy; a private school owned by Representative Samuel Enders was entirely funded from the national budget. The report also said Montserrado County Senator Saah Joseph, in 2020, as Chairman of the Senate health committee annually allocates US\$ 141,000.00, to his company for ambulance services.

It is no longer a secret that Senator Jeremiah Koung has emerged as a powerful symbol of the rotten sweetness of democratized corruption in Liberia. The Legislature of which Koung is part is among the most dangerously corrupt

institution in Liberian history. How did Joseph Nyymah Boakai, a man that wants to replace President Weah, select such a character? How can Liberia's former Vice President, Joseph Nyumah Boakai who is on record during the 2017 presidential debate admitting the Johnson-Sirleaf/Boakai administration failed by saying, "we squandered opportunities" select someone the CENTAL report said was involved in the high level of corruption at the National Legislature? Did the former Vice President squander another opportunity?

On the surface, you will be tempted to believe that our democracy is finally working - checks and balances. Illusions! The reality is that we are witnessing the smooth operation of the smartest and pathologically corrupt political operatives in post-conflict Liberia (I have not forgotten the gibberish of "innocent" until proven guilty). To say Senator Koung along with his political godfather, Senator Prince Yomie Johnson are the most potent political operatives is not an overstatement. Even before

Koung rose to power, he was highly connected by

virtue of his political godfather, ex-warlord, and current senator Prince Yormie Johnson- the strong man of Nimba politics. Senator Johnson has been sanctioned by the U.S. government for alleged corruption. The sanctions against Johnson come under the Global Magnitsky Act.

To demonstrate that he is untouchable, Jeremiah Koung ignored the CENTAL two years investigation report which linked him and his colleagues to corruption and ran for the senate seat in Nimba, and with his political godfather, Senator Prince Yomie Johnson, and the ruling CDC backing, he won the senatorial seat at the same time, Joseph Nyuman Boakai's backed CPP senatorial candidate, Edith Gongloe lose her senatorial bid.

The newest scandal is the appropriation of US\$3.6 in the 2020/2021 budget that Jeremiah Koung and his colleagues at the Legislature awarded themselves in the name of legislative engagement and public accessibility fund with each legislator taking US\$30,000. while public institutions including hospitals, and schools are hugely underfunded. Sadly Senator Koung and his colleagues are diverting funds through budget paddling and redirecting those funds among themselves.

One of the primary reasons corruption has thrived in Liberia is the legislators are also involved in malice at all levels and have been clever enough to fool our people. Koung is a career legislator, having served two terms as a representative before being elected as a senator. But he has never been very vocal on national issues and hardly chided the Unity Party administration as a representative on any shortcomings or as Senator in the current CDC administration on any weaknesses.

Is Joseph Nyumah Boakai complicit in encouraging the democratization of corruption in Liberia by choosing Jeremiah Koung as his running mate? Is it a major, general mistake for Mr. Boakai to be romancing corrupt individuals while pretending to be a rescuer? I see the ongoing caricature as simply a case of democratization of corruption; a case of birds of the same feathers flock together, literally.

Senator Jeremiah Koung and his political godfather, Senator Prince Yomie Johnson are smooth political operators that belong to the MDR. The MDR as previously stated was founded by Senator Prince Yomie Johnson who supported Mr. George Weah of the Coalition of Democratic Change in the 2017 presidential election. In 2010, Johnson founded the National Union for Democratic Progress Party (NUDP) and ran as a presidential candidate in the 2011 presidential election. He placed third, with 11.6% of the vote, and supported the Unity Party's Ellen Johnson Sirleaf who won the election as the incumbent president.

On December 9, 2021, Prince Yomie Johnson was placed under sanctions by the US Treasury under the Global Magnitsky Act. According to the U.S. Department of the Treasury's Office of Foreign Assets Control (OFAC), "as a Senator, Johnson has been involved in pay-for-play funding with government ministries and organizations for personal enrichment. As part of the scheme, upon receiving funding from the Government of Liberia (GOL), the involved government ministries and organizations launder a portion of the funding for the return to the involved participants. The pay-for-play

funding scheme involves millions of U.S. dollars. Johnson has also offered the sale of votes in multiple Liberian elections in exchange for money."

Recently, Prince Yomie Johnson recently broke ties with the ruling Coalition for Democratic Change government headed by President George Weah, alleging that the Weah-led government refused to incorporate its members of his MDR into key government positions, thereby, reconfirming the U.S. Department of the Treasury sanctions on him (pay-for-play ). After publicly falling out with President Weah and his CDC, Senator Johnson, the founder of MDR, gave his blessing to Senator Jeremiah Koung to assume the position of Standard Bearer of the MDR and lead the Party's operations in preparation for the 2023 General and Presidential Elections as Prince Johnson battle for his senatorial seat in the 2023 elections. The MDR leader, Jeremiah Koung became the vice standard bearer of the Unity Party overnight after he and his political godfather outsmarted
