Ethiopian singer buried nid ethnic unrest

he funeral has been held for Ethiopian singer Hachalu Hundessa as unrest over his death has spread from the Oromia region where he was seen as a hero.

Troops have been deployed in the capital, Addis Ababa, where armed gangs were roaming to target ethnic Oromos.

At least 81 people have been killed in protests in Oromia since Hachalu was shot dead on Monday night.

The motive for his killing remains unclear, but the 34year-old had said he had received death threats.

His songs focused on the rights of the country's Oromo people, the country's largest ethnic group, and became anthems in a wave of protests that led to the downfall of the previous prime minister in 2018.In Addis Ababa, eight people were killed in violence that included multiple bomb blasts, says BBC Ethiopia reporter Kalkidan Yibeltal.

Our reporter says ethnic and religious tensions have intensified in the aftermath of the killing."Hachalu is not dead. He will remain in my heart and the hearts of millions of Oromo people forever," the Reuters news agency quotes his widow Santu Demisew Diro as saying at the funeral. The ceremony took place at a stadium in Hachalu's home town of Ambo, west of the capital, and was broadcast live on Oromo Broadcasting Network television.

"I request a monument erected in his memory in Addis where his blood was spilt," Ms Santu said. Our reporter says the stadium was not full as many residents in Ambo stayed

at home amidst heavy security after days of violence.

There are reports that mourners had tried to delay the funeral until the release of influential Oromo politician Jawar Mohammed.Dozens of people have been detained, including Mr Jawar, who was arrested after protesters tried to block Hachalu's body from leaving the capital on Tuesday. On Thursday, the for more rights for the Oromo who feel they been politically marginalised by previous governments, appeared in court in Addis Ababa. His case was adjourned for two weeks.

He supported reformist Prime Minister Abiy Ahmed, himself an Oromo, when he came to power in April 2018 but has since become an ardent critic.

More arrests have been made in the capital, including that of prominent journalist and activist Eskinder Nega.On Wednesday, Mr Abiy warned that those behind Hachalu's death wanted to derail his reform programme.

"This week, a very heinous crime was committed on artist Hachalu Hundessa. Those who planned the crime are those who are not happy with the current change in the country.

"We have two choices as a people. To fall into the trap being set up by detractors or to deviate from their trap and stay on the course of reforms. Choosing the first is to willingly aid them in our demise," the prime minister said. Since his youth, Hachalu Hundessa was a thorn in the flesh of successive governments.

As a student in Ambo, a city at the forefront of the campaign by Oromos for selfrule, Hachalu joined student groups calling for freedom. At the age of 17, he was imprisoned for five years for his political activities.

He became increasingly politicised in prison, as he increased his knowledge about Ethiopia's history, including its rule by emperors and autocrats - and also developed his music skills."I did not know how to write lyrics and melodies until I was put behind bars. It is there that I learned," he said in 2017.

He released his first album Sanvii Mootii (Race of the King) in 2009, a year after walking free, and it turned him into a music star, and a political symbol of the Oromo people's aspirations. BBC



Uganda private schools unable to pay teachers

gandan teachers employed by private schools have had no income for four months since schools closed because of the coronavirus pandemic.

The schools normally rely on getting fees from parents and since the lockdown no money has been paid.

Kampala, Miriam Susan Apolot told the BBC that she hasn't been able to pay the teachers' salaries since February.

At the start of the lockdown, employers against laying off

the government had warned staff during this time. But school owners want to avoid keeping teachers on the payroll

and accumulating months of unpaid salaries.

Some have been laying them off, with the promise that if things normalise, they would be considered for rehiring.

The Private School Teachers' Union argues that education is a public service and that the government should at least pay 50% of the private teachers' salaries.

According to the head of the education ministry, Alex Kakooza, the government is not ignoring the plight of the teachers and is putting together a plan to bail out businesses - private schools included.Meanwhile, some school owners are selling off their facilities.

On a property listing website. I found at least seven schools in and around Kampala that have been put up for sale in the past month.

Property agents say their clients are desperate to pay off the bank loans that they had used to set up the institutions. BBC

SA police suspended for evicting naked man

our police officers in Cape Town are to be suspended after dragging a naked man from a house in an eviction caught on

Footage shows the man being thrown to the ground and stopped from re-entering the shack in Khayelitsha settlement.

When he manages to break free and run into the home made of corrugated iron, its front wall is ripped off leaving him exposed.

South Africa's housing minister Lindiwe Sisulu called the incident "inhumane".

"We wish to condemn with the strongest terms an act which sought to degrade an individual like what we have witnessed," she said, adding it "has no place in our democratic South Africa."In a statement on Wednesday evening, the city of Cape Town's safety and security chief Richard Bosman said: "We are in the process of suspending four staff members involved in the incident, pending the outcome of the investigation."The suspension also ensures that staff are not targeted while on duty. We are saddened by the conduct depicted on the video footage, and we do not condone any forceful and dehumanising



conduct by our staff members."

Local media report that the part of Khayelitsha where the video was filmed is subject to an eviction order and has been earmarked for redevelopment.

Only 49 homes are allowed to "temporarily remain on the land until after the lockdown," Mr Bosman said.

"After the removal of illegal structures, new attempts are made to invade again on a daily basis."

South African law dictates that once a court order is secured, evictions "must be conducted in a humane manner" and in some instances, such as cases where the resident cannot find somewhere secure to live, "the state must provide temporary alternative accommodation". BBC

Confrontation is unhealthy for business

THE NATIONAL SECURITY Agency (NSA) an investigative arm of the state, is reportedly probing the Chief Executive Officer of Orange Liberia, Mamadou Coulibaly, for alleged involvement with protesters who recently erected roadblocks with burning tires in Monrovia, demanding cancelation of surcharge imposed on GSM companies by the Government of Liberia.

THE SUSPICION BY the government stems from earlier Writ of Prohibition filed before the Supreme Court of Liberia by Orange Liberia against the surcharge. The High Court however, denied the petition.

AND SO WHEN an erratic pressure group here, Council of Patriots, mobilized youth into the street last week, burning tires and erecting roadblocks in demand of cancelation of the surcharge, government suspects that CEO Coulibaly, who had earlier gone to court against the levy, may be behind all this hence; Police called him for questioning and subsequently turned Coulibaly over to the NSA for further interrogation.

IT IS NOT only disappointing, but highly counterproductive for a business entity to be in confrontation with the government under which it operates. This is bad business practice. Rather than going to court on the matter, we think CEO Coulibaly should have sat with the Liberia Telecommunications Authority (LTA) the regulatory body, to discuss all outstanding issues.

IN 2018, THE LTA issued Order# 0016-02-25-19, imposing floor prices and surcharges on one-net voice calls and data. Before issuing the Order, the LTA got all stakeholders involved and their inputs were considered.

IF THE GSM companies in this case, Orange Liberia, had reservations it should choose dialogue with the relevant government entities to reach common grounds for peaceful business environment.

LEST WE BE misconstrued here; the New Dawn holds no suspicion against CEO Coulibaly, neither does it support or defend ongoing interrogation by the government.

BUT WE URGE both sides to quickly realize that a confrontational business environment poses threat to the economy, something that neither parties wants to see in Liberia, particularly Orange Liberia, as a foreign partner.

WE CAN BUT only hope that the questioning would be concluded soon and suspicions cleared so that CEO Coulibaly would return to his business and carry on normal operations without having to constantly be on the watch for plain-clothe security coming to take him for interrogation.

THE LAST THING that this country wants is a business environment that is clouded with mistrust and strain, because such atmosphere drives away the dollars the economy needs to thrive.

With hopes of a sharp rebound from the pandemic-induced recession quickly fading, policymakers should pause and take stock of what it will take to achieve a sustained recovery. The most urgent policy priorities have been obvious since the beginning, but they will require hard choices and a show of political will.

history, it hasn't been that long since economies around the world began to close down in response to the COVID-19 pandemic. Early in the crisis, most people anticipated a quick V-shaped recovery, on the assumption that the economy merely needed a short timeout. After two months of tender loving care and heaps of money, it would pick up where it left off.

It was an appealing idea. But now it is July, and a V-shaped recovery is probably a fantasy. The post-pandemic economy is likely to be anemic, not just in countries that have failed to manage the pandemic (namely, the United States), but even in those that have acquitted themselves well. The International Monetary Fund projects that by the end of 2021, the global economy will be barely larger than it was at the end of 2019, and that the US and European economies will still be about 4% smaller.

The current economic outlook can be viewed on two levels. Macroeconomics tells us that spending will fall, owing to households' and firms' weakened balance sheets, a rash of bankruptcies that will destroy organizational and informational capital, and strong precautionary behavior induced by uncertainty about the course of the pandemic and the policy responses to it. At the same time, microeconomics tells us that the virus acts like a tax on activities involving close human contact. As such, it will continue to drive large changes in consumption and production patterns, which in turn will bring about a broader structural transformation.

We know from both economic theory and history that markets alone are ill suited to manage such a transition, especially considering how sudden it has been. There's no easy way to convert airline employees into Zoom technicians. And even if we could, the sectors that are now expanding are much less labor-intensive and more skill-intensive than the ones they are supplanting.

non-human-contact sectors are expanding, reflecting improvements in their relative attractiveness, the associated spending increase will be outweighed by the decrease in spending that results from declining incomes in the shrinking sectors.

Moreover, in the case of the pandemic, there will be a third effect: rising inequality. But it is quite another thing to extend unemployment insurance, health care, and additional support to the most vulnerable.

> The short-run priorities have been clear since the beginning of the crisis. Most obviously, the health emergency must be addressed (such as by ensuring adequate supplies of personal protective equipment and hospital capacity), because there can be no economic recovery until the virus is contained. At the same time, policies to protect the most needy, provide liquidity to prevent unnecessary bankruptcies, and maintain links between workers and their firms are essential to ensuring a quick restart when the time comes.

> But even with these obvious essentials on the agenda, there are hard choices to make. We shouldn't bail out firms - like old-line retailers that were already in decline before the crisis; to do so would merely create "zombies," ultimately limiting dynamism and growth. Nor should we bail out firms that were already too indebted to be able to withstand any shock. The US Federal Reserve's decision to support the junk-bond market with its asset-purchase program is almost certainly a mistake. Indeed, this is an instance where moral hazard really is a relevant concern; governments should not be protecting firms from their own folly.

A More Humane Post-**Pandemic Social Contract**

Beyond a public-health crisis, the COVID-19 pandemic is an economic and humanitarian crisis - one that is exposing and widening our societies' fault lines. Though addressing systemic inequities is extremely difficult, there are reasons to hope that the pandemic will spur progress toward greater social justice.

EW HAVEN - Never have the complexities of the relationship between human health and economic wellbeing been more apparent than during the COVID-19 crisis. How can we enforce life-saving social-distancing rules without destroying livelihoods? Why are some groups suffering so much more than others, both clinically and economically? What are those who face lower risks willing to sacrifice for the common

With no vaccine or cure for COVID-19, social-distancing protocols, together with maskwearing and hand washing, quickly emerged as our best defense against the virus. For some industries, the adjustment was relatively straightforward: close down offices and have employees work remotely.

As it turns out, far more work can be done remotely than was previously thought. Physical proximity has long been viewed as essential to the collaboration that is so essential to running a business, let alone innovating. Yet during the pandemic, I finished a joint paper without meeting my co-authors in person; participated in many fruitful online meetings and conferences; and even advised Japanese Prime Minister Shinzo Abe from my home in New England, rather than flying to Tokyo, as I have done in the past.

My case is hardly rare. Just a few months ago, no one would have imagined that news reporters or talk-show hosts would be broadcasting from their homes. And while some economic activities are likely to move back into shared office spaces or studios as soon as possible, others may remain fully or partly remote. Many companies, including tech giants like Twitter, have already announced plans to keep employees at home indefinitely.

Yet plenty of activities cannot be done remotely. Social distancing has thus meant temporarily closing many businesses, from restaurants to factories, and limiting travel. This has had serious economic repercussions, including supply-chain disruptions, declining demand, and rising unemployment. The International Monetary Fund now expects global GDP to contract by 4.9% this year.

Many have accepted the economic hit, in the interest of "flattening the curve" of infection. After all, unless and until the virus is contained, economies cannot reopen fully. New Zealand has emerged as an exemplar of this approach, though many other countries, as well as some US states, have embraced it. In the meantime, governments, particularly in the advanced economies, have offered unprecedented monetary and fiscal stimulus to keep their economies afloat.

Yet not everyone has been willing to prioritize public health above economic considerations. Yes, in some places, such as India, blanket lockdowns had their own serious public-health consequences. But in others, leaders made the callous calculation that protecting the economy - specifically the stock market - was more important than protecting people from COVID-19. Here, US President Donald Trump and his Republican enablers, such as Senate Majority Leader Mitch McConnell, are the worst offenders.

Those rushing to save Wall Street may subscribe to the logic of Jeremy Bentham, the father of modern utilitarianism, who argued that the goal of public policy must be to ensure the "greatest happiness of the greatest number," measured by a country's total income. Those who would place protecting public health first affirm the Harvard philosopher John Rawls' theory of social justice, which requires public policy to be "to the greatest benefit of the least advantaged."

Ultimately, however, meeting either standard will require societies and governments to go far beyond social distancing or stimulus payments to tackle deeply embedded systemic inequalities. While the virus itself does not discriminate by wealth, race, social status, or any other such markers, it has disproportionately affected the poor, as well as racial and ethnic minorities. In the US, black and Latino populations in the US face significantly higher COVID-19 infection and mortality rates.

This is partly because members of minority groups are more likely to hold the "essential" jobs that have been exempted from shelter-in-place rules, such as grocery-store workers, bus drivers, couriers, and home health aides. According to one study, black workers comprise nearly 12% of all employees in the US, but 17% of front-line workers.

Such professions are not only likely to be lower paid, but also frequently offer few benefits, such as paid sick leave or health insurance. Social and economic factors, including higher poverty rates and higher likelihood of living in under-resourced neighborhoods, compound the health risks, as do long-standing inequities in health-care access and outcomes.

This is not only an American phenomenon. A recent study showed similar racial disparities in the United Kingdom. And all over the world, the poorest groups - unable to stay home, living in crowded environments that may lack piped water, and without access to medical facilities - are suffering the most. Many are face growing food insecurity.

Beyond a public-health crisis, COVID-19 is a social and humanitarian crisis - one that is exposing and widening our societies' fault lines, as the protests over racial injustice in the US and elsewhere have shown. But addressing systemic inequities is extremely difficult, not least because members of the privileged group are likely to cling to their advantages.

Rawls captured this dynamic by basing his theory of justice on an "original position": What choices would people make about the social contract if they didn't know any of their individual attributes, such as wealth, race, values, or capabilities? Behind this "veil of ignorance," they would presumably choose a system that ensures the security and dignity

NaFAA signs 3.5 million Euros project

s part of efforts to improve food security, nutrition and income in rural Liberia, the National Fisheries and Aquaculture Authority (NaFAA) has entered a memorandum of understanding with AfricaRice and the Ministry of Agriculture to implement an EU sponsored Project titled, "Desira", focusing on rice and fish integration.

According to NaFAA, the signatories to the MOU are Director General Glassco, Dr. InoussaAkintayo, Country Director AfricaRice, and the Minister of Agriculture Madam Jennie Cooper.

Integrated rice and fish farmers are

roles as food producers and ensuring food and nutrition for their families.

Protest at Bushrod Island Magisterial Court -over Dixon Seboe Vs. Bervina Brook Case

group of protesters in defense of defendant Bervina Brook, who is standing trial on charges of 'Criminal Coercion and Disorderly Conduct filed before the Bushrod Island Magisterial Court by Montserrado County Electoral District #16 Representative Dixon Seboe on July 1, 2020 have reportedly stormed the court premises, demanding the accused unconditional release.

Representative Seboe is pressing criminal coercion and disorderly conduct charges against defendant Brook who had earlier accused him of raping her.

During preliminary hearing into the case presided over by Judge James F. Dudu, the angry protestors argued that Rep. Soboe sued the defendant to prevent her from pressing alleged 'Rape' charges against him.

The protest compelled party litigants, magistrates and state prosecutors who were already in court on official businesses to remain inside the court house for fear of any

eventuality that may occur.

Court sources told this paper that during hearing into the case, lawyers representing Representative Dixon Seboe requested the court for a change of venue due to what they termed, growing public sentiments in the case.

Our source disclosed that state prosecutors however rejected a Motion of Change of Venue on grounds that the case at bar originated in the Bushrod Island Magisterial Court.

Following legal battle between the opposing lawyers, Magistrate James F. Dudu denied the state prosecutor's request.

Defendant Bervina Brook is alleging that she was sexually abused by the Montserrado County District #16 lawmaker some time ago, but the allegation is yet to be investigated and proven.

Meanwhile, calm has returned to the court with regular businesses proceeding in accordance with the court's mandate. -Editing by Jonathan Browne

Senate tussle over SOE extension | Private schools are

enators on Capitol Hill Wednesday, 1 July tussled over the extension of the State of Emergency by one month as proposed by President George Manneh Weah.

Argument erupted in the Senate following a report by its committee that

coronavirus case, a committee was set up by the Senate President Pro Tempore Albert Chie to look into Mr. Weah's SOE extension proposal.

The committee chaired by Montserrado County Senator Saah Joseph included other members in persons of Bong Senator Dr. Henrique Togba; Lofa Senator Stephen Zargo;



recommends that the extension of the State of Emergency as requested by Mr. Weah be adhered to and all the health protocols be abided to.

While the Senate was shut down for two weeks after Assistant Senate Secretary General Genevie Massaquoi became a confirmed Sinoe Senator Augustine Chea and Bomi Senator Morris Saytumah, respectively.

In its report to the plenary, the committee recommends that the extension of the State of Emergency be adhered to and all the health protocols be abided to.

The committee furthers that from the pronouncement of the first State of Emergency, the cases were not as many as they are now in Liberia, noting that the State of Emergency (SOE) will help contain the virus.

Senator J. Milton Teahjay of Sinoe County says that though he supports the State of emergency's extension, the country needs to open up, adding that businesses need to be carried on in order for the country to make progress.

"We cannot allow our economy to be locked down, Liberia will be losing a lot," Teahjay argues.

Mr. Sando Johnson, Senator for Bomi County, says there is no need for the extension of the State of Emergency, adding that the Legislature needs to communicate with the Executive to enforce the Public Health Law.

According to Senator Johnson, citizens are not complying with the Public Health Laws, therefore the government needs to make it mandatory.

Also speaking, Montserrado County Senator Abraham Darius Dillon says he is not in favor of the SOE's extension, noting that there is no scientific proof to show that the SOE will help with the crisis.

He argues that Liberia

Father jails son for terroristic threat

t was a shocking moment at the Temple Justice Wednesday, 1 July when a father identified as Samuel S. Dean, Sr., issued writ of arrest against his 21 years old son Samuel S. Dean, Jr. for the act of terroristic threats, resulting to the junior's detention at the Monrovia Central Prison.

The father, Mr. Dean who was seen very emotional in his wheelchair on the grounds of Temple of Justice, says his son has been a very bad child.

He accuses his son of being allegedly involved in lot street activities ranging from alleged drug addiction, robbery and the abduction of of teen street girls, among.

"I just want to go home, sleep in peace and get ready for my treatment tomorrow. There is no big school in Liberia [that] I didn't send this child -

Mr. Dean laments that one day while he was at home resting, his son and his street friends attacked his (father's) house and made away with all of his belongings including Television set and Ice box, among others.





Article 87 a) Les pouvoirs d'urgence ne comprennent pas le pouvoir de suspendre ou d'abroger la Constitution, de dissoudre le pouvoir législatif ou de suspendre ou de révoquer le pouvoir judiciaire ; et aucun amendement constitutionnel ne doit être promulgué pendant l'état d'urgence. Lorsque l'Assemblée législative n'est pas en session, elle doit être convoquée immédiatement en session extraordinaire et rester en session pendant toute la période de l'état d'urgence.

Les priorités de l'économie du COVID-19

EW YORK - Bien que cela semble déjà de l'histoire ancienne, peu de temps s'est écoulé depuis que les économies du monde entier ont commencé à se fermer en réponse à la pandémie de COVID-19. Au début de la crise, beaucoup s'attendaient à une reprise en forme de v, partant de l'hypothèse selon laquelle l'économie avait simplement besoin d'une courte pause. Après deux mois de petits soins et de montants colossaux d'argent, l'économie reprendrait certainement là où elle s'était arrêtée.

L'idée était séduisante. Seulement voilà, aujourd'hui au mois de juillet, la reprise en forme de v apparaît comme une illusion. Il faut en effet s'attendre à une économie post-pandémie anémique, et pas seulement dans les pays qui n'ont pas su gérer la pandémie (notamment les États-Unis, pour ne pas les nommer), mais également dans ceux qui se sont montrés efficaces face à la situation. Le Fonds monétaire international estime que fin 2021, l'économie sera à peine supérieure à son niveau de fin 2019, et que les économies américaine et européennes se seront réduites de 4%.

Les perspectives économiques actuelles peuvent être observées à deux niveaux. La macroéconomie nous conduit à penser que les dépenses diminueront, compte tenu de l'affaiblissement du bilan des ménages et des entreprises, d'une vague de faillites qui détruira les capitaux organisationnels et informationnels, ainsi que d'une forte tendance à la précaution, induite par une incertitude quant à l'évolution de la pandémie et aux réponses politiques apportées. Dans le même temps, la microéconomie nous indique que le virus agit comme une taxe sur les activités impliquant un proche contact humain, et qu'il est par conséquent voué à entraîner d'importants changements dans les modèles de consommation et de production, ce qui pourrait engendrer une plus large transformation structurelle.

Nous savons grâce à la théorie économique et à l'histoire que les marchés à eux seuls ne suffisent pas pour gérer une telle transition, compte tenu notamment de sa soudaineté. Reconvertir les employés de compagnies aériennes en techniciens de la plateforme Zoom n'est pas chose facile. Et même si nous y parvenions, les secteurs qui se développent aujourd'hui sont beaucoup moins intensifs en main-d'œuvre, et plus intensifs en qualifications, que les industries qu'ils viennent remplacer.

Nous savons également que les grandes transformations structurelles ont tendance à engendrer un problème keynésien traditionnel, en raison de ce que les économistes appellent les effets de revenus et de substitution. Même si plusieurs secteurs n'impliquant pas de contact humain se développent, ce qui illustre l'amélioration de leur attractivité relative, l'augmentation associée des dépenses sera contrebalancée par une diminution des dépenses résultant de la baisse des revenus dans les secteurs en contraction.

Par ailleurs, dans le cas de la pandémie, un troisième effet interviendra: le creusement des inégalités. Les machines ne pouvant pas être infectées par le virus, elles apparaîtront relativement plus attrayantes pour les employeurs, notamment dans les secteurs en contraction recourant à une maind'œuvre moins qualifiée. Et dans la mesure où les individus à faibles revenus doivent dépenser une part plus importante de ces revenus dans les biens de base, par rapport aux plus fortunés, tout creusement des inégalités lié à l'automatisation entraînera nécessairement un effet de contraction.

Deux motifs supplémentaires de pessimisme

viennent s'ajouter à ces difficultés. Premièrement, si la politique monétaire peut aider certaines entreprises à faire face à des contraintes temporaires de liquidités - comme pendant la Grande Récession de 2008-2009 - elle ne peut résoudre les problèmes de solvabilité, ni stimuler l'économie lorsque les taux d'intérêt sont déjà proches de zéro.

En outre, aux États-Unis et dans plusieurs autres pays, les objections « conservatrices » à l'augmentation des déficits et des niveaux de dette feront obstacle à la relance budgétaire nécessaire. Certes, les mêmes acteurs ont bien volontiers réduit l'imposition des milliardaires et des grandes sociétés en 2017, renfloué Wall Street en 2008, et prêté à une poignée de géants des affaires cette année. Mais les choses changent lorsqu'il s'agit d'étendre l'assurance chômage, la couverture santé, et d'autres aides en faveur des plus vulnérables.

Les priorités à court terme sont claires depuis le début de la crise. Priorité évidente, l'urgence sanitaire doit être surmontée (notamment en assurant un niveau suffisant d'équipements de protection personnelle et de capacité hospitalière), dans la mesure où aucune reprise économique ne sera possible tant que le virus ne sera pas sous contrôle. Dans le même temps, les mesures politiques de protection des plus démunis, d'apport de liquidités pour empêcher des faillites inutiles, ainsi que de maintien du lien entre les employés et leur entreprise, sont essentielles pour assurer un redémarrage rapide le moment venu.

Malgré l'évidence de ces priorités inscrites à l'agenda, des choix difficiles devront être faits. Nous ne pouvons procéder au sauvetage d'entreprises - de type détaillants traditionnels - qui déclinaient déjà avant la crise, sans quoi nous engendrerions des entités « zombies », ce qui en fin de compte limiterait le dynamisme et la croissance. Nous ne devons pas non plus renflouer des sociétés qui étaient déjà trop endettées pour pouvoir supporter le moindre choc. Maintenant que les dépenses publiques se déverrouillent à une échelle massive, le public est en droit d'exiger des sociétés bénéficiaires d'aides qu'elles contribuent à la justice sociale et raciale, à l'amélioration de la santé, ainsi qu'à la transition vers une économie plus écologique et davantage basée sur la connaissance. Ces valeurs doivent s'observer non seulement dans la répartition de l'argent public, mais également dans les conditions que nous imposons à ses bénéficiaires.

Comme mes coauteurs et moi-même le soulignons dans une récente étude, les dépenses publiques judicieusement orientées, notamment les investissements dans la transition écologique, peuvent se révéler opportunes, intensives en main-d'œuvre (contribuant ainsi à remédier au problème de l'explosion du chômage), et hautement stimulantes car beaucoup plus rentables que par exemple les baisses d'impôts. Il n'y a aucune raison économique pour que les pays, États-Unis inclus, n'adoptent pas des programmes de relance durable sur la voie des sociétés qu'ils prétendent être.

ismissed former Deputy Commerce Minister Madam Jemima Wolokollie says her life is in danger, days after she was dismissed from her position and subsequently expelled from the ruling Coalition for Democratic Change or CDC party.

Madam Wolokollie told local radio Joy FM that unknown men from the National Security Agency (NSA) have been tailing her since her dismissal and subsequent expulsion from the ruling party.

"Look (referring to what appears to be a failed government loan scheme) because right now NSA is tailing me, my life is in danger," she told her hosts.

But Madam Wolokollie insists that her initial suspension had nothing to do with grudge insubordination to her immediate boss, Prof Wilson Tarpeh, rather it was a fallout from a question she had asked during a meeting in Grand Bassa County back then.

She said it is unfortunate that some of the leaders within the ruling party lack discipline and have refused to be discipline into leadership.


