EDITORIAL

Welcoming IIA's effort in auditors' mysterious deaths

NEWS THAT THE Institute of Internal Auditors (IIA) in Lake Mary Florida, America, has written the United States Government to help with investigation into the mysterious deaths of four government employees in Liberia, including three professional auditors and a manager is encouraging. It is not just welcoming but would bring relief to families of the victims, who are very eager to establish how their relatives died suspiciously at different times under separate circumstances.

PRESIDENT GEORGE MANNEH Weah while speaking at his family church in Rehab Community outside Monrovia recently, appealed to the U.S. government to assist with investigation into the mysterious deaths that have left Monrovia residents panicking and restless.

IIA PRESIDENT AND Chief Executive Officer Richard F. Chambers in a formal communication to U.S. Secretary of State Mike Pompeo, dated 16 October 2020 writes, "While evidence of any wrongdoing in the recent deaths of the four auditors so far appears inconclusive, the United States and Liberia have a special relationship dating back more than 160 years and supporting this notable ally would be an important gesture of our countries' commitment to each other's security."

THE LETTER WITH copy published online, continues: "As you may be aware, four government auditors in Liberia, including the country's senior auditor, recently met with their untimely deaths, and it is our understanding that Liberia President George Weah has reached out to the United States for help in investigating the incidents. The Institute of Internal Auditors, a U.S.-based organization representing public-and private-sector auditors in Liberia and nearly 200 countries and territories, respectfully urges you to accept President Weah's request and authorize the assistance of appropriate U.S. expertise and resources to help review circumstances around the deaths."

WE HAIL MR. CHAMBERS for selflessly moving to solicit his government's support, as earlier requested by President George Weah in unearthing facts surrounding the mysterious deaths. This important to lay all misinformation, disinformation and interpretations to rest, and bring perpetrators to justice.

WE BELIEVE WHOEVER did those killings along with their accomplices has again beamed the world's attention on Liberia for all sinister motives, particularly just as the country prepares for senatorial election and national referendum in December.

NOT ONLY THAT, these suspicious deaths signal to the rest of the world that Liberia is not safe for investment and economic activities thus, subjecting the country to isolation and abandonment.

THIS IS WHY it is very important that Liberian authorities exert all efforts to get to the bottom of these mysterious deaths to restore public confidence both at home and abroad.

IT IS OUR hope that Secretary of State Pompeo would respond favorably to the request to put U.S. government's expertise and resources at the disposal of the Government of Liberia in professionally bringing these matters that seem very related to close.

IT IS HIGHLY regrettable and disappointing that these fine sons and a daughter of our country - Albert Peters, Assistant Commissioner for Internal Audit, Liberia Revenue Authority; Victoria Asmah 'Gifty' Lamah, Manager, Tax Payer Services Division, LRA; George Fahnboto, Auditor, LRA; and Emmanuel BartenNyeswa, Director-General, Internal Audit Agency of Liberia respectively, were discovered dead at different locations in just over eight days, from October 3-10, 2020.

How Israel Failed Its COVID Test

Israel is besieged not only by a deadly virus, but by identity politics, sectarian strife, and dishonest leadership. As the economic consequences of lockdown multiply, social and political tensions will only rise.

TEL AVIV - When the Jewish new year began late last month, Israel was enduring its second nationwide lockdown, after daily per capita COVID-19 infection and death rates reached some of the world's highest levels. How did a country with practically closed external borders, sophisticated technological and institutional capacities, a high-quality and efficient health-care system, and a culture of solidarity in wartime fail so spectacularly at addressing the pandemic?

Although long years of neoliberal economics have certainly taken their toll on the country's welfare system, the answer lies elsewhere. Partly, it is Prime Minister Binyamin Netanyahu's deceitful, divisive approach to managing the crisis - and to governing more generally - that has been laid bare. But, more fundamentally, Israel's pandemic failure reflects the deeply fragmented society and dysfunctional political system of which Netanyahu has taken advantage throughout his career.

The virus has exposed Israel as a polarized federation, whose various tribes put their sectarian interests ahead of the common good. The ultra-Orthodox community, for example, has sought to exercise its autonomy above all - and it has paid the price, with the country's highest COVID-19 infection rates. Though this community comprises only about 12% of Israel's population, it accounts for about half of all infected people over 65 and under 18. Until recently, Israel's Arab community - 21% of the population - did not lag far behind.

But Israel's minorities do not have a monopoly on the defiance of norms. Breaking conventions, an innate lack of discipline, and disregard for authority - the very traits to which some experts attribute the country's extraordinary creativity as a "startup nation" - are national hallmarks. Netanyahu and his ministers who were caught violating the precautionary rules they had imposed on the country reflect a broader phenomenon: The government hasn't exactly been a role model for the unruly public.

Netanyahu has built his career on stoking sectarian divisions. In contrast to French President Emmanuel Macron, who has now launched a campaign against "Islamist separatism" in France, Netanyahu has thrived on a rapidly escalating Kulturkampf. In particular, he has formed a corrupt coalition with the ultra-Orthodox community, whose political support he has bought with the labor and sacrifice of other segments of society.¹

For starters, he actively encourages the unproductive, burdensome lifestyle of the ultra-Orthodox, who have staggeringly high fertility rates (averaging 7.1 children per woman, compared to 3.1 overall). Moreover, barely half of ultra-Orthodox men participate in the labor market. And the community includes about 135,000 yeshiva students, who refuse military service and study only scripture - an education that leaves them unfit for modern life.

Who pays for this lifestyle? Israel's dynamic secular middle class, which produces much of the country's wealth, carries the burden of military service, and accounts for a large share of the government's tax revenues.

Now, the pandemic is compounding these costs. Rather than heeding expert advice and imposing targeted lockdowns on hard-hit communities - such as the ultra-Orthodox - Netanyahu chose nationwide measures, punishing the groups that

make Israel's economy run to avoid targeting a key constituency. The entire country is effectively a hostage to political expediency.

But Netanyahu's motivation for imposing another lockdown extends well beyond mollifying the ultra-Orthodox community. His corruption trial, which has already been delayed by his lawyers' obstructive tactics, will resume in January. Netanyahu would eschew no dirty trick to disrupt the proceedings, which threaten to keep his bribery and corruption scandals, and questions about his fitness to lead, in the national consciousness.

Netanyahu's anti-corruption trial is definitely also a key motive for his repeated thwarting of an agreement on a new budget. As long as there is no agreement, there will be regular opportunities to dissolve parliament and hold new elections, an outcome that might finally enable Netanyahu to form a coalition willing to bar the indictment of a serving prime minister.

To be sure, in late August, Netanyahu agreed to a 100-day extension with his coalition partner, the Blue and White party's Benny Gantz, narrowly avoiding Israel's fourth election in two years. But that probably reflects the fact that opinion polls indicate a sharp decline in support for Netanyahu's Likud party. Netanyahu probably hopes that this will change by the time the next budget deadline arrives.

In the meantime, he is hoping to change the conversation, not by providing real leadership, but by stifling dissent. He has been using the COVID-19 crisis as a pretext for conducting China-style digital surveillance and sharply limiting the freedom to protest.

Mass demonstrations over Netanyahu's alleged corruption and the government's handling of the pandemic have been raging for months. To get protesters off the streets - and out of the news - Netanyahu backed a rule banning protesters from holding demonstrations more than one kilometer (0.61 miles) from their place of residence, under the guise of stopping the spread of COVID-19. The measure was also aimed at appeasing his Orthodox allies, as it created a false symmetry between the ban on protests in open spaces (where the risk of infection is minimal) and the restriction of prayers in synagogues (a hotspot of infections).

But the move backfired. Unable to participate in the single localized protest in front of the prime minister's Jerusalem residence, demonstrators began protesting close to home - all across the country.

This nationwide display of popular rage is also a model of creative, orderly civic resistance. The array of groups leading the charge - with names such as "Black Flag" and "Crime Minister" - largely comprise young, educated, and conscientious Israelis and many self-employed workers facing severe economic hardship. They are unlikely to give up easily, despite Netanyahu's best efforts.

But while Netanyahu's narcissistic leadership demands resistance, the upheaval in Israel carries significant risks. Israel is besieged not only by a deadly virus, but by identity politics, sectarian strife, and dishonest leadership. As the economic consequences of lockdown multiply, social and political tensions will only rise. As President Reuven Rivlin noted ominously last week, "The air is full of gunpowder."

father to allow his son Blamo, Jr. to go to Bomi Hill at the Jungle Gym Diamond Creek to help fix his motorbike.

While preparing for service on Sunday morning, Lovettee Johnson narrates that they were surprised to receive a call informing them that their children got drowned in the river and since then, their bodies are yet to be found.

Police Spokesman Moses Carter says the report received at central from the police investigators in Bong County says a canoe carrying six people allegedly sank in the St. Paul River, adding that three persons survived while the other three remain at large.

The three persons that are at large are said to be the strangers allegedly hired by St. Moses to travel to Bong Mines for the work.

But the daughter of Mr. Robert Blamo, Sr., Robertline Blamo tells the NewDawn that her father and the families of the other missing men were told by community dwellers that the information that a canoe sank in the river in their town was strange news to them.

Robertline explains that the information provided by the residents of Bong Mines prompted a serious protest in the town from the aggrieved families.

According to her, riot police moved to the scene and put everyone indoor, but her father Mr. Blamo and the other aggrieved families are planning to work with the elders and the traditional leaders of the town to find out if there is any possibility that their children might have broken any rule within the town for which could be held.

Robertline concludes that since the missing children's families arrived in Bong Mines, Bong County, they have not seen or heard anything from Mr. Moses Ahoussouhe who had allegedly hired them before they went missing.

She claims that the only information they have gathered from Moses is that he is afraid of unveiling himself to the families because they might want to do harm to him.

On Wednesday, 21 October families of the three missing men intensified protest at the St. Moses Funeral

Parlour on the Somalia Drive, demanding their children from Moses Ahoussouhe.

The family of one of the missing men, Siafa Boimah, joined Bloma's family with support from friends and besieged the main road opposite the St. Moses Funeral Home for hours, causing a huge traffic.

Officers of the Liberia national Police (LNP) later moved in for the third and put things under control.

Speaking on behalf of missing Siafa's family at the protest scene, Hassan Ryan Kamara tells this paper that their family strongly do not want to believe the many stories coming from Bong Mines, Bong County that a canoe carrying six people sank in the St. Paul River and only the three strangers on board got drowned.

Mr. Kamara explains that prior to the incident, victim Siafa Boimah worked as an electrical technician with a mining company that is in alleged partnership with Moses Ahoussouhe's mining company.

According to him, Moses Ahoussouhe allegedly decided not to use the same protocol in doing business with the mining company, but hired Siafa Boimah as an individual to do some electrical work for him at his diamond creek in Bong Mines.

"When we got the news on Sunday that our brother and his friends got drowned in the river, we contacted our family member who is ranking leader in the society over there," says Kamara.

According to Kamara, his brother told the family that he suspects foul play in the matter.

For her part, victim Siafa Boimah's fiancée Zenebu Dukuly narrates that on Wednesday, 14 October, Siafa returned from work and started making a list of electrical materials.

She says Siafa told her that he was going out of town to be back on Friday, 16 October, but she got the news on Sunday that Siafa's phones had been ringing with someone allegedly aborting the calls.

Zenebu laments that she and her three years old daughter have been home alone why worrying and praying that Siafa would return home safely.--

established that Sayon is not a licensed driver to operate a motor vehicle and there was no valid insurance which is a wanton disregard for the safety of persons.

The court indicates that Sayon's acts contravene Section 2.80 of the Vehicle and Traffic of the Republic of Liberia.

In an interview with the defendant at the court, he explains that he was picking up a passenger on Broad Street on Tuesday, 20 October when he got questioned by an officer as to why he had to stop allegedly at a busstop.

He claims that he has a license and the car in question is allegedly insured. However Sayon indicates that he has already misplaced his driver's license after an accident that occurred before his encounter

with the officer in central Monrovia.

"I have a license but," he alleges, saying he got a new driver's license last month but he didn't go to the court to challenge the officer.

He says he only wants to appeal to the judge, asking the judge to call Zone 9 Police Depot to confirm that he has documents for his vehicle.

"Please I did not [come] here for [a] challenge; I want you to understand that please," he says during the interview, adding that he didn't go to the court with a lawyer because he never intended challenging the ticket issued by the police.

"I came to find a remedy so I can be able to, because the car is parked at Slipway Depot," he concludes.

PHIL, MERCK partner to reach girls with HPV vaccine in Liberia

A partnership has begun between Public Health Initiative Liberia (PHIL) and MERCK & Co, an American Multinational Pharmaceutical company for the conduct of social mobilization to increase the demand for the Human Papilloma or HPV Vaccine for the prevention of Cervical Cancer.

by the Human Papilloma Virus (HPV) which is the leading cause of cancer found in Liberian women between the ages of 15 to 45-years. Studies found that there are over 100 types of HPV, with at least 14 known to cause cancer. According to WHO, types 16 and 18 are mostly responsible for 70percent of cervical cancer cases in the

In November of 2019, the government of Liberia through the Ministry of Health's Expanded Program on Immunization with support from Gavi, the Vaccine Alliance launched the HPV Vaccine as part of the routine immunization services for girls at the age of 9 to prevent Cervical Cancer.

Given that HPV is a sexually transmitted infection, the vaccine is highly effective when administered to children. Currently, the government is prioritizing girls that are nine-years-old.

The vaccination is ongoing at all public and private health facilities in the 15 counties that do offer immunization services and is being administered twice, one after every six months for girls at the age of nine.

The need for the ongoing mobilization and community engagements cannot be overemphasized as the shutdown of schools coupled with the fear of visiting facilities because of COVID-19 among Liberians has affected the demand generation activities around this vaccine.

PHIL executive Director Madam Joyce L. Kilikpo believes that the support from MERCK came at a critical time as all efforts are being made by governments and partners in ensuring important services such as routine immunization is not affected badly due to the

world. HPV is the main cause of cervical cancer, which is leading cancer in Liberia women between the ages of 15 and 45. Representative Gabriel Nyankan heads the propaganda aspect of the campaign.

Mr. Andrew Peters of the National Patriotic Party is named as national campaign manager while Gender Minister Mrs. PisoSaydee-Tarr takes charge of media and communication.

CDC Youth League Chair and Monrovia Mayor Jefferson T. Koijee serves as operations man, while Dr. Samora P. Z. Wolokolie is the policy and strategy person.

Mr. John S. Youboty is named as treasurer, Mr. Randolph C. J. Cooper, finance officer and Mr. Bill Twehway, county coordinator.

Commenting on criticism against President George Manneh Weah for the downturn of the economy, Chairman Morlu argues that Mr. Weah is working tirelessly to turn the table, adding that the challenges Liberia faces have existed from the foundation of the country.

He alleges that President Weah has built more roads than former President Ellen Johnson Sirleaf, claiming that things are now falling into their rightful place.

Morlu expresses thanks and appreciation to the Liberian people and supporters of CDC for standing with President Weah during the trying times of the country.

According to him, the economy dropped drastically due to the departure of the United Nations Mission in Liberia (UNMIL) and the international community, but opposition leaders are blindly accusing the president for something that he inherited.

Pope Francis supports same-sex unions

Pope Francis is calling for same-sex couples to have legal protection when forming civil partnerships, the BBC reports.

The Potif's latest comment comes as a clear contradiction on his earlier stance on homosexual marriage, having been reportedly quoted as saying, that legally equating same-sex relationships to heterosexual marriages would be "an anthropological regression".

Pope Francis had also said that if same-sex couples were allowed to adopt, "there could be affected children ... every person needs a male father and a female mother that can help them shape their identity".

But the BBC says speaking in a TV documentary called Francesco just released in Rome, the Pope, in an apparent turnaround, said that nobody should be thrown out or be made miserable because they are homosexual.

comments on civil unions, the film also shows him encouraging two gay men to attend church with their three children.

The BBC notes that this is his first vocal backing as Pope - and will undoubtedly be welcomed by many on the more liberal wing of the church and criticised by the conservatives.

Pope Francis's biographer, Austen Ivereigh, told the BBC he was "not surprised" by the latest comments.

"This was his position as Archbishop of Buenos Aires," said Mr Ivereigh. "He was always opposed to marriage being for same-sex couples. But he believed the church should advocate for a civil union law for gay couples to give them legal protection."

Under current Catholic doctrine, gay relationships are referred to as "deviant behaviour".

In 2003, the Vatican's doctrinal body, the



Correspondents say it's thought to be the first time he has suggested civil law should support LGBT couples in a partnership.

Observers say the comments are his clearest remarks yet on gay relationships, in a documentary directed by Evgeny Afineevsky.

"Homosexual people have a right to be in a family," he said in the film, which according to the BBC, premiered on Wednesday, 21 October 2020, saying "They are children of God and have a right to a family. Nobody should be thrown out or made miserable over it."

Pope Francis: "What we have to create is a civil union law. That way they are legally covered."

The film Francesco, about the life and work of Pope Francis, premiered as part of the Rome Film Festival.

As well as the Pope's

Congregation for the Doctrine of the Faith, said that "respect for homosexual persons cannot lead in any way to approval of homosexual behaviour or to legal recognition of homosexual unions".

It remains to be seen how the Catholic Church in Africa, including Liberia would react to the Potif's latest stance on such an issue that has shook the Roman Catholic Church globally to its foundation, with victims coming public after years.

The BBC says in 2019, the Southern African Catholic Bishops' Conference (SACBC) admitted that 35 cases of clerical abuse of minors have been reported in South Africa since 2003, and three priests were defrocked, and one is serving a life sentence for the crime, while in Liberia, a former priest wrote to the Vatican alleging sexually predatory behaviour by two bishops.

-As family intensifies protest for 3 missing men

Residents in Bong Mines where three grown up men allegedly hired by funeral home proprietor Moses Ahoussouhe went missing, have told protesting family members that it's a strange news coming from Monrovia that the victims drowned in the St. Paul River in the town, sparking new concerns on the

men's whereabouts.

On Tuesday, 20 October, aggrieved members of three separate families and friends representing Robert Blamo, Jr., 29, Siafa Boimah, 33 and Blama protested at the St. Moses Funeral Parlour in Topoe Village demanding the proprietor Moses Ahoussouhe to produce the three men.

According to the spokesperson of the protesters

Lovettee Johnson, these men were all motorcycle technicians specialized in heavy duty motor bikes.

According to Lovettee, since Saturday, 15 October, Mr. Ahoussouhe who popularly is called by the name of his funeral home St. Moses, allegedly called the father of the Blamo, Jr., asking the

Koijee's order leaves many heads scratching

Business owners, bankers and employees of offices on Broad Street, in central Monrovia had a rude awakening on the early morning of Wednesday October 21, when they were told they could no longer park their vehicles in front of their offices and stores.

This was a new order from Monrovia City Mayor Jefferson Koijee, without a prior. Men dressed in city

police uniforms had been deployed to enforce this overnight mandate. It came as a military order," one lawyer told this writer. "Can you imagine the kind of country we are living in nowadays," added another.

Both men work at a local law firm with its office directly situated on the main street.

Broad Street is one of the most busiest streets in Monrovia, and with no public or private parking lot in the country, many business owners,



bankers and stores owners including customers usually park their vehicles on the sidewalk in front of their stores or offices.

But all that was changed on Wednesday, as officers from the City Mayor's office patrolled the street ensuring that no one park his or her vehicle on the street.

The officers refused to provide answers to office
